The mission of the Institute is to safeguard and transmit the intangible cultural heritage of traditional Chinese medicine(TCM), to research TCM culture, and to transmit the history, literature, and cultural artefacts related to TCM for the purposes of preserving the worldview and life-view of TCM. Our duty is to assist the communities and groups concerned to inscribe their intangible cultural heritage of TCM into the inventories and to support their safeguarding work. We also make suggestions to government bodies regarding policies for safeguarding, and promote awareness of the importance of the safeguarding of the intangible cultural heritage of TCM to the general public through education and exhibitions.

The Institute for the History of Chinese Medicine and Medical Literature includes the Research Centre for Chinese Medical Culture, the Research Division for Chinese Medical History and the Research Division for Literature of TCM, the Museum for the History of TCM, as well as other organizations. We have been engaged in safeguarding and researching the culture, history, literature and artefacts of TCM for many years. Since 2004, when China joined the "Convention for the Safeguarding of the Intangible Cultural Heritage," the Institute, in keeping with the spirit of the Convention, has developed a large number of projects related to the safeguarding of the intangible cultural heritage of TCM.

- 1. Taking the initiative to bring the concepts and methodology related to safeguarding intangible cultural heritage into the Chinese medicine community. Organizing the effort to inscribe heritages of TCM into the National Inventory of Intangible Cultural Heritage.
- 2. Supporting the application of "Traditional Chinese Medicine" for inscription into the "Representative List of the Intangible Cultural Heritage of Humanity." We also guided the entry of "Acupuncture and moxibustion of traditional Chinese medicine" into the list.
- 3. Developing a national-scale initiative to survey and research the intangible cultural heritage of TCM. We procured a large amount of first-hand materials and have organized them for use in further research.
- 4. Working in close contact with the communities and groups concerned. From 2006-2011, we continuously organized conferences and forums for the purpose of disseminating information regarding the concepts and methodology of intangible cultural heritage to the communities and groups concerned. We have worked in close cooperation with the communities and groups concerned to make progress towards the

transmission and development of the intangible cultural heritage of TCM.

- 5. Pioneering the development of the theory of safeguarding intangible cultural heritage of TCM. We have published monographs and books on this subject, and have made policy suggestions to relevant government bodies.
- 6. We have organized six exhibitions on intangible cultural heritage of TCM in Beijing, Chengdu, and other places in China. We have also used media resources, such as newspaper columns and public competitions regarding intangible cultural heritage of TCM, to educate the general public and raise awareness of the importance of safeguarding intangible cultural heritage of TCM.

There are currently 44 members and personnel in the Institute, most of whom are researchers engaged in researching the culture, history, literature and artefacts of TCM. The Director of the Institute, Liu Changhua, was the first person to bring the concepts and methodology related to safeguarding intangible cultural heritage into the Chinese medicine community. He is also a member of the National Expert Committee for Intangible Cultural Heritage. He has made a great contribution to research on safeguarding intangible cultural heritage of TCM and has many achievements in this area. Due to his outstanding contributions, he was awarded the title of "Progressive Worker for the Safeguarding of National Intangible Cultural Heritage" by the China Ministry of Culture.

The Institute for the History of Chinese Medicine and Medical Literature is engaged in researching the culture, history, literature and artefacts of TCM. For many years, we have worked in close cooperation with communities and groups that create, maintain and transmit intangible cultural heritage of TCM. In recent years, due to our work in developing projects for safeguarding intangible cultural heritage of TCM, we have worked with these communities and groups concerned even more closely and have a deep understanding of their goals and needs regarding safeguarding. We assisted these communities and groups in applying for the National Inventory of Intangible Cultural Heritage. The Institute has already organized 3 batchs of 75 items related to TCM to be inscribed in the National Inventory of Intangible Cultural Heritage. From 2006-2011, we continuously organized forums on safeguarding intangible cultural heritage of TCM. Based on the principle of mutual respect, we engaged in exchange and dialogue with the communities and groups concerned. These forums also allowed us to communicate about the concepts and methodology of intangible cultural heritage and to further understand the difficulties they face in safeguarding intangible cultural heritage of TCM and collaborate in finding solutions. We collected and organized community opinions and made policy suggestions to the government based on our conclusions.
