Background: Following a proposal by the Government of the People's Republic of Bangladesh to establish the International Mother Language Institute (IMLI) in Dhaka as a category 2 institute under the auspices of UNESCO, a technical mission was undertaken in November 2014 to assess its feasibility. The evaluation of the proposal was carried out in conformity with the criteria outlined in document 37 C/18 Part I.

Purpose: Following 197 EX/Decision 16 Part II, the present document contains a draft resolution for the approval of the granting to the Institute of the status of a category 2 institute under the auspices of UNESCO. For reference, document 197 EX/16 Part II describes the proposal and reviews the prerequisites for the establishment of the Institute, and provides the scientific and institutional rationale behind the proposal of Bangladesh in conformity with document 37 C/18 Part I relating to the principles and guidelines for the establishment and functioning of institutes and centres under the auspices of UNESCO (category 2) as approved by the General Conference in 37 C/Resolution 93.

Decision required: paragraph 3.

1. The Executive Board, at its 197th session, considered document 197 EX/16 Part II on the proposed establishment of the International Mother Language Institute (IMLI), in Dhaka, Bangladesh, as a category 2 institute under the auspices of UNESCO. Having examined the above document, which describes the proposal and analyses its feasibility in accordance with the guidelines contained in document 37 C/18 Part I relating to the principles and guidelines for the establishment and functioning of institutes and centres under the auspices of UNESCO (category 2) as approved by the General Conference in 37 C/Resolution 93, the Executive Board welcomed the proposal to place this institute under UNESCO's auspices.

2. Background: Following a proposal by the Government of Ethiopia to establish an African Regional Centre for Ecohydrology (ARCE) in Addis Ababa as a category 2 centre under the auspices of UNESCO, a UNESCO mission was undertaken in June 2015 as part of the evaluation of the feasibility of establishing the proposed Centre, which would specialize in and provide support to regional research and cooperation in the field of environmental protection and sustainable development within the context of the ecohydrology theme of the International Hydrological Programme of UNESCO. A draft agreement between UNESCO and the Government of Ethiopia has been prepared in conformity with the standard model agreement indicated in document 37 C/18 Part I and is available on the Natural Sciences web pages for consultation.
