## **CONCEPT NOTE** 1

World Heritage properties such as living religious and sacred sites, constitute to this day the largest thematic category on the World Heritage List, and require specific policies for protection and management that take in account their distinct associated sacred or spiritual value as a key factor for their conservation.

It is in this spirit that the World Heritage Committee, during its 35th session (Decision 35 COM 5A, UNESCO, 2011) requested the World Heritage Centre, in collaboration with the Advisory Bodies, to elaborate a thematic paper proposing to State Parties general guidance regarding the management of their cultural and natural heritage of religious interest, and in compliance with the national specificities.

In conformity with the World Heritage Committee Decision 37 COM 5A, the Initiative on Heritage of religious interest is managed by the Steering Group in charge of coordinating the elaboration of the thematic paper composed of officially designated World Heritage Centre and the Advisory Bodies (ICOMOS, ICCROM, IUCN) representatives.

The establishment of a constructive dialogue with all stakeholders concerned is essential for developing general guidance on management of heritage of religious interest towards deeper understanding of associated sacred and spiritual values of World Heritage properties and their link with Outstanding Universal Value. Such meeting with international experts and religious communities can also provide crucial inputs in developing the most appropriate approaches in tackling challenging problems of heritage protection and generating understanding and mutual respect.

In 2013, it was announced by the World Heritage Centre, that a *cycle of Thematic Consultations*<sup>2</sup> should be launched world-wide, through a selected sample of representative case studies, for addressing sustainable management and use of properties of religious interest.

Following the thematic and regional activities and consultations, such as the International Seminar for religious representatives involved in the management and use of the World Heritage properties (Moscow, Russian Federation, 2013), the Multidisciplinary Workshop on the Strategic Framework for the Conservation and Management of the Mount Athos Cultural and Natural Heritage (Thessaloniki, Greece, 2013), ICCROM Forum on Asian Buddhist Heritage (Seoul, Korea, 2013), IUCN World Parks Congress (Sydney, Australia, 2014), the UNWTO Congress on Tourism and Pilgrimage (Santiago de Compostela, Spain, 2014) and the UNWTO Conference on Religious Heritage and Tourism (Elche, Spain, 2014), the State Party (TBC SPECIFY) decided to support an *Experts Thematic Consultation Meeting* on sustainable management of the World Heritage properties of religious interest with focus on (REGION TBC). This meeting could be organize in support of the UNESCO's work to implement the World Heritage Committee decisions on heritage of religious interest.

These consultations will, among others, be based on the results of the second cycle of the **Periodic Reporting exercise** and will take into account a number of conclusions and recommendations drawn from the state of conservation reports and previous international meetings and activities related to this subject.<sup>3</sup>

Moreover, the initiative and the cycle of its activities are implemented in close coordination with other World Heritage Programmes and initiatives<sup>4</sup>, and take into account the relevant United Nations General Assembly resolutions and documents, such as for example the *Global Code of Ethics for Tourism*, endorsed by the United Nations General Assembly in 2001.<sup>5</sup>

## **Overall Objective**

The main objective of this Expert Meeting would be to contribute to the development, by the WHC/Advisory Bodies Steering Group on Heritage of Religious Interest, of the thematic paper proposing to States Parties general guidance regarding the management of their cultural and natural heritage of religious interest, and in compliance with the national specificities, as requested by the World Heritage Committee.

## **Expected output**

The main output of the meeting shall be draft recommendations for development of general guidance regarding the management of the cultural and natural heritage of religious interest in compliance with the national specificities.

## **Proposed thematic areas for discussions:**

- 1. Understanding heritage of religious interest
- Discussion on mapping of World Heritage cultural and natural properties of religious interest and definition of thematic sub-categories;
- Development of a preliminary cross-cutting contextual frame ("une grille de lecture") as a necessary basis for the development of an outline of the *General Guidance*;
- 2. Assessing values, attributes and aspects of authenticity
- Discussion on the establishment of recommendations on how to assess Outstanding Universal Value and associated sacred or spiritual values of properties
- Guidance on identification of attributes and aspects of authenticity
- 3. Conservation and management
- Consolidation of knowledge on study, development and practical application of national and international normative instruments in terms of cooperation between state and religious communities for the preservation of World Heritage properties;
- Discussion on World Heritage management requirements and their implications at property of religious interest levels including access for visitors, heritage specialists, pilgrims, prayers;
- Discussion on current conservation and management regimes within the World Heritage properties of religious interest
- Discussion on definition of the key contextual issues related to heritage protection and factors affecting the World Heritage properties of religious interest;
- Sharing experiences, information and perspectives in terms of efforts undertaken to balance the competing requirements of faith and conservation;
