## Questions and Comments from board members as regards the modification of rules:

On the addition of the rule 6.4 of The Rule of administration for the Governing Board and the deletion of the rule 2-1 of Rules for the Executive Committee

Curtis: Clarification of the relationship between committee and board is needed. Advisory body is necessary for technical substantive research issues advised by the board's decisions and quality controls.

Chair: What do you think on the relationship between committee and board, prof. Kono?

Kono: The relationship between board and committee and the function of advisory board needs clarification. This is very important point and we must clarify them at this meeting.

Chair: On the relationship between board and committee, what do you think?

Curtis: On rule of executive committees function, I would like to remove the first paragraph (2-1). When compared with rule 2.1 of governing board, what is the function of governing board if the five items of rule 2-1 of the executive committee is transferred to and discussed in the executive committee? So the rule 2-1 of executive committee must be deleted. On the rule 2-2, it remains undeleted. Fujimoto: On the budget, if it should be discussed in the governing board, the board should be yearly held. What do you think on this point?

Curtis: On the budget, at the governing board, we discuss the budget supposing that it would be almost the same in the second year.

Kono: The work plan and budget is the most important matter concerning on the activity of the IRCI. We discuss the budget at the board supposing that there would

be no major change on the second year's budget. If there is a very large modification on the budget of the second year, we can discuss it using, for example, TV conference.

Other board members: We can use document review, mail review and other devices to discuss such problems.

Fujimoto: Rule 6.4 is added to the Rule of Administration for the Governing Board to use the TV conference and other remote communications to held governing board.

Kono: Rule 2-1 of executive committee will be deleted?

Chair: We adopt the rules with the modification discussed above.

On the modification of the rule 3 (7) of Rules for the Executive Committee and modification of the rule 2 of Rules for the Advisory Body and addition of the rule 3.2 of Rules for the Advisory Body

Chair: On the rules for the advisory body, how do you think of the member of the body that is prescribed in rule 3?

Curtis: We also need to discuss the rule 2 of advisory body. It is not clear that the minimum number of the body and the region from which the member will be selected.

Kondo: Who has the appointive power of Advisory Board? I suggest that at least one member of the body shall be selected from the area other than the Asia-Pacific region.

Fujii: We are thinking that members of Advisory Board are recommended from Society for Japanese Folk Music.

Chair: Who has the appointive power?

Fujimoto: I would like to suggest that the Centre shall submit the list of candidates for the members of the advisory body to the governing board for its approval.

Board members: I agree it.

Kondo: On rules of the process of selection of the member, it will be inscribed to the rule?

Fujimoto: Yes. That is added as the rule 3.2. On the rule 3(7) of Rules for the Executive Committee, we would like to add the phrase because there is no previous

explanation of the advisory body if we delete the rule 2.1 of Rules for the Executive Committee.

Kono: If we delete rule 2.1 of the Rules for the Executive Committee, we also need to modify the rule 2 of the advisory body because there is no subject discussed at the advisory body. We need to modify the rule 2. I shall propose the modified rule.

Kono: It is consisted of two sentences. The advisory body shall advice the Centre for its implementation of examinations, adoptions and decisions of the Governing Board as according to the rule of administration for Governing Board. The advisory body shall receive reports on the Centre's above mentioned implementation.

Curtis: The first one is good, the second one makes me wondered. The report should be directly presented to the Board and Advisory Body advices to the Board on the report. The report line should be one.

Curtis: If the Board requests the advice to the Advisory Body, the Body will advice to the Board on the report submitted.

Chair: The first sentence is as prof. Kono suggested, the second sentence is as Mr. Curtis modified.

Kondo: The Advisory Body will, shall or may?

Curtis: "shall" is too strong.

Curtis: The advisory board may advise the governing board on the report submitted by the Centre.

Fujimoto: They will be added to the rule 2.
