<u>Item 6A of the Provisional Agenda</u>: Distribution among electoral groups of membership of the Intergovernmental Committee for the Safeguarding of the Intangible Cultural Heritage

SUMMARY

Article 5 of the Convention establishes an Intergovernmental Committee for the Safeguarding of the Intangible Cultural Heritage which is to be composed of representatives of States Parties to the Convention and which is to be elected by the States Parties meeting in General Assembly. This document contains a proposal for the distribution among electoral groups of membership of the Committee.

Decision required: paragraph 5

- 1. Pursuant to Article 5.1 of the Convention, the General Assembly shall elect an Intergovernmental Committee for the Safeguarding of the Intangible Cultural Heritage, hereinafter referred to as "the Committee", which will be composed of representatives of 18 States Parties.
- 2. As of 27 June 2006, the Convention is in force among the following 45 States:

- 3. Article 5.2 of the Convention also provides that the number of States Members of the Committee is to be increased to 24 once the number of the States Parties to the Convention reaches 50. If that number is reached before the first Committee meeting, it is desirable that the General Assembly convenes an extraordinary session in order to elect six additional Committee Members.
- 4. Pursuant to Rule 13 of the provisional Rules of Procedure for the purpose of the election at the 1st ordinary session of the General Assembly, the distribution of the 18 seats among the six electoral groups would be as follows:

The General Assembly,

- 1. Having examined document ITH/06/1.GA/CONF.201/6A,
