Action Plan for Implementing the World Heritage Convention in South-East and North-East Asia

Introduction

The UNESCO Workshop on Periodic Reporting Follow-up for Cultural World Heritage in North-East and South-East Asia took place at the Historic City of Malacca, Malaysia from 12 to 16 December 2005. Some fifty participants representing fourteen Asian States Parties and observers were present at the Workshop. The participating countries included: Brunei Darussalam, Cambodia, China, DPR of Korea, Indonesia, Lao PDR, Japan, Malaysia, Mongolia, Philippines, Republic of Korea, Singapore, Thailand and Vietnam. A list of participants to the Workshop is enclosed in **Annex 1**.

It should be noted that this was the first time that observers from Brunei Darussalam and Singapore participated in UNESCO activities on the implementation of the 1972 World Heritage Convention.

The organization of the UNESCO Workshop on Periodic Reporting Follow-up in South-East and North-East was decided in December 2004 during the seventh extraordinary session of the World Heritage Committee (Paris) when the work plan for Periodic Reporting follow-up in Asia and the Pacific Region was adopted.

Between 1997 and 2003, States Parties of Asia and the Pacific region, in collaboration with the UNESCO World Heritage Centre and the Advisory Bodies to the World Heritage Committee (ICOMOS, IUCN and ICCROM), carried out the first cycle of the Periodic Reporting exercise, by which thirty-nine (39) States Parties reported on the application of the World Heritage Convention and the state of conservation of eighty-eight (88) World Heritage properties inscribed on the World Heritage List up to and including 1994. In addition, States Parties were requested to provide updated information on management and administrative arrangements, on factors affecting the property and on existing monitoring mechanisms.

To follow-up on the first cycle of the Periodic Reporting, the World Heritage Committee adopted a regional programme called *ActionAsia: 2003-2009* in July 2003. This Workshop is one of the sub-regional activities organized by the UNESCO World Heritage Centre in line with the Committee's decision.

Objectives of the Workshop

- provide the participants with a training opportunity on the revised Operational Guidelines and provide a Forum to exchange opinions and concerns on conservation and management of cultural World Heritage in North-East and South-East Asia;
- review of issues emerged from the first cycle of the Periodic Reporting exercise, pertaining to cultural heritage properties in the region;
- elaborate Action Plans in line with four strategic objectives (4Cs) adopted by the World Heritage Committee in 2002 (Credibility, Conservation, Capacity-building and Communication) to address the needs of States Parties concerned;
- Present some useful tools to improve the state of conservation of cultural heritage properties, such as site management planning, including tourism management; cultural heritage and Environmental Impact Assessment (EIA), and to develop monitoring indicators on the state of conservation;

Main activities during the Workshop

The Workshop was the first meeting of national experts and site managers from the States Parties of North-East and South-East Asia to discuss the common issues emerged from the first cycle of the Periodic Reporting Exercise and to develop an effective Action Plan to follow-up on Periodic Reporting. The meeting was also an important training activity on the revised Operational Guidelines for the Implementation of the World Heritage Convention (February 2005).

While preparing the Workshop, the participants were requested to prepare their country presentations on:

- 1. the general overview of cultural World Heritage conservation in the participant's Government: current situation and major challenges in the preservation of cultural World Heritage properties.
- 2. one of the inscribed cultural World Heritage properties or one Tentative List site, introducing its values, management and conservation issues, including monitoring indicators to examine the state of conservation.

The country presentations focused on the main issues regarding the conservation and management of World Heritage cultural properties and the main areas they would need assistance, at national, regional and international levels. These presentations, either thematic or country/site-based, helped the participants to understand the World Heritage conservation process and develop an effective Action Plan to implement the WH Convention.

Three Working Groups were organized during the Workshop, focusing on the elaboration of Action Plans in line with the four Strategic Objectives (the four "Cs") adopted by the World Heritage Committee. The UNESCO staff and international resource persons were attached to the Working Groups to act as facilitators. Each Working Group identified a Rapporteur to record the conclusions of discussions and prepare the Draft Action Plan to be developed by the Group. The final Action Plan (attached) was formulated on the basis of the thematic and country presentations and discussions. The Rapporteurs of the Working Groups presented the Draft Action Plan formulated during the Workshop. The UNESCO World Heritage Centre, with the assistance of the Rapporteurs, finalized the Action Plan and sent it to all participants for comments. The current document was finalized by April 2006 and was ready for presentation to the 30th session of the World Heritage Committee in July 2006.

With the excellent logistical support from the Department of Museums and Antiquities, the Ministry of Culture, Arts and Heritage of Malaysia, it was possible produce on-the-spot a hand-out proceeding of the Workshop and two CD-Roms, containing the Basic Information Documents (World Heritage publications on the State of World Heritage in Asia and the Pacific etc) and the other composed of all Powerpoint presentations made by the country representatives, UNESCO staff and international resource persons during the Workshop.

The Action Plan for Periodic Reporting Follow-up in North-East and South-East Asia

The Action Plan defines concrete actions that could be implemented by the countries concerned, either individually or collectively, in order to address the needs identified through the Periodic Reporting exercise. These actions are in line with the four Strategic Objectives set by the World Heritage Committee in 2002 (the four "C's": Credibility, Conservation, Capacity-Building and Communication) and consistent with the main recommendations adopted by the Committee at the time of its consideration of the Periodic Reporting exercise for Asia and the Pacific in 2003. It is expected that each State Party of North-East and South-East Asia would identify, within this Action Plan, its own priorities for implementation over the next years, and thus determine a "National" Action Plan as a basis for cooperation with the UNESCO World Heritage Centre and the Advisory Bodies (ICOMOS and ICCROM).

This Action Plan should be implemented, to the extent possible, over the next few years, with resources from the States Parties' own budgets, the World Heritage Fund and other possible external sources. A key indicator to assess implementation and facilitate the achievement of the stated objectives will be the establishment, within each of the eastern Asian State Party, of a national World Heritage coordinating mechanism, involving all concerned institutions, NGO and the academic sector (See Action Plan, under "Credibility"). The setting up of these focal points for World Heritage activities within each country will greatly enhance their capacity to implement the Convention.

Among the most interesting results of this consultation were the proposal to organize a series of sub regional and/or national workshops on Sustainable Tourism Management in North-East and South-East Asia, with specific reference to visitor management and site interpretation; the

identification of a number of potential themes for serial and trans-boundary nominations in Asia and the Pacific region, such as the cultural routes of the Silk Road, Sacred Mountains, and a focus on site management and the need to strengthen capacity of States Parties in cultural heritage conservation.

The outcome of the Workshop will be presented to the World Heritage Committee at its 30th session in July 2006, together with the outcomes of three other similar Workshops, which were organized to follow-up on the Asia-Pacific Periodic Reporting exercise in the Pacific (October 2004), South Asia (April 2005) and Central Asia (November 2005).
