The Russian

Federation shall abide to the provisions of the Convention in reference to those two elements.

Currently, the World Heritage concept is not sufficiently reflected in the legislation. There is on-going development of the amendments to the acting federal laws, as well as improvement of legal and practical regulation in accordance with the Convention provisions.
