Robert Frank (France) is Professor of the History of Contemporary International Relations at the University of Paris I, Panthéon-Sorbonne, and Director of Identities, International Relations and Civilisations of Europe (IRICE). He is also Chairperson of the Commission of History of International Relations. His many publications and articles concern the history of international relations in the twentieth century and include “Penser historiquement les relations internationales” [A historical approach to international relations], *Annuaire français des relations internationales*, 2003. He coordinated issues of the review *Relations internationales*, No. 115 and 116 (autumn and winter 2003) on the theme “Diplomacy and cultural transfer in the twentieth century”.

Ilya V. Gaiduk (Russia), Ph.D., Senior Research Fellow, Institute of World History, Russian Academy of Sciences. Fellow in 2005-2006 at the Woodrow Wilson International Center for Scholars, Washington, DC. Formerly a fellow of the Norwegian Nobel Institute in Oslo (1995) and of the Kennan Institute for Advanced Russian Studies (2001-2002) in Washington, DC. Ilya Gaiduk’s main area of scholarly interest is Cold War history and Soviet foreign policy during the Cold War. The ongoing project deals with the study of Soviet policy on the United Nations during the Cold War era. It also involves an analysis of Soviet attitude towards United Nations specialized agencies, particularly, towards UNESCO and ECOSOC, at various periods of the Cold War. Ilya Gaiduk is the author of “The Great Confrontation: Europe and Islam through the Centuries” (Chicago: Ivan Dee, 2003), “Confronting Vietnam: Soviet Policy toward the Indochina Conflict, 1954-1963” (Washington: Wilson Center Press; Stanford: Stanford University Press, 2003) and “The Soviet Union and the Vietnam War” (Chicago: Ivan Dee, 1996). He is a co-editor of a number of books on Cold War history published in Russia.

Mohieddine Hadhri (Tunisia), Professor of international relations at the University of Tunis. He is Docteur d’Etat from the University of Paris I, Sorbonne (1983). Founder and Director of the Centre for Mediterranean and International Studies in Tunis (CETIMA), Mohieddine Hadhri is also a founding member of the “Société Internationale des Historiens de la Méditerranée” (SIHMED). He is an organizer of many seminars and colloquia on contemporary issues relating to the Mediterranean region and North-South relations. Professor Hadhri is the author of some fifty publications and articles concerning the Maghreb, the Mediterranean and the Arab World, in particular: “Dialogue de Civilisations en Méditerranée”, Tunis, ed. L’Or du Temps, 1997, 234 p.; “La Méditerranée et le Monde arabo-méditerranéen aux portes du XXI^e Siècle : Choc de Cultures

ou Dialogue de Civilisations ?”, Tunis, Centre de Publication Universitaire, 2004, 245 p. and “L’Europe et le Monde arabe: Dix ans après Barcelone. 1995-2005”. Professor Hadhri’s ongoing research deals with various issues relating to the “New International Order in a Global World”.

Akira Iriye (Japan) is Charles Warren Research Professor of History, Harvard University. Professor Iriye is a senior scholar in the field of the history of international relations. He is the author of numerous books dealing with international relations in general and with international organizations in particular, including *Cultural Internationalism and World Power* (1997) and *Global Community: The Role of International Organizations in the Making of the Contemporary World* (2002). He is working on a short history of the contemporary world that will stress the theme of dialogue or conflict among civilizations, and on a global history of the United States of America.

José Paradiso (Argentina) is Director of the School of International Relations at the Salvador University (Buenos Aires) and Director of the Master’s Programme in Latin American Integration at *Universidad de Tres de Febrero* (Buenos Aires). He is Professor at the Buenos Aires campus of the University of Bologna. José Paradiso is a specialist in international relations, security and regional integration issues and the author of many publications on foreign policy, international relations and contemporary Latin American history and integration.

Emma Rothschild (United Kingdom) is Director of the Centre for History and Economics and has been a Fellow of King’s College, Cambridge, United Kingdom, since 1988. Since 2004, she has been Visiting Professor of History at Harvard University. She has also taught at the Ecole des Hautes Etudes en Sciences Sociales in Paris. She is the chairperson of the Kennedy Memorial Trust and of the United Nations Foundation Board Executive Committee. She has written extensively on economic history and the history of economic thought. *Economic Sentiments: Adam Smith, Condorcet and the Enlightenment* was published in 2001 by Harvard University Press in English, and in Italian and Portuguese in 2003.

Jean-François Sirinelli (France) is Professor of Contemporary History (Chair of twentieth-century political and cultural history) and Director of the History Centre at the Institute of Political Science of Paris (Science Po). He is Chairperson of the French Committee of Historical Sciences and co-Director of the *Revue historique*. His most recent works are *La culture de masse en France de la Belle Epoque à aujourd’hui* [Mass culture in France from the Belle Epoque to the present] (Fayard, 2002, edited jointly with Jean-Pierre Rioux) and *Les Baby-boomers* (Fayard, 2003). He has just published *Comprendre le XXe siècle français* [Understanding twentieth-century France] (Fayard).

Glenda Sluga (Australia) is Associate Professor of History at the University of Sydney. She is currently working on an international history of the ideas of nation, race, and rights, which focuses on the formation of a new world order during the two decades after 1945 and the implementation of these ideas in the creation and organization of the United Nations and UNESCO. Her work is being funded by the Australian Research Council. She has developed her interest in these themes in a number of publications, including most recently *The Problem of Trieste and the Italo-Yugoslav Border* (SUNY, 2001) and *The Nation, Psychology and International Politics, 1870-1919* (Palgrave Macmillan, forthcoming). She is also editing with Sunil Amrith a special issue of *The Journal of World History* devoted to new historical work on the United Nations.

Romila Thapar (India) is Professor Emeritus at the Jawaharlal Nehru University, New Delhi. Her principal area of study is Ancient India. Romila Thapar is also known for her involvement in bringing historical knowledge to a wider public. Her major works are *Asoka and the Decline of the Maurya*, *Ancient Indian Social History: Some Interpretations, Recent Perspectives of Early Indian History* (editor), *A History of India Volume One* and *Early India: From the Origins to AD 1300*. She has taken a strong stance against communalism and the communalisation of history textbooks.

In 2003, she was the First Holder of the Kluge Chair in Countries and Cultures of the South at the Library of Congress, United States of America.

Ibrahima Thioub (Senegal) is Professor of Modern and Contemporary History and Director of the Department of History at Cheikh Anta Diop University in Dakar. He is President of the West African Research Association (WARA).

- Editor of the review *Afrique et Histoire*;
- Co-Director of the Groupe d'études et de recherche sur l'exclusion et la marginalité au Sénégal (GERMES) [Study and research group on exclusion and marginality in Senegal], Cheikh Anta Diop University, Dakar.

Current research:

- Knowledge-control policies in the French West African colonies;
- History of confinement in Senegal.

He is the author of many publications, in particular in the fields of contemporary African history and of methodological issues in writing history in and about Africa.

Thomas G. Weiss (United States of America) is Presidential Professor of Political Science at the City University of New York (CUNY), Graduate Center and Director of the Ralph Bunche Institute for International Studies, where he is co-director of the United Nations Intellectual History Project (UNIHP) and chair of the board of the Academic Council on the United Nations System. He was editor of *Global Governance*, Research Director of the International Commission on Intervention and State Sovereignty, Research Professor at Brown University's Watson Institute for International Studies, Executive Director of the Academic Council on the United Nations System and of the International Peace Academy, a member of the United Nations secretariat and a consultant to several public and private agencies. He has written or edited some 35 books and numerous scholarly articles about multilateral approaches to international peace and security, humanitarian action, and sustainable development.
