From 1998 to 2001, she was a Member of the UNESCO Executive Board and chaired Commission I during the 31st Session of the General Conference. She initiated the Group of Chairs and Presidents of National Commissions, with New Zealand, Iceland and Canada.

She widely contributed to the influence and protection of Cultural Heritage in her country in 1999, by becoming Special Envoy for Cultural Heritage in Barbados.
