8. National Commission of the Costa Rica for UNESCO:

- President (Since June 2014): Ms Sonia Martha Mora Escalante Secretary-General: (TBC).
- Legislation: The legal instrument of the National Commission (in the form of a Governmental Decree), which settles its organization; dates back to 1959 and was reorganized in 1992. The National Commission is a decentralized body, which is both governmental and private.
- Structure of the Commission: The National Commission is composed of the following organs:
 - The Executive Board, comprising 25 members: Ministers involved in UNESCO areas of competence as well as persons elected among the members of the General Assembly. The Board meets every month and debates on the activity report issued by the Permanent Secretariat every month;

- Eight Specialized Committees (composed of voluntary workers) which meet once a month and which are in charge of: Education, Science and Technology, Culture, MAB, Music, Youth, Information and Communication, and MOST. All the committees deal with the labour of Human Rights and Superior Values tending to the formation of a Culture of Peace.
- Composition of the Commission Secretariat: There are 10 persons working for the National Commission: the Permanent Secretary; two coordination officers for the Associated Schools and the UNESCO Clubs; one professional archivist for the Documentation Center; an accountant; and five support staff.
- Fund-Raising: The National Commission has been involved in fund-raising activities.
- Documentation Centre: The Documentation Centre of the National Commission essentially gathers publications from UNESCO and national institutions. It receives more than 2000 visitors a year. One professional archivist serves the Centre.
- Cooperation with other National Commissions and UNESCO Field Offices: The National Commission punctually cooperates with National Commissions from Central America, through the dissemination of information and publications. The UNESCO Field Office in San José actively supports the National Commission.
