OVERVIEW:

The Joint Programme aims to improve cross-cultural understanding and reconciliation in Bosnia and Herzegovina while also promoting the country's multicultural identity, through a bottom-up approach focusing on the educational sphere, on culture-related partnerships between local authorities and the private sector, and on the development of the creative industries.

- Capacity-building, development and implementation of cultural policies and legal frameworks
- > Improvement of cross-cultural understanding at the community level
- Fostering local economic development through cultural production, cultural tourism and cultural heritage

GEOGRAPHICAL SCOPE:

National, with special attention given to the municipalities of Novo Sarajevo, Sokolac, Tesanj, Gradiska, Bijeljina, Bihac, Jajce, Srebrenik, Prijedor, Rudo

SNAPSHOT OF MAIN ACTIONS TO DATE:

- Development and implementation of cultural policies and legal frameworks: "BiH Joint
 action plan for implementation of culture strategy" developed through a participatory
 process and agreed by institutional partners; publications on UNESCO 2003 and 2005
 conventions; cultural statistics elaborated
- Cross-cultural understanding improved at the community level:
 - Publication of handbooks, guidelines, books, surveys, related to cultural diversity such as "Intercultural guides for teachers and parents and children in education" and "Toolkit for culture sensitivity in media"
 - Debates on interculturalism in local communities
 - <u>Introduction of interculturalism as an approach to teaching</u>: Report on existing curricula from the perspective of intercultural understanding prepared; mapping of teachers' competencies for intercultural education; trainings organised for school teachers and school principles
 - <u>Implementation of locally-driven projects</u> such as the rehabilitation and valorisation of 17 religious sites
- Strengthening of cultural industries and tourism: 50 new cultural goods produced in the
 areas of visual arts and crafts, design and creative services; 60 festivals and performances
 organised; support provided to 20 cultural SMEs

SUCCESS STORIES:

Revitalization of the old medieval fortress and 'Eminagica family' house in the municipality of Tesanj

Cultural tourism in the municipality of Tesanj has been enhanced through the restoration of a medieval fortress and the house of a prominent family from the Ottoman Empire, where visitors can now engage in cultural activities including cooking, traditional arts and designs, lectures and classes on traditional activities of the Ottoman Empire, and cultural performances.

❖ Intercultural camp in Municipality of Rudo: a tool for reconciliation through promotion of cultural diversity

A powerful tool for reconciliation and social cohesion has been created through the transformation of an abandoned local school in the Municipality of Rudo into an intercultural camp for over 5,000 BiH children of all ethnical backgrounds.
