Report by the Director-General on the execution of the programme adopted by the General Conference ((190 EX/4 Part I (A) and Add., Part I (B) and Add. online; 190 EX/4 Part II; 190 EX/INF.19; 190 EX/INF.21; 190 EX/INF.23; 190 EX/INF.24; 190 EX/INF.28; 190 EX/INF.29; 190 EX/53; 190 EX/54 Part I)

The Executive Board,

A. Content of the report

- 1. Recalling recommendation 13 of 33 C/Resolution 92, and 33 C/Resolution 78, in which the General Conference requested the Executive Board to report to it at each session on the implementation of the current Programme and Budget (C/5), together with the results achieved in the previous biennium (C/3),
- 2. Also recalling 34 C/Resolution 89 inviting the Executive Board to have a wider and more strategic assessment of the performance of the programmes, including the EX/4 document, by expressing its views progressively during the biennium through explicit decisions on the performance of individual programmes at the main-line-of-action (MLA) level;
- 3. <u>Having examined</u> document 190 EX/4 and document 190 EX/INF.24 (report of the Ad Hoc Preparatory Group), as well as the information provided in SISTER on the allocations made from the Special Emergency Multi-Donor Fund,
- 4. <u>Further recalling</u> that the purpose of the Special Emergency Multi-Donor Fund is to meet the shortfall in programme funding for the 2010-2011 and 2012-2013 biennia, and to deliver the Organization's priority programmes and reform initiatives as determined by Member States in documents 35 C/5 and 36 C/5,
- 5. <u>Thanks</u> the Director-General for her presentation of the key achievements, challenges and lessons learned, and the response under each of the five major programmes to the financial situation:
- 6. Notes that the scope of UNESCO's activities under each expected result in document 36 C/5 has been significantly reduced as compared with the range of activities originally foreseen, and that much of the progress towards the expected results described in the 190 EX/4 report was made possible through extrabudgetary funding and some allocations made from the Special Emergency Multi-Donor Fund, as well as some contributions in kind:
- 7. <u>Also notes</u> that the low expenditure rate in the first six months of the biennium calls for an acceleration in programme implementation;
- 8. <u>Invites</u> the Director-General to continue her efforts to ensure the efficient implementation of the programme, and to strengthen activities at the regional and country levels, in line with the priorities of the Member States, while striking a balance between statutory and operational activities, and Headquarters and field implementation, taking into account the discussions at the 190th session of the Executive Board;
- 9. <u>Also invites</u> the Director-General to direct funding from the Special Emergency Multi-Donor Fund to the implementation of the activities foreseen under document 36 C/5 Approved which could not be funded because of the budget shortfall, in accordance

with Article 1 of the Financial Regulations of the Special Emergency Multi-Donor Fund, and to that end, to be guided by the following criteria:

- to advance the two global priorities;
- to respond to the needs of the priority groups;
- to push forward overall reform, including progress in field reform;
- to ensure the implementation of statutory activities;
- to support operational activities at the country level.

B. Format of the report

- Recalling 176 EX/Decision 29, 34 C/Resolution 89, 184 EX/Decision 4, 186 EX/Decision 4, 189 EX/Decision 4, 190 EX/Decision 4, and document 179 EX/4 Part II 35 C/3 Draft,
- Expresses its satisfaction with the improved format and structure of the EX/4 report, including clearer linkages between the results achieved, the main lines of action (MLAs) and expected results, as well as the presentation and content of the executive summary;
- 12. <u>Invites</u> the Director-General to present in future EX/4 reports a summary assessment on progress achieved in the implementation of the two global priorities, Africa and gender equality, as well and to continue her efforts towards a more consistent and harmonized approach in reporting across all programme sectors;
- 13. <u>Welcomes</u> the time-bound action plan for implementing the recommendations of the Internal Oversight Service (IOS) in order to enhance monitoring and reporting presented in document 190 EX/INF.21;
- 14. Reiterates its earlier requests to include a draft decision in future EX/4 reports.

- 1. <u>Noting with deep concern</u> the occupation of the northern regions of Mali, which constitute practically two-thirds of the national territory, by armed groups,
- Considering the damage inflicted on heritage sites in northern Mali, particularly properties inscribed on the World Heritage List, and therefore of importance for all humanity,
- 3. <u>Taking into account</u> the inscription of the Timbuktu and Tomb of Askia sites on the List of World Heritage in Danger, and the establishment of the Special Fund for the Safeguarding of Mali's World Heritage Sites,
- 4. <u>Encourages</u> the Director-General to continue her action for the safeguarding of cultural heritage in northern Mali, including libraries and collections of ancient manuscripts, and to extend such action to the preservation of socio-educational institutions in northern Mali that fall within UNESCO's fields of competence:

- 5. Requests the Director-General:
 - (a) to take all appropriate steps to strengthen cooperation with Mali under the Programme and Budget for 2012-2013 (36 C/5) approved by the General Conference at its 36th session, and by mobilizing extrabudgetary resources;
 - (b) to urge the Member States of UNESCO, governmental and non-governmental organizations, international and private institutions to provide emergency assistance in UNESCO's fields of competence;
 - (c) to ensure follow-up to this decision through the implementation of post-conflict programmes under UNESCO's action for countries in crisis;
 - (d) to report on the progress made in her statutory EX/4 reports during the present biennium.

Cooperation between UNESCO and the Global Geoparks Network

- 1. Recalling 36 C/Resolution 31 on cooperation between UNESCO and the Global Geoparks Network (GGN),
- 2. <u>Taking into account</u> the relevance for UNESCO of geoparks and of cooperation with the Global Geoparks Network,
- 3. <u>Having examined</u> document 190 EX/5 Part I Add., the report of the Director-General on the consultations undertaken during the first half of 2012 on how to improve cooperation between UNESCO and the Global Geoparks Network and the related budgetary and administrative elements.
- 4. <u>Encouraged</u> by the progress made on defining a potential structure and mechanism for a UNESCO global geoparks initiative;

- 5. Requests the Director-General to submit a more comprehensive proposal concerning such an initiative and formalization of its relationship with the Global Geoparks Network;
- 6. <u>Decides</u> that the proposal should cover:
 - (a) an analysis which incurs no additional budgetary implications for UNESCO and which outlines efforts to secure external funding partners for further capacitybuilding and for additional Global Geoparks Network activities, including the outcome of consultations held with the International Union of Geological Sciences (IUGS) and the International Union for the Conservation of Nature (IUCN);
 - (b) a mapping of UNESCO's work relevant to geoparks in order to identify areas of potential duplication, synergies and added value, and how a UNESCO global geoparks initiative would improve on current practice;
 - (c) mechanisms for strengthening UNESCO's oversight role, in coordination with the Member States concerned, and for maintaining the current strong quality control, and for preserving, protecting and promoting geoparks;
 - (d) mechanisms for reinforcing the capacity-building and knowledge-transfer dimensions;
 - (e) presentation of possible operational guidelines for the Global Geoparks Network, to be decided upon by the Executive Board, ensuring the highest selection standards and allowing for equitable geographical distribution;
 - (f) management of long-term development of the Global Geoparks Network;
 - (g) identification of the implications of accepting sites already designated under existing Global Geoparks Network criteria, and the proposal of any adjustments that may be considered necessary;
- 7. <u>Also requests</u> the Director-General to report to it at its 191st session on the progress made in this regard.

DRAFT DECISION

Submitted by: Algeria, Egypt, Saudi Arabia, Tunisia and United Arab Emirates

The Executive Board,

- 1. Having examined document 190 EX/5 Part I.C.
- 2. Recalling previous UNESCO decisions related to the Ascent to the Mughrabi Gate in the Old City of Jerusalem; particularly decision 189 EX/5. II and decision 36 COM 7A.23.II of the World Heritage Committee (St. Petersburg 2012),
- 3. Also recalling the relevant provisions on the protection of cultural heritage including in the four Geneva Conventions (1949), the relevant provisions of the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict of 1954, the Convention for the Protection of the World Cultural and Natural Heritage of 1972, the inscription of the Old City of Jerusalem and its Walls at the request of Jordan on the World Heritage List

After a roll-call vote of 28 votes in favour, 23 votes against and 4 abstentions,

Abstentions: Angola, Gabon, Thailand and Viet Nam.

Absent: Barbados, Ethiopia and Papua New Guinea.

the following States having voted for the adjournment of the debate: Austria, Belarus, Belgium, Brazil, China, Czech Republic, Denmark, Grenada, Haiti, Italy, Japan, Kazakhstan, Kenya, Malawi, Mexico, Monaco, Montenegro, Republic of Korea, Russian Federation, Saint Lucia, Slovakia, Spain, Syrian Arab Republic, The former Yugoslav Republic of Macedonia, United Kingdom of Great Britain and Northern Ireland, United States of America, Uzbekistan and Venezuela (Bolivarian Republic of).

the following States having voted against: Afghanistan, Algeria, Bangladesh, Burkina Faso, Congo, Cuba, Djibouti, Egypt, Ecuador, France, Gambia, Ghana, India, Indonesia, Mali, Namibia, Nigeria, Pakistan, Peru, Saudi Arabia, Tunisia, United Arab Emirates and Zimbabwe.

(1981) and on the List of World Heritage in Danger (1982), and the recommendations, resolutions and decisions of UNESCO.

- 4. <u>Noting</u> the Sixth Reinforced, Seventh, Eighth and Ninth, Tenth and Eleventh Monitoring Reports and their addendums prepared by the World Heritage Centre,
- 5. Recognizes the concerns raised, in this regard, about the decision by "the Jerusalem District Planning and Construction Commission" on the town planning scheme for the Mughrabi Ascent, and the subsequent decision by Israel's "National Council for Planning and Construction" to adopt "an alternative plan for the Mughrabi Ascent", approved on 31 October 2010 by the above-mentioned Commission;
- 6. Requests that, despite the decisions mentioned in paragraph 5, the process for the design of the Mughrabi Ascent be inclusive of all parties concerned, in accordance with obligations and duties of such parties as stipulated in the content of previous World Heritage Committee decisions;
- 7. Reaffirms in this regard that no measures, unilateral or otherwise, shall be taken which will affect the authenticity, integrity and cultural heritage of the site, in accordance with the Convention for the Protection of the World Cultural and Natural Heritage of 1972 and the relevant provisions on the protection of cultural heritage of the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict of 1954;
- 8. Acknowledges receipt of the Jordanian design for the restoration and preservation of the Mughrabi Ascent, submitted to the World Heritage Center on 27 May 2011, and thanks Jordan for its cooperation in accordance with the relevant provisions of UNESCO Conventions for the Protection of Cultural Heritage;
- 9. <u>Affirms</u>, in this regard, that the UNESCO process for the follow-up of the design of the Mughrabi Ascent which aims at finding an accepted and monitored solution concerning the Mughrabi Ascent among all parties concerned; be <u>coordinated</u> with all such parties, in accordance with the spirit and content of previous World Heritage Committee decisions and recognizes the concerns raised regarding Israel's submission and content of its plan for the Mughrabi Ascent, referred to in Paragraph 5, and requests that the World Heritage Centre be proactive and follow closely, in the context of the Reinforced Monitoring Mechanism, the developments associated with this process and evaluation of the design received in accordance with paragraph (8) above;
- 10. Notes with satisfaction the access provided by Israel to the Mughrabi Ascent for Jordanian and Waqf experts on 23 May, 8 August and 28 November 2010, and reiterates its request that Israel resumes the cooperation commenced with concerned parties, in particular with Jordanian and Waqf experts to enable agreement on and implementation of a final design for the restoration and preservation of the Mughrabi Ascent among all parties concerned;
- 11. Also notes in this regard, reports of preliminary discussions reached by Jordan and Israel respectively regarding the Mughrabi Ascent which stipulate, inter alia, that no measures, unilateral or otherwise, shall be taken on the site in accordance with paragraph (7) above, and the necessity of an accepted design and implementation thereof among all parties concerned; and reiterates in this regard, the need for the parties concerned to cooperate on all related aspects of this issue and further regrets Israel's refusal to implement World Heritage Committee consensus decision 36 COM 7A.23.II;

Requests the Director-General to conduct consultations, in close cooperation with Member States and the International Council of Museums, and to undertake an independent preliminary study, with extrabudgetary resources, of the desirability, the technical and legal aspects, and the scope, rationale, added value, and administrative and financial implications of a standard-setting instrument on the protection and promotion of museums and collections, for examination by the Executive Board at its 191st session, with a view to inscribing this item on the agenda of the 37th session of the General Conference;
- 9. <u>Also requests</u> the Director-General to include in the above-mentioned independent preliminary study an assessment of the relevant international instruments and programmes and an indication of how they relate to the protection and promotion of museums and collections;

The Executive Board,

- 1. Having examined document 190 EX/13,
- 2. Recalling resolutions and decisions of UNESCO on Jerusalem, as well as the provisions of the four Geneva Conventions (1949) and their additional Protocols, the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict (1954) and its additional Protocols and the Convention for the Protection of the World Cultural and Natural Heritage (1972),
- 3. Affirming that nothing in the present decision, which is aimed at the safeguarding of the Cultural Heritage of East Jerusalem, shall in any way affect the relevant United Nations resolutions and decisions, in particular the relevant Security Council resolutions on the legal status of Jerusalem,
- 4. <u>Deplores</u> the ongoing Israeli practices and the Israeli settlers incursions in East Jerusalem, that dangerously and irreversibly affect the city's distinctive character, both religious and cultural, historical and demographical, and <u>urges</u> the Israeli Authorities to take the necessary measures to prevent these abuses;
- 5. Affirms in this regards that the integrity and authenticity of East Jerusalem must be protected;
- 6. <u>Notes with deep concern</u> the absence of progress in the implementation of its previous 185 EX/Decision 14 concerning this item, and <u>reiterates</u> its request to the Director-General to appoint, as soon as possible, a permanent and eminent expert(s) to be stationed in East Jerusalem to report on a regular basis about all the aspects covering the architectural, educational, cultural and demographical situation in the City of East Jerusalem;
- 7. Reaffirms the requirement to promptly and fully implement the above-referenced decision and resolution, and urges the Israeli authorities to facilitate its implementation in conformity with its adherence to UNESCO decisions and conventions;
- 8. Asks the Director-General to maintain her efforts to implement the above mentioned decision and resolution;
- 9. <u>Decides</u> to include this item on the agenda of the 191st session of the Executive Board and <u>invites</u> the Director-General to submit to it a progress thereon.

The Executive Board,

1. Having examined document 190 EX/14,

2. Recalling UNESCO decisions on the two Palestinian sites in Hebron/al-Khalīl and in Bethlehem, as well as the provisions of the four Geneva Conventions (1949) and their additional Protocols, the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict (1954) and its additional Protocols and the Convention for the Protection of the World Cultural and Natural Heritage (1972) and also recalling the Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property (1970),

After a roll-call vote of 28 votes in favour, 23 votes against and 4 abstentions,

the following States having voted for the adjournment of the debate: Austria, Belarus, Belgium, Brazil, China, Czech Republic, Denmark, Grenada, Haiti, Italy, Japan, Kazakhstan, Kenya, Malawi, Mexico, Monaco, Montenegro, Republic of Korea, Russian Federation, Saint Lucia, Slovakia, Spain, Syrian Arab Republic, The former Yugoslav Republic of Macedonia, United Kingdom of Great Britain and Northern Ireland, United States of America, Uzbekistan and Venezuela (Bolivarian Republic of).

the following States having voted against: Afghanistan, Algeria, Bangladesh, Burkina Faso, Congo, Cuba, Djibouti, Egypt, Ecuador, France, Gambia, Ghana, India, Indonesia, Mali, Namibia, Nigeria, Pakistan, Peru, Saudi Arabia, Tunisia, United Arab Emirates and Zimbabwe.

Abstentions: Angola, Gabon, Thailand and Viet Nam.

Absent: Barbados, Ethiopia and Papua New Guinea.

- 3. <u>Bearing in mind</u> that the two concerned sites located in Hebron/al-Khalīl and in Bethlehem are an integral part of the occupied Palestinian territory and that no unilateral action should be undertaken by the Israeli authorities,
- 4. <u>Affirming</u> that nothing in the present decision, which aims at the safeguarding of the Palestinian cultural heritage, shall in any way affect the relevant United Nations resolutions and decisions, in particular the relevant Security Council resolutions.
- 5. <u>Expresses its deep concern</u> over the ongoing Israeli works in Hebron/ al-Khalīl, such as the construction of a separation wall inside the Old City of Hebron and the creation of private roads for settlers, that dangerously and irreversibly affect the city's distinctive character, both religious and cultural, historical and demographical;
- 6. Regrets the denial of freedom of movement and freedom of access to places of worship due to the above mentioned Israeli practices and other Israeli restrictions;
- 7. <u>Also regrets</u> the Israeli authorities refusal to comply with 185 EX/Decision 15 concerning "the two Palestinian sites of Al-Haram Al-Ibrahimi/Tomb of the Patriarchs in Al-Khalīl/Hebron and the Bilāl Ibn Rabāh Mosque/Rachel's Tomb in Bethlehem" and <u>urges</u> them to act in accordance with the mentioned decision in conformity with their adherence to UNESCO decisions and conventions:
- 8. <u>Decides</u> to include this item on the agenda of the 191st session of the Executive Board and <u>invites</u> the Director-General to submit to it a follow-up report thereon.

- 1. Having examined document 190 EX/16,
- Noting the importance of preserving and strengthening of communication and information programmes at UNESCO, which inter alia is carrying out an important global initiative to preserve and ensure access to the documentary heritage of humanity.
- Emphasizing the importance of synergy of the Memory of the World and Information for All Programmes in preserving documentary heritage, including digital heritage, of humanity.
- 4. <u>Thanks</u> the government of Poland for hosting the expert meeting in Warsaw from 8 to 10 May 2012, and <u>noting with satisfaction</u> that the meeting was attended by 50 experts from all regions;
- 5. <u>Takes note</u> of the recommendations of the aforementioned expert meeting;
- 6. Requests the Director-General to elaborate a draft action plan which includes a time-frame and financial implications for strengthening the Memory of the World Programme based on 36 C/Resolution 59 and the recommendations formulated by the expert meeting in Warsaw, and to submit this draft action plan to the Executive Board at its 191st session for its consideration;
- 7. Recommends that the Director-General make greater efforts to strengthen policies and capacities for archives, museums, libraries and other institutions that house such heritage;

8. <u>Also requests</u> the Director-General to undertake a preliminary study of the technical, financial and legal aspects on the desirability of a standard-setting instrument on preservation and access to documentary heritage for examination by the Executive Board at its 191st session.

- 5. Reiterating the principle that the amount of the prizes shall be determined in consultation between the Director-General and the donor, inasmuch as moral values are more important than monetary values,
- 6. <u>Takes note</u> of the Director-General's proposed revisions to the Overall Strategy for UNESCO Prizes;
- 7. <u>Endorses</u> the inclusion in the Overall Strategy for UNESCO Prizes of a feasibility study framework for the creation of UNESCO prizes, as contained in Annex I of document 190 EX/17, taking into account the need to revise paragraph 2.1 of Annex I;
- 8. <u>Further endorses</u> the amendments made to Articles 5.1, 6.1, 6.2 and 8.1 of the Proposed Standard Model Text for Statutes, (171 EX/19, Annex I) as reproduced in Annex II of document 190 EX/17;
- 9. Requests the Director-General to submit to it at its 191st session a revised and balanced proposal, taking into account the principle that moral values are more important than monetary values;

- 2. Having examined documents 190 EX/18 Part I and 190 EX/INF.16,
- Aware that the network of category 2 institutes and centres is making a significant contribution to the achievement of UNESCO's strategic programme objectives, particularly at the country level, and that the present management framework for category 2 institutes/centres (35 C/22 and Corr.) sets clear overall boundaries and principles for engagement,
- 4. <u>Acknowledges</u> that maintaining and coordinating the category 2 network has cost implications for the Organization pertaining to staff time and regular programme resources, and that measures are needed to reduce these costs, having regard to special needs of developing countries;
- 5. <u>Thanks</u> the Director-General for the work to improve the implementation of the Integrated Comprehensive Strategy for Category 2 Institutes and Centres (35 C/22 and Corr.), in line with the recommendations contained in the Internal Oversight Service's joint audit and evaluation of the management framework for category 2 institutes;
- 6. Recommends that the General Conference, at its 37th session, amend the current Integrated Comprehensive Strategy for Category 2 Institutes and Centres so as to further strengthen category 2 status renewal procedures, improve alignment of category 2 institutes/centres' operations with UNESCO's results-based management approach and sectoral strategies, strengthen the monitoring and reporting requirements of the network, and reduce the cost to UNESCO of maintaining this network in terms of human and financial resources, taking into consideration suggestions in paragraph 23 of document 190 EX/18 Part I, as well as the special needs of developing countries;
- 7. <u>Also recommends</u> that any personal or institutional names given to category 2 institutes or centres shall be of persons or institutions whose outstanding moral, intellectual, scientific or artistic legacy is fully consonant with the ideals and objectives of UNESCO;

 - (c) setting norms and standards in its fields of competence and supporting and monitoring their implementation;
 - (d) strengthening international and regional cooperation in its fields of competence, and fostering alliances, intellectual cooperation, knowledge-sharing and operational partnerships;
 - (e) providing advice for policy development and implementation, and developing institutional and human capacities;
- 7. <u>Takes note</u> of the proposals made by the Director-General concerning the Organization's two overarching objectives, and, taking into account the discussions at the 190th session of the Executive Board, <u>requests</u> the Director-General to reflect expressly in these overarching objectives social inclusion, ethical and social challenges and communication and information;

 - (e) appropriate levels of resources and inputs required to attain expected results;
 - (f) a cost classification;
- 7. Requests the Director-General to submit to it at its 191st session document 37 C/5 based on a budget ceiling of \$653 million for 2014-2015 representing a zero nominal growth budget level as compared with document 36 C/5 Approved (2012-2013), on the understanding that:
 - (a) this amount will be re-evaluated in accordance with a revised constant dollar budget reporting rate;
 - (b) as a consequence of this re-evaluation, the budget ceiling appearing in document 37 C/5 will be different from \$653 million as the part of contributions in euros will be converted for reporting purposes to dollars according to the revised constant dollar budget reporting rate;
 - (c) the total amount of contributions requested in euros and dollars from all Member States will be the same as for document 36 C/5;

8. <u>Further invites</u> the Director-General to present an implementation plan for document 37 C/5 which sets out spending priorities for the Organization based on the expected cash flow situation for 2014-2015.

 - (d) Consideration by the Executive Board, at its 191st session, in private meeting, of the draft contract establishing the terms of appointment, salary, allowances and status of the Director-General.
 - (e) At the 192nd session (the session immediately preceding the 37th session of the General Conference), consideration by the Executive Board, in private meeting, of the names put forward, pursuant to paragraphs 2 and 3 of Rule 58 of the Rules of Procedure of the Executive Board. The Board would, at a private meeting, interview the candidates through the procedure that will be established at the 191st session. After discussions at a private meeting at the end of the interview process, the Board shall choose through secret ballot the candidate whom it will recommend to the General Conference.
 - (f) The candidate to be proposed by the Executive Board to the General Conference would be chosen by secret ballot by the Board pursuant to paragraph 1 of Rule 54 and paragraph 3 of Rule 58 of the Rules of Procedure of the Board.
 - (g) The Board would inform the General Conference of the name of the candidate nominated by the Board pursuant to paragraph 4 of Rule 58 of the Rules of Procedure of the Executive Board, and submit to the General Conference a draft

contract establishing the terms of appointment, salary, allowances and status of the Director-General."

1. <u>Taking note</u> of document 190 EX/5 Part II on the Internal Oversight Service (IOS) evaluation report concerning Priority Africa,

- 2. Recalling the recommendations of the independent external evaluation of UNESCO (185 EX/18),
- 3. <u>Also recalling</u> successive debates held concerning Priority Africa and the reform of UNESCO field network stressing the need for a new orientation to Priority Africa,
- 4. Having examined document 190 EX/45.
- 5. Requests the Director General, in consultation with the Member States, in particular African Member States, to:
 - (a) present in draft document 37 C/4 (Draft Medium-Term Strategy for 2014-2021) a number of flagship programmes for Africa to be submitted to the Executive Board at its 191st session;
 - (b) present in draft document 37 C/5 (Draft Programme and Budget for 2014-2017) the Priority Africa Action Plan for the implementation of flagship programmes with strategic objectives, expected outcomes, time-frames and performance indicators to be submitted to the Executive Board at its 191st session;
 - (c) allocate in draft document 37 C/5 (Draft Programme and Budget for 2014-2017) adequate human and financial resources from regular and extrabudgetary resources for the effective implementation of the Priority Africa Action Plan, in particular in the field offices;
 - (d) act in coordination with Member States, relevant partners and African institutions in the planning, development, implementation and evaluation of the Priority Africa Action Plan:
- 6. <u>Also requests</u> the Director General to elaborate the role, structural linkages and operational modalities of the Africa Department in relation to the programme sectors, the UNESCO Liaison Office in Addis Ababa and the field offices in Africa, and to report to it thereon at its 191st session.

46 Further enhancing the transparency of UNESCO programmes (190 EX/46; 190 EX/53)

The Executive Board,

- Recognizing that programme transparency is fundamental to its success,
- 2. <u>Noting</u> that UNESCO, through the early implementation of the International Public Sector Accounting Standards (IPSAS), has shown itself capable of being a leading institution in the adoption of new transparency standards,
- 3. <u>Also noting</u> that UNESCO continues to improve its own transparency through improved websites, greater use of SISTER and other measures.
- 4. <u>Notes</u> that UNESCO is working within the United Nations system on a harmonized reporting standard.
- 5. <u>Reiterates</u> the commitment of UNESCO to publish programme information in line with an internationally agreed United Nations transparency reporting standard.

47 Proposal for the proclamation by the United Nations of 2015 as international year of light (190 EX/47; 190 EX/INF.17; 190 EX/55)

The Executive Board,

- 1. Recognizing the importance of light and optical technologies in the lives of the citizens of the world, and for the future development of global society on many levels.
- Stressing that enhanced global awareness of, and increased education in, the science and technologies of light is vital for addressing challenges such as sustainable development, energy, and community health, and for improving the quality of life in both the developed and the developing worlds,
- 3. <u>Considering</u> that the applications of light science and technology are vital for existing and future advances in medicine, communications, entertainment and culture, and that light-based technologies respond directly to the needs of humankind by providing access to information and increasing societal health and well-being,
- 4. <u>Being aware</u> that the year 2015 coincides with the anniversaries of a series of important milestones in the history of the science of light, specifically the contributions of Ibn al-Haitham in 1040, the notion of light as a wave proposed by Fresnel in 1815, the electromagnetic theory of light propagation by Maxwell in 1865, the embedding of light in cosmology through general relativity in 1915, and the discovery of the cosmic microwave background in 1965,
- 5. Being also aware that the celebration of the anniversaries of these discoveries in 2015 will provide an unparalleled opportunity to highlight the continuous nature of scientific discovery in different contexts, with particular emphasis on promoting science education among young people and women, especially in developing countries and emerging economies,
- 6. Having examined document 190 EX/47,
- 7. Welcomes and endorses the unanimous resolution of the International Union of Pure and Applied Physics (IUPAP) at its 2011 General Assembly, the unanimous decision of the Council of Synchrotron Light for Experimental Science and Applications in the Middle East (SESAME) at its 19th session in December 2011, and the leadership and initiative of the international scientific community through the large number of partner scientific learned societies, unions and institutions, to have 2015 proclaimed international year of light;
- 8. <u>Invites</u> the Director-General to support all efforts leading the United Nations General Assembly to proclaim 2015 international year of light;
- 9. Recommends that the General Conference adopts a resolution in this regard at its 37th session.

48 World Arabic Language Day (190 EX/48; 190 EX/55)

The Executive Board,

1. <u>Aware</u> of the Arabic language's role in and contribution to the preservation and dissemination of human civilization and culture,

- 2. <u>Also aware</u> that Arabic is the language of 22 of the Member States of UNESCO, that it is one of the Organization's working languages, that it is spoken by more than 422 million Arabs, and is used by more than 1.5 billion Muslims,
- 3. <u>Understanding</u> the need to implement more wide-ranging cooperation between peoples through linguistic pluralism, cultural rapprochement and dialogue among civilizations, in line with what is set out in the Constitution of UNESCO,
- 4. Recalling resolution 3190 (XXVIII) adopted by the United Nations General Assembly of 18 December 1973 at its 28th session, by which it included Arabic as one of the official and working languages of the General Assembly and its main committees,
- 5. Welcoming the decision announced on 19 February 2010 in document OBV/853-PI/1926 issued by the United Nations Department of Public Information, which concerns the celebration of international days for the six official languages of the United Nations, and designates 18 December as World Arabic Language Day,
- 6. <u>Appreciating</u> the assurances provided by the Arab States and those with Arabic as an official language concerning the preservation, protection and celebration of the language,
- 7. <u>Invites</u> the Director-General to promote the celebration of World Arabic Language Day on 18 December of every year as one of the international days marked by UNESCO, it being understood that this should have no financial impact on the regular budget of the Organization.
