#### I. Item 1. 2012-2013 Publications Plan and policy issues

- 1. The Chair presented an overview of the Publications Plans received from all sectors.
  - All sectors have made considerable efforts to reduce publications. While the targeted 50% reduction in the number of publications planned has not been met, a 45% reduction in the number proposed has been achieved overall, with further reductions in the quantity of printed copies to be produced. Many publications will be produced in online form only.
- 2. The Chair, ADG/ERI, has written to the Director-General to confirm the strong efforts made and is awaiting her final decision on whether to accept the Publication Plan.
- 3. All sectors and offices need to continue their efforts to reduce publications and to respond decisively to the call from the Director-General to reduce costs, especially printing costs.
- 4. The Chair referred to the Memo from ADG/MSS 'UNESCO's printed materials' [DIR/MSS/CLD/2012/014]. He praised MSS for taking this initiative and reiterated the importance of following UNESCO rules to avoid waste.
- 5. The Chair called on the Member for MSS to discuss the memo.
- 6. The Member for MSS summarized the contents of the memo, noting that the IOS review and recommendations called for a reduction in the Organization's printing activities.
- 7. MSS is available to help sectors in these efforts and to provide advice on print runs and other production possibilities. However sectors often bypass UNESCO rules and use external print suppliers, in which case CLD has little recourse to provide these important services.
- 8. CLD will follow the recommendations of the Board and will not print publications that have not been approved by the Board, or that have been approved for online publication only.
- 9 The Member for SHS requested that ERI/DPI produce a single document outlining all policy decisions taken by the Board.
  - The Chair agreed that such a document will be produced. Certain areas require finalization following input from Board Members. For example, the revised proposal concerning forewords and prefaces will be considered by the Board at the next meeting in May. Once complete, the policy document will be circulated.
  - The Secretary, Chief, Publications Unit, ERI/DPI, added that a unesco.int site is being developed by Samantha Wauchope, ERI/DPI, in conjunction with the Web team. Although this project has been delayed as a result of funding and staffing difficulties, it is a priority and will be completed shortly.
- 10. The Member for Field Offices suggested that revised publishing and submission guidelines be developed similarly reflecting the decisions of the Publications Board and included on the unesco.int site.
- 11. The Member for Field Offices pointed out that the Board is often presented with submissions in the final stage of development, often with launches planned only one week after the Board meeting. This makes it impossible for the Board's review to have any real impact on the work produced.
- 12. Noting that the Publications Board has met 11 times now, the Member for Field Offices suggested that it could be useful to evaluate the impact of a select number of the publications accepted so far.
  - The Board agreed that this would be a useful exercise, although the finalization of the policy document should be completed first.

### II. Item 2. Approval of the minutes of the previous meeting

1. The Board accepted final revisions and approved the minutes of the 15 February meeting.

## III. Review of publication proposals

Following the withdrawal of one submission, twenty-five publication proposals were reviewed by the Board, including two series of two and six titles respectively, (see Annex 2). Of these, nineteen were approved and six were returned for reconsideration and review by the sectors concerned.

The following general points were made during the course of the discussions:

- 1. Members noted the large number of submissions presented to the Board at each meeting in the final stages of development or layout.
  - The Board called on all present to be proactively involved in ensuring that submissions are presented to the Board during the development stages of the publication project to increase the effectiveness and impact of the Board's recommendations.
- 2. Proposals are still being submitted using older versions of the submission form. Noting that the form was finalized in December, the Board called on all sectors to use the definitive version for all future submissions.
- 3. The representative for GE commended all present on the completion of Gender Review Checklists for every proposal submitted today.
- 4. The importance of ensuring that forewords or prefaces by the DG are limited to high-value or high-profile publications was reiterated.
  - Members agreed that policy guidelines must be finalized and circulated as soon as possible.
- Attention was drawn to the inclusion of the costs of expert meetings in some publishing budgets. Members felt that this could be misleading and that these costs should be dissociated from publication costs.
- 6. Following discussion of publications to be produced in Indonesian and in Uzbek, Members highlighted the importance of encouraging multilingualism and the need to develop quality control and peer review guidelines for the publication of titles in languages for which qualified UNESCO staff members with the required linguistic skills are not available to review a publication's content.
  - The Board noted that such guidelines are especially important in the case of indigenous languages.
- 7. The Board emphasized the importance of its work, the results of which can be diminished when Members are not able to attend the entire meeting.
- 8. The need for impartial, external peer review was highlighted during discussions.
  - To avoid conflicts of interest, peer reviewers should have no connection to the authors or authoring agencies, or to publication partners.
  - For publications covering a number of countries or regions, a geographic balance is preferable among peer reviewers.
