I. Item 1. Approval of minutes

1. The Board approved the minutes of the 4 July meeting.

II. Item 2. Stock management and distribution

- 1. The Secretary, Chief, Publications Unit, ERI/DPI, reminded Board Members of UNESCO's requirements to reduce its stock of publications in accordance with United Nations system IPSA (International Public Sector Accounting Standards) regulations.
 - Following an initial stock evaluation carried out two years ago, UNESCO is now re-assessing its stocks
 presently held at Bonvin to identify publications that can be donated to suitable groups or
 organizations.
 - ERI/DPI will provide sector ADGs with a list of their publications stocks by the end of this year. In some
 cases sectors could contact authors or authoring partners who may wish to take excess stocks.
- 2. ERI/DPI has also proposed to the Executive Board the discontinuation of the present system of statutory distribution of publications.
- 3. The Ex Officio Member for AFR asked whether stocks it holds are considered part of UNESCO's stock.
 - Small supplies of publications held by sectors that are used regularly for example, given as gifts to
 visitors are not viewed as stored publications. However larger stocks that are taking up office space
 unnecessarily must be assessed, especially in light of the need to find more office space for staff
 members who will be moved from Bonvin to Fontenoy.
- 4. The Member for Field Offices asked whether field offices would be included in the survey of publication stocks.
 - UNESCO has little information on the stocks of publications held by field offices. The Secretary agreed that it would be a good idea to include field offices in the general overview of what stocks are held and how they are being used.
 - The representative for Institutes asked what method would be used to assess stocks.
 - ERI/DPI is working with UNESCO's accounting services to put a value on all publication stock, including for-sale and free publications. A cost-recovery strategy will be developed to make all publications available for sale.

III. Item 3. Review of publication proposals

Ten proposals were presented to the Board, one of which had been revised following review at the September 2011 meeting of the Publications Board. The Board approved six proposals, including the resubmission, with four returned for reconsideration and review by the sector concerned.

The following general points were made during the course of the discussions:

- 1. The Member for Field Offices proposed that ERI/PUB draft a policy on the selection of publishing partners to emphasize the need to select major companies that can add value to co-published works. He suggested that this policy should be discussed by Board Members at the next policy meeting.
- 2. The Member for MSS stressed the need to develop a methodology to quantify staff time so as to have a real idea of the full costs of each publication project.
 - The Secretary added that the present submission form does not allow for a distinction to be made between research and writing costs. Other costs that should be considered include peer review, and coordination costs.

- 3. The Chair emphasized the pressure on all sectors to decrease the number of publications they produce, and the corresponding need to ensure that all UNESCO publications are high-quality and based on well thought out plans that focus on their potential impact.
 - Members agreed that publishing is often not the best way to promote, publicize and disseminate research results, and that other avenues should be considered rather than routinely developing publications.
- 4. Members requested that ERI/DPI develop readily available information on the publication projects passed by the Board and their estimated media impacts.
