Since 1997 course of Human Rights has been taught in many higher educational institutions and universities of the Republic of Uzbekistan. The Chair is a scientific-methodical centre on teaching courses on Human Rights in higher educational institutions. The disciplines that are taught in the Chair are newly set up and are taught only in the Chair.

The Chair of UNESCO in Human Rights, Peace, Democracy, Tolerance and International Understanding co-operates with the National Commission for UNESCO to organise seminars and meetings. In the current semester there were meetings of graduate and post-graduate students with the representatives of National Institutions on Human Rights: National Centre of the Republic of Uzbekistan for Human Rights, Ombudsman of Oliy Majlis that contributed the process of teaching positively.
