ELECTION OF A CHAIRPERSON, VICE-CHAIRPERSONS AND RAPPORTEUR

Decision required: paragraph 3.

1. As required by Rule 4 of its Rules of Procedure, the Conference of the Parties shall elect a Chairperson, one or more Vice-Chairpersons and a Rapporteur. The Conference of the Parties might wish to consider electing six officers in total on the basis of equitable geographical representation (one from each of the electoral groups as established by the General Conference of UNESCO – herewith attached as Annex 1).
2. The terms of office of the Chairperson, Vice-Chairpersons and Rapporteur will extend from the opening of the current session until the opening of the next ordinary session of the Conference of the Parties when a new Chairperson, Vice-Chairpersons and Rapporteur will be elected.

3. The Conference of the Parties may wish to adopt the following resolution:

The Conference of the Parties,

1. *Elects* [name and State Party] as Chairperson of the Conference of the Parties,
