Expresses its sincere thanks to the Director-General for his sustained efforts for the safeguarding of the cultural and natural heritage of the Old City of Jerusalem, in compliance with 32 C/Resolution 39 of the General Conference and 171 EX/Decision 18 of the Executive Board, and reiterates its concern as to the obstacles and practices affecting the safeguarding of the cultural and natural heritage of the Old City of Jerusalem;

#### **ANNEX**

Specific multi-stage procedure for the monitoring of the implementation of UNESCO conventions and recommendations for which no specific institutional mechanism is provided

Stage 1: Frequency of submission of reports on the monitoring of the implementation of UNESCO conventions and recommendations for which no specific institutional mechanism is provided

In accordance with the provisions of Article IV, paragraph 4, and Article VIII of the Constitution, reports shall be submitted every four years unless the General Conference, in the case of specific conventions or recommendations, decides otherwise.

### Stage 2: Transmission of conventions and recommendations to Member States

Pursuant to the provisions of the Rules of Procedure concerning recommendations to Member States and international conventions covered by the terms of Article IV, paragraph 4, of the Constitution, while transmitting a certified copy of any convention or recommendation to Member States, the Director-General will formally remind them of their obligation to submit the convention or recommendation in question to their competent national authorities in accordance with Article IV, paragraph 4, of the Constitution, and will also draw their attention to the difference in the legal nature of conventions and recommendations.

The Secretariat will ensure that the standard-setting texts adopted by the General Conference are widely disseminated to Member States and the public.

# Stage 3: Establishment of reports for monitoring the effective implementation of conventions and recommendations

## (a) Consultations concerning conventions

The Secretariat shall submit to the Executive Board its proposals concerning the modalities of consultation of Member States on any measures they have respectively adopted pursuant to Article IV, paragraphs 4 and 6, and Article VIII of the Constitution. To this effect, it shall prepare draft guidelines for the preparation of reports based on the framework guidelines adopted by the Executive Board, to which the Secretariat will add, in view of the wide variety of UNESCO's standard-setting instruments, specific questions on which additional information is sought in the light either of the conclusions of the previous consultation or of the information available.

The Executive Board shall entrust the examination of these proposals to its Committee on Conventions and Recommendations (CR).

After the guidelines have been approved by the Executive Board, the Director-General will invite the Member States to submit their report on the action taken on the convention, within a period of six months. Each Member State must submit such a report pursuant to Article 17, paragraph 1, of the Rules of Procedure concerning recommendations to Member States and international conventions covered by the terms of Article IV, paragraph 4, of the Constitution.

## (b) Collection of information concerning recommendations

The Secretariat will collect from Member States and National Commissions and from the various partners of the Organization such as non-governmental organizations (NGOs), information on the implementation of the recommendation in question.

This collection of information may be conducted on the basis of the model guidelines.

### (c) Preparation of reports

With regard to the conventions, the Member States may prepare reports, with the cooperation and support of the National Commissions, in accordance with the model guidelines approved by the Board. Within the limit of available resources, the guidelines may be made accessible on the Internet to Member States to enable them to draw up and submit their report to the Secretariat by electronic means.

With regard to the recommendations, the Secretariat will prepare a report on their implementation by the Member States, on the basis of the information collected, in particular with regard to national legislation.

### (d) Technical assistance provided by the Secretariat to Member States

In order to reduce their workload, the Secretariat will provide Member States, at their request or at the request of the General Conference, with technical assistance, which will focus both on a better understanding of the objectives of the convention or recommendation in question and on practical procedures for the preparation of their reports, in particular, the collection of information and the drafting of the reports.

# Stage 4: Consideration by the Executive Board of the reports for monitoring the effective implementation of conventions and recommendations

The Secretariat will submit to the Executive Board a summary of the reports received from Member States on the measures taken for the implementation of the conventions. The Executive Board may, if it so desires, ask the Secretariat to submit to it for consideration all the reports for each country.

With regard to recommendations, the Secretariat will submit its consolidated report on the implementation of these instruments, prepared on the basis of the information collected.

The documents prepared by the Secretariat will be examined by the Executive Board, which will entrust the task to the Committee on Conventions and Recommendations. The debates and work of the Executive Board and the CR Committee arising from their consideration of the reports will take place in public meetings.

The Executive Board will transmit these documents to the General Conference, together with its observations or comments and any that the Director-General may make, following their consideration by the Executive Board.

# Stage 5: Decision of the General Conference concerning the reports for monitoring the effective implementation of conventions and recommendations

The General Conference may take, as necessary, a decision with regard to the summaries of reports concerning the implementation of the conventions and recommendations.

The Director-General shall regularly inform the General Conference and the Executive Board with respect to the implementation of the decisions taken by the General Conference.

## Model guidelines

The Executive Board,

Recalling 15 C/Resolution 12.2, 23 C/Resolution 29.1 and 32 C/Resolution 77, 165 EX/Decision 6.2, 170 EX/Decision 6.2, 171 EX/Decision 27, 174 EX/Decision 21, 175 EX/Decision 28 and 176 EX/Decision 33 on the first aspect of the terms of reference of the Committee on Conventions and Recommendations (CR) relating to the implementation of UNESCO's standard-setting instruments,

- 2. <u>Having examined</u> document 177 EX/35 Parts I and II, and the report of the CR Committee thereon (177 EX/74),
- 3. <u>Having noted</u> that of the eight conventions for whose monitoring the CR Committee is now responsible, three are monitored regularly,
- 4. <u>Decides</u> accordingly to approve the framework guidelines as set out in annex to this decision for the three conventions referred to below:
  - Convention against Discrimination in Education (Paris, 14 December 1960);
  - Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property (Paris, 14 November 1970);
  - Convention on Technical and Vocational Education (Paris, 10 November 1989).

### **ANNEX**

#### **Framework Guidelines**

- I. Information on the legislative, judicial, administrative and other measures taken by the State at the national level
- (a) Pursuant to Article IV, paragraphs 4 and 6, and Article VIII of the Constitution, each State may provide information on its status in respect of UNESCO's conventions by indicating whether it plans to accede to the instruments to which it is not yet Party or which it has signed but not yet ratified.<sup>1</sup>
- (b) States should describe the specific legal framework governing the protection on their territory of the rights guaranteed by the UNESCO convention to which they are Parties. They should indicate, inter alia, whether the rights set forth in the convention are protected by their constitution, by a basic legislative text or by any other national provision, and whether the UNESCO convention has been incorporated into national legislation, and should make reference to the legal, administrative or other authorities competent in relation to the rights guaranteed by the convention and the scope of such competence.
- II. Information on the implementation of the convention (with reference to its provisions)

This part of the report provides States with an opportunity to concentrate on more specific questions pertaining to the implementation of the instrument concerned. It should contain the information requested by the Committee on Conventions and Recommendations in its most recent guidelines for the preparation of reports, and should set out the specific measures taken to respond to any concerns expressed by the Committee in its observations made at the conclusion of the examination of the State Party's previous report.

(a) Convention against Discrimination in Education

States should provide detailed information on:

(i) the means employed to proscribe discrimination in education for the reasons set out in the Convention, and to ensure equality of treatment in education;

In the case of the conventions on education, States Parties may wish to include information <u>transmitted to the United Nations treaty bodies</u> on their endorsement of other international human rights standards, in particular when such information is directly related to States' implementation of the provisions of UNESCO's conventions. States could indicate if they are Parties to regional human rights instruments.

- (ii) the measures taken to ensure equal opportunities in education, and to attain education for all (EFA), including gender parity in education, and to implement strategies and programmes in order to achieve in the country the full exercise by all of the right to education without discrimination or exclusion;
- (iii) progress made with respect to ensuring universal access to primary and secondary education, including technical and vocational education, and the means employed to protect the right of national minorities to carry out their own educational activities.
- (b) Convention on Technical and Vocational Education

States should provide detailed information on:

- the measures taken to define strategies and implement programmes and curricula for technical and vocational education designed for young people and adults, within the framework of the respective education systems;
- (ii) the measures taken to review periodically the structure of technical and vocational education, study programmes and plans, training methods and materials, as well as the forms of cooperation between the school system and the world of work, and the measures taken to give persons teaching in the field of technical and vocational education an opportunity to update their skills:
- (iii) the measures taken to facilitate international cooperation and to participate actively in international exchanges concerning study and teacher-training programmes, methods, equipment standards and textbooks in the field of technical and vocational education.
- (c) Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property

States should provide detailed information on the measures taken to:

- (i) combat the illicit transfer of ownership, such as setting up one or more national services for the protection of the cultural heritage, and establishing and keeping up-to-date a national inventory of protected cultural property whose export would constitute an appreciable impoverishment of the national cultural heritage;
- (ii) combat illicit excavations, such as supervising archaeological excavations, ensuring the preservation *in situ* of certain cultural property, and protecting certain areas reserved for future archaeological research;
- (iii) control the export of cultural property, such as introducing an appropriate certificate by which the exporting State would specify that the export of the cultural property in question is authorized.

# III. Methods introduced to draw the attention of the various authorities in the country to the instrument and to remove obstacles encountered

- (a) The report should contain an assessment of the effectiveness of the methods introduced to draw the attention of the various authorities of the country to the instrument and to remove obstacles encountered. It should highlight the difficulties encountered in implementing the key provisions of the convention, and the legal and practical obstacles encountered by States in implementing the convention.
- (b) States should describe briefly the main issues that need to be resolved in order to promote the implementation of the key provisions of the convention in the country, or

- what measures have been taken to launch an awareness-raising campaign and to promote ratification.
- (c) States should describe the measures taken to raise awareness of the basic principles of the convention, including their translation into national and, where necessary, local languages, and their national or local dissemination, in particular to non-governmental organizations. States should specify the activities undertaken or supported by the National Commission with a view to promoting the convention and fostering debate on critical issues, in relation to the rights enshrined in the convention.

Results of the seventh consultation of Member States on the implementation of the Convention and the Recommendation against Discrimination in Education (1960) (177 EX/36; 177 EX/74)

- 6. <u>Commends</u> the steps undertaken at the national level in order to meet the continuing challenges to the full implementation of the provisions of the Convention and Recommendation against Discrimination in Education;
- 7. Notes that as of 31 July 2007, 94 Member States had ratified the Convention;
- 8. <u>Invites</u> Member States which have not become a party to the Convention to consider doing so, and to make the Convention and Recommendation against Discrimination in Education as well as the Protocol instituting a Conciliation and Good Offices Commission of 1962 better known to the bodies, target groups and other entities concerned with matters dealt with therein, in line with Article 16.2 of the Rules of Procedure concerning recommendations to Member States and international conventions covered by the terms of Article IV, paragraph 4, of the Constitution of UNESCO:
- 9. Requests the Director-General to put special emphasis on and widely publicize the Convention against Discrimination in Education, and intensify his efforts to encourage Member States to adopt effective domestic measures intended to secure education for all without discrimination or exclusion as part of the EFA process:
- 10. <u>Invites</u> the Director-General to take appropriate action as a follow-up to the seventh consultation:
- 11. <u>Invites</u> all Member States to take an active part in the meeting of the States Parties to the Convention against Discrimination in Education and other Member States, to be held on 24 October 2007 on the sidelines of the 34th session of the General Conference;

- 12. <u>Requests</u> the Director-General to transmit document 177 EX/36, along with this decision and any related comments, to the General Conference at its 34th session for consideration and follow-up decision;
- 13. Recommends that the General Conference invite the Director-General to initiate the eighth consultation of Member States in order that its results may be examined by the Executive Board and then submitted to the General Conference at its 37th session in 2013.

- 4. Recognizes the key importance of the theme it addressed at its fifth and sixth meetings;
- 5. <u>Invites</u> all Member States, in that regard, to fulfil their respective commitments and international obligations relating to universalizing access to free primary education for all:
- 6. <u>Encourages</u> Member States without sufficient resources to seek international cooperation and assistance with a view to securing compulsory primary education free of charge for every child, and <u>invites</u> States in a position to assist to consider such requests for cooperation and assistance to promote the full exercise of the right to education;
- 7. Requests the Director-General to consider, in consultation with Member States, the recommendations made by the Joint Expert Group in paragraph 22 of document 177 EX/37;
- 8. <u>Invites</u> the Joint Expert Group to continue its consultations relating to monitoring the progressive achievement of the full exercise of the right to education, and to continue to examine key issues within its mandate;

Having examined document 177 EX/38 on the examination by the Executive Board of the new report by Member States and other States Parties on measures taken to implement the Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property (hereinafter "the 1970 Convention") and the two annexes to that document, which contain, respectively, the guidelines issued to facilitate the preparation of national reports on measures taken to protect and monitor cultural property, and the summaries of those reports,
- 3. <u>Noting</u> that the number of reports submitted by States Parties to the 1970 Convention remains very inadequate in view of the obligation of each State Party to report under Article 16 of the Convention,
- 4. <u>Noting with satisfaction</u> that several Member States not yet Parties to the 1970 Convention have provided information regarding their intention to ratify the Convention,
- 5. <u>Stressing</u> the importance of transmitting to UNESCO precise information on the measures taken by States to protect cultural property on their territory, particularly concerning the successes, failures and obstacles encountered in implementing the Convention, and on any requests for assistance which they might make in that respect,
- 6. <u>Considering</u> that action to combat trafficking in cultural property needs to be strengthened at the national as well as the international level,
- 7. <u>Invites</u> the States that are not yet Parties to the 1970 Convention and to the 1995 UNIDROIT Convention, which complements it, to consider acceding to them;
- 8. Reminds States Parties of their obligations under the 1970 Convention in respect of effective implementation, and in particular their obligation to report under Article 16 thereof:
- 9. <u>Emphasizes</u> that the content of such reports should be as detailed as possible to enable an accurate understanding and evaluation of the implementation of the 1970 Convention:
- 10. <u>Encourages</u> States Parties to the 1970 Convention to assess the national measures taken to implement the Convention so that areas of weakness may be identified and appropriate adjustments or improvements made as necessary;
- 11. <u>Invites</u> Member States and the Director-General to pursue activities aimed at strengthening regional and worldwide cooperation, particularly by encouraging the introduction of an international system to facilitate the restitution of stolen or illicitly exported cultural property;
- 12. Recommends that the General Conference adopt at its 34th session the following draft resolution:

"The General Conference.

Having examined the reports by Member States and other States Parties to the 1970 Convention on measures taken by them to implement the Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property (1970), and the information provided by the States Parties on measures taken to protect cultural property and monitor its illicit import, export and transfer of ownership,

Stressing the importance of transmitting to UNESCO precise information on the measures taken by States to protect cultural property in their territory, particularly

concerning the successes, failures and obstacles encountered in implementing the Convention, and on any requests for assistance which they might make in that respect,

Considering in particular the obstacles and progress mentioned by States in regard to action to combat the growing traffic in cultural property on the Internet,

Aware of the very great usefulness of these national reports for the Director-General and for the additional activities that he has undertaken since the 32nd session in regard to the protection of cultural property,

Noting with satisfaction the growing number of States Parties to the 1970 Convention, and *noting* the intentions of those that plan to become Parties and thus strengthen the effective scope of this international instrument,

- 1. Calls on all States that are not yet Parties to the 1970 Convention to consider acceding thereo;
- Recommends that States consider acceding to the UNIDROIT Convention on Stolen or Illegally Exported Cultural Objects (1995), which complements the 1970 Convention:
- 3. Encourages States to take cognizance of and apply without delay the Basic Actions concerning Cultural Objects being offered for Sale over the Internet, drawn up jointly by UNESCO, Interpol and the International Council of Museums (ICOM);
- 4. *Invites* States and the Director-General to pursue activities aimed at strengthening regional and international cooperation, in particular through the Intergovernmental Committee for Promoting the Return of Cultural Property to its Countries of Origin or its Restitution in Case of Illicit Appropriation;
- 5. Also invites the Director-General to assist States, at their request, in their efforts to implement the 1970 Convention, to prepare reports on such implementation, or on the means of becoming Parties to the Convention, and to propose other arrangements for the examination of national reports which are complementary to existing procedures."

  - (i) have a wider and more strategic assessment of the performance of the programmes, including the EX/4 document, by expressing its views progressively during the biennium through explicit decisions on the performance of individual programmes at the main-line-of-action level;
  - (ii) reflect on an improved time-frame to fully address all the issues involved in the preparation of the C/5 and C/6 documents;
  - (iii) better synchronize the process of preparation of the C/3, EX/4 and C/5 documents through streamlining and proper sequencing of these documents in an improved format;

- 2. Having examined document 177 EX/47,
- 3. <u>Notes</u> the use of the unspent balance of unliquidated obligations to liquidate other outstanding legal obligations of the Organization as explained in Note 5(ii)(c) to the Financial Statements (34 C/30 Annex, annexed to document 177 EX/47);
- 4. <u>Decides</u> to transmit the financial report of the Director-General together with the interim financial statements of UNESCO as at 31 December 2006 for the financial period ending 31 December 2007 to the General Conference at its 34th session.

48 Report by the Director-General on the actual position concerning all payment plans agreed upon between UNESCO and Member States in arrears with their contributions (177 EX/48 and Add.; 177 EX/78)

- 1. Having examined documents 177 EX/48 and Add.,
- 2. <u>Expresses its gratitude</u> to Member States that have paid their contributions for the financial period 2006-2007 and to those that have sped up the payment of their contributions in response to appeals;
- 3. <u>Notes</u> that the considerable efforts made by many Member States have not been enough to prevent recourse to internal borrowing at the end of November 2006 to supplement the resources of the Working Capital Fund for the purpose of financing the approved programme;
- 4. Recalls that the prompt payment of contributions is an obligation incumbent on Member States under the Constitution and the Financial Regulations of the Organization;

- 5. <u>Strongly supports</u> the approaches the Director-General is continuing to make to Member States with a view to obtaining timely payment of contributions;
- 6. <u>Urges</u> Member States, on receipt of the Director-General's request for payment of assessed contributions, to inform him as promptly as possible of the date, amount and method of payment of the forthcoming contribution, in order to facilitate his management of the Organization's treasury function;
- 7. <u>Urgently appeals</u> to those Member States that are behind with the payment of their contributions to pay their arrears without delay;
- 8. <u>Noting</u> in particular the failure of 17 Member States to pay up to 25 September 2007 the amounts due by them against payment plans approved by the General Conference for settlement of their accumulated arrears in annual instalments,
- 9. Recalling the request of the General Conference to the Director-General to report to it at its 34th session thereon,
- 10. <u>Urgently appeals</u> to those Member States in arrears on payment plans to settle their outstanding instalments as well as their regular assessed contributions at the earliest possible time, bearing in mind the risk of loss of voting rights that may otherwise ensue at the 34th session of the General Conference;
- 11. <u>Having taken note</u> of the options presented with regard to the incentive scheme to encourage prompt payment of contributions,
- 12. Recommends that the General Conference:

Resolve that the existing scheme to encourage prompt payment of contributions should be continued until the end of the following biennium (2008-2009), as follows:

- (a) the resources to be distributed to eligible Member States shall consist of:
  - (i) all other income classified as miscellaneous income within the definition of Article 7.1 of the Financial Regulations except UNDP support costs, net of exchange adjustments, interest costs on borrowing, bank and investment charges, and taking into account the balance of the currency fluctuation account of the split-level assessment system;
  - (ii) interest on investments of the Working Capital Fund;
  - (iii) contributions resulting from the assessment on new Member States under the provisions of Article 5.9 of the Financial Regulations, exclusive of contributions that may be assessed on former Member States rejoining the Organization;
  - (iv) any unobligated or unspent balances of appropriations available for apportionment to Member States as defined in Articles 4.3 and 4.4 of the Financial Regulations, after deducting therefrom any contributions relating to the appropriation of each financial period that remain unpaid;
- (b) the incentive points of eligible Member States shall be calculated by reference to the weighted scale shown in Annex VI of document 126 EX/35, taking into account dates and amounts of contributions paid, rounded to the nearest thousand United States dollars;

- (c) the funds available from the sources defined above at the end of the financial period shall be prorated to Member States that have paid in full their assessed contributions by the end of each year of the financial period concerned; if a Member State that has not paid in full for the first year pays the amount assessed for both years of the financial period before the end of the second year, that Member State will qualify for incentive points in the second year on the basis of contributions paid in respect of the amount assessed for that second year;
- (d) the share of resources to be distributed to each Member State shall be calculated according to the proportion of the incentive points accumulated by the Member State to the total pool of incentive points for the entire financial period;
- (e) the appropriate share of each eligible Member State shall be deducted from the contribution assessed on it for the second year of the subsequent financial period;

Further resolve that the relevant provisions of Articles 4.3, 4.4, 5.2 and 7.1 of the Financial Regulations shall be suspended for a two-year period commencing 1 January 2008;

13. <u>Requests</u> the Director-General to further examine these arrangements and to submit his findings to it at its 182nd session.

#### **ANNEX**

# Memorandum of Understanding between the South Asian Association for Regional Cooperation (SAARC) and the United Nations Educational, Scientific and Cultural Organization (UNESCO)

*Inspired* by the spirit of cooperation among Member States, which forms the basis of the foundation and operations of SAARC and UNESCO,

Founded upon the commonality of aims, goals and concerns, centred upon the development of UNESCO's fields of competence, e.g. education, culture, communication and information, and the sciences, between SAARC and UNESCO,

Considering the need to strengthen cooperation between UNESCO and the Member States of SAARC, and

Realizing that education, culture, communication and information and the sciences play a key role in socio-economic development and cultural progress,

SAARC and UNESCO agree on this Memorandum of Understanding, taking into account:

- the Charter of the South Asian Association for Regional Cooperation;
- the Constitution of UNESCO and its Medium-Term Strategy.

Accordingly, SAARC and UNESCO agree to cooperate mutually, as appropriate and possible and in agreed ways, to help Member States to:

- achieve Education for All, agreed upon at the World Education Forum, Dakar, 2000;
- achieve education-related SAARC Development Goals (SDGs);
- 3. promote pluralism through education by promoting dialogue among civilizations;
- 4. promote science and technology education, quality education and teacher training through increased use of ICTs and distance learning;
- conserve their cultural, tangible and intangible heritage; promote and protect their cultural diversity, in particular, their cultural, natural and intangible heritage, as well as their cultural expressions, while supporting a fruitful intercultural and interreligious dialogue, notably through:

   protecting and safeguarding activities for cultural heritage;
   promoting accession to and implementation of UNESCO's relevant standard–setting instruments; and
   enhancing capacity-building initiatives in these fields;
- 6. protect their environment and ecosystem;
- 7. build the capacity required for further advancement of education, culture, communication and information and the sciences;
- 8. facilitate technical cooperation, including capacity-building in the areas of education, culture, communication and information and the sciences;
- 9. promote freedom of expression and universal access to information.

To achieve the aforesaid aims, SAARC and UNESCO may:

- (i) inform each other of their initiatives and plans relevant to education, culture, communication and information and the sciences;
- (ii) exchange reports, technical publications and other documentation relevant to education, culture, communication and information and science activities;
- (iii) promote research, analysis and dissemination of information on such themes as enhancing technical cooperation and human resource development, including programmes in the mutually agreed areas;
- (iv) develop mutually agreed projects and programmes of collaboration.

This Memorandum of Understanding shall enter into force upon signature by the Secretary-General of SAARC and the Director–General of UNESCO.

Thematic debate: Facing the multidisciplinary challenges of knowledge societies and global climate change: UNESCO's contributions to United Nations reform at the regional and country levels (177 EX/INF.6; 177 EX/77)

- Noting with appreciation the holding of a thematic debate on the theme "Facing the multidisciplinary challenges of knowledge societies and global climate change: UNESCO's contributions to United Nations reform at the regional and country levels" on 2 October 2007 during its 177th session,
- 2. <u>Noting with gratitude</u> the remarks made by Mr Jean-Louis Borloo, Minister of State of France for Ecology, Sustainable Development and Planning, Dr Rajendra Pachauri, Chairperson, Intergovernmental Panel on Climate Change (IPCC), Mr Hamadoun Touré, Secretary-General, International Telecommunication Union (ITU), and Mr José Mariano Gago, Minister of Science, Technology and Higher Education of Portugal and President, European Council of Ministers of Higher Education,
- 3. Recalling Mahatma Gandhi's adage that "welfare of the last and impact on the least privileged" is of immediate importance,
- 4. <u>Bearing in mind</u> the importance of North-South-South (triangular) and South-South cooperation when addressing climate change.
- 5. Recognizing that climate change is a defining challenge of our times, and <u>noting</u> the importance of widely disseminating scientific knowledge, promoting sustainable development, and building knowledge societies as tools for addressing that challenge,
- 6. <u>Also recognizing</u> the important role of the mass media and information in raising awareness about issues related to climate change,
- 7. <u>Further recognizing</u> the unique advantages and multidisciplinary competencies available within UNESCO for making fundamental contributions to promoting sustainable development by building a knowledge base through scientific research and monitoring, taking advantage of its decentralized networks,

- 8. <u>Emphasizing</u> the need for ethical education for sustainable development, harnessing indigenous and traditional knowledge as well as human and social science research for developing national and regional initiatives to raise awareness of and help to address climate change,
- 9. <u>Invites</u> the Director-General to continue contributing to the global efforts to address climate change within UNESCO's mandate and competencies, as appropriate, by:
  - (a) strengthening efforts to finalize UNESCO's strategy on climate change, in consultation with Member States:
  - (b) emphasizing, in particular, the educational dimensions at all levels, and with particular focus on education for sustainable development (ESD);
  - (c) linking activities pertaining to higher education and scientific research, taking into account, as appropriate, the recommendations of the Overall Review of Major Programmes II and III after approval by the General Conference;
  - (d) consulting closely with the Intergovernmental Panel on Climate Change (IPCC), relevant United Nations bodies and other international bodies and experts on UNESCO's strategy on climate change and, as appropriate, with National Commissions and other representatives of civil society;
- 10. <u>Welcomes</u> the setting up by the Director-General of an intersectoral Secretariat Task Force on Climate Change under his chairmanship as a positive step in developing UNESCO's existing climate-related activities in an integrated manner;

- 3. <u>Further recalling</u> the role that UNESCO is called upon to play in order to satisfy the right to education for all, and to meet the need for Palestinians to have safe access to the education system,
- 4. Recalling paragraph 31 of the Medium-Term Strategy for 2002-2007 (31 C/4 Approved), defining a "road map for a revitalized UNESCO: principles of action and programming", and paragraph 12 of 31 C/Resolution 43,
- 5. <u>Committed</u> to the safeguarding of monuments, works of art, manuscripts, books and other historical and cultural properties to be protected in the event of conflicts,

- 6. <u>Deeply convinced</u> that the continuous strengthening of the reconstruction and development process in the Palestinian Territories should be carried out in a context of non-violence and of mutual respect and recognition, as promoted by the objectives of the road map,
- 7. <u>Supports</u> the efforts made by the Director-General with a view to the implementation of 33 C/Resolution 70 and 176 EX/Decision 49, and <u>requests</u> him to do everything possible to ensure that they are fully implemented in the framework of the Programme and Budget for 2006-2007 (33 C/5 Approved);
- 8. <u>Expresses its appreciation</u> for the substantial contributions of all concerned Member States, intergovernmental organizations and non-governmental organizations to UNESCO's action in the Palestinian Territories, and <u>appeals</u> to them to continue assisting UNESCO in this endeavour;
- Thanks the Director-General for the results that have been obtained in relation to the implementation of a number of current educational and cultural activities, and <u>invites</u> him to strengthen UNESCO's financial and technical assistance to the Palestinian educational and cultural institutions in order to address new needs and problems resulting from recent developments;

Expresses its continuing concern at any actions undermining the cultural and natural heritage, and cultural and educational institutions, as well as at any impediments which prevent Palestinian and all other schoolchildren and students from being an integral part of their social fabric and from exercising fully their right to education, and calls for the observance of the provisions of 33 C/Resolution 70 and 176 EX/Decision 49;
- 11. <u>Encourages</u> the Director-General to continue to reinforce his action in favour of the reconstruction, rehabilitation and restoration of the Palestinian archaeological sites and cultural heritage;
- 12. <u>Invites</u> the Director-General to address the needs for capacity-building in all UNESCO's fields of competence by expanding the financial assistance programme for Palestinian students both from the regular budget and from extrabudgetary resources, and <u>thanks</u> Saudi Arabia for its generous contribution in this regard;

16. <u>Decides</u> to include this item in its agenda at its 179th session, and <u>invites</u> the Director-General to submit to it a progress report thereon.

- 4. - 3. <u>Takes note</u> of the importance of regional cooperation on the critical question of water, which might be fostered by a water centre for sustainable development in Central America and the Caribbean in Santo Domingo, Dominican Republic;

Requests the Director-General to begin study of the proposal for the establishment of a water centre for sustainable development in Central America and the Caribbean in Santo Domingo, Dominican Republic as a category 2 centre in accordance with document 33 C/19, relating to the principles and guidelines regarding the establishment and operation of UNESCO institutes and centres (category 1) and institutes and centres under the auspices of UNESCO (category 2) as approved in 33 C/Resolution 90, and the guidelines of the strategy for UNESCO's category 1 and category 2 water-related centres.

Proposal for the establishment of an institute for African culture and international understanding at the Olusegun Obasanjo Presidential Library in Abeokuta, Ogun State, Nigeria, as a category 2 institute under the auspices of UNESCO (177 EX/69; 177 EX/78; 177 EX/79 Part II)

- 1. Having examined document 177 EX/69,
- 2. <u>Welcoming</u> the proposal by the Government of Nigeria for the establishment of an institute for African culture and international understanding under the auspices of UNESCO (category 2),
- 3. <u>Stressing</u> the importance of this proposal for safeguarding Africa's unique cultural heritage and fostering cultural diversity and intercultural dialogue in Africa,

- 1. Recalling the foundation of the international township of Auroville, in South India, in February 1968, when the youth of 124 Member States participated in the ceremony by depositing the soil of their countries in the foundation urn to symbolize the coming together of the nations of the world,
- 2. <u>Noting</u> that the Charter of Auroville, announced at the Foundation Ceremony, declares that Auroville belongs to nobody in particular but to humanity as a whole,
- 3. Recognizing that the aims of Auroville are to promote international understanding, peace, innovative education, a learning society, and all-round material and spiritual development for harmonious individual and collective growth, and that such aims contribute to the advancement of the objectives of UNESCO, especially dialogue among civilizations, cultures and religions, cultural diversity, and culture as a factor for development,

- 4. Recalling that in 1983 the General Conference adopted a resolution inviting Member States and international non-governmental organizations to participate in the development of Auroville as an international cultural township,
- 5. <u>Conscious</u> therefore of the broad range of activities undertaken by governments, National Commissions for UNESCO, and international non-governmental organizations to promote the development of Auroville as an important international cultural programme.
- 6. Recognizing the value of such civilizing experiences as an invaluable and integral part of the commonly shared human experience,
- 7. Also recognizing that Auroville is a successful and unique model project, proving the capacity of an international community, after 40 years of existence, to continue to live up to its initial founding ideals of peace and international harmony and within the spirit of mutual respect and understanding, tolerance, dialogue, cultural diversity, quality education and sustainable development which are also UNESCO's own values and principles, as well as some of its major priorities,
- 8. <u>Noting</u> that 28 February 2008 will mark the 40th anniversary of the setting up of Auroville project,
- 9. <u>Invites</u> the Director-General to reinforce the association of UNESCO, and in particular its Culture Sector, with Auroville in the context of the commemorative activities for its 40th anniversary.

71 Creation of a network of national authorities to support migrants who are victims of discrimination and xenophobia (177 EX/71; 177 EX/INF.11; 177 EX/78; 177 EX/79 Part III)

- 1. Recalling 164 EX/Decision 3.4.2 adopted in April 2002, which invited the Director-General to develop "an integrated strategy to combat racism, discrimination, xenophobia and related intolerance",
- 2. <u>Taking into account</u> the integrated strategy to combat racism, discrimination, xenophobia and related intolerance adopted by the General Conference at its 32nd session in 2003,
- 3. Recalling the establishment of Coalitions of Cities against Racism, Discrimination and Xenophobia on three continents, and the adoption of their respective 10-point Plans of Action,
- 4. <u>Noting the results</u> of the 16th Ibero-American Summit of Heads of State and Government, held in Montevideo, Uruguay, from 3 to 5 November 2006, the theme of which was "Migration and Development", as well as the Final Declaration of the first Ibero-American Forum of Local Authorities, held in Montevideo, Uruguay, from 25 to 27 October 2006,
- 5. <u>Also noting</u> the International Convention on the Protection of the Rights of All Migrant Workers and Members of Their Families, adopted by the United Nations General Assembly in 1990, which has been in force since 2003,
- 6. <u>Aware</u> that in the twenty-first century, mobility and migration, whether within States or across borders, voluntary or involuntary, is a reality for a growing number of persons,

- 7. Affirming that both countries of emigration and countries of immigration would benefit if intending migrants were better informed about their potential legal rights in the event that they are victims of discrimination or xenophobia, as well as about their duty to comply with the requirements of the destination country, and once migrants have arrived in the destination country, about the means of ensuring that their rights are respected,
- 8. <u>Invites</u> the Director-General, within the existing framework of the International Coalition of Cities against Racism to undertake a study to assess the proposal in document 177 EX/71 "Creation of a network of national authorities to support migrants who are victims of discrimination and xenophobia";
- 9. <u>Further invites</u> the Director-General to present to it the results of the study at its 180th session, including administrative and financial implications, and within the context of UNESCO's programmes and its strategic objectives on issues relating to discrimination and xenophobia, as adopted in document 34 C/5;
- 10. <u>Encourages</u> Member States to share with UNESCO information regarding the possible creation of a network of national authorities in this regard.

## 72 Situation of Iraqi refugee pupils and students in the Syrian Arab Republic (177 EX/72; 177 EX/INF.11; 177 EX/79 Part II)

- 1. Having examined document 177 EX/72,
- 2. Recalling UNESCO's education for all (EFA) goals and the Millennium Development Goals (MDGs) concerning education and teaching to be achieved by 2015,
- Expressing its concern over the high and growing numbers of Iraqi refugee pupils and students in the Syrian Arab Republic as a result of the situation in Iraq, and over the financial, social and structural consequences arising therefrom, which no State can bear alone without adversely affecting its economic, social and educational planning capacities,
- 4. <u>Commending</u> the efforts of the Syrian Arab Republic to alleviate the suffering of Iraqi refugee pupils and students by endeavouring to integrate them into its schools and universities and by meeting their basic needs,
- 5. Requests the Director-General:
  - (a) to dispatch a mission to examine and assess the situation of these pupils and students in order to find ways of meeting their needs in cooperation and coordination with the educational authorities of the Syrian Arab Republic concerned:
  - (b) to continue consultations and ensure appropriate coordination with relevant United Nations agencies with a mandate for assisting refugees, as well as with the Iraqi Government;
  - (c) to submit a report, closely coordinated with the UNHCR and UNICEF appeals, containing the results of its consultations and recommendations and practical measures aimed at mobilizing the international community to provide the necessary urgent assistance to the Government of the Syrian Arab Republic in support of its efforts to meet the needs of the Iraqi pupils and students for the current academic year;

6. <u>Decides</u> to include this item in the agenda of its 179th session, and <u>requests</u> the Director-General to submit to it an interim report on this matter.

## 73 Celebration of the 60th anniversary of the Universal Declaration of Human Rights (177 EX/73; 177 EX/78; 177 EX/79 Part II)

The Executive Board,

- 1. Recognizing the utmost importance of the Universal Declaration of Human Rights for the promotion and exercise of human rights and fundamental freedoms,
- 2. <u>Underlining</u> the significance of the 60th anniversary of the Universal Declaration of Human Rights for giving new impetus to international and national efforts aimed at ensuring universal respect for and enjoyment of all human rights civil, cultural, economic, political and social and fundamental freedoms, recognizing that all human rights are equal and mutually reinforcing,
- 3. Recalling the Vienna Declaration and Programme of Action adopted by the World Conference on Human Rights on 25 June 1993,
- 4. <u>Also recalling</u> the United Nations Millennium Declaration and the Millennium Development Goals, as well as the 2005 World Summit Outcome document, which underscored the importance of human rights for the work of the United Nations system,
- 5. <u>Emphasizing</u> the specific responsibilities and competence of UNESCO with regard to human rights, as well as its reflection on emerging human rights in the context of UNESCO's core mandates.
- 6. <u>Affirming</u> UNESCO's key role in the promotion of human rights, including *inter alia* human rights education,
- 7. <u>Further recalling</u> UNESCO's contribution to the celebration of the 40th and 50th anniversaries of the Universal Declaration of Human Rights in 1988 and 1998,
- 8. Having considered document 177 EX/73,
- Urges all public and private institutions within the Member States, civil society, including non-governmental organizations, educational institutions and educators, as well as National Commissions and human rights institutions, to contribute to the celebration of the 60th anniversary by undertaking activities in order to further promote and protect human rights and fundamental freedoms;
- 10. Requests the Director-General, in the light of the proposals of Member States, and in consultation with the United Nations High Commissioner for Human Rights, to submit to the General Conference at its 34th session a draft plan of action, a timetable and a cost estimate for the celebration by UNESCO of the 60th anniversary of the Universal Declaration of Human Rights;
- 11. <u>Invites</u> the Director-General to take the appropriate steps to implement the plan of action as approved by the General Conference, <u>further invites</u> the Director-General to seek extrabudgetary resources to support implementation of that plan, and <u>invites</u> Member States to consider making extrabudgetary contributions in this regard.
