# PROTOCOL INSTITUTING A CONCILIATION AND GOOD OFFICES COMMISSION TO BE RESPONSIBLE FOR SEEKING THE SETTLEMENT OF ANY DISPUTES WHICH MAY ARISE BETWEEN STATES PARTIES TO THE CONVENTION AGAINST DISCRIMINATION IN EDUCATION: NOMINATIONS AND REPORT OF THE COMMITTEE ON CONVENTIONS AND RECOMMENDATIONS THEREON 


#### Abstract

SUMMARY In accordance with Article 3, paragraph 2, of the above Protocol, the Director-General communicates to the Executive Board the list of persons nominated by the States Parties to the Protocol for the purpose of the election of five members of the Conciliation and Good Offices Commission by the General Conference at its next session.

Under the terms of the same paragraph, the Executive Board is required to transmit this list to the General Conference with such suggestions as it may consider useful.

Decision proposed: paragraph 14.


1. At its 12th session on 10 December 1962, the General Conference adopted a Protocol instituting a Conciliation and Good Offices Commission to be responsible for seeking the settlement of any disputes which may arise between States Parties to the Convention against Discrimination in Education. ${ }^{1}$
2. Article 1 of this Protocol established, under the auspices of UNESCO, a Conciliation and Good Offices Commission, to be responsible for seeking the amicable settlement of disputes, between States Parties to the Convention, concerning the application or interpretation of the Convention.

[^0]3. The Protocol having entered into force on 24 October 1968, the General Conference at its 16th session, under Article 2 of the Protocol, elected the 11 members of the Commission on 6 November 1970.
4. The term of office of one member of the Commission, Mr Iskander Ghattas (Egypt), expiring, the General Conference at its 33 rd session will be required to fill the corresponding vacant seat.
5. Three further seats, vacant since the 32 nd session, and the vacant seat of a member of the Commission elected at that same session of the General Conference, Mr Louis Peter van Vliet (Netherlands), who decided to stop being a member as of 1 September 2004, also remain to be filled.
6. A list of members of the Commission, with indication of the dates of their election or reelection, appears in Annex I.
7. Under Article 2 of the Protocol, the members of the Commission must be persons of high moral standing and acknowledged impartiality. They serve in their personal capacity. In the election of members of the Commission, the General Conference shall endeavour to include persons of recognized competence in the field of education and persons having judicial experience, or legal experience, particularly of an international character. It shall also give consideration to equitable geographical distribution of membership and to the representation of the different forms of civilization as well as of the principal legal systems.
8. Article 4, paragraph 1, of the Protocol provides that the Commission may not include more than one national of the same State.
9. Article 3, paragraph 1, of the Protocol provides that the members of the Commission shall be elected from a list of persons nominated for the purpose by the States Parties to the Protocol, after consultation with their National Commissions for UNESCO. Each State Party may nominate not more than four persons, who must be nationals of States Parties to the Protocol.
10. In pursuance of paragraph 2 of the same Article, the Director-General, by letter DG/18/2005/006 of 5 March 2005, invited the States Parties to the Protocol to submit nominations, specifying the vacant seat for which they are submitting the nomination. In accordance with the Record of the Meeting of the States Parties to the 1962 Protocol (Paris, 7 and 8 October 2003), ${ }^{2}$ the Director-General also recalled the terms of Article 7 of the Protocol, whereby, subject to the provisions of Article 6, members of the Commission shall remain in office until the election of their successor.
11. The list of States Parties to the Protocol as at 1 June 2005 is reproduced in Annex II.
12. At the date of the preparation of the present document no State had presented any candidates.
13. It is further to be noted that at the request of its Chairperson, Mr Francesco Margiotta-Broglio (Italy), the Commission will meet on 13 and 14 October 2005 in parallel with the 33rd session of the General Conference, so as to examine and adopt proposed amendments to the Rules of Procedure of the Commission ${ }^{2}$ that may help revitalize this procedure.
14. The Board may wish to adopt a draft decision along the following lines:

The Executive Board,

1. Recalling the provisions of Article 3 of the Protocol instituting a Conciliation and Good Offices Commission to be responsible for seeking the settlement of any disputes which may arise between States Parties to the Convention against Discrimination in Education,
2. Having taken note of document 172 EX/24 and of the fact that no persons have yet been nominated by the States Parties to the aforementioned Protocol for the purpose of the election of five members of the Commission,
3. Requests the Director-General to transmit to the General Conference any candidatures which he may receive before the opening of its 33 rd session.

She is a founding member and member of the board of the Al Karma Center for Human Development, another NGO working in the field of research and projects related to human development. She is also a founding member and member of the board of the Egyptian National Competitiveness Council, formed by academicians, business people and civil society to enhance Egypt's competitiveness among comparable nations and to support Egypt's direction towards the knowledge-based society.

Dr El-Kaffass is a member of the Supreme Policies Council/the Policies Secretariat of the National Democratic Party - the majority party of Egypt. She is also a member of the Parliamentarian Committee of the Party and executive board member of its Education and Scientific Research Committee. Further, she is a member of the education committee of the National Specialized Councils of Egypt, formed of politically appointed intelligentsia to advise on education reform in Egypt. Through her membership in these political committees she has played a recognized role in developing and promoting a number of policies related to educational reform in Egypt such as the policy on decentralization and community participation, secondary education reform, student comprehensive evaluation, enhancing student life, establishing the knowledge-based society, reforming scientific research and linking education to the labour market, among others. Dr El-Kaffass has recently been appointed by Egypt's Prime Minister as member of the Technical Committee for the Cabinet of Ministers' Team on Human Development. The Team on Human Development is formed of 12 cabinet ministers whose responsibilities directly impact human development such as education, culture, health, youth, employment, media and others. The goal of the Team is to coordinate policies and procedures taken by different ministries in a collaborative effort to ensure human development in Egypt.

Dr El-Kaffass is holder of a Ph.D. degree in Higher Education Administration from Bowling Green State University, Ohio, United States of America, with specialization in organizational assessment and development. Her Master's Degree is in Public Administration with specialization in organizational development from the American University in Cairo, and her bachelor's degree is in Political Science, with specialization in political sociology from the American University in
