Informal Meeting of National Commissions for UNESCO during the 185th session of the Executive Board

(Friday 15 October 2010 at 08:40 – 10:00 in Room VI)

SUMMARY REPORT

- 1. At the invitation of Mr Eric Falt, Assistant Director-General for External Relations and Public Information (ADG/ERI), an informal breakfast meeting of National Commissions for UNESCO was held on 15 October 2010. It was organized to review the recent activities and to exchange information relating to National Commissions. The meeting was chaired by Mr Luis Ramallo, President of the Spanish National Commission and the Chairperson of the Coordinating Group of National Commissions. More than 60 participants, representing over 40 National Commissions from all regions as well as the UNESCO Secretariat, took part in the meeting (**Annexes:** The agenda of the meeting and the list of participants).
- 2. In his opening remarks, Mr Eric Falt informed the participants of the recent establishment of the new ERI Sector (following the integration of the former BPI into the former ERC) and its priorities. Mr Falt stated that one of his objectives as ADG/ERI was to contribute to the strengthening of UNESCO's relations with National Commissions. He expressed satisfaction that National Commissions were involved in all levels of UNESCO's action, its outreach to civil society as well as in its governance (for instance, 16 out of 58 members of the current Executive Board are either Chairs or Secretaries-General of National Commissions). He also commended National Commissions' initiatives and efforts in promoting the North-South-South cooperation, such as the Partnership with Africa and the Euro-Arab Dialogue. Noting that over 170 National Commissions took part in the DG consultations on the draft 36 C/5, Mr Falt thanked the host Member States (Morocco, Republic of Korea, United Kingdom, Uganda and Trinidad and Tobago) for their hospitality. Referring to the deliberations in the current session of the Executive Board, Mr Falt stressed that the Secretariat and Member States need to work together to strengthen the status and operational capacities of National Commissions. In that connection, he suggested that an evaluation of the performances and best practices of NatComs as well a comparative study of national cooperating networks of other UN sister agencies could be undertaken. He concluded by saying that the transformation of UNESCO into an efficient, visible and truly intellectual entity would perhaps entail also the transformation of its National Commissions.
- 3. Mr Amir Piric, Chief of the Evaluation Section (IOS/EVS), spoke about the Independent External Evaluation of UNESCO (IEE), which submitted its report to the Executive Board (Document 185 EX/18). Mr Piric briefly explained several steps which enabled the external evaluators to prepare their report (including the consultations with National Commissions) with the help of extra budgetary funding. In replying to the questions posed by the participants, he explained that in the IEE report the added value of National Commissions was examined in the context of UNESCO's wider network of civil society partners and intellectual/scientific communities. He said that while there was a clear understanding of the importance of National Commissions, there were nevertheless several National Commissions, which were short of resources and capacities.
- 4. During the ensuing exchange of views, the representatives of several National Commissions (e.g. Egypt, Uzbekistan, Slovenia, New Zealand, Brazil, Sri Lanka, Mali, Congo, Serbia, Latvia, Greece, Germany, Uganda, Tunis, Norway, Costa-Rica, France, Canada, United Kingdom, Spain, etc.) took the floor to make the following remarks and suggestions:

General remarks

- The importance of National Commissions as national cooperating bodies of UNESCO is undeniable. They represent a unique network and a comparative advantage for UNESCO within the UN. They assure the sustainability of UNESCO's action in Member States. These fundamental principles must be respected by all members of the Secretariat. The Organization should make the most of them, especially in strengthening its cooperation with them.
- The role of National Commissions as "privileged" counterparts of UNESCO and the focal points in each Member State needs to be clarified, especially with regard to their participation in programme execution as stipulated in UNESCO's administrative manuals. It was noted that although the direct responsibility for programme execution remained within the Secretariat, including its Field Offices, National Commissions should continue, wherever appropriate, to be involved in programme delivery via contractual arrangements.
- The report of the Independent External Evaluation of UNESCO does not sufficiently focus on the role of National Commissions. The report and its recommendations essentially touch on the need to strengthen the capacities of National Commissions but it does not elaborate on the participation and contribution of National Commissions in UNESCO's wide-ranging action and its presence in the field.
- In many countries, especially where UNESCO is not a resident agency, National Commissions are often considered "to be UNESCO" by local populations. Furthermore, the Organization and its objectives are known at the national level largely thanks to the work of National Commissions.
- The existing rules and regulations of UNESCO stipulate that the Secretariat should keep National Commissions informed of any activity taking place in their country or involving their nationals. Unfortunately, these provisions are sometimes not respected, especially by UNESCO Field Offices, which in consequence causes confusions and frustrations.
- The status of National Commissions should be carefully examined in the context of the larger reform within the UN system and UNESCO's participation in the "UN Delivering as One" process in which National Commissions are also invited to play a role. The coordination and cooperation between National Commissions and UNESCO Field Offices in this regard must be improved.
- One of the efficient ways of strengthening the operational capacities of National Commissions is to involve them in programme execution. By implementing concrete activities and projects, National Commissions can build efficiently their capacities, gain experience and obtain credibility and recognition.
- The cooperation among National Commissions, especially within the North-South-South context, should be further expanded, as one of the efficient ways of promoting international cooperation and capacity-building of National Commissions.

Specific suggestions

• The National Commissions need a more formal inter-regional platform to engage in inter-regional interaction, in addition to the current regional mechanisms (e.g. quadrennial conferences, consultations on C/4 & C/5, informal regional meetings during the General Conference, etc.). While the efforts in holding informal meetings on the margins of the Executive Board sessions are appreciated, there is a clear need to formalize such meetings, so that (1) more time could be secured for deliberations and debates

and (2) the observations and recommendations made therein could be adequately followed-up.

<u>Note</u>. Several participants regretted that there was no sufficient time to discuss all items on the draft agenda of the informal meeting, which lasted about an hour.

- A working group of selected National Commissions (one representative per each region) can be set up to reflect on how to prepare and organize future interregional meetings of National Commissions. Such a group could work via emails with the help of the NAC Section.
- There could be a half or one day meeting during sessions of the Executive Board for discussion on issues relating to National Commissions.
- The strengthening of National Commissions' capacities is a shared responsibility of Member States and the UNESCO Secretariat. The Director-General should send a new circular letter to Member States with a strong message on the added value of National Commissions and on the need to strengthen them.
- Clear criteria should be set to assess the efficiency of National Commissions. To
 that end, the National Commissions should regularly prepare the annual reports of their
 activities and send them to UNESCO. Each National Commissions should decide itself
 on the format for its reports.
- 5. In his reply to the above remarks, Mr Jacques Rao, DIR/ERI/RSC, stated that this type of meetings and discussions with National Commissions were always useful and constructive. He assured the participants that as in the past, the Secretariat would prepare the minutes of the discussions and send it to all National Commissions. He said that the Secretariat was committed to study the proposals expressed by the participants (e.g. the move from informal meetings of NatComs during the Executive Board into **a more formal gatherings**; providing more time for debate as well as adequate premises/facilities for future meetings; creating **an interregional platform** for interaction; considering the role of National Commissions in the new field network and the UN Delivering as One process, preparation of the DG's circular letter to governments; requesting **annual reports** from National Commissions on their activities; etc.) and to explore the possibility of implementing them. He also encouraged the participating NatCom officials to share their constructive views, addressed to the Secretariat, also with Executive Board members and relevant government officials. Finally, he indicated that the ERC/RSC/NAC Section will follow-up on the idea of setting-up a small representative working group of National Commissions to advise on the implementation of these proposed changes.
- 6. Mr Xiaolin Cheng, Chief, ERI/RSC/NAC, underscored that the NAC Section was currently finalizing, in collaboration with donor countries, several activities to promote the North-South-South cooperation among National Commissions and to contribute in their capacity-building. In that connection, he informed the participants of the upcoming events and training programmes, including an interregional forum on the rapprochement of cultures and the usual interregional seminar for new Secretaries-General of National Commissions (early next year).
- 7. The participants paid tribute to Ahmed Sayyad, former ADG/ERC as well as to Mr Walter Lerouge, former President of the Flemish National Commission (now Honorary President of the Flemish National Commission), and Mr Harry Reeves, former Secretary-General of the UK National Commission, for their dedication to UNESCO's ideals and for their contribution in strengthening National Commissions' worldwide network.
