Comprehensive report by the Director-General on UNESCO's standard-setting instruments

SUMMARY

Pursuant to 33 C/Resolution 88 of the General Conference, the Director-General submits to the Executive Board this information document which contains particulars, as at 1 July 2013, of the standard-setting activities envisaged at UNESCO and a comprehensive report on all the Organization's standard-setting instruments, and more particularly on the status of ratification of conventions, for transmission to the General Conference at its 37th session, along with any comments the Executive Board may consider it useful to make at this session.

No decision is required.
