



# Outline of contribution from Japan through the Japanese Funds-in-Trust

UNESCO has enjoyed a long-standing and solid cooperation with the Government of Japan. The Ministry of Education, Culture, Sports, Science and Technology of Japan (MEXT) deposited its first Funds-in-Trust in 1969 and the Ministry of Foreign Affairs also did its first Funds-in-Trust in 1989. Since then, Japan has been one of the UNESCO's most notable donors in terms of voluntary contributions and has been actively engaged in the promotion of international cooperation in the fields of education, natural sciences, social and human sciences, culture as well as communication and information, thus helping UNESCO to fulfill its tasks to entrench the values of "peace in the minds of men".

**Japan's annual voluntary contributions to UNESCO amounted to about US\$ 11-12 millions (Year 2008).**

## Priorities

Japan has been involved in the UNESCO activities through several funds-in-trust schemes. In particular, Japanese contribution focuses on Education for All (EFA), the preservation and safeguarding of tangible and intangible cultural heritage, capacity building of human resources in developing countries, Education for Sustainable Development (ESD), promotion of scientific research including the projects related to International Hydrological Programme (IHP), Intergovernmental Oceanographic Commission (IOC) and the Man and the Biosphere Programme (MAB), and promotion of international cooperation and mutual understanding.

## Geographical focus

The Japanese cooperation through the UNESCO / Japan Funds-in-Trust is extended throughout the world, with focuses on **Asia-Pacific and Africa**.

## The Ministry of Foreign Affairs of Japan

The Ministry of Foreign Affairs of Japan is currently assisting to finance the three following programmes:

- **Preservation of the World Cultural Heritage** – UNESCO and Japan celebrate this year the 20th anniversary of this funds-in-trust which was established in 1989. Its purpose is to preserve the tangible cultural heritage such as historical monuments and archaeological remains of great value.
- **Safeguarding of Intangible Cultural Heritage** – As one of the main actors who have actively contributed to the 2003 Convention for the Safeguarding of the Intangible Cultural Heritage, Japan has strongly promoted the ratification of the Convention by other member countries and supported its implementations at national, regional and international levels.

- **Capacity-building of Human Resources** – this large scale funds-in-trust has been financing, since its establishment in 2000, a number of projects which aim in strengthening human capacity in the developing countries (especially in LDC). This funds-in-trust covers all the five programme sectors' actions, namely Education, Natural Sciences, Social and Human Sciences, Culture as well as Communication and Information. The priorities are accorded to the World Water Assessment Programme (WWAP), EDUCAIDS (preventive education against HIV/AIDS), TTISSA (teacher training projects in Sub-Saharan African countries), fellowships programmes, International Programme for the Development of Communication (IPDC), assistance for science reform, youth violence prevention, etc.

## The Ministry of Education, Culture, Sports, Science and Technology of Japan

The Ministry of Education, Culture, Sports, Science and Technology of Japan (MEXT) provides financial assistance to the projects under following programmes.

To promote mutual understanding by means of exchange of students, teachers and other professionals, international meeting and other activities in all UNESCO's fields of competence:

- Promotion of International Cooperation and Mutual Understanding.

To support the UNESCO's implementation of the UN Decade of Education for Sustainable Development as well as activities in education at all level from non-formal, primary, secondary and higher education:

- Education for Sustainable Development (ESD);
- Education for All (EFA);
- Preventive Education against HIV/AIDS;
- Mobile Training Team under the APEID programme;
- Promotion of Effective Use of Information and Communication Technologies in Education.

To foster the UNESCO's activities in science which contribute to scientific advancement as well as capacity building in the areas of freshwater, biodiversity and ecosystem, ocean, basic science and science policy:

- Scientific Programmes on Global Challenges in Asia and the Pacific Region;
- Promotion of Scientific Programmes for Sustainable Development in Asia and the Pacific;
- Promotion of Intergovernmental Oceanographic Commission/ Sub-Commission for the Western Pacific.

# Présentation de la contribution apportée par le Japon par l'intermédiaire des Fonds-en-dépôt japonais

L'UNESCO jouit d'une coopération ancienne et solide avec le Gouvernement du Japon. Le ministère japonais de l'éducation, de la culture, des sports, des sciences et des technologies a déposé pour la première fois un fonds-en-dépôt en 1969 et le ministère des affaires étrangères a fait de même en 1989. Depuis lors, le Japon est l'un des donateurs les plus remarquables de l'UNESCO en termes de contributions volontaires et s'engage activement en faveur de la promotion de la coopération internationale dans les domaines de l'éducation, des sciences naturelles, sociales et humaines et de la culture, ainsi que de la communication et de l'information, aidant ainsi l'UNESCO à remplir ses missions en vue d'enraciner les valeurs de la « paix dans l'esprit des hommes ».

**Les contributions volontaires annuelles du Japon à l'UNESCO étaient de l'ordre de 11 à 12 millions de \$US pour l'année 2008.**

## Priorités

Le Japon participe aux activités de l'UNESCO par l'intermédiaire de plusieurs mécanismes de fonds-en-dépôt. La contribution japonaise se concentre en particulier sur l'Éducation pour tous (EPT), la préservation et la sauvegarde du patrimoine culturel matériel et immatériel, le renforcement des capacités des ressources humaines dans les pays en développement, l'éducation en vue du développement durable (EDD), la promotion de la recherche scientifique, notamment des projets liés au Programme hydrologique international (PHI), à la Commission océanographique intergouvernementale (COI), au Programme sur l'homme et la biosphère (MAB), et à la promotion de la coopération internationale et de la compréhension mutuelle.

## Geographical focus

La coopération japonaise administrée par l'intermédiaire du fonds- en-dépôt UNESCO/Japon s'étend au monde entier, en mettant particulièrement l'accent sur l'Asie-Pacifique et l'Afrique.

## Le ministère des affaires étrangères du Japon

Le ministère des affaires étrangères du Japon contribue actuellement au financement des trois programmes suivants :

- **Préservation du patrimoine culturel mondial – L'UNESCO** et le Japon célèbrent cette année le 20<sup>e</sup> anniversaire de ce fonds-en-dépôt créé en 1989, qui a pour objet de préserver le patrimoine culturel matériel que sont notamment les monuments historiques et les vestiges archéologiques de grande valeur.
- **Sauvegarde du patrimoine culturel immatériel** – En tant que l'un des principaux acteurs qui ont contribué activement à la Convention adoptée en 2003 pour la sauvegarde du patrimoine culturel immatériel, le Japon s'est employé à promouvoir fortement la ratification de la Convention par les autres pays membres et a soutenu sa mise en œuvre aux niveaux national, régional et international.

- Renforcement des capacités des ressources humaines – Ce fonds-en-dépôt de grande ampleur finance, depuis sa création en 2000, divers projets visant à renforcer les capacités humaines dans les pays en développement (en particulier dans les PMA). Il couvre l'ensemble des actions des cinq secteurs de programmes, à savoir l'éducation, les sciences naturelles, les sciences sociales et humaines et la culture, ainsi que la communication et l'information.

Sont notamment prioritaires le Programme mondial pour l'évaluation des ressources en eau (WWAP), EDUSIDA (éducation préventive contre le VIH et SIDA), TTISSA (projets de formation des enseignants dans les pays d'Afrique subsaharienne), des programmes internationaux de bourses, le Programme international pour le développement de la communication (PIDC), l'aide à la réforme scientifique et la prévention de la violence des jeunes.

## Le ministère japonais de l'éducation, de la culture, des sports, des sciences et des technologies

Le ministère japonais de l'éducation, de la culture, des sports, des sciences et des technologies apporte une aide financière aux projets engagés dans le cadre des programmes suivants.

En vue de promouvoir la compréhension mutuelle au moyen d'échanges d'élèves, d'enseignants et d'autres professionnels, de réunions internationales et d'autres activités relevant de tous les champs de compétence de l'UNESCO :

- Promotion de la coopération internationale et de la compréhension mutuelle.

En vue de soutenir la mise en œuvre par l'UNESCO de la Décennie des Nations Unies pour l'éducation au service du développement durable, ainsi que des activités à tous les niveaux de l'éducation – non formelle, primaire, secondaire et supérieure :

- L'Éducation en vue du développement durable (EDD) ;
- L'Éducation pour tous (EPT) ;
- L'éducation préventive contre le VIH / SIDA ;
- L'Équipe mobile de formation dans le cadre du programme APEID ;
- La promotion de l'utilisation efficace des technologies de l'information et de la communication dans l'enseignement.

En vue de favoriser les activités de l'UNESCO dans le domaine des sciences contribuant aux progrès scientifiques et au renforcement des capacités dans les domaines de l'eau douce, de la biodiversité et des écosystèmes, des océans, des sciences fondamentales et des politiques scientifiques :

- Les programmes scientifiques consacrés aux défis mondiaux dans la région Asie et Pacifique ;
- La promotion de programmes scientifiques en vue du développement durable en Asie et dans le Pacifique ;
- La promotion de la Commission océanographique intergouvernementale/Sous-Commission pour le Pacifique occidental.

Founded in 2000 as a leading project of UNESCO-Japan Funds-in-Trust, the World Water Assessment Programme (WWAP) is a flagship programme of UN-Water bringing 26 UN agencies and numerous prominent non-UN institutions together to develop the tools and skills needed to achieve a better understanding of the processes, management practices and policies that will help improve the supply and quality of global freshwater resources.

WWAP's overarching mission is to promote sustainable social and economic development at local, national, regional and global scales. To this end, WWAP seeks to influence leaders in government, civil society and private sector, so that the availability and quality of water is taken into account in policy and decision making processes.

Créé en l'an 2000 et conçu comme un des principaux projets du fonds-en-dépôt UNESCO/Japon, le Programme mondial pour l'évaluation des ressources en eau (WWAP) est un programme phare d'ONU-Eau, dans le cadre duquel 21 institutions du système des Nations Unies et nombre d'autres organisations importantes coopèrent afin de mettre au point les outils et de développer les compétences nécessaires pour mieux comprendre les processus et les pratiques et politiques de gestion qui contribueront à améliorer l'approvisionnement en eau douce et la qualité des ressources en eau à travers le monde. La principale mission du WWAP est de promouvoir un développement socioéconomique durable aux niveaux local, national, régional et mondial. À cette fin, le WWAP s'emploie à influer sur les responsables des milieux gouvernementaux, de la société civile et du secteur privé afin que les disponibilités en eau douce et la qualité de cette dernière soient prises en compte dans l'élaboration des politiques et la prise des décisions.




La communication et la sensibilisation sont d'une importance fondamentale pour ce qui est de promouvoir les objectifs de la Décennie des Nations Unies pour l'éducation en vue du développement durable (DEDD, 2005-2014). # Proclamation of Masterpieces of the oral and intangible heritage of humanity (Phase I to III)

One of the initial steps in raising-awareness about the importance of the safeguarding of the intangible cultural heritage was the proclamation by UNESCO in 2001, 2003 and 2005 of 90 Masterpieces of the Oral and Intangible Heritage of Humanity. The proclamation of these cultural expressions and cultural spaces provided better visibility of the intangible cultural heritage and led to the development of safeguarding activities worldwide, many of them with the support of Japan. While no new proclamations take place since the entry into force of the Convention for the Safeguarding of the Intangible Cultural Heritage in 2006, the experience acquired in implementing safeguarding activities has made a major contribution to the development and implementation of the Convention. The former Masterpieces have all been incorporated in the Representative List established under article 16 of the Convention, from where they continue ensuring better visibility of intangible heritage and awareness of its significance.

L'une des premières mesures de sensibilisation à l'importance de la sauvegarde du patrimoine culturel immatériel, a été la proclamation par l'UNESCO, en 2001, 2003 et 2005, de 90 chefs-d'œuvre du patrimoine oral et immatériel de l'humanité. La proclamation de ces expressions et espaces culturels a conféré une meilleure visibilité au patrimoine culturel immatériel et a conduit à la mise en œuvre d'activités de sauvegarde dans le monde entier, pour bon nombre avec le soutien du Japon. Si aucune nouvelle proclamation n'a eu lieu depuis l'entrée en vigueur de la Convention pour la sauvegarde du patrimoine culturel immatériel en 2006, l'expérience acquise dans la réalisation d'activités de sauvegarde a contribué de manière importante à l'élaboration et à la mise en œuvre de la Convention. Les chefs-d'œuvre proclamés ont tous été intégrés à la Liste représentative établie au titre de l'article 16 de la Convention, d'où ils continuent d'assurer la visibilité du patrimoine immatériel et de faire prendre conscience de son importance.



# **DESD (UN Decade of Education for Sustainable Development) Monitoring and Evaluation Process**

The objective of Phase I of the DESD Monitoring & Evaluation (M&E) (2007-2009) process was to collect data on contexts and structures of work on ESD. The information indicates the current state of play of ESD in countries across the world. In close collaboration with the DESD Secretariat, the UNESCO Regional Bureaux worked closely with Member States to implement the DESD M&E components that have been identified in the Global Monitoring & Evaluation Framework. The main outcome of the project is the mid-decade review entitled “Learning for a Sustainable World - Review of contexts and structures for Education for Sustainable Development”. The draft version was presented at the ESD World Conference, 31 March-2 April 2009, Bonn, Germany.

L'objectif de la Phase I du processus de suivi et d'évaluation de la DEDD (2007-2009) était de collecter des données sur les contextes et les structures de travail concernant l'EDD. Les informations recueillies montrent la situation actuelle en matière d'EDD dans divers pays du monde entier. En étroite collaboration avec le Secrétariat de la DEDD, les bureaux régionaux de l'UNESCO ont coopéré de manière approfondie avec les Etats membres pour mettre en œuvre les composantes de suivi et d'évaluation de la DEDD identifiées dans le Cadre mondial de suivi et d'évaluation de la DEDD. The Zafimaniry community is the sole remaining repository of a woodcraft culture previously widespread in Madagascar. This craft tradition bears witness to the central role of wood in all aspects of life and death of the Zafimaniry community. The project aimed at raising awareness within the Zafimaniry community about the value of their traditions and at improving living standards among them through the creation of income-generating activities. Research and documentation of the Zafimaniry's woodcrafting knowledge was conducted and workshops focusing on teaching and transmitting traditional techniques were organized. Structures at the national, regional and local levels to assure the safeguarding of the knowledge in the long term were also established.

The project contributed to fostering the continued practice of woodcrafting through certain measures, including the preservation of the community's natural environment.

## F / Madagascar

La communauté des Zafimaniry est la dernière dépositaire d'une culture de travail du bois, autrefois très répandue dans toute l'île. Cette tradition artisanale témoigne du rôle central de ce matériau dans tous les aspects de la vie et de la mort de la communauté des Zafimaniry. For monitoring and continuous exchange among three countries, a multinational safeguarding committee composed of tradition bearers, Chewa authorities, and the respective national implementation agencies in each country has been created and actively leading the project implementation.



The celebration of the 100th anniversary of the birth of Léopold Sédar Senghor informed public opinion on the importance of cultural exchanges in promoting peace and cultural awareness, through the exhibition of Senghor's lifetime achievements. Senghor was one of the precursors of the Negritude movement, a pioneer of the Independences, a member of the French Academy, but most importantly an influential man of culture. The initiative brought in more than a thousand participants, resulted in the promotion of cultural dialogue and solidarity, and broadened people's understanding of Senghor's cultural legacy.



The San Sebastian Fortress is the most emblematic monument of the Island of Mozambique, a property inscribed on the World Heritage List in 1991. Built in the 16th century by the Portuguese colonial rulers, it bears witness to the island's early function as main trading port on the sea route to India. Japan FIT provided funding for restoration works to halt the advanced stage of degradation, and to stabilize and rehabilitate the structures of the Fortress all by involving local capacity to a maximum extent. Other donors followed Japan in this ambitious project aiming at developing international cooperation for the sustainable development of Mozambique Island and safeguarding World Cultural Heritage in Africa.

## F / Mozambique

La forteresse de San Sebastian est le monument le plus emblématique de l'île de Mozambique, inscrit sur la Liste du patrimoine mondial en 1991. Construite au XVI<sup>e</sup> siècle par la puissance coloniale portugaise, elle témoigne du rôle premier de l'île comme principal port de commerce sur la route maritime de l'Inde. # Accessing Higher Education Despite the Crisis: Catch-Up Courses for Tawjihee Students in Gaza

In December 08-January 09, the conflict affecting the Gaza Strip resulted in heavy civilian casualties, psychological trauma especially for children and young people and considerable damage to school infrastructure. In early response to the deepening humanitarian crisis, this project addressed the urgent need for providing students of the Gaza Strip, who had missed out a month of schooling, with alternative learning opportunities. More specifically, the project benefitted 5,000 Tawjihi students, meaning students in the upper-secondary grades. It focused on preparing for the public Tawjihi exams, that is the end of secondary education exams, held in June 09. The students were from the areas worst affected by the conflict. The 6 week catch-up course programme took place in 12 schools throughout the Gaza Strip and was a critical opportunity to support students' chances of successfully passing the exams despite the difficult circumstances.

## F / Territoire palestinien occupé

En décembre 2008 et janvier 2009, le conflit qui touche la bande de Gaza a fait beaucoup de victimes civiles, a provoqué des traumatismes psychologiques, en particulier parmi les enfants et les jeunes, et a considérablement endommagé les infrastructures scolaires. Pour réagir rapidement à la crise humanitaire qui allait s'aggravant, ce projet s'est attaché à répondre à l'urgente nécessité d'offrir aux élèves de la bande de Gaza, qui avaient manqué l'école pendant un mois, des possibilités de se remettre à niveau.

Plus précisément, le projet a bénéficié à 5 000 élèves du deuxième cycle de l'enseignement secondaire, qu'il a préparés à passer l'examen public de fin d'études secondaires, le Tawjihee, tenu en juin 2009. Les élèves venaient des zones les plus durement frappées par le conflit. Le cours de rattrapage de six semaines a été dispensé dans 12 écoles de toute la bande de Gaza, offrant aux élèves la possibilité d'améliorer radicalement leurs chances de réussir les examens en dépit des difficultés du moment.

The project aimed at training basic education teachers during their service to develop their competencies 'academically & professionally' and to enhance the quality of basic education in Yemen. The main outcomes achieved through phase I to II are as follows: Training of trainers with the coverage of all Yemeni Governorates, Educational equipment and materials needed were provided, training manuals for fields of the training were developed, revised, printed and disseminated nation wide, training centers fully equipped, Capacity building for national experts in developing training materials and conducting skillfully workshops' activities has been achieved and national exhibitions for educational materials and aids, produced by trainees during the 20 workshops, were organized at the end of the training, in the 4 training centers.

### F / **Yémen**

# Restoration of the laboratories of the Iraq National Museum in Baghdad

Since the 1991 Gulf War, the National Museum in Bagdad was said to have lost some 15,000 artifacts to looters notably in the April 2003 rampage. As a response to this dramatic event, UNESCO immediately increased efforts to protect, conserve and rehabilitate priceless testimony to the rich historical and cultural patrimony of Iraq against different kinds of threats. The rehabilitation of conservation laboratories of the National Museum and training of its conservation staff have been the main field of cooperation between UNESCO and the Iraqi authorities since then. Given that many artefacts have been returned to the museum thanks to the national and international efforts, there is an urgent need of making conservation laboratory operational and improving capacities of museum conservation experts for emergency conservation. As of today, thanks to the Japan's funding through UNESCO, the project has yielded comprehensive results despite severe security situation. Training sessions were organized in Japan to avoid security problems and 11 Iraqi experts were trained with 3 and 6-month training sessions from 2004 to 2009, notably in modern conservation practice and the use of the high-tech equipment provided by the project. The conservation work is steadily advancing and conservation laboratories are now operational. Items such as coins, clay objects and wooden objects are being restored.



F / **Irak**

Depuis la guerre du Golfe de 1991, le musée national de Bagdad se serait fait dépouiller d'environ 15 000 pièces, notamment lors du pillage d'avril 2003. En réponse à cet épisode tragique, l'UNESCO a immédiatement renforcé les mesures de protection, de conservation et de remise en état de ce témoignage inestimable du riche patrimoine historique et culturel de l'Irak confronté à différentes menaces.

La remise en état des laboratoires de conservation du musée national et la formation de son personnel de conservation constituent depuis lors le principal domaine de coopération entre l'UNESCO et les autorités irakiennes. Étant donné que de nombreuses pièces ont été restituées au musée grâce aux efforts nationaux et internationaux, il est urgent de rendre opérationnels les laboratoires de conservation et d'améliorer les capacités des experts conservateurs du musée en matière de conservation d'urgence.

À l'heure qu'il est, grâce au financement japonais par l'intermédiaire de l'UNESCO, le projet a porté de nombreux fruits, malgré des conditions de sécurité très difficiles. Des sessions de formation ont été organisées au Japon, pour éviter les problèmes de sécurité, et 11 experts iraquiens ont bénéficié de sessions de formation de trois à six mois organisées entre 2004 et 2009, notamment sur les pratiques de conservation modernes et l'utilisation des équipements de haute technologie fournis dans le cadre du projet.

Les travaux de conservation avancent sans discontinuer et les laboratoires de conservation sont désormais opérationnels. Des biens tels que des pièces de monnaie ou des objets en argile et en bois sont en cours de restauration.

The project designed to safeguard the Song of Sana'a – a rich Yemenite musical tradition – aimed at promoting knowledge about the tradition, raising awareness about its functions and its importance for society, ensuring its transmission to younger generation, and promoting research and inventory making activities. The activities have contributed to, among other, identifying traditional artists, collecting old recordings and musical instruments, producing new recordings (CD, DVDs), training a number of young people in music playing as well as in lute making, and organizing a wide awareness raising campaign which has enhanced the knowledge and appreciation of this musical tradition throughout the country.



Designed to safeguard Viet Nam's ancient court music and promote its social and cultural values in today's society, the project centred on strengthening the transmission of Nha Nhac to younger practitioners through a two-year instruction programme for twenty musicians, with secured employment at the Hue Royal Theatre awaiting at the end of their studies.

To restore the tradition's former glory, performing costumes were reproduced, new musical instruments produced and musical works were revitalized. Wide media coverage and activities for students and music teachers in Hue contributed to enhanced public awareness of Nha Nhac's significance, in Viet Nam's history and today.

### F / Viet Nam

More than a decade after the end of civil conflict in the country and extensive support from the international community, the rich cultural heritage in Cambodia still suffers from various problems such as permanent decay of materials used for temples or structural destabilization, the lack of national human resources to face related problems not only concerning conservation and restoration, but also the new challenge of sustainable development of the site and the region in which the Angkor archaeological park is situated. This project was developed to assist the Cambodian stakeholders, in particular APSARA authority, in enhancing their management and operational capacities and benefiting to a large extent from international expertise to tackle various problems encountered by one of the most important monuments of the site of Angkor – the temple of Bayon.

Results expected include research, conservation and restoration work on the site and an empowerment of local experts through various training activities to be conducted by highly-qualified international expert teams.



## F / Cambodge

Plus d'une décennie après la fin de la guerre civile dans le pays et malgré le soutien important apporté par la communauté internationale, le riche patrimoine culturel du Cambodge souffre encore de divers problèmes, tels que la dégradation permanente des matériaux utilisés pour les temples ou la déstabilisation des structures et le manque des ressources humaines nationales nécessaires pour faire face aux problèmes connexes liés non seulement à la conservation et à la restauration, mais également aux nouveaux défis du développement durable du site et de la région dans laquelle est situé le parc archéologique d'Angkor. Le projet a été conçu afin d'aider les parties prenantes cambodgiennes, en particulier l'APSARA, à améliorer leur gestion et leurs capacités opérationnelles et à bénéficier dans une large mesure de l'expertise internationale afin de régler les nombreux problèmes rencontrés par l'un des monuments les plus importants du site d'Angkor : le temple du Bayon. Les résultats attendus sont notamment des travaux de recherche, de conservation et de restauration sur le site et une autonomisation des experts locaux au moyen de diverses activités de formation qui devront être dirigées par des équipes d'experts internationaux hautement qualifiés.

At the World Heritage property of the Cultural Landscape and Archaeological Remains of Bamiyan Valley, the phase I and phase II of the project 'Safeguarding of the Bamiyan Site', were respectively completed in December 2004 and in March 2008. The activities were jointly implemented by UNESCO World Heritage Centre and the UNESCO Kabul office, in close cooperation with the Afghan Ministry of Culture and Information, the Ministry of Urban Development and the Provincial authorities of Bamiyan.

This project has achieved significant results in mitigating the ascertained and potential dangers that put the property on the List of World Heritage in danger after the destruction of the Giant Buddha statues in 2001. These include: the stabilization of the Giant Buddha niches, *in situ* conservation of the remaining sculpture in the back wall of the Small Buddha niche, removal of the rubble and safeguarding of the fragments of the Buddha sculptures from both niches, archaeological survey and conservation of mural paintings in the Bamiyan Valley, enhanced site security and site management through the development of a Management Plan and Cultural Master Plan and through training in documentation and conservation for Afghan professionals.

## F / République islamique d'Afghanistan

Concernant le bien du patrimoine mondial constitué par le paysage culturel et les vestiges archéologiques de la vallée de Bâmiyân, les phases I et II du projet intitulé « Sauvegarde du site de Bâmiyân » ont été achevées, respectivement en décembre 2004 et mars 2008. Les activités ont été mises en œuvre conjointement par le Centre de l'UNESCO pour le patrimoine mondial et le Bureau de l'UNESCO à Kaboul, en étroite coopération avec les ministères afghans de la culture et de l'information et du développement urbain, et les autorités de la province de Bâmiyân.

Ce projet a été très efficace s'agissant de réduire les menaces réelles et potentielles qui ont conduit à inscrire ce bien sur la Liste du patrimoine mondial en péril, après la destruction des statues de bouddhas géants en 2001. On citera notamment: la stabilisation des niches des bouddhas géants, la conservation *in situ* de la sculpture restante sur la paroi du fond de la niche du petit bouddha, le ramassage des gravats et la sauvegarde des fragments des sculptures de bouddhas des deux niches, la réalisation d'une enquête archéologique et la conservation des peintures murales de la vallée de Bâmiyân, ainsi que le renforcement de la sécurité du site et la gestion de ce dernier grâce à l'élaboration d'un plan de gestion et d'un maître plan culturel et à l'organisation, à l'intention de professionnels afghans, d'une formation dans le domaine de la documentation et de la conservation.

The project was formulated in follow-up to the regional project on Community Learning Centres (CLCs), funded by JFIT-CLCs during 1998–2004. The overall objective of the project is to further strengthen CLCs as effective delivery mechanisms of literacy and continuing education programmes and community development within the framework of the national Education for All (EFA) action plans and UN Literacy Decade.

Countries were provided support to carry out innovative activities including persons with disabilities with special focus on girls and women, encouraged to strengthen linkages and networks and undertake research studies.

Research studies of 9 countries have been published, the CLC-MIS regional guide published and disseminated, capacity of the CLC personnel at different levels developed through regional and national training workshops.

Ce projet découle d'un précédent projet régional sur les centres d'éducation communautaire (CLC), financé par le JFIT-CLC entre 1998 et 2004. Son objectif général est de renforcer encore les CLC en tant que mécanismes efficaces pour la mise en œuvre de programmes d'alphabétisation et de formation continue et le développement communautaire, dans le cadre des plans d'action nationaux d'Éducation pour tous (EPT) et de la Décennie des Nations Unies pour l'alphabétisation.

Given that no Pacific Member States had ratified the Convention for the Safeguarding of the Intangible Cultural Heritage as of December 2007, the first sub-regional meetings in the Pacific, aimed at raising awareness about the Convention, was organized in Fiji in December 2007. During the meeting, several participating States requested assistance from UNESCO in preparing the ratification and implementation of the Convention. As its follow-up, three national consultation meetings were organized in the year 2008 among which two were organized with the financial support of JFIT (Papua New Guinea and Tonga). Following the ratification by Papua New Guinea in September 2008, the second sub-regional meeting was organized in Tonga in December 2008, and experiences of Papua New Guinea as well as other countries' efforts were shared with the sub-region.

Au cours de la réunion, plusieurs États participants ont demandé l'aide de l'UNESCO pour préparer la ratification et la mise en œuvre de la Convention. During more than two years, the project gave an impetus to the safeguarding of the classical music tradition of Shashmaqom in Uzbekistan and Tajikistan, promoting it as an important living heritage of Central Asia. Besides the support provided to research and field work, inventory making and publications, the project succeeded in reinforcing the transmission of Shashmaqom through master-apprentice training programmes in musical performance and traditional instrument making. A major achievement was the cooperation brokered between the Uzbek and Tajik artists and authorities, culminating in the International Festival of Shashmaqom Performers that saw Tajik and Uzbek artists join together to raise awareness for the safeguarding of their common musical heritage.

## F / Ouzbékistan et Tadjikistan

Durant plus de deux ans, le projet a donné un élan à la sauvegarde de la tradition musicale classique du shashmaqom en Ouzbékistan et au Tadjikistan, la promouvant comme un important patrimoine vivant d'Asie centrale. Parallèlement au soutien qu'il apportait à des travaux de recherche et au travail sur le terrain, à la réalisation d'inventaires et à des publications, le projet a réussi à renforcer la transmission du shashmaqom grâce à des programmes de formation à l'exécution musicale et à la facture instrumentale traditionnelle reposant sur la transmission de maître à élève. L'une de ses principales réalisations a été de permettre une coopération entre les artistes et les autorités ouzbeks et tadjiks, qui a culminé lors du Festival international des interprètes du shashmaqom, lequel a réuni des artistes tadjiks et ouzbeks afin de sensibiliser à la sauvegarde de leur patrimoine musical commun.



The Intergovernmental Oceanographic Commission (IOC) Sub-Commission for the Western Pacific (WESTPAC) aims to develop, co-ordinate and implement regional marine scientific research programmes, ocean observations and services, data and information management and capacity building in the Western Pacific region.

Supported by JFIT, ten IOC/WESTPAC training courses on Harmful Algal Blooms (HABs) have been regularly held since its first course in 1995 to improve the knowledge on the biological and chemical nature, population dynamics and environmental effects of harmful algae through providing scientific knowledge.

At the same time, IOC/WESTPAC training course on NEAR-GOOS (North-East Asian Regional - Global Ocean Observing System) Data Management was organized 8th times from 1997 to develop human resources in the field of oceanographic data and information management.

By using JFIT, several regional training workshops on biodiversity conservation and natural resources management were conducted in the region to exchange experience, information and best practices; and studies were carried out to nominate potential biosphere reserve sites as BR in Myanmar and Malaysia (Lake Chini, Malaysia, is enlisted as BR in May 2009).

In cooperation with UNESCO Apia, the project assisted in the development of the Pacific MAB Network (PacMAB) in December 2006 as the vehicle for exchange and cooperation among new and emerging biosphere reserves and national MAB focal points in Pacific countries.

The Voice of the Voiceless project aims to promote and preserve music expressions, rituals and dances that integrate the cultural heritage of Latin America in order to foster respect to the cultural diversity and to favor the processes of social integration.

Through the project, diverse works of inventory and registry of intangible heritage in several zones of Argentina and Uruguay were implemented, the systematic research has been carried in Bolivia and the three volumes of collection “*The voice of the voiceless*” were produced. In addition, the cultural events composed of live presentations of music, rituals and dances were organized to share their intangible heritage and to make opportunities for intercultural dialogues in favour of respect for cultural diversity.

The dance, song and drumming style known as 'Tumba Francesa' (French Drum) was brought to Cuba by Haitian slaves in the 1790s. It embodies one of the oldest and most tangible links to the Afro-Haitian heritage of Cuba's Oriente province. The main objective of the project is to ensure its viability by reinforcing the intergenerational transmission of knowledge and skills. A main component of the project was dedicated to strengthen local capacities for safeguarding the 'Tumba Francesa', in particular related to the drawing up of an inventory of elements related to it, the organization of training workshops with the bearers and local actors, the recreation of costumes and restoration of musical instruments, and the production of multimedia material. This resulted in the creation of a documentation centre, a documentary and a multimedia website, which will support future actions to safeguard the 'Tumba Francesa'.

La «Tumba Francesa» représente l'un des liens les plus anciens et les plus vivants avec le patrimoine afro-haïtien de la province orientale de Cuba. Le principal objectif du projet est d'en assurer la viabilité en renforçant la transmission intergénérationnelle des connaissances et du savoir-faire. L'une des principales composantes du projet a été consacrée au renforcement des capacités locales de sauvegarde de la «Tumba Francesa», en particulier en ce qui concerne l'établissement d'un inventaire des éléments qui y sont associés, l'organisation d'ateliers de formation avec ses détenteurs et acteurs locaux, la recréation de costumes et la restauration d'instruments de musique, ainsi que la production de matériel multimédia. Cette initiative a conduit à la création d'un centre de documentation, d'un documentaire et d'un site Web multimédia, qui viendront à l'appui des actions futures de sauvegarde de la «Tumba Francesa».



# **Strengthening the transmission of the Textile Traditional Knowledge of Taquile**

The Taquile textile arts are a mode of creation that involves Taquile's inhabitants of all ages. The safeguarding action plan of this textile was designed to preserve and enhance the transmission of the textile arts and to strengthening their cultural identity. First, the skills and knowledge involved in the textile arts as well as related social practices were documented by Taquile community members, especially young people who elaborated a local inventory of their textile arts. Then, intergenerational and inter-communal transmission of the technologies, aesthetics and cultural practices involved in the textile arts were strengthened by reinforcing local education institutions and promoting exchanges of knowledge and skills between older and younger weavers. Finally, Taquilean cultural and artistic expressions were promoted through producing a documentary video and educational materials to be used in Taquilean schools.

## F / **Pérou**

Les arts textiles de Taquile sont un mode de création auquel participent les habitants de Taquile de tout âge. Le plan d'action pour la sauvegarde de ces arts a été conçu pour en préserver et en renforcer la transmission et pour en consolider l'identité culturelle. Dans un premier temps, les techniques et savoirs qui caractérisent ces arts textiles, ainsi que les pratiques sociales qui y sont associées, ont été recensés par les membres de la communauté de Taquile, en particulier les jeunes, qui en ont dressé un inventaire local. Ensuite, la transmission intergénérationnelle et intercommunautaire des techniques, de l'esthétique et des pratiques culturelles intervenant dans ces arts a été consolidée par le renforcement des institutions de formation locales et la promotion des échanges de savoir et de compétences entre les tisseurs anciens et les plus jeunes. Enfin, les expressions culturelles et artistiques de Taquile ont été promues grâce à la production d'un documentaire vidéo et de matériels pédagogiques qui seront utilisés dans les écoles de Taquile.


