¹ The Inter-Agency Committee (IAC) for the UN Decade of Education for Sustainable Development (DESD: 2005-2014) was established by UNESCO as a forum of UN agencies for open-ended collaboration towards the effective implementation of the Decade. It brings together 17 UN agencies all committed to achieving the DESD goals: UNESCO, FAO, ILO, UNAIDS, UNCCD, UNDP, UNFCCC, UNFPA, UN-Habitat, UNHCR, UNICEF, UNU, WFP, WHO, World Bank and WTO.

² Biosphere Reserves (BRs) are sites recognized under the UNESCO Man and the Biosphere (MAB) Programme which innovate and demonstrate approaches to conservation and sustainable development. As agreed at the III World Congress of Biosphere Reserves held in Madrid, Spain, in February 2008, UNESCO will further promote and utilize Biosphere Reserves as "learning sites" for the UN DESD.

³ In response to the UN DESD, UNU-IAS proposed the establishment of Regional Centres of Expertise on Education for Sustainable Development (RCEs). An RCE is a network of formal, informal and non-formal education and learning-related organisations with joint strategies to promote ESD in the region within which they operate. By October 2010, 77 regional multi-stakeholder networks have been officially acknowledged by UNU as RCEs around the world. RCEs, both locally and globally, provide a platform for collaboration among diverse stakeholders for ESD.
