BHURBAN DECLARATION

- Institutionalize Forum of Ministers on Social Development of Asia to enhance consultations, dialogue and exchange of experience with a view to optimizing the effectiveness of social policies.
- Theme of public accountability adopted as the principal substantive focus of the Forum for the first year;
- Chairmanship of the Forum conferred on Pakistan for the first year. The Chairperson of the Forum is to:
 - Define, in consultation with participating countries, practical modalities for: organizing the Forum, promoting networking of relevant national institutions, as well as to propose modalities for collaboration with civil society and recognized research institutions;

- Candidature of India endorsed for the next meeting.

FORUM STRUCTURES

COMPOSITION OF FORUM

To begin with the Forum of Ministers on Social development of Asia comprises of Bangladesh, India, Maldives, Nepal, Pakistan, and Sri Lanka as founding member countries. Other Asian countries are eligible to become member of the Forum for which they have been invited as provided in the Bhurban Declaration.

CHAIR

- Organize and chair Ministerial Meetings that, at least once every year, bring together the member-countries' Ministers in charge of social areas.
- ☐ Draw up a working program of preparatory meetings and agenda for the Ministerial Forum.
- Coordinate results of the Conclusions of the Chair- a document adopted by consensus at the Meetings and which constitutes the most important tool for providing follow-up to the directions of the Ministerial Forum.
- Follow up on the document approved at Ministerial Meeting one year from its agreement.
- Administer and manage the technical secretariat.

FOCAL POINTS

- **■** Identification by member countries
- Networking of Focal Points
- Focal Points to work in parallel to thematic Working Group on adopted theme

WORKING GROUP

- Comprises of a representative from each member countries who are experts on the topic or issue defined by the Ministers.
- Country representative to coordinate work related to the topic with the concerned ministries/national institutions of the respective country.
- Working Group to meet at least once, between each Ministerial Meeting. These Working Group Meetings shall conduct an in-depth discussion of the topic or issue defined by the Ministers and shall receive input based on the experience of each of the region's countries in programs related to the topic or issue in question: obstacles; successes; failures.

NETWORKING OF NATIONAL INSTITUTIONS

- Each member country to designate its relevant national institutions for the network for sharing of information and experience related to the topic or issue identified by the Ministers which shall form the title of such network.
- Since theme of public accountability has been selected as the principal substantive focus of the Forum for the first year, the first such network shall be titled as 'Network of National Institutions on Public Accountability for the Forum of Ministers on Social Development of Asia'.
- National Institutions on Public Accountability would post a webpage containing following country specific information related to the above topic:

- Existing legal framework (laws, rules, regulations) and policy.
- Implementation structures and programmes.
- Results achieved.
- > Issues confronted.
- > Future work
- An interface of the above web pages shall be provided through the web page maintained by the Technical Secretariat of the Forum. In addition UNESCO has dedicated a special section devoted to the Asian Forum on Website of MOST.

TECHNICAL SECRETARIAT

- The principal function of Technical Secretariat shall be to establish communication and specify different aspects of the cooperation mechanisms, as well as to oversee the development of thematic research relating to social issues drawn up by members of the Forum.
- The specific responsibilities of the Technical Secretariat shall be, in consultation with the Focal Points and Working Group, to:
 - > Oversee the periodicity of communication, which benefits the work, and the atmosphere of cordiality among the members of the Forum.
 - ➤ Be a dynamic liaison for the initial exchange of experts, know-how, or concrete projects of horizontal cooperation.

- > Coordinate the Focal Points and Working Group Meeting prior to each Ministerial Meeting.
- Define parameters for the preparation and submission of the conclusions of the Working Group Meeting to be presented at the upcoming Ministerial Meeting.
- Seek new economic opportunities and follow up on requests for funding and financial support sent to international organizations, inviting them to participate in discussing the topics on the agenda of the Ministerial Meetings.
- > Approach donors/international organizations for funding the Working Group/Forum meetings.

- > Contribute toward and propagate horizontal cooperation among the different Forum member countries.
- > Coordinate programs for the Ministerial Meetings.
- Encourage the participation of Forum members in regional and international conferences.
- Provide a webpage titled 'Network of National Institutions on Public Accountability for the Forum of Ministers on Social Development of Asia' with an interface of web pages of the designated national institutions of the member countries for consultation on issues brought forth at the Forum and related meetings/initiatives.

FINANCIAL ARRANGEMENTS

- Local Cost including boarding and lodging for the meetings of Focal Points/Working Group and meetings of the Forum may be borne by the country holding Chair of the Forum in collaboration with donors.
- Travel cost for the above meetings may be borne by the participating countries.
