EXECUTION OF THE PROGRAMME

Report by the Director-General on the implementation of the Programme and Budget (33 C/5) and on results achieved in the previous biennium (2006-2007) (Draft 35 C/3) (179 EX/4 – Draft 35 C/3 (Rev. in English only); 179 EX/4 Add.; 179 EX/INF.8; 179 EX/INF.9; 179 EX/INF.10; 179 EX/INF.13; 179 EX/INF.16; 179 EX/INF.17; 179 EX/INF.18; 179 EX/58; 179 EX/59)

- 1. Recalling 33 C/Resolution 92 and 34 C/Resolution 89,
- 2. Having examined document 179 EX/4 Draft 35 C/3 (Rev. in English only),
- 3. Recalling that the commitment to the results-based management (RBM) approach, taking into account both the qualitative and quantitative dimensions of the activities, is vital for programme planning, delivery and monitoring,

- 4. Recognizing that document 179 EX/4 Draft 35 C/3 (*Rev. in English only*) is part of the ongoing strengthening of the report by the Director-General on the performance of the programme in previous biennia,
- 5. <u>Welcoming</u> the quick response by the Director-General to 34 C/Resolution 89, in particular the presentation in tabular form of results achieved against C/5 expected results for each main line of action (MLA), and his continued efforts to align the previously separate statutory C/3 and EX/4 reports at the end of the biennium,
- 6. Noting that document 179 EX/4 Draft 35 C/3 (*Rev. in English only*) attempts to capture salient parameters for assessing the programme performance of the Organization, and that the process adopted has highlighted the scope for further improvements of the C/3 document as a governance tool,
- 7. <u>Also noting</u> that, as a consequence of the reduction in the number of MLAs, the budgetary information in SISTER 2 for Member States may not be sufficient,
- 8. <u>Further noting</u> the Internal Oversight Service (IOS) finding that there is a challenge in verifying achievements relating to UNESCO's objectives in the area of capacity-building,
- 9. <u>Further noting</u> the Internal Oversight Service finding that there is a need to develop an approach for assessing the achievement of the objectives in the Medium-Term Strategy,
- 10. <u>Welcomes</u> the achievements made during the 2006-2007 biennium, which demonstrate that UNESCO continues to fulfil roles and furnish essential services to tackle challenges in all its fields of competence;
- 11. <u>Underlines</u>, however, that there is still room for improvements regarding programme performance and the results-based management of the Organization;
- 12. <u>Invites</u> the Director-General to find the best means to overcome the challenges relating to results-based management, including results attainment and cost-effectiveness, as identified in paragraphs 102 to 125 of document 179 EX/4;
- 13. <u>Welcomes</u> the Director-General's intention to use document 179 EX/4 Draft 35 C/3 (*Rev. in English only*), as well as documents 34 C/4 and 34 C/5, in preparation for future key programming documents of the Organization, specifically the next Draft Programme and Budget (35 C/5);
- 14. <u>Urges</u> the Director-General to continue improving the C/3 and EX/4 reports according to the guidelines in 34 C/Resolution 89, ensuring a more coherent and consistent report, and paying special attention to the need for reporting on outcomes and on cost-effectiveness, and to the need for a functional programme monitoring system to include feedback from stakeholders regarding the value of UNESCO's activities;
- 15. <u>Requests</u> the Director-General to provide easier access to SISTER 2, and to hold appropriate training sessions for the Permanent Delegations on a regular basis;
- 16. <u>Also requests</u> the Director-General to provide Member States, at their request, with information on the implementation of specific programme components addressed in the expected results of the main lines of action.

- 1. Recalling 162 EX/Decision 3.1.2, in which it noted the proposal of the Director-General to limit the use of appointments of limited duration (ALDs) to posts financed from extrabudgetary funds,
- 2. Having examined document 179 EX/5 Add.,
- 3. <u>Endorses</u> the Director-General's proposal to use regular programme funds, on an exceptional basis, for an appointment of limited duration contract to fill the established post of the Ethics Officer.

Follow-up to the Fourth International Conference on Environmental Education

- 1. Recalling 34 C/Resolution 19 on further promotion of the United Nations Decade of Education for Sustainable Development (2005-2014) and the inspirational work of the Earth Charter, as well as the Millennium Development Goals (MDGs),
- 2. Recalling also 175 EX/Decision 55 and 177 EX/Decision 9,
- 3. <u>Taking note</u> with satisfaction of the positive outcome of the Fourth International Conference on Environmental Education entitled "Environmental Education towards a Sustainable Future: Partners for the Decade of Education for Sustainable Development" sponsored by UNESCO, the United Nations Environment Programme (UNEP) and the Government of India, held in Ahmedabad, India, from 24 to 28 November 2007.
- 4. <u>Noting</u> that the Conference adopted the Ahmedabad Declaration 2007: A Call to Action (179 EX/INF.4 Rev.),
- 5. <u>Noting further</u> that the Ahmedabad vision presented in the Ahmedabad Declaration is based on the conviction that through education, human lifestyles can be achieved which support ecological integrity, economic justice, sustainable livelihoods and respect for all life, and <u>also noting</u> the close interlinkage in all societies between humankind and nature.
- 6. <u>Considering</u> in that context that the Ahmedabad Declaration called upon the United Nations system and governments worldwide to support environmental education and develop sound education for sustainable development policy frameworks, and urged commitment to their implementation,
- 7. <u>Noting</u> that education for sustainable development is essential in the quest for a vision and alternative models for a sustainable future as well as for forging strong international partnerships, in particular, North-South-South and South-South partnerships.

- 8. <u>Underlining</u> the message by Mahatma Gandhi ("My life is my message") in the context of the need to search vigorously, with creativity and imagination, for a change in values in order to achieve sustainable living,
- 9. <u>Also underlining</u> the interlinkage between research, environmental education and education for sustainable development, and the important role played by UNESCO in this regard as the lead agency responsible for promoting the United Nations Decade of Education for Sustainable Development and its International Implementation Scheme, and <u>bearing in mind</u> the growing momentum for education for sustainable development,
- Welcoming the convening of the International Forum on Education for Sustainable Development (ESD) Dialogue 2008 organized by Japan, as well as the forthcoming UNESCO World Conference on Education for Sustainable Development to be held in 2009 in Germany,
- 11. <u>Congratulates</u> UNESCO on its actions to ensure the success of the Fourth International Conference on Environmental Education, in close cooperation with the United Nations Environment Programme and the Government of India;
- 12. <u>Invites</u> UNESCO Member States to support and ensure the follow-up to the Ahmedabad Declaration by developing sound education for sustainable development policy frameworks, and to commit themselves to their implementation;
- 13. Requests the Director-General, in the framework of the United Nations Decade of Education for Sustainable Development, to highlight measures to be taken by UNESCO for implementation and follow-up to the Ahmedabad Declaration;
- 14. <u>Invites</u> the Director-General to take all necessary measures, in consultation with other United Nations agencies concerned for the wide dissemination of the Ahmedabad Declaration;
- 15. <u>Also requests</u> the Director-General to submit to it at its 180th session a progress report on the implementation of this decision.

- 11. <u>Expresses its full support</u> to the newly appointed Rector of the United Nations University, Professor Dr Konrad Osterwalder;
- 12. <u>Stresses</u> the need for increased collaboration between UNESCO and the United Nations University in areas of joint expertise and competence, including the promotion of synergies and a clear division of labour with a view to avoiding overlap;
- 13. <u>Invites</u> the Director-General and the Rector of the United Nations University, to present to the Executive Board, at its 181st session, a plan of possible joint activities taking into account, *inter alia*, UNESCO's priorities, to be carried out in the 2010-2011 biennium;

The Executive Board,

- 1. Having examined document 179 EX/7 and its annex,
- 2. Welcomes the proposal of the Government of China to establish an international centre on space technologies for cultural and natural heritage in Beijing, China, under the auspices of UNESCO, which is in line with the existing principles and guidelines for institutes and centres, as outlined in document 33 C/19, approved by the General Conference in 33 C/Resolution 90:
- Encourages the Director-General to further strengthen the partnership between UNESCO and the Chinese Academy of Sciences through the continuation of implementation of joint activities, pending the establishment of the centre as a category 2 centre under the auspices of UNESCO;
- 4. Requests the Director-General, in conformity with Article 16 of the Model Agreement contained in Annex II to 33 C/Resolution 90, to conduct an evaluation before any renewal of the agreement to be concluded between the Government of China and UNESCO takes effect, and to share the results of such an evaluation with the Executive Board for its review;
- 5. Recommends that the General Conference, at its 35th session, approve the establishment of the international centre on space technologies for cultural and natural heritage in Beijing, China, under the auspices of UNESCO (category 2), and authorize the Director-General to sign the Agreement between UNESCO and the Government of China contained in the annex to document 179 EX/7.

- 8. <u>Invites</u> the Director-General to seek extrabudgetary resources to ensure the implementation of that plan, and <u>also invites</u> Member States and other funding sources to consider making extrabudgetary contributions in this regard;
- 9. <u>Further invites</u> the Director-General to report to it at its 180th session on the 60th anniversary commemorative activities.

- 4. <u>Emphasizes</u> that UNESCO's core contributions to address climate change rest on two principal pillars:
 - (a) the sound and unbiased generation, dissemination and use of data, information and research concerning climate change (the knowledge base), in close

- partnership with Member States, the other competent organizations of the United Nations country teams, and other relevant stakeholders, such as bilateral development partners, NGOs and civil society;
- (b) the application of holistic and integrated approaches in the use of educational tools, specific sectoral measures, and public awareness activities;
- 5. <u>Recommends</u> that the Director-General foster collaboration and an intersectoral approach among the intergovernmental science programmes of UNESCO as a knowledge base on climate change, and further promote education for sustainable development as a key element with which to address climate change;
- 6. <u>Further emphasizes</u> that the strategy should be aimed at helping Member States to build and maintain the requisite knowledge base, and to adopt measures for adapting to the impacts of climate change, contributing to the mitigation of its causes, and strengthening sustainable development;
- 7. <u>Approves</u> hereby in principle the overall terms of the UNESCO strategy for action on climate change, as contained in Annex I of document 179 EX/15;
- 8. Requests the Director-General to submit to it at its 180th session a strategy which has been refined in the light of the discussions during the 179th session of the Executive Board;

- Considering Resolution XXIV-3 on "The Past, Present and Future of Africa within the IOC Programmes" adopted by the UNESCO Intergovernmental Oceanographic Commission (IOC) Assembly at its 24th session, recommending that the Executive Secretary of the Intergovernmental Oceanographic Commission ensure the implementation of the resolutions and decisions taken in favour of Africa (30 C/5, para. 02240),
- 2. <u>Also considering</u> Article 76 in Part VI "Continental shelf" of the United Nations Convention on the Law of the Sea,
- 3. Recalling the role of the United Nations Division for Ocean Affairs and the Law of the Sea and the collaboration between the latter and the UNESCO Intergovernmental Oceanographic Commission,
- 4. <u>Taking into account</u> the existence of the special Trust Fund established by United Nations General Assembly resolution 55/7 of 30 October 2000 to assist developing countries and small island developing States in the preparation of their dossiers with a view to the submission of requests for the extension of the limits of their continental shelf,
- 5. Recalling the Director-General's message at the Eighth Summit of the Heads of State and Government of the African Union, devoted to the themes of "Science, Technology and Scientific Research for Development" and "Climate Change in Africa", a message stressing, among other things, the importance for the countries concerned of the United Nations Convention on the Law of the Sea
- 6. Also recalling the plan of action concerning UNESCO's participation in the implementation of the decisions and Declaration by the African Union Summit on Science, Technology and Scientific Research for Development (January 2007) approved by the Executive Board at its 177th session, and including among its expected results IOC assistance to African States in the preparation of their submissions to extend their continental shelves.

- 7. <u>Emphasizing</u> that the UNESCO General Conference at its 34th session adopted a Programme and Budget which, *inter alia*, stresses the need to increase support for programmes for the integrated management of coastal zones, applications of remote sensing for water resources and climate change, and for strengthening the Framework for Action of the Global Ocean Observing System in Africa (GOOS-AFRICA),
- 8. <u>Further recalling</u> Assembly/AU/Decision 179 taken at the Summit of Heads of State of the African Union in February 2008 on the extension of the African continental shelf and climate change, which "calls on the specialized agencies of the United Nations system to provide the coastal Member States all the assistance required to conduct the necessary studies for submitting applications for the extension of their continental shelf".
- 9. <u>Aware</u> of the major issues relating to the preservation of ecosystems and the integrated management of marine and coastal resources for the sustainable development of Africa,
- 10. <u>Concerned</u> at the imminence of the deadline of 12 May 2009 for the deposit of dossiers for the extension of the continental shelf beyond 200 nautical miles under the United Nations Convention on the Law of the Sea,
- 11. <u>Congratulates</u> the Director-General on his efforts to strengthen the Organization's support for Africa;
- 12. <u>Invites</u> the Director-General to take all appropriate measures to ensure that UNESCO and its Intergovernmental Oceanographic Commission implement IOC Resolution XXIV-3, and also strengthen their assistance in support of the African Member States concerned in order to speed up the process of study, formulation and submission of requests for the extension of the limits of their continental shelf, within the time limit required, in close conjunction with the specialized agencies of the United Nations system, in particular the United Nations Environment Programme (UNEP) and the United Nations Division for Ocean Affairs and the Law of the Sea, as well as with the NEPAD Programme for Coastal and Marine Environment;
- 13. <u>Requests</u> the Director-General to address this issue in the relevant intersectoral platforms, and to report to it thereon at its 181st session.

Inclusion of the Regional Post-Graduate Training School on Integrated Management of Tropical Forests and Lands (ERAIFT) in the intersectoral platforms on Africa and education for sustainable development

- Recalling 28 C/Resolution 2.4 of the General Conference of UNESCO (1995) and the Seville Strategy for Biosphere Reserves which confirmed the importance of biosphere reserves for the conservation of biodiversity, and the N'Sele Declaration (Kinshasa, Democratic Republic of the Congo, 1991) which set out the main lines of an action programme on environmental education and the implementation of pilot projects on research and training,
- 2. <u>Stressing</u> that the future of humanity depends, in particular, on education and public awareness-raising geared to environmental protection and sound management of biosphere reserves,

- 3. <u>Considering</u> that climate change currently affecting the world is linked in particular to the poor management of biodiversity,
- 4. <u>Commending</u> UNESCO and its international partners on the implementation of a project in support of the establishment and operation of the Regional Post-Graduate Training School on Integrated Management of Tropical Forests and Lands (ERAIFT) in the Democratic Republic of the Congo, the country with the largest expanse of tropical forest in Africa.
- 5. Recognizing that the forests of Africa constitute the world's second largest area of tropical forest (second world biosphere reserve) and that they should be better managed,
- 6. <u>Bearing in mind</u> the African Convention on the Conservation of Nature and Natural Resources (Algiers, 1968, and Maputo, 2008) which advocates the sound management of forest resources, guarantor of a country's sustainable development for the greatest good of its people,
- 7. <u>Bearing in mind</u> that the establishment of the Regional Post-Graduate Training School on Integrated Management of Tropical Forests and Lands (ERAIFT) is enshrined in special recommendation No. 4 of the Regional Seminar in N'Sele on "African tropical forests a heritage to be protected urgently" (Kinshasa, Democratic Republic of the Congo, 1991),
- 8. Considering the suggestions of the International Coordinating Council of the Programme on Man and the Biosphere (MAB) at its eighteenth session held at UNESCO Headquarters (Paris, 25-29 October 2004) that guidance be given on the Secretariat's initiative aimed at networking ERAIFT-DRC with the world's three major tropical forest regions, namely the Amazon, the Congo Basin and South-East Asia (Indonesia and Malaysia),
- 9. <u>Drawing on</u> the agreement in principle to establish a transboundary biosphere reserve signed by the Democratic Republic of the Congo and Uganda at the time of the meeting of the International Coordinating Council of the Programme on Man and the Biosphere (MAB) (Madrid, 4-9 February 2008),
- 10. <u>Taking into account</u> the content of the Memorandum signed on 10 September 2005 by UNESCO and the Government of the Democratic Republic of the Congo regarding the establishment of the Regional Post-Graduate Training School on Integrated Management of Tropical Forests and Lands (ERAIFT),
- 11. Referring to the spirit of assistance of Project PNUD/ZAI/97001/01/13 "Support for the establishment and operation of the Post-Graduate Training School on Integrated Management of Tropical Forests (ERAIFT)",
- 12. <u>Considering</u> that the Regional Post-Graduate Training School on Integrated Management of Tropical Forests and Lands (ERAIFT) has, since its establishment, had the operational status of a UNESCO-MAB project,
- 13. <u>Further considering</u> that the Regional Post-Graduate Training School on Integrated Management of Tropical Forests and Lands (ERAIFT) is the only institution in sub-Saharan Africa specializing in the integrated management of tropical forests and lands,
- 14. <u>Taking into account</u> the importance of the Regional Post-Graduate Training School on Integrated Management of Tropical Forests and Lands (ERAIFT) in the management and safeguarding of the world ecosystem in general and the African ecosystem in particular,

- 15. <u>Considering</u> the satisfactory and promising results obtained by the School in its 10 years of operation,
- 16. Recalling 177 EX/Decision 25 (I), in which it recommended that the Director-General be requested to report regularly, as from the 179th session, on the development and implementation of the various intersectoral platforms envisaged for the execution of the Programme and Budget for 2008-2009 (34 C/5), and which was endorsed by the General Conference when it adopted document 34 C/5,
- 17. Having examined document 179 EX/16,
- 18. - 4. <u>Invites</u> the External Auditor to establish the reasons for the cost overruns on the renovations done on the Fontenoy site, and to confirm that all the contracts were awarded within the existing procedures;
- 5. <u>Notes</u> that under the present circumstances, the conclusion of the Director-General and the Headquarters Committee is that there is no feasible option for ensuring the financing of the Miollis/Bonvin site renovation unless Member States decide on a specific allocation of the necessary funds through assessed contributions;
- 6. Also notes the significant progress achieved in regard to security at Headquarters;

- 7. <u>Further notes</u> the difficulties encountered by the Organization's Security Service in fulfilling its tasks satisfactorily, continuously and in all circumstances;

- 5. <u>Committed</u> to the safeguarding of monuments, works of art, manuscripts, books and other historical and cultural properties to be protected in the event of conflict,

- 6. <u>Deeply convinced</u> that the continuous strengthening of the reconstruction and development process in the Palestinian territories should be carried out in a context of non-violence and of mutual respect and recognition, as promoted by the objectives of the roadmap,
- 7. <u>Supports</u> the efforts made by the Director-General with a view to the implementation of 34 C/Resolution 58 and 177 EX/Decision 62, and <u>requests</u> him to do everything possible to ensure that they are fully implemented in the framework of the Programme and Budget for 2008-2009 (34 C/5 Approved);

- 6. <u>Being further aware</u> that the year 2011 provides an opportunity to highlight the need for international scientific collaboration on the one hundredth anniversary of the founding of the International Association of Chemical Societies,
- 7. Having examined documents 179 EX/47 and Add. Rev.,
- 8. Welcomes the unanimous resolution of the International Union of Pure and Applied Chemistry (IUPAC), at its 2007 Council meeting, to have 2011 proclaimed as the international year of chemistry, and to play a lead role in coordinating and promoting chemistry activities at the national and regional levels around the world;
- 9. <u>Invites</u> the Director-General to support all efforts to have the United Nations General Assembly proclaim 2011 the international year of chemistry;

- 5. Requests the Director-General to report on UNESCO's activities on human rights and cultural diversity, through the Executive Board, in order to contribute to the Secretary-General's report on this subject to be presented at the sixty-fourth session of the General Assembly.

49 A UNESCO strategy for technical and vocational education and training (TVET) (179 EX/49 and Add.; 179 EX/INF.7 Rev.; 179 EX/57)

- 1. Referring to documents 34 C/4 and 34 C/5, which identify quality technical and vocational education and training (TVET) as well as access thereto as an integral part of UNESCO's education mandate,
- 2. <u>Noting</u> that the progress achieved in primary school enrolment worldwide as outlined in the *EFA Global Monitoring Report 2008*, requires significant progress in access to quality TVET for the increasing number of young people that complete primary education,
- 3. Reiterating that TVET is an integral part of education for all (EFA) and of education for sustainable development, and recalling in this context the recent partnership meeting in Bangkok with the United Nations Industrial Development Organization (UNIDO), the International Labour Organization (ILO) and private partners, and the Second Decade of Education for Africa, which identifies TVET as one of the seven areas of focus,
- 4. <u>Underlining</u> that globalization requires people to develop knowledge and vocational and technical skills which enhance employment opportunities, which help them to develop entrepreneurial capacities and raise their productivity on a continuous basis, and hence that TVET institutions should not only provide initial opportunities, but increasingly provide lifelong training,
- 5. Recalling that TVET will be a priority for UNESCO's action in Africa as well as an important element in the development of educational policies and management in small island developing States and in post-conflict and post-disaster situations as outlined in the Medium-Term Strategy for 2008-2013 (34 C/4),
- 6. <u>Emphasizing</u> the need for a holistic UNESCO strategy for TVET aimed at a well coordinated and integrated approach by Headquarters, UNESCO institutes and centres such as the UNESCO International Centre for Technical and Vocational Education and Training (UNEVOC), the UNESCO European Centre for Higher Education (CEPES), the UNESCO Institute for Lifelong Learning (UIL), and the UNESCO International Institute for Educational Planning (IIEP), as well as the UNESCO field offices,
- 7. Requests the Director-General to elaborate, on the basis of document 34 C/4, a succinct and operable strategy to support TVET in the Member States, based on the needs defined by the governments of the Member States concerned, which promotes cooperation with other development partners in a coherent manner at the country level;
- 8. <u>Invites</u> the Director-General in so doing to place due emphasis on:
 - (a) the scope of TVET in the context of UNESCO's mandate and work;
 - (b) fields of action for UNESCO and expected outcomes;
 - (c) vital aspects of TVET such as access, quality in terms of relevance and coherence, development of qualifications and competencies, entrepreneurial capacities, social responsibility and other aspects. Support activities should be designed to promote effective participation by women, and to meet their specific training needs;

- (d) the roles of the different units of UNESCO involved in TVET and the division of labour between these units in view of ensuring complementarity and effectiveness;
- (e) the development of country-specific needs assessment in cooperation with other relevant international organizations, NGOs and the private sector (such as chambers of commerce, employers' associations and trade unions), taking into account formal and informal sector needs:
- (f) the promotion through TVET of employment opportunities, self-employment, and micro-entrepreneurship at the country level by contributing to consultations, coordination and cooperation with relevant institutions, NGOs and other entities active in the fields of micro-financing and other forms of start-up capital;
- (g) integration of TVET into Common Country Assessments (CCAs) and United Nations Development Assistance Frameworks (UNDAFs), as well as into joint programming in pilot countries;
- (h) information on and dissemination of best practices through South-South cooperation and North-South-South cooperation;
- (i) identifying best practices for the integration of TVET into secondary education;
- 9. <u>Requests</u> the Director-General to present an outline of this strategy to it at its 180th session, and to submit the draft strategy to it at its 181st session;
- 10. <u>Further requests</u> the Director-General to incorporate relevant elements of TVET, where appropriate, into UNESCO's world conferences on education in 2008-2009, and to align them with the specific themes of those conferences.
