- 1. <u>Having examined</u> documents 181 EX/4 Part I and Add.-Add.3 and Part II and Corr., and 181 EX/INF.10,
- Recalling:
 - (a) 34 C/Resolution 89 and 180 EX/Decision 4,

- (b) the request contained in document 34 C/5 to the Director-General to report on the achievement of the expected results, providing information on the cost-efficient use of human and financial resources, following the principles of transparency, efficiency and rationalization,
- (c) that the EX/4 document constitutes a key document in the preparation of the Executive Board's report on the C/5 document currently being implemented and on the results of the previous biennium,

- 5. Noting with satisfaction the progress achieved:
 - (a) under Major Programme I, especially with regard to education for all (EFA), equity in education, and the results achieved with regard to education in Africa,
 - (b) under Major Programme II, especially the launching of the three national tsunami centres, and the contribution of the UNESCO Strategy for Action on Climate Change to the NEPAD environment initiative,
 - (c) under Major Programme III, especially with regard to the reaffirmation of the universality of human rights, capacity-building in Africa in the field of bioethics, and the establishment of the Coalition of African Cities against Racism and Discrimination.
 - (d) under Major Programme IV, especially in the representativity of the World Heritage List and in capacity-building in the management and conservation of cultural heritage,
 - (e) under Major Programme V, especially in raising awareness of freedom of expression, and in the increased involvement of women in the formulation of national information policies,
 - (f) by the UNESCO Institute for Statistics (UIS) with regard to timeliness and quality of data,
- 6. <u>Also noting with satisfaction</u> the positive results achieved in incorporating UNESCO's priorities in development assistance frameworks and joint programmes at the country level and in strengthening inter-agency collaboration at the global level,
- 7. Recognizing the efforts to focus the education programme on areas of greatest need and to improve the participation of researchers and community associations in the Management of Social Transformations (MOST) Programme,

- 8. <u>Invites</u> the Director-General, in preparing future reports on the execution of the programme adopted by the General Conference, to present information more conducive to an assessment of the Organization's capacity to deliver, by:
 - (a) including, to the extent possible, in the overall assessment of key results of the major programmes at the global, regional and country levels, as appropriate, the main challenges and possible future action regarding the achievement of the expected results;
 - (b) explaining differences between expected results and results achieved in the Report of the Director-General on the Activities of the Organization (C/3 document);
 - (c) bringing out more clearly the contribution of extrabudgetary-financed activities in the pursuit of the C/5 expected results;
- 9. <u>Also invites</u> the Director-General to take the necessary measures to meet the challenges identified in document 181 EX/4 Part I, in particular by:
 - (a) addressing the considerable lack of data in developing countries and the difficulty of bringing together stakeholders, as reported under the intersectoral platform on strengthening national research systems;
 - (b) raising awareness of education policy-makers of the importance of media literacy as a key component of teacher education;
 - (c) ensuring proper follow-up to and implementation of results and recommendations of forums of ministers of social development;
- 10. Further invites the Director-General to:
 - (a) determine stages in the implementation of the Priority Gender Equality Action Plan and report on progress and challenges in the biennial report in 2011, with emphasis on cooperation with other United Nations agencies;
 - (b) highlight the priority of gender equality, and report on progress made thereon, including indications of resources earmarked for coordination purposes and for interventions by the programme sectors, beginning with document 36 C/5;

The Executive Board,

- 1. Recalling 177 EX/Decision 9 and 34 C/Resolution 19,
- 2. <u>Having examined</u> documents 181 EX/5 Add. and 181 EX/INF.15 on the progress of work on UNESCO's efforts for the United Nations Decade of Education for Sustainable Development (2005-2014),
- 3. Recognizing the crucial importance of the mid-Decade review undertaken by the UNESCO World Conference on Education for Sustainable Development in Bonn (31 March-2 April 2009) and its preparatory meetings in Bordeaux (France), Gothenburg (Sweden), Nairobi (Kenya), Tokyo (Japan) and Khanty-Mansiysk (Russian Federation), not only to strengthen and extend the outcomes of the Decade into the next five years but also to ensure long-term implementation of education for sustainable development (ESD),
- 4. <u>Welcomes</u> the offer made by the Government of Japan to host the end-of-Decade world conference on ESD and co-organize it with UNESCO;
- Also welcomes the initiative by the Government of Brazil to host in June 2010 the Children and Youth International Conference – Let's Take Care of the Planet to discuss the contribution of the younger generations to addressing the global socialenvironmental changes;
- 6. <u>Underlines</u> the importance of the Bonn Declaration adopted at the World Conference in Bonn, by which Member States, other stakeholders and UNESCO committed themselves to adopting the concrete measures needed to achieve a successful outcome of the Decade as well as to ensure the long-term implementation of its goals;
- 7. <u>Also underlines,</u> in particular, the commitment of Member States expressed in the Bonn Declaration to integrate ESD into national policies and budget plans and to reorient education and training systems in order to address concerns of sustainability through coherent policies at the national and local levels;
- 8. <u>Stresses</u> that measures requested of UNESCO as lead agency for the Decade in the Bonn Declaration must be initiated as soon as possible, and <u>calls on</u> the Director-General to formulate a draft strategy for the second half of the Decade based on the Bonn Declaration, as well as on findings of other ESD meetings and the Fourth International Conference on Environmental Education in Ahmedabad (2007);
- 9. <u>Further calls</u> on the Director-General to submit the Bonn Declaration as well as the draft strategy together with a progress report on the United Nations Decade of Education for Sustainable Development to the Executive Board at its 182nd session and to the General Conference at its 35th session.

Implementation of 34 C/Resolution 47 and 180 EX/Decision 5 (II) relating to the Ascent to the Mughrabi Gate in the Old City of Jerusalem

- 1. Having examined 180 EX/Decision 5 (II) and documents 181 EX/5 and Add. 4,
- 2. <u>Recalling</u> 176 EX/Special Plenary Meeting/Decision, 177 EX/Decision 20, and 179 EX/Decisions 9 and 52,
- 3. <u>Further recalling</u> Decisions 31COM 7A.18 and 32COM 7A.18 adopted by the World Heritage Committee respectively at its 31st session (Christchurch, 2007) and 32nd session (Quebec City, 2008),
- 4. Also recalling the relevant provisions on the protection of cultural heritage including, as appropriate, the four Geneva Conventions (1949), the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict of 1954, the Convention for the Protection of the World Cultural and Natural Heritage of 1972, the inscription of the Old City of Jerusalem and its Walls, at the request of Jordan, on the World Heritage List (1981), and on the List of World Heritage in Danger (1982), and the recommendations, resolutions and decisions of UNESCO,
- 5. Reaffirming the purpose and spirit of the professional encounter at the technical level of 13 January 2008, as well as the follow-up meeting of 24 February 2008,
- 6. <u>Noting</u> the sixth reinforced monitoring report (February 2009) prepared by the World Heritage Centre,
- 7. Regretting the postponement of the follow-up meeting of experts, which was scheduled for 12 November 2008, as called for in Decision 32COM 7A.18 adopted by the World Heritage Committee in Quebec City and reiterated in 180 EX/Decision 5 (II), owing to circumstances which impeded Jordanian experts from having access to the Mughrabi Ascent site,
- 8. Recognizing the existence of deep concerns regarding the decision taken by the Jerusalem District Planning and Construction Commission on the town planning scheme for the Mughrabi Ascent,

- 9. Requests that, despite the decision mentioned in paragraph 8, the process for the design of the Mughrabi Ascent be inclusive of all parties concerned, in accordance with the spirit and content of previous World Heritage Committee decisions;
- 10. Reaffirms in this regard that no measures, unilateral or otherwise, should be taken which will affect the authenticity and integrity of the site, in accordance with the Convention for the Protection of the World Cultural and Natural Heritage of 1972 and, as necessary, the relevant provisions on the protection of cultural heritage of the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict of 1954;

- 3. Reaffirming the Medium-Term Strategy for 2008-2013 (34 C/4) and its two global priorities Africa and gender equality its overarching and strategic programme objectives, as well as its intersectoral orientation, and <u>further reaffirming</u> the universal character of UNESCO's mandate.
- 4. <u>Mindful</u> of the impact of the current global financial, economic and social crisis on the financial capacities of Member States, in particular developing countries,
- 5. <u>Urges</u> Member States to focus on the crucial role and potential contribution of education, the natural sciences, the social and human sciences, culture, and communication and information in the efforts to overcome the present crisis, and to maintain and increase investments and international cooperation in these fields, thereby laying a foundation for recovery, sustainable development, social cohesion and stability;

- (iv) The Board shall consider, in private meeting, all the names of the candidates so suggested, provided that no candidature shall be considered unless biographical details are available, in accordance with Rule 58, paragraph 2, of the Rules of Procedure of the Executive Board.
- (v) The candidates will be interviewed in private meeting at the 182nd session.
- (vi) The duration of each interview will be a maximum of one hour. It will consist of two parts:

First part: Oral presentation by the candidate, lasting up to 20 minutes.

Second part:

- (a) Each electoral group will designate its representative(s), who will ask each candidate one question.
- (b) The questions, which should not exceed two minutes each, may be asked in any of the six working languages of the Executive Board, and the candidates will reply in English or in French. In the interview, they will be encouraged to state their ability to handle the two working languages of the UNESCO Secretariat or to develop it further.
- (c) The candidate will have a maximum of five minutes in which to answer each question.
- (d) The candidate will have up to 30 minutes in which to answer the six questions asked by the electoral groups.
- (vii) The order of the interviews of the candidates and the order in which the electoral groups ask their questions will be determined by lots drawn at the first private meeting of the 182nd session.
- (viii) The interviews of the candidates will be broadcast simultaneously on-screen in Room XI, access to which will be limited to one representative per Member State

- of UNESCO not a Member of the Executive Board, pursuant to Rule 29, paragraph 1, of the Rules of Procedure of the Executive Board.
- (ix) After completion of all interviews, the Executive Board will discuss privately, in a private meeting, in preparation for the balloting process, without analysing or discussing the outcome of the interviews, in accordance with Rule 58, paragraph 2, of the Rules of Procedure of the Executive Board.
- (x) Voting will be by secret ballot in private meeting, in accordance with Rule 58, paragraph 3, of the Rules of Procedure of the Executive Board.
- (xi) Each candidate will be offered appropriate office facilities on the day of his or her interview.

- 4. <u>Noting</u> the memoranda of understanding which UNESCO has concluded with the United Nations Development Programme (UNDP) and the United Nations Environment Programme (UNEP), which define areas in which the organizations can effectively collaborate in pursuit of national development objectives,
- 5. <u>Further noting</u> the evaluation by UNESCO's Internal Oversight Service (IOS) of UNESCO's participation in the eight pilot countries of the "Delivering as One" initiative (181 EX/20), and taking note with satisfaction of the consistent statements of the governments in the pilot locations that interactions with the United Nations system are becoming more effective, simpler, less time-intensive and less costly (181 EX/20, para. 14, and 181 EX/49, para. 10),
- 6. Recognizing the need to pursue the discussion and keep UNESCO's governing bodies informed of the participation of UNESCO in the United Nations system-wide reform, including the possibilities available for the Organization to align its planning cycle with the future quadrennial cycle of policy review of operational activities for development of the United Nations system starting from 2012, as proposed in United Nations General Assembly resolution 63/232 (see 181 EX/49, para. 5),
- 7. Recalling the importance of an effective decentralization system and structure to support UNESCO's operational activities within the United Nations system,
- 8. <u>Noting with concern</u> that a final report on an adjusted decentralization system and structure, building on the comprehensive action plan for the implementation of the 2007 triennial comprehensive policy review requested by the Executive Board in 180 EX/Decision 6 (II), has not been presented.

- 8. <u>Calls upon</u> all Member States which are in a position to do so to strengthen their support for South-South cooperation and for triangular cooperation;
- 9. <u>Invites</u> the Secretariat to develop, as a matter of urgency, a fundraising strategy for the Fund, to be presented to it at its 182nd session;

- 4. <u>Further noting</u> that the information society is founded on the purposes and principles of the Charter of the United Nations, and should fully respect and uphold the Universal Declaration of Human Rights,
- 5. <u>Stressing</u> that information and communication strategies should be geared to strengthening cultural diversity, and also should facilitate freedom of expression and the dialogue among civilizations,
- 6. <u>Emphasizing</u> the importance of efficient use of the media and information and communication technologies (ICTs) in promoting the Millennium Development Goals (MDGs) and other internationally agreed development goals,
- Taking note with concern of the continued imbalances and inequalities in the field of information and communication, which are being further aggravated by the current world crises, affecting development prospects, particularly those of developing countries,

- 8. <u>Underlining</u> the role of UNESCO to facilitate access to information and ICTs, and to promote the development of communications in favour of Member States, in particular of developing countries, to counter the ever-increasing challenges of a globalized world,
- 9. Recognizing the positive impact of ICTs on sustainable development,
- 10. <u>Further recognizing</u> the important role of the Information for All Programme (IFAP) and the International Programme for the Development of Communication (IPDC) in bridging the digital divide, and in preserving cultural diversity, human rights and access to pluralistic, free and independent sources of information, and <u>calling for</u> their continual strengthening and support to fulfil their mandates in this field,
- 11. <u>Invites</u> the Director-General to take appropriate measures with a view to reducing the existing digital divide in knowledge and technologies in the field of information and communication to build an inclusive knowledge society and to promote ICTs for sustainable development;
- 12. Requests the Director-General, in preparing submissions for the United Nations Secretary-General's report to be presented at the 65th session of the General Assembly, to report to it at its 184th session on UNESCO's progress at the international and regional levels in implementing the relevant action lines of the World Summit on the Information Society, including the measures taken by UNESCO to reduce the existing digital divide;
- 13. <u>Further requests</u> the Director-General, during the preparation of his regular biennial report on the communications for development programmes in the United Nations system, which is to be submitted to the United Nations General Assembly, to submit a report to the Executive Board at its corresponding spring session on the activities undertaken by UNESCO in this area, taking into account the contributions of the Member States in this regard.

Institution of a UNESCO/Juan Bosch prize for the promotion of social science research in Latin America and the Caribbean (181 EX/56; 181 EX/INF.14 Add.2; 181 EX/66)

- 1. Bearing in mind that the Government of the Dominican Republic, with the support of the Latin America and the Caribbean group (GRULAC), and in coordination with the Permanent Delegations of Cuba, the Bolivarian Republic of Venezuela and Costa Rica, is proposing the establishment of a UNESCO/Juan Bosch prize for the promotion of social science research in Latin America and the Caribbean, to be awarded every two years for the best thesis in the social sciences written by young people in the region,
- 2. <u>Considering</u> that this proposal is consistent with UNESCO's objectives and policies, and ties in with overarching objective 3 "Addressing emerging social and ethical challenges" of the Medium-Term Strategy 2008-2013, and with strategic programme objective 7 "Enhancing research-policy linkages on social transformations",
- 3. <u>Further considering</u> that the proposed prize complies with the new strategy and criteria for UNESCO prizes set out in document 171 EX/19, in accordance with 171 EX/Decision 24.
- 4. Having examined document 181 EX/56,
- 5. <u>Expresses</u> its deep gratitude to the countries supporting and collaborating in this initiative, in particular the Government of the Dominican Republic for its generous offer

- of a donation of \$125,000, which will cover all ordinary operational costs relating to this prize for three biennia;
- 6. <u>Approves</u> the Statutes of the UNESCO/Juan Bosch Prize for the Promotion of Social Science Research in Latin America and the Caribbean, as set out in Annex I to document 181 EX/56;
- 7. <u>Takes note</u> of the Financial Regulations that govern the Special Account established for this Prize, as set out in Annex II to document 181 EX/56;
- 8. <u>Urges</u> Member States and other donors to support this initiative and thus strengthen UNESCO's programmes in the field of research in the social sciences.

The global economic and financial crisis and its effects on education (181 EX/57; 181 EX/INF.14 Add.; 181 EX/68 Part II)

The Executive Board,

- 1. Recalling 33 C/Resolution 15, 174 EX/Decision 9, 174 EX/Decision 10 and 180 EX/Decision 7,
- 2. Having examined document 181 EX/57,
- 3. <u>Expresses</u> serious concern over the worldwide financial and economic crisis, which is adversely affecting the financing of all UNESCO sectors, in particular education and the achievement of the Dakar goals,
- 4. Reiterating in this regard the conclusions and recommendations of the 48th session of the International Conference on Education, which emphasized that funding for education should be a top priority, and that the financial crisis should not serve as a pretext for reducing the allocation of resources to education at either the national or the international levels.
- <u>Calls upon</u> national governments to allocate adequate domestic resources to education, and upon development partners to fulfil their previous pledges, which, as underlined in the Oslo Declaration in December 2008, would lead to a significant increase in financing for developing countries, which would in turn mitigate the impact of the global financial crisis;
- 6. <u>Notes with satisfaction</u> that the governance mechanisms for the South-South Cooperation Programme/Fund for Education are in place, and <u>calls upon</u> development partners to consider contributing to the Programme/Fund;
- 7. <u>Underlines</u> the importance of the debt-for-education swap mechanisms;
- 8. <u>Invites</u> the Director-General to elaborate a fundraising strategy aimed at calling upon donors to contribute to the South-South Cooperation Programme/Fund for Education;
- 9. Requests the Director-General to present to it at its 182nd session a preliminary report, coordinating, as appropriate, with United Nations and other relevant international organizations, on the impact of the current financial and economic crisis on the efforts of developing countries to achieve the EFA goals;
- 10. <u>Further requests</u> the Director-General to present to it at its 184th session a concise and analytical report on this matter.

- 4. <u>Taking note with concern</u> of the delays reported by many countries in reaching the Dakar goals,
- 5. Reaffirming the need to accelerate progress towards the education for all (EFA) goals and the Millennium Development Goals (MDGs), and to provide the requisite financing,
- 6. <u>Emphasizing</u> the importance of the role that UNESCO must play as lead agency for coordinating EFA and the Global Action Plan within the United Nations system,
- 7. Also reaffirming the importance of quality, equity and inclusion, priorities highlighted in the recommendations of the Seventh Meeting (Dakar, 11-13 December 2007) and of the Eighth Meeting (Oslo, 16-18 December 2008) of the High-Level Group on Education for All,
- 8. <u>Further reaffirming</u> the importance of the broadened concept of inclusive education as underlined by the International Conference on Education at its 48th session (Geneva, 25-28 November 2008),
- 9. <u>Taking note</u> of the Bonn Declaration following the UNESCO World Conference on Education for Sustainable Development (Bonn, 31 March 2 April 2009),
- Further taking note of the results of the International Conference on Adult Education (CONFINTEA) meetings, and <u>looking forward</u> to the decisions to be taken at the next meeting in Belém, Brazil,
- 11. <u>Noting</u> the common denominator of the recommendations of these three meetings, which points to the need for fundamental priorities which are the responsibility of Member States, such as quality, equity and inclusion
- 12. <u>Emphasizing</u> the importance of building in a concerted way on the debates held during the aforementioned three meetings and on the conclusions reached by them,
- 13. <u>Invites</u> the Director-General to present to it at its 182nd session a concise analytical report on the follow-up to and implementation of the recommendations of these meetings at the national, regional and international levels;
- 14. Requests the Director-General to submit to the General Conference at its 35th session an analytical and results-based report on progress made with respect to education for all:

15. <u>Calls upon</u> donor countries to cooperate with host countries, where necessary, to facilitate the participation of the greatest possible number of developing countries in international meetings on education.

- Calls upon the Director-General to participate actively in the integrated United Nations response to the Gaza Early Recovery and Reconstruction Plan developed by the Palestinian Authority, by focusing on UNESCO's contribution to its educational and cultural heritage protection components;
- 11. <u>Thanks</u> Finland and Japan for their generous financial contributions to the UNESCO projects retained in the United Nations Flash Appeal for Gaza, and <u>invites</u> Member States, international governmental and non-governmental organizations and relevant international and national institutions, as well as private institutions, to further assist in this regard through extrabudgetary funding;
