## 9.2 Amendments to be made to the Rules of Procedure of the Executive Board (81 EX/6)

#### Rules 9. Members

(1) The Executive Board shall be elected by the General Conference from among the delegates appointed by the Member States and shall consist of thirty-four members, each of whom shall represent the government of the State of which he is a national.

### Rule 26. Quorum

(1) At meetings of the Board the quorum shall consist of eighteen members or duly appointed deputies, of whom at least ten shall be titular members.
