The month of November was marked by a number of activities focused on enhancing cooperation between UNESCO and the National Commissions.

Video-conference with El Salvador National Commission

In collaboration with the Permanent Delegation and the National Commission of El Salvador for UNESCO, a video-conference was organized for enhancing the capacities of this National Commission. The training session brought together some twenty members of the El Salvador National Commission.

This innovative and low-cost activity provided participants with an overview of cooperation between UNESCO and El Salvador while also responding precisely to questions raised. A large number of participants were in attendance, including high-level members of the National Commission. The use of Spanish contributed to the success of this training session.

I am pleased with the successful outcome of this video-conference with the El Salvador National Commission and would invite other National Commissions to explore the possibilities of taking advantage of this new form of communication for training.

Electronic Forum of the Open-Ended Tripartite Working Group

As you know, an electronic forum (e-Forum), designed as a workspace to collect proposals on the Action Plan for the implementation of recommendations, was launched last week, following the first meeting of the open-ended Tripartite Working Group. We have organized the e-Forum into six sequential discussion modules, each devoted to one of the recommendations made by IOS in its final report, thus allowing for a more focused and detailed discussion.

We will dedicate two weeks to discuss the first recommendation (clarifying the role of National Commissions) given its general nature and particular importance. We will then allocate a shorter but adequate amount of time to each of the other five recommendations. You will be sent an e-mail reminding you about which recommendation item shall be up for discussion. It is expected that the e-Forum discussions shall end 10 January 2013 at the latest.

International Year of Water Cooperation (2013)

At its 65th session in December 2010, the UN General Assembly proclaimed 2013 as the International Year of Water Cooperation. The UN General Assembly expressed its concern about "the slow and uneven progress in achieving the goal of halving the proportion of people who do not have sustainable access to drinking water and to basic sanitation services, when climate change and other global issues have serious effects on the quantity and quality of water."

UNESCO, applying a multidisciplinary approach which blends the natural and social sciences, education, culture and communication, is preparing to take an active part in the events of the Year, for which the plan will be finalized in early 2013. Given the intrinsic nature of water as a transversal and universal element, the United Nations International Year of Water Cooperation naturally would embrace and touch upon all these aspects.

We wish to reiterate the UN's call to take appropriate measures to organize activities and make relevant proposals for activities to be undertaken at all levels to celebrate it. National Commissions could, in this regard, play an important role in the development of initiatives and coordination in their respective countries.
