2. Seminar on the Pathway to Growth, 8 June 2015, Yangon, Myanmar

Over 150 people, students, academics and representatives of the private sector were treated to a stimulating panel discussion on economic reform at the Yangon University of Economics organized by the Centre of Excellence for Business Skills Development (CEBSD). The keynote speaker, Charles Schneider, Senior Operations Officer World Bank Group, discussed the key issues and constraints of operating a business in Myanmar, including access to finance, land and electricity, and, significantly for education and training, access to skilled workers. ### **Guest Entrepreneur – Simon Osborne**

"We envisage a future where we can empower and educate individuals, regardless of academic status, to intern across ASEAN cost-effectively, and leverage the latest technology to share their experiences with others around the world."



This is the mission of the Asia Internship Programme (AIP). Simon Osborne, Managing Director of AIP, graduated with a first class honours degree in Fraud and Criminal Justice from Visa Inc. Business School. He has over 10 years of retail banking experience and is a multi-award winning Visa Qualified Fraud Analyst. He initiated and developed the United Kingdom's first electronic fraud declaration and Proactive, Asset, Recovery, and Strategy (PARS) which has helped UK banks to save millions in fraud losses.

## Q: What inspired you to start Asia Internship Programme, and why Thailand?

A: We ran an internship programme for a company called Broadgate Financial and we listened to the interns that came on board there. We really heard what they were talking about, what they wanted to see, and hoped to experience during their internships. Because of the success of that programme, we created the AIP, (forming the practice part of our <u>student eco-system</u>) which is essentially creating positions for students in any kind of industry they want to go into, anywhere in Southeast Asia. Thailand is particularly popular for international internships and is a central hub, especially with ASEAN on the way. Plus, it's still an emerging market in a way.

### Q: What to do think of the entrepreneurship ecosystem in Thailand, compared to England?

A: It is continuously evolving. Thailand has presented itself to have the right economic climate for business start-ups. More graduates are wanting to become entrepreneurs and this is evidenced by the number of emerging start-ups and the numerous co-working spaces available. England on the other hand is more bureaucratic and the cost of setting up a business is more expensive than in Thailand. For instance our company AIPGlobal.co's pre-seed incubator ADEPTO has invested in the first private tech incubator in Thailand, TechGrind as a testament to the number of students wanting to enter entrepreneurship.

#### Q: What is your strategy for entrepreneurial decision-making?

A: I see failure as an opportunity to keep on improving / challenging myself to do better for the consumer, my team and company. When it comes to strategy, we want to identify and seize every opportunity presented to us that represents an enhancement to the lives of our consumer no matter how small that maybe. What I can say is that as a company, it is a unified and collective decision. I would never make a decision without first consulting my team.

#### Featuring Coin ⇒Back: An Enterprise for Public Good

Around 100 million tourists arrive in ASEAN every year and the number is still growing. According to the survey conducted at Suvarnabhumi airport in Bangkok, most of the tourists have leftover coins before leaving the country that most of the time goes unused. Although the average leftover coins per person is about US\$1, which is not a lot, if you combined all the travellers in the world, it can be

substantial. Social entrepreneurs act as the change agents for society, by seizing opportunities others miss in order to improve systems, inventing and disseminating new approaches that create social value. A social project, named **Coin=Back**, is coming into being, with the aim to promote social inclusion and sustainable development, by creating a personalized and transparent donation experience to raise funds for various organizations with different causes.

Donors, who want to get rid of their leftover coins before leaving the country, can find Coin⇒Back kiosks in the international airports, duty free shops, tourist attractions and other hubs for foreigners. After the machine counts up the amount, donors can choose the cause they want to donate to from different categories. Generally, there are four categories, namely education, culture, environment, and poverty. Lastly, donors may get the receipt and scan the QR code, by which they can track the donation, until it arrives to the beneficiary. Discount coupons are also designed to award those who donate at shops in the airport for the last minute shopping.

Offline crowd funding and online track platform make this idea possible to provide more personalized and engaging donation platform. By harnessing both technology and social media, Coin⇒Back believes that the travellers can see the impact of their contribution, and stay connected to that particular organization after making their donations. This important feature will motivate travellers to remain involved and interact with the projects that they feel strongly about.

Coin=Back is negotiating with international organizations/airports/duty-free shopping malls/hotels at this moment, and hopefully, we will see its launch in this October.
