

The Pacific Overview





Pacific Education

- Varies by country:
 - The Northern Pacific Countries follow the US Education and qualifications System
 - Cook Islands and Niue follow the New Zealand education and qualifications system;
 - Nauru follow the Queensland State of Australia education system
 - Other Pacific countries follow their own education systems (inherited from UK, New Zealand and/or France)



Pacific Higher Education

- Fiji: 3 Universities + TVET Providers+ Theological Schools
- PNG: 6 Universities=15 other HE Institutions+250 TVET providers and Community Colleges
- Samoa: 1 University = TVET Providers
- Solomon Islands: 1 University + TVET providers
- Tonga, Vanuatu, Kiribati and Tuvalu: TVET Providers



Socio-cultural Factors

- Most are small Island states
- Economies are small
- Education and training sectors are small



Political realities

- Pacific countries are independent democratic states
- Regional organisations complement national development
- Pacific Forum Leaders have endorsed the Pacific Framework for Regionalism



The Pacific Qualifications Framework

Genesis:

- 2001 Forum Education Ministers Meeting
- 2004: Heads of Education systems recommended to begin with a Register as prerequisite to a Framework
- However, having a Register without a Framework was just an inventory of varied qualifications and institutions
- So we started with a meta-framework for already developed national qualifications frameworks (Fiji,

Challenges

- The rate and Capacity of national agencies to accredit Institutions and Programmes in particular
- Stakeholder awareness, engagement and confidence
- Stakeholder know-how in the application of the PRQS for their purposes
- Relationships with other national and regional Frameworks



Challenges

- Domains of Level Descriptors are nationally determined
- Formulating learning outcomes and recognition of qualifications



Lessons Learnt

- Growing recognition of the PQF as an important instrument in regional capacity building and support of regional initiatives;
 - Development of regional qualifications
- The PQF & PQAF facilitate the development of regional qualifications given capacity limitations and constraints
- Importance of a robust regional quality assurance that complements national quality assurance;



The Future...?

- Confirm the role of the PQF/PRQS in supporting Labour Mobility schemes;
- Develop and populate a Regional Skills Register
- Explore quality assurance of certification of awards
- Further develop regional qualifications as needed



Fine-tuning

- Need to consider the formulation of Learning Outcomes against QF Level Descriptors;
- Capacity building on Programme accreditation and quality audit;
- Alignment of the PQF against other NQFs and RQFs
- Development of a Skills Register re-labour mobility
