UNESCO observes World Down Syndrome Day in Karachi

KARACHI: UNESCO in collaboration with Pakistan Down Syndrome Association commemorated World Down Syndrome Day in a local hotel in Karachi. A large number of activists for the Rights of Persons with disabilities, representatives of media and Civil Society organizations participated at the event. The United Nations has declared 21st March as 'World Down Syndrome Day' in 2012 and it was the first time that this day has been celebrated in Pakistan by UNESCO and Pakistan Down Syndrome Association. PDSA is linked with Down Syndrome International-DSI, which is globally engaged in raising awareness about the rights of people with Down syndrome.

While reading the message of UNESCO's Country Director to Pakistan, Dr. Kozue Kay Nagata, Mr. Kazi Avaz Mahessar, Provincial Coordinator of UNESCO in Sindh, highlighted the importance of early intervention through Early Childhood Care and Education in the development of children with Down syndrome. He said that persons with disabilities are often seen as the objects of pity and misfortune and are often left helpless on their own or with their parents.
