## Financing for Development Events to be Held in Lead-up to Doha

### Active Participation of Civil Society Called For

The Monterrey Consensus, which was adopted at the International Conference on Financing for Development in Mexico in 2002, called for a global alliance for development. All stakeholders in the Monterrey process, including civil society, reaffirmed their commitment to staying fully engaged – nationally, regionally and internationally – and to ensuring proper follow-up to the implementation of agreements and commitments reached at the Conference.

Building on that commitment, the UN General Assembly has decided to hold a [Follow-up International Conference on Financing for Development \(FfD\)](#) in Doha, Qatar in the second half of 2008.

A series of high-level intergovernmental events on Financing for Development will lead up to the Conference:

- (1) Spring Meeting of ECOSOC with BWIs, WTO and UNCTAD (NY, 16 April 2007)
- (2) First ECOSOC Development Cooperation Forum (Geneva, July 2007)

- (3) GA High-level Dialogue on Financing for Development (New York, fourth quarter of 2007)
- (4) Spring Meeting of ECOSOC with BWIs, WTO and UNCTAD (New York, April 2008)
- (5) Second ECOSOC Development Cooperation Forum (New York, July 2008)

*(all dates and locations are subject to confirmation by Member States)*

All of these projects are undertaken in close consultation with experts from the public and private sectors, academia and civil society.

Current focus areas include:

(I) Rethinking the role of National Development Banks

(II) Financing basic utilities for all

(III) Strengthening the business sector and entrepreneurship in developing countries: the potential of diasporas
