13. Peace and Security in Africa

During the period under review, the Security Council held nine meetings, adopted one resolution and issued three presidential statements under the agenda item entitled, "Peace and security in Africa". The deliberations of the Council focused on the developments in the Sahel region and the challenges posed by the outbreak of Ebola at the end of 2014.

In the context of the Sahel, the deliberations in the Council concentrated on the implementation of the United Nations Strategy for the Sahel and its three main pillars, namely, governance, security and resilience. The Council adopted two presidential statements expressing concern about the situation in the Sahel region.⁵⁴ The Council also reaffirmed its strong commitment to the sovereignty, territorial integrity, political independence and unity of countries of the Sahel region and reiterated the importance of national and regional ownership of the United Nations Integrated Strategy for the Sahel. The Council further welcomed the establishment of the Group of Five for the Sahel (G5), and encouraged the Office of the Special Envoy of the Secretary-General for the Sahel (OSES) to work closely with the G5 countries, as well as other countries of the region, and regional and international actors to tackle the threats to peace, security and development in the Sahel.

The Council led the multilateral response to the Ebola health crisis by adopting resolution 2177 (2014), which was sponsored by a record number of 134 Member States. The Council determined that the unprecedented extent of the Ebola outbreak in Africa constituted a threat to international peace and security, and underlined that unless the outbreak is contained, it might lead to further instances of civil unrest, social tensions and a deterioration of the political and security climate in the most affected countries.⁵⁵ The Council called on Member States, *inter alia*, to lift general travel and border restrictions, facilitate the delivery of humanitarian assistance and provide urgent resources and assistance. In addition to the resolution, the Council issued a presidential statement on 21 November 2014⁵⁶, and held an open debate on 13 August 2015 further to the concept note, which was
