

41. Cooperation between the United Nations and regional and subregional organizations in maintaining international peace and security

During the period under review, the Security Council held four meetings and adopted two presidential statements in connection with the item entitled “Cooperation between the United Nations and regional and subregional organizations in maintaining international peace and security”. The Council discussed the partnership between and among the United Nations, the European Union and the African Union in various issues relating to the maintenance of international peace and security, including the emerging migrant crisis.¹³⁵

The Council on 14 February 2014 adopted its first presidential statement on the cooperation between the United Nations and the European Union, by which the Council commended the European Union’s involvement in international negotiations and mediations, its commitment to international peacekeeping, peacebuilding, humanitarian presence and financing as well as logistical support, and its role in supporting the United Nations operations in the areas of mutual concern.¹³⁶ By a presidential statement, the Council recognized the role of the African Union in efforts to prevent or settle conflicts in the African continent, and commended the increased contribution of the African Union to the maintenance of peace and security, including peacekeeping.¹³⁷ The Council also welcomed the continued cooperation between the two organizations on different components of the African Peace and Security Architecture.¹³⁸
