

### **30. Small arms**

During the period under review, the Security Council held two meetings in connection with small arms and adopted one resolution. Resolution [2220 \(2015\)](#) focused on strengthening international cooperation in preventing, combating and eradicating the illicit transfer, destabilizing accumulation and misuse of small arms and light weapons in all its aspects, particularly through the effective implementation of Council-mandated arms embargoes and through information-sharing mechanisms, with the assistance of peacekeeping missions and other relevant United Nations entities.
