Item 2 of the provisional agenda: Election of a Chairperson, one or more Vice-Chairperson(s) and a Rapporteur of the Conference of Parties

Decision required: paragraph 3

1. In accordance with the Rules of Procedure of the Conference of Parties (Rule 5), the Conference shall elect a chairperson, one or more vice-chairpersons and a rapporteur. The Conference of Parties may wish to consider electing a Bureau comprising a total of six members, that is, one member from each of the electoral groups established by the General Conference of UNESCO (see Annex).

2. The term of office of the chairperson, the vice-chairperson(s) and the rapporteur will run from the opening of the current session until the opening of the next regular session of the Conference of Parties, when a new Bureau will be elected.
