Education for All: the possible dream

In 1990 the international community set itself a monumental challenge: to provide basic education for all the people of the world and reduce illiteracy. Ten years later great steps forward have been made yet much still remains to be done.

At the dawn of a new millennium the world community has a unique opportunity to examine how much nearer it is to achieving its goal of Education for All (EFA) and to set priorities for the next century. How well have countries delivered on their EFA commitment? Which strategies accelerate the provision of basic education? How can countries make the EFA dream a reality?

To answer these questions, hundreds of national leaders, United Nations agency heads, education policy-makers

and practitioners will gather at the World Education Forum in Dakar, Senegal, in April 2000. Brought together by UNDP, UNESCO, UNFPA, UNICEF and the World Bank, delegates will examine the findings of the most in-depth assessment of basic education ever undertaken and set out plans to meet the basic learning needs of all in the new century.

The rise of Education for All

The Education for All initiative began in 1990 in Jomtien, Thailand, where representatives of 155 governments, 33 intergovernmental bodies and 125 non-governmental organizations pledged to work towards the goal of education for all. Now, at the close of the decade, more than 180 countries are undertaking a two-year audit of their basic education programmes. The World Education Forum will provide the first opportunity for the international community to examine the worldwide results of the EFA 2000 Assessment.

The findings and recommendations of each regional group, together with a global synthesis report, will be presented to the Forum to provide the clearest picture possible of basic education around the world.

The EFA 2000 Assessment will provide vital information on all types of programmes, activities and services that aim to meet the basic learning needs of children, youth and adults. At the country level, it will enable governments and their partners to consider a comprehensive picture of their progress towards EFA goals and identify effective strategies for progress. At the international level, it will provide the basis for dialogue and cooperation for years to come.

World Education Forum Objectives

- "Every person child, youth and adult shall be able to benefit from educational opportunities designed to meet their basic learning needs." So begins Article 1 of the World Declaration on Education for All, a document that remains the touchstone for all education development and is as pertinent today as when it was adopted in 1990.
- The aim of the World Education Forum is to help turn the vision of the Declaration into reality. Delegates will be invited to adopt a new Framework for Action, a bold, practical document designed to help nations meet the basic learning needs of all by 2015.
- The new Framework for Action will redefine strategies and set clear operational goals and strategic objectives. It will build on the findings of the EFA 2000 Assessment and help develop partnerships between governments, civil society and the international community to meet measurable education targets.
- The new Framework will be widely distributed to interested parties and communicated to major United Nations development conferences taking place in 2000 and 2001.

Venue

The World Education Forum will take place at the conference centre of the Le Méridien Président Hotel, Dakar, from 26 to 28 April 2000. Set in a 35-acre coastal park only 15 minutes outside the city centre, the hotel will provide an excellent location for the deliberations of the Forum.

In hosting the event, the Government of Senegal recognizes the great importance of basic education for national progress. Sub-Saharan Africa faces some of the greatest challenges in education, yet many African countries have pursued their EFA goals, launched several bold initiatives and registered some notable successes. The Government of Senegal hopes the Forum will provide renewed momentum to all nations to expand educational opportunities for all and reduce adult illiteracy.


