 - (c) to implement the approved medium- and long-term staffing strategy, taking into account the strategy and programmes of the Organization within the limits of the future budgets;
 - (d) to report back on the implementation of the staff policy at its 174th session, including the results of the policies already in place, and to present a first review of the medium- and long-term staffing strategy at its 176th session.

- 5. <u>Invites</u> the Director-General to take all necessary measures to ensure UNESCO's response to United Nations General Assembly resolutions 57/254, 58/219 and 59/237;
- 6. <u>Further invites</u> the Director-General to pursue his consultations with other United Nations agencies, with Member States and with civil society, with a view to enabling UNESCO to play a major and visible role in the effective implementation of the Decade;
- 7. <u>Invites</u> the Director-General to bring a more strategically focused, consolidated version of the scheme to it for consideration its 172nd session;

The Executive Board,

- 1. <u>Recalling</u> 167 EX/Decision 3.4.3 requesting the Director-General to undertake a feasibility study on this proposal and examine, *inter alia*, the possibility of including the proposed regional centre as a regional centre of excellence in an international basic sciences programme,
- 2. Having examined document 171 EX/9 and its Annex,
- 3. <u>Aware</u> of the importance of international and regional cooperation for the development of science and technology in Asia and the Pacific, in particular in the area of biotechnology training and education,
- 4. Welcoming the proposal of the Government of India,
- 5. Takes note of the observations and conclusions of the feasibility study;
- 6. <u>Deeming</u> the considerations and proposals contained therein to be such as to meet the requirements needed for UNESCO to grant its auspices to the regional centre,
- 7. Recommends that the General Conference, at its 33rd session, approve the establishment of the regional centre for biotechnology training and education in India under the auspices of UNESCO, and authorize the Director-General to negotiate and sign an appropriate agreement, it being understood that the obligations of UNESCO shall not be other than those indicated in the Annex to this decision.

ANNEX

Agreement
between the Government of India
and the United Nations Educational,
Scientific and Cultural Organization (UNESCO)
concerning the Establishment of a Regional Centre
for Biotechnology Training and Education in India

Whereas the General Conference, at its 33rd session, decided that a regional centre for biotechnology training and education would be established in India under the auspices of UNESCO,

Whereas the Government of India has contributed and stands ready to contribute further to the establishment and operation of the Regional Centre in its territory,

Bearing in mind that the Government of India has already taken a number of effective measures and steps to ensure the necessary infrastructure and facilities for the Regional Centre,

Desirous of concluding an agreement with a view to ensuring the establishment and operation of the said Regional Centre and to defining the terms and conditions governing the support that it shall be granted, under the guidelines laid down by the General Conference (21 C/Resolution 40) for regional centres set up by a State with UNESCO's participation,

The United Nations Educational, Scientific and Cultural Organization, hereinafter called "UNESCO", and the Government of India, hereinafter called "the Government",

HAVE AGREED AS FOLLOWS:

Article 1 – Establishment

The Government agrees to take any measures which may be required for the setting up of the Regional Centre for Biotechnology Training and Education in India, hereinafter called "the Regional Centre", as provided for under this Agreement.

Article 2 – Participation

- 1. The Regional Centre shall be an autonomous institution at the service of Member States of UNESCO which, by their geographical proximity to the Regional Centre and their common interest in its objectives in the field of biotechnology, desire to cooperate with the Regional Centre.
- 2. Member States of UNESCO wishing to participate in the Regional Centre's activities, as provided for under this Agreement, shall send the Director-General of UNESCO notification to this effect, and shall designate a national institution working in the field of biotechnology which shall be competent to represent the Member State. The Director-General shall inform the Regional Centre and the Member States mentioned in Article 2, paragraph 1, above, of the receipt of such notifications.

Article 3 – Objectives and functions

- 1. The objectives of the Regional Centre are:
 - (a) to promote capacity-building through education and training and research and development in biotechnology for sustainable development objectives through regional and international cooperation;
 - (b) to facilitate transfer of knowledge and technology relating to biotechnology at the regional level;
 - (c) to create a hub of biotechnology expertise in the South Asian Association for Regional Cooperation (SAARC) region, and more generally in the Asia region, and to address human resources needs in the region;
 - (d) to create a network of satellite centres in the region;
 - (e) to promote and strengthen South-South cooperation.
- 2. The functions of the Regional Centre shall be:
 - (a) to execute educational and training activities to transfer knowledge in biotechnology;
 - (b) to undertake research, development and scientific investigation in collaboration with relevant research centres in the region;
 - (c) to hold scientific symposiums and conferences (regional and international) and to conduct short-term and long-term training courses and workshops in all areas of biotechnology;
 - (d) to collect universally available information with a view to setting up a data bank;
 - (e) to collect and disseminate, through networking, the relevant local knowledge;
 - (f) to disseminate the outcomes of research activities in different countries through the publication of books, articles, etc.;
 - (g) to promote collaborative research and development networking programmes in specific areas of biotechnology, and exchange and mobility of scientists at the regional level in this context with due consideration for issues pertaining to intellectual property rights of collaborating institutions.

- 3. The Regional Centre shall pursue the above objectives and functions in close collaboration with other relevant regional and international networks, the centres collaborating with UNESCO, microbial resources centres (MIRCENs) and biotechnology education and training centres (BETCENs) in the region.
- 4. The Regional Centre shall carry out the above functions dependent on the extent to which regional and international resources can be mobilized.

Article 4 - Governance

- 1. The Board of Governors:
 - (a) The Regional Centre shall be administered by a Board of Governors composed of:
 - (i) a representative of the Government;
 - (ii) a representative of each of the other Member States that (1) has sent the Director-General of UNESCO notification, as provided for under Article 2, paragraph 2, above; or that (2) makes a substantial contribution to the operating budget or running of the Regional Centre, and is thus accorded a seat by decision of the Board of Governors;
 - (iii) a representative of the Director-General of UNESCO.
 - (b) The Secretary of the Department of Biotechnology of the Indian Ministry of Science and Technology shall be the Chairperson of the Board of Governors. The person designated by the Chairperson shall be the representative of the Government.
 - (c) The Board of Governors shall have all the powers required for the running and administration of the Regional Centre. It shall:
 - (i) approve the annual work plan and budget of the Regional Centre;
 - (ii) examine the annual reports submitted by the Director of the Regional Centre as provided under Article 6 below;
 - (iii) study and approve the Centre's internal procedures, including financial regulations and staff rules;
 - (iv) approve the Regional Centre's organizational structure and number of staff;
 - (v) convene special consultative sessions to which it shall invite, in addition to its own members, the Director of the Regional Centre and representatives of other interested countries and international organizations, in order to obtain proposals for strengthening the scope of services of the Regional Centre and for carrying out projects and activities relevant to the Regional Centre, and to expand the Regional Centre's fund-raising strategy and capabilities.
 - (d) The Board of Governors shall meet in ordinary session once a year; it shall meet in an extraordinary session if summoned by the Chairperson, either on his own initiative or at the request of at least half of its members.
 - (e) The Board of Governors shall adopt its own rules of procedure. For the first meeting the procedure shall be established by the representatives of the Government and of the Director-General of UNESCO.

2. The Executive Committee:

- (a) shall be constituted, in consultation with the Board of Governors, for the day-to-day management of the Centre;
- (b) shall comprise the Director of the Regional Centre and representatives of the Department of Biotechnology, of the Indian Ministries of External Affairs and Human Resources Development, of three countries of the region (representation by rotation), and of UNESCO.

- 3. The Programme Advisory Committee:
 - (a) shall be constituted to provide technical advice for planning, execution, review and monitoring of the programme of the Regional Centre;
 - (b) shall comprise scientific, technical and legal experts nominated by the Government, countries of the region and UNESCO, and experts invited from outside the region.

4. The Secretariat:

shall be established to execute the day-to-day activities of the Regional Centre under the authority of the Director of the Regional Centre.

Article 5 – Secretariat

- 1. The Regional Centre's Secretariat shall consist of a Director and such staff as is necessary for the proper functioning of the Regional Centre.
- 2. The Director shall be appointed by the Board of Governors in consultation with the Director-General of UNESCO.
- 3. The other members of the Secretariat may comprise:
 - (a) members of UNESCO's staff who may be made available to the Centre, as provided for by the Organization's regulations;
 - (b) any person appointed by the Director, in accordance with the procedures laid down by the Board of Governors:
 - (c) government officials who may be made available to the Regional Centre, as provided by the Government's regulations.

Article 6 – Duties of the Director

- 1. The Director shall discharge the following duties:
 - (a) direct the work of the Regional Centre in conformity with the programmes and directives established by the Board of Governors;
 - (b) propose the draft work plan and budget to be submitted to the Board of Governors for approval;
 - (c) prepare the provisional agenda for the sessions of the Board of Governors and submit to it any proposals that he may deem useful for the administration of the Regional Centre;
 - (d) prepare reports on the Regional Centre's activities to be submitted to the Board of Governors;
 - (e) represent the Regional Centre in law and in all civil acts.

Article 7 – Financial arrangements

- 1. The Regional Centre's resources shall derive from catalytic funds allotted by the Government and, for start-up activities, by UNESCO, subject to the decisions of the General Conference, as well as from such contributions as it may receive from other Member States of UNESCO within the region for the establishment of a core fund following an agreed process through the administrative mechanisms of the Regional Centre, from external sources to be explored with intergovernmental organizations and international non-governmental organizations, and from payments for services rendered. The Member States may also provide voluntary contributions to the Core Fund, including contributions in the form of secondment of scientists, researchers, teachers, officers, etc.
- 2. The travel costs of the representatives of Member States participating in the sessions of the administrative bodies of the Regional Centre shall be met by the Member States participating in the Regional Centre. The local costs shall be covered by the Core Fund.
- 3. The Regional Centre may, with the approval of the Board of Governors, receive donations, gifts and legacies.

Article 8 – Contribution of the Government

- 1. The Government shall provide the Regional Centre with appropriate office space, equipment and facilities.
- 2. The Government shall make available to the Regional Centre the necessary staff, and contribute special funds which shall cover:
 - (a) the salaries and compensations of the Secretariat staff, including the Director;
 - (b) the communication, utilities and maintenance costs of the Regional Centre, plus the expenses of holding the sessions of the Board of Governors and special consultative sessions;
 - (c) the cost of studies, training, and publication activities, complementing the contributions from other sources.

Article 9 – Contribution of UNESCO

- 1. UNESCO shall provide technical assistance as and when required and as appropriate, for the establishment and operation of the Regional Centre, including assistance in the formulation of the short-term, medium-term and long-term programmes of the Regional Centre.
- 2. UNESCO shall provide some catalytic support within the framework of the regular biennial Programme and Budget (C/5 document), particularly for start-up activities of the Regional Centre, it being understood that UNESCO may only contribute financially to concrete activities/projects of the Regional Centre if those are deemed in line with UNESCO's programme priorities. UNESCO shall not, however, provide financial support for administrative or institutional purposes.
- 3. It shall encourage the international governmental and non-governmental financial entities, as well as Member States of UNESCO, to provide financial and technical assistance and to propose applicable projects to the Regional Centre, and shall facilitate contacts with other international organizations relevant to the functions of the Regional Centre.
- 4. It shall provide the Regional Centre with relevant UNESCO publications and other pertinent material, and shall disseminate information on the activities of the Regional Centre via the UNESCO website and other newsletters and mechanisms at its disposal.
- 5. It shall participate, when appropriate, in the scientific, technical and training meetings held by the Regional Centre.

Article 10 – Legal status, privileges and immunities

- 1. The Regional Centre shall enjoy on the territory of India the personality and legal capacity necessary for the exercise of its functions.
- 2. The Government shall apply to UNESCO and its officials and experts and to the representatives of Member States and Associate Members attending the sessions of the governing bodies and the Programme Advisory Committee, the provisions of the 1947 Convention on the Privileges and Immunities of the Specialized Agencies, to which it has been party since 1949.
- 3. The Government shall authorize the entry, free of visa charges, the sojourn on its territory and the exit of any person invited to attend the sessions of the governing bodies or proceeding to the Regional Centre on official business.
- 4. The goods, assets and income of the Regional Centre shall be exempt from all direct taxes. Further, the Regional Centre shall be exempt from the payment of any fees or taxes in respect of equipment, supplies and material imported or exported for its official use.
- 5. The Regional Centre may have accounts in any currency, hold funds and foreign exchange of any kind, and transfer them freely.
- 6. The Government shall be responsible for dealing with any claims which may be brought by third persons against UNESCO, against members of its staff or against other persons employed by the Regional Centre, and shall hold UNESCO and the above-mentioned parties harmless from any claims or liabilities resulting from

operations of the Regional Centre under this Agreement, except where it is agreed by UNESCO and the Government that such claims or liabilities arise from the gross negligence or wilful misconduct of such persons.

Article 11 – Final clauses

- 1. The present Agreement shall come into force upon its signature by the two parties. It shall remain in force for a period of six years following its date of entry into force and may be reviewed for a similar period as agreed upon between the parties provided that the renewal of the designation of the Regional Centre as a category 2 centre has been recommended by the Executive Board of UNESCO.
- 2. The present Agreement may be revised by consent between the Government and UNESCO.
- 3. Either party shall have the right to terminate this Agreement by giving six months prior written notice to the other party.

- 1. Recalling 21 C/Resolution 40.1 and 165 EX/Decision 5.4,
- 2. <u>Further recalling</u> the implementation plan highlighting the needs to mitigate the effects of drought and floods which was adopted at the World Summit on Sustainable Development in Johannesburg, South Africa, in 2002, and the ministerial declaration underlining the need for comprehensive efforts against water-related disasters from the Third World Water Forum in Kyoto, Shiga and Osaka, Japan in 2003, and Resolution XVI-4 adopted at the 16th session of the International Hydrological Programme (IHP) Intergovernmental Council held from 20 to 24 September 2004 in Paris,
- 3. <u>Having examined</u> document 171 EX/11 and Add. and Add. Corr.,
- 4. <u>Welcomes</u> the proposal of the Government of Japan to establish the international centre for water hazard and risk management (ICHARM) under the auspices of UNESCO, which is in line with the existing principles and guidelines (21 C/36) and the proposed strategy for this category of institutes and centres (165 EX/20 and 167 EX/16);
- 5. <u>Recommends</u> that the General Conference, at its 33rd session, approve the establishment of the international centre for water hazard and risk management (ICHARM), under the auspices of UNESCO, and authorize the Director-General to sign the agreement between the Government of Japan and UNESCO which is annexed to the present decision.

ANNEX

Agreement between the Government of Japan and the
United Nations Educational, Scientific and Cultural Organization (UNESCO)
concerning the Establishment of the
International Centre for Water Hazard and Risk Management (ICHARM)
under the Auspices of UNESCO

The United Nations Educational, Scientific and Cultural Organization (hereinafter referred to as "the Organization") and the Government of Japan (hereinafter referred to as "the Government"),

HAVE AGREED AS FOLLOWS:

Article 1 – Establishment

The Government agrees to take appropriate measures, in accordance with the laws and regulations of Japan, that may be required for the setting up of the International Centre for Water Hazard and Risk Management (ICHARM) in Japan (hereinafter referred to as "the Centre") as provided for under this Agreement.

Article 2 – Participation

- 1. The Government agrees to take appropriate measures, in accordance with its laws and regulations, which may be required for the Public Works Research Institute (hereinafter referred to as "PWRI") to operate the Centre under the Agreement between PWRI and the Organization, as may be amended by mutual agreement.
- 2. The Centre shall be an integral part of PWRI, which enjoys on the territory of Japan the personality and legal capacity necessary for the exercise of its functions, in accordance with laws and regulations of Japan, and shall serve Member States of the Organization which may, as a result of problems in the field of water-related hazards and risk management, desire to cooperate with the Centre.

Article 3 – Objective and functions

- 1. The objective of the Centre shall be to conduct research, capacity-building and information networking activities in the field of water-related hazards and risk management at the local, national, regional and global levels in order to prevent and mitigate their impacts with a view to sustainable and integrated river basin management.
- 2. In order to achieve the above objective, the functions of the Centre shall be:
 - (a) to promote scientific research and undertake effective capacity-building activities at the institutional and professional levels;
 - (b) to create and reinforce networks for the exchange of scientific, technical and policy information among institutions and individuals;
 - (c) to develop and coordinate cooperative research activities, taking advantage particularly of the existing scientific and professional capacity of the relevant International Hydrological Programme (hereinafter referred to as "IHP") networks, the World Water Assessment Programme, the International Flood Initiative/Programme, and the relevant programmes of non-governmental organizations, and involving international institutions and networks operating under their auspices;
 - (d) to conduct international training courses especially for the practitioners and researchers of the world;
 - to organize knowledge and information transfer activities, including international symposia and workshops, and to engage in appropriate awareness-raising activities targeted at various audiences, including the general public;
 - (f) to develop a strong programme of information and communication technology;
 - (g) to provide technical consulting services;
 - (h) to produce technical publications and other media items relating to the activities of the Centre.
- 3. The Centre shall pursue the above objective and functions in close coordination with IHP.

Article 4 – Advisory Board

The Government and the Organization recognize that the following provisions are included in the Agreement between PWRI and the Organization:

- (a) The Advisory Board for the Centre shall be established. Six members of the Advisory Board shall be elected by the IHP Intergovernmental Council, while other members (no more than seven) shall be appointed by the Chief Executive of PWRI. A representative of the Director-General of the Organization should be included in the Advisory Board as a full member.
- (b) The functions of the Advisory Board shall be:
 - (i) to advise on the draft work plan and budget submitted by the Director of the Centre;
 - (ii) to examine and advise on the reports submitted by the Director of the Centre.
- (c) The Chief Executive of PWRI is responsible for making a final decision on the work plan and budget based on the advice from the Advisory Board.
- (d) The Advisory Board shall meet once every two years and whenever necessary.
- (e) The Centre shall function as a secretariat of the Advisory Board.

The Government and the Organization recognize that the following provisions are included in the Agreement between PWRI and the Organization:

- (a) The Centre shall consist of a Director and staff necessary for the activities of the Centre.
- (b) The Director shall be appointed by the Chief Executive of PWRI in consultation with the Director-General of the Organization, and direct the work of the Centre.
- (c) The Centre's staff shall include:

- (i) the members employed by the Chief Executive of PWRI;
- (ii) researchers or professionals appointed and/or invited by the Chief Executive of PWRI to contribute to the Centre's activities.

Article 6 – Financial matters

- 1. The Government shall take appropriate measures, in accordance with its laws and regulations, which may be required for the Centre to receive adequate funds.
- 2. The Government and the Organization recognize that the following provision is included in the Agreement between PWRI and the Organization:

The Centre's resources shall derive from sums allotted by PWRI, from such contributions as it may receive from other governmental or intergovernmental organizations or any non-governmental organizations, and from payments for services rendered.

Article 7 – Contribution of the Organization

- 1. The Organization shall provide technical and administrative assistance for the establishment and operation of the Centre, including assistance in the formulation of the short-term, mid-term and long-term programmes of the Centre.
- 2. In conformity with the relevant policies of the Intergovernmental Council of IHP, the Organization may delegate to the Centre the execution of activities concerning water-related hazards and risk management, and may provide support within the framework of each regular biennial programme and budget, particularly to reinforce its start-up period.
- 3. The Organization shall introduce the Centre to the international governmental and non-governmental financial entities, as well as Member States of the Organization, and encourage them to provide financial and technical assistance and to propose relevant projects to the Centre, and shall facilitate contacts with other international organizations relevant to the functions of the Centre.
- 4. The Organization shall provide the Centre with IHP publications and other pertinent material, and shall disseminate information on the activities of the Centre via the IHP website and other mechanisms at its disposal.
- 5. The Organization shall participate, whenever appropriate, in the scientific, technical and training meetings held by the Centre.

Article 8 – Final clauses

- 1. The present Agreement shall enter into force upon its signature by the Government and the Organization. It shall remain in force until the end of the fifth year following the signature of the present Agreement, and may be renewed for a similar period as agreed upon between the Government and the Organization.
- 2. The present Agreement may be revised by agreement between the Government and the Organization.
- 3. Either party shall have the right to terminate the present Agreement by giving six months' prior written notice to the other party.

- 4. <u>Reconfirming</u> UNESCO's commitment to encouraging international intellectual cooperation in promotion of the dialogue between civilizations and of peace,
- 5. <u>Thanks</u> UNESCO for the efforts made in its activities to promote philosophical reflection and to underscore the role of different philosophical systems;
- 6. <u>Invites</u> the Director-General to implement the intersectoral strategy on philosophy contained in document 171 EX/12 through close intersectoral cooperation, especially with the Education Sector, and in partnership with relevant partners, in particular National Commissions for UNESCO.

Proclamation of a world philosophy day (171 EX/48 Rev.; 171 EX/INF.12; 171 EX/64 Part I; 171 EX/65)

- 1. Recalling the Universal Declaration of Human Rights, which stipulates in Article 26 that "everyone has the right to education" (para. 1) and that "education shall be directed to the full development of the human personality ... It shall promote understanding, tolerance and friendship among all nations, racial or religious groups ... for the maintenance of peace" (para. 2),
- 2. <u>Recalling also</u> the Constitution of UNESCO, which declares that "the States Parties to this Constitution, believing in full and equal opportunities for education for all, in the unrestricted pursuit of objective truth, and in the free exchange of ideas and knowledge, are agreed and determined to develop and to increase the means of communication

- between their peoples and to employ these means for the purposes of mutual understanding and a truer and more perfect knowledge of each other's lives",
- 3. <u>Mindful</u> of the eminent role played by philosophy in the development of humanity,
- 4. <u>Convinced</u> of the importance of philosophy, and concerned about the need to protect humanity from the dual threat of obscurantism and extremism,
- 5. Recalling the fundamental role of philosophy in the promotion of tolerance and peace,
- 6. <u>Underscoring</u> that UNESCO has the ambition of imbuing public opinion with moral and philosophical which are conducive to strengthening respect for human beings, love of peace, solidarity and attachment to an ideal of culture,
- 7. Recalling that one of UNESCO's particular aims is to encourage progress in philosophical studies, to support the activities of associations, universities and all other institutions with a similar goal, and to foster international exchanges and publications in the field, in particular through the holding of Philosophy Day at UNESCO, which has been celebrated since 2002 at the Organization's Headquarters and in more than 70 Member States,
- 8. Having examined document 171 EX/48 Rev.,
- 9. <u>Urges</u> Member States to:
 - (a) pursue their efforts to promote philosophy within their countries;
 - (b) support the proclamation of a world philosophy day to confirm the traditional place of that discipline in civic life so that philosophy may pursue its universal mission in the service of cultural diversity and peace in the world;
 - (c) strengthen the teaching of that discipline in their countries, and encourage initiatives involving philosophical activities by different partners within the discipline;
 - (d) use the guidelines established by UNESCO, such as the intersectoral strategy on philosophy, and promote them within the framework of international cooperation on questions relating to philosophy education and within the scientific community;
- 10. <u>Takes note</u> of the conclusions of the feasibility study presented by the Director-General on the celebration of a world philosophy day (171 EX/INF.12), including an indication of the expected results as well as an assurance that there will be no additional financial implications for the regular budget of UNESCO;
- 11. <u>Recommends</u> that the General Conference, at its 33rd session, proclaim the third Thursday of November every year "World Philosophy Day";
- 12. <u>Recommends</u> that the General Conference request the General Assembly of the United Nations to associate itself with this celebration and encourage the Member States of the United Nations to do likewise.

- 8. <u>Takes note</u> of the preliminary draft drawn up by the International Bioethics Committee, which is contained in the annex to document 171 EX/13, and <u>considers</u> that it constitutes a basis for the governmental negotiations aimed at finalizing the draft declaration;
- 9. <u>Considers</u> that the government experts, at the meeting in June 2005, should prepare and present a draft to the Director-General with a view to its transmission to the General Conference at its 33rd session in October 2005.

- 4. Expresses its sincere thanks to the Director-General for his sustained efforts for the safeguarding of the cultural and natural heritage of the Old City of Jerusalem, in compliance with 32 C/Resolution 39 of the General Conference as well as 170 EX/Decision 3.6.1 of the Executive Board, and reiterates its concern as to the obstacles to the safeguarding of the cultural and natural heritage of the Old City of Jerusalem;
- 5. <u>Congratulates</u> the Director-General on the holding of the first meeting of the International Committee of Experts on the Safeguarding of the Cultural Heritage of the Old City of Jerusalem at UNESCO Headquarters on 26 and 27 January 2005, <u>invites</u> him to pursue his efforts with a view to establishing an action plan in conformity with the main lines established by this Committee, and <u>requests</u> him to present to it a progress report on the implementation of the plan of action for the safeguarding of the cultural and natural heritage of the Old City of Jerusalem;
- 6. <u>Further invites</u> the concerned parties to cooperate with UNESCO for the implementation of the action plan, and <u>reiterates its appeal</u> to the Member States with a view to their financial contribution to the full implementation of this action plan;

- 3. <u>Reaffirming</u> all provisions of the Medium-Term Strategy for 2002-2007 (31 C/4 Approved),
- 4. Recalling 170 EX/Decision 4.1,
- 5. <u>Further recalling</u> General Assembly resolution 57/2 on the New Partnership for Africa's Development (NEPAD),

6. <u>Mindful</u> of the various reform initiatives and proposals under consideration by the United Nations and, in that connection, <u>underlining</u> the importance of the continued reform process of UNESCO,

UNESCO in a reforming United Nations system

- 7. Welcomes the explicit orientation of programme strategies and action throughout document 33 C/5 towards the Millennium Declaration, the internationally agreed development goals contained therein, and other internationally agreed targets in UNESCO domains, with special emphasis on the central goal of halving poverty by 2015:
- 8. <u>Underlines</u> the ongoing need to articulate and align UNESCO action more clearly with respect to these objectives with a view to attaining concrete results, especially at the country level, in all domains of UNESCO;
- 9. Resolves that the principal characteristics and comparative advantages of UNESCO in its role as a specialized agency of the United Nations must be clearly articulated and reflected in the next Medium-Term Strategy for 2008-2013 (34 C/4), based on the provisions of the Constitution, which are as relevant as ever in today's world;
- 10. <u>Expresses appreciation</u> for UNESCO's strategy to concentrate its activities in the fields of its core mandate, and <u>appreciates</u> the progress achieved towards this goal, as shown in document 33 C/5:
- 11. <u>Affirms</u> that UNESCO must continue to protect and promote its primary responsibility for its core mandate, <u>commends</u> the Director-General for his efforts in that regard, <u>encourages</u> supportive efforts and cooperation by other organizations of the United Nations system in performing this responsibility, avoiding duplication and strengthening complementarity, and to that end <u>underlines</u> the importance of ensuring that in the activities of United Nations coordination mechanisms, the core mandates of specialized agencies are fully brought into play, on an equal footing with those of United Nations funds and programmes;
- 12. <u>Welcomes</u> in that regard the Director-General's statement that UNESCO is intensifying its contribution to both global and country-level activities of the United Nations system, such as the Chief Executives Board (CEB) and the United Nations Development Group (UNDG) as well as in United Nations country teams, and <u>encourages</u> the Director-General to pursue these efforts vigorously, which are also aimed at enhancing effectiveness and harmonization of activities by the United Nations system in support of the sustainable development of Member States;

Strengthening action on some core issues

13. <u>Recalls</u> the five functions of UNESCO set out in the Medium-Term Strategy for 2002-2007 (para. 30 of document 31 C/4), and <u>underlines</u> the need to reinforce building of human and institutional capacities in Member States in all the Organization's fields of competence;

- 14. <u>Emphasizes</u> the function of standard-setter, which requires systematic attention at all stages, including striking a balance between expert and intergovernmental inputs during the preparatory phase of elaborating a convention or normative instrument, allowing sufficient time for the negotiation process as well as for in-country consultations so as to enhance national ownership and prospects for ratification, and <u>recalls</u> in this regard paragraph 17 of 170 EX/Decision 4.1;
- 15. <u>Affirms</u> the need to mainstream fully the needs and requirements of Africa, the least developed countries (LDCs), women and youth throughout all programmes of the Organization in accordance with the provisions of the Medium-Term Strategy for 2002-2007 (31 C/4 Approved), and <u>urges</u> the Director-General to ensure full implementation of these requirements in the work plans pertaining to document 33 C/5;
- 16. Recognizes the critical role women play in the realization of UNESCO's strategic objectives and in the pursuit of internationally agreed development goals, and <u>urges</u> that women be empowered to contribute more effectively in the implementation of the programme, including through enhanced participation in decision-making processes;
- 17. Requests the Director-General to intensify efforts to mainstream the needs of women with a view to achieving women's empowerment and gender equality and, in particular, to pursue the internationally agreed development goal of gender parity in education at all levels, as contained in the United Nations Millennium Declaration;
- 18. <u>Urges</u> UNESCO to take full advantage of the creativity of women, and specifically their contributions to science and the knowledge society, while tackling poverty, illiteracy and the threat of HIV/AIDS, which afflict women disproportionately, to intensify education to overcome violence against women, and to facilitate in all these endeavours solidarity action involving women from North and South;
- 19. <u>Calls upon</u> the Director-General to address the needs of young people as the successor generation, to respond to their expectations and ideas, to empower them to participate as partners in all areas of competence of the Organization, and to enable them to make a concrete contribution, including through partnerships, and in that regard <u>welcomes</u> the institutionalization of the Youth Forum preceding the General Conference;
- 20. <u>Requests</u> the Director-General to implement staff capacity development and training programmes fostering women, gender and youth mainstreaming, drawing on corporate training funds;
- 21. <u>Emphasizes</u> UNESCO's unique mandate and responsibility to foster a dialogue among civilizations and cultures with a view to promoting peace, understanding among peoples and a better reciprocal knowledge of cultural, ethnic, linguistic and religious diversity, and to that end <u>requests</u> the Director-General during 2006-2007 to intensify concrete action in all fields of UNESCO's competence, together with a broader involvement of women and young people, and to include appropriate interdisciplinary approaches in the next Medium-Term Strategy (34 C/4), bearing in mind document 171 EX/40 on the dialogue among peoples and the action areas indicated throughout document 33 C/5;
- 22. Recommends that document 33 C/5 include action promoting the dialogue among and with indigenous peoples, following up on the International Decade of the World's Indigenous People (1995-2004), and placing emphasis on education integrating the cultural and linguistic specificities in line with education for all (EFA) and other

- internationally agreed development goals and the preservation and protection of the tangible and intangible heritage of the indigenous peoples;
- 23. <u>Underlines</u> the important role of UNESCO in post-conflict and post-disaster situations, and <u>recommends</u> that in document 33 C/5 explicit reference be made in the various Major Programmes concerned to relevant General Conference resolutions and Executive Board decisions, specifically to General Conference resolutions 32 C/Resolutions 50, 51 and 52 pertaining to Angola, Côte d'Ivoire and the Democratic Republic of Congo, and to Executive Board decisions 170 EX/Decision 9.2 on Afghanistan and 170 EX/Decision 9.4 on Iraq;

24. <u>Notes with satisfaction</u> the substantial progress achieved in the reform process, and <u>calls</u> for a further strengthened implementation of the change management measures;

Programme concentration and prioritization

- 25. <u>Welcomes</u> the concentration and focus of the programme contained in document 33 C/5, but <u>considers</u> that a further prioritization on an ongoing basis is desirable, linked to clear goals, expected results, timelines and well-defined sunset clauses based on clearly defined expected results and timelines, and backed up by evaluations;
- 26. Notes that the Secretariat's revised programme management cycle represents a common global framework linking Headquarters, field offices and institutes, requests the Director-General to establish, in the context of the decentralization process, clear lines of management responsibility ensuring an effective targeting of all programme activities, and invites him in the context of the preparation of the Medium-Term Strategy for 2008-2013 (34 C/4) to present a vision on the optimum division and balance of functions of cluster offices, national offices, regional bureaux, institutes and Headquarters;

Results-based programming, management and monitoring (RBM)

27. Recognizes the progress made in the introduction of the results-based programming, management and monitoring (RBM) approach of UNESCO, requests the Director-General to pay particular attention to the integration of quality dimensions into the formulation of results and performance indicators as well as of impact assessments, and to intensify staff training in RBM from the corporate training budget, and underlines the need to move towards a results-based budgeting (RBB) approach, which will identify staff costs, in the presentation of document 34 C/5;

Decentralization

28. <u>Commends</u> the Director-General for his commitment to decentralization, <u>recognizes</u> the progress so far achieved, and <u>requests</u> him to continue to refine the strategy, including the authority and responsibility of field offices within UNESCO's organizational structure and programmatic decision-making, to continue to apply it in a flexible manner, and to pursue measures aimed at harmonization within the larger United Nations framework;

29. <u>Requests</u> the Director-General to assign sufficiently senior specialists with requisite competences to field offices, to make more use of national experts as a cost-effective option, and to encourage greater involvement of National Commissions in programme implementation and related decision-making based on consultations with the field offices concerned;

National Commissions

- 30. Recognizes that National Commissions, embedded in the structure of UNESCO as constituent elements, provide visibility to UNESCO in Member States, represent a mechanism for implementing UNESCO programmes at the national and international levels, have a coordinating function at the national level in UNESCO's areas of competence in close cooperation with UNESCO field offices and Headquarters, and in this function are a unique model in the United Nations system for cooperation with civil society and other stakeholders;
- 31. Requests the Director-General to ensure that within the structure of the Secretariat, the organizational unit dealing with National Commissions has sufficient operational space and flexibility to respond to the needs of National Commissions in performing their role;

Human resources strategy

32. <u>Takes note</u> of the submission of a mid-/long-term staffing strategy, including the emphasis on career development and staff competencies (171 EX/6 Part I), <u>welcomes</u> the announcement by the Director-General that in document 33 C/5 the same level of intake of Young Professionals will be maintained as in document 32 C/5, and <u>requests</u> the Director-General, in addressing the renewal of staff, to pay particular attention to the career development of Young Professionals;

Extrabudgetary resources

33. Welcomes the presentation of extrabudgetary resources in document 33 C/5, which facilitates a holistic overview, reiterates the need to ensure a full alignment of activities funded from extrabudgetary sources with the priorities of the regular programme, underlines the need to clearly identify the contribution of extrabudgetary resources to expected results concerned, and requests the Director-General to provide, on a regular basis, information regarding extrabudgetary resources in his reports on the implementation of the programme, as well as to provide information on the overall strategy for the use and mobilization of extrabudgetary resources, including measures to improve the predictability of such resources, transparency in the mechanisms, and the results obtained:

Visibility and public information

34. Requests the Director-General, and invites Member States to promote more vigorously the visibility and presence of UNESCO globally with respect to its core mandate and priority programmes, and to tailor specific messages to well-defined target groups, making full use of all tools and approaches – particularly the excellent UNESCO web portal, press releases and media advisories, publications, video and photographic material – with a view to stimulating a broad-based public engagement in and awareness of UNESCO programmatic themes;

Major Programmes

Major Programme I – Education

- 35. Affirms that education is at the heart of UNESCO's mandate, with education for all (EFA) and its six Dakar goals as an agreed priority, for the attainment of which UNESCO must exercise full leadership as the lead coordinating agency of the global EFA movement addressing all educational levels and aimed at promoting quality education;
- 36. Recommends that document 33 C/5 should include action in response to the relevant provisions of 171 EX/Decision 7, which reads as follows:

- 1. Recalling 170 EX/Decision 3.4.2 (I),
- 2. Having examined document 171 EX/8 and Corr.,
- 3. <u>Thanks</u> the Director-General for the efforts made to follow up the EFA Strategic Review;
- 4. <u>Takes note</u> of the outcomes of the initial consultations with key stakeholders to facilitate the preparation of a comprehensive mapping of the current and future contributions of each partner to achieve the EFA goals and education-related millennium goals;
- 5. Requests the Director-General to intensify consultations and high-level dialogue with key international stakeholders, particularly the World Bank, UNDP, UNICEF and UNFPA, to agree on the specific roles, responsibilities and contributions of each stakeholder for the period 2005-2015 in achieving the EFA goals;
- 6. Requests Member States to urge the key international stakeholders through their governing bodies to fully respect the framework of inter-agency coordination and cooperation for the achievement of the EFA goals, with UNESCO as the lead coordinating agency;
- 7. <u>Further requests</u> the Director-General to prepare, on the basis of these consultations and of consultations with the Working Group and High-Level Group on EFA, a concise global action plan to achieve the EFA goals, including resource mobilization, to be presented to the Executive Board at its 174th session;
- 8. <u>Also requests</u> the Director-General to develop a management framework for a decentralized and results-oriented education programme reflecting UNESCO's specific contributions, especially in capacity-building for Member States, including those from its institutes and field offices, at the international, regional and country levels;

- 9. <u>Encourages</u> the Director-General to consider appropriate organizational changes which may be necessary in order to implement the above-mentioned management framework:
- 10. Requests the Director-General to ensure that all four strategic objectives and corresponding implementation plans presented in the EFA strategy for 2005-2015 develop in alignment with the global plan as it unfolds and in a manner consistent with the management framework;
- 11. Reiterates that the heart of EFA activity lies at the country level, emphasizes that strong national leadership and national capacity are essential for achieving the Dakar goals, which should be integrated into national development and poverty reduction frameworks, and stresses the need for the international community to fulfil the commitments it made in Dakar, as amplified by the Monterrey Consensus, by substantially increasing its assistance, ensuring better coherence between the donors, and aligning aid with country-led national development strategies;
- 12. <u>Further requests</u> the Director-General to keep the Executive Board regularly informed regarding the additional extrabudgetary resources which may be necessary for the Organization to efficiently implement its EFA strategy and plans, including regional ones.";
- 37. <u>Strongly supports</u> the three core initiatives proposed by the Director-General, namely the Literacy Initiative for Empowerment (LIFE), the Teacher-Training Initiative for Sub-Saharan Africa, and the Global Initiative on HIV/AIDS and Education, for which UNESCO has been designated as lead agency by the Committee of Cosponsoring Organizations of UNAIDS;
- 38. <u>Underlines</u> UNESCO's particular mandate to foster women's and girls' education and to assist countries in attaining the agreed objective of achieving gender parity at all levels of education by 2015, as stipulated in the United Nations Millennium Declaration;
- 39. <u>Notes</u> that "literacy with special emphasis on education for rural people" has been selected as the theme for the fifth EFA High-Level Group Meeting (Beijing, 28-30 November 2005), and <u>emphasizes</u> that UNESCO should pay particular attention to rural education, which is critical for the attainment of the six Dakar goals and for the attainment of the objectives of the United Nations Literacy Decade (2003-2012);
- 40. Requests the Director-General to reflect in document 33 C/5 support to the E-9 countries as a flagship activity, providing information on the proposed follow-up to the decisions taken at the Fifth E-9 Ministerial Review Meeting in Cairo (19-21 December 2003) and a synthesis of all action envisaged in E-9 countries under Major Programme I, including indicative allocations, expected results and performance indicators;
- 41. <u>Underlines</u> the importance of technical and vocational training, and <u>recommends</u> that in the proposed resolution contained in paragraph 01410 the following words be added at the end of paragraph (a)(ii) "taking into account the significant contribution of the Bonn UNEVOC Centre for the implementation of these activities";

- 42. Requests the Director-General to strengthen significantly UNESCO's action for the effective implementation of the United Nations Decade on Education for Sustainable Development (2005-2014) through a holistic and intersectoral approach, and to do so in close cooperation with other United Nations organizations, Member States and civil society, and emphasizes the need to reflect more adequately the importance of the Decade throughout document 33 C/5;
- 43. <u>Welcomes</u> the proposals made by the Director-General pertaining to higher education (Subprogramme I.4.2) and to teacher training in Africa (Subprogramme I.2.3), and <u>recognizes</u> that capacity-building through teacher training plays a pivotal role in the efforts to achieve the EFA goals and as an integral part of quality education;
- 44. Requests the Director-General to include among the activities of both Major Programme I and Major Programme IV action to follow up on the World Conference on Arts Education, within existing financial resources, especially in Subprogrammes I.3.1 and IV.2.3; and recommends to amend accordingly, in paragraph 01310, paragraph (a)(i) of the proposed resolution to read "developing the whole person, including aspects of physical education and health, arts education, and facilitating ..."; to amend paragraph (a)(ii) of the proposed resolution contained in paragraph 04230 to read "; promote the arts, in close cooperation with artistic NGOs, including contributing to the follow-up to the World Conference on Arts Education ...", and taking into account the actual results of the World Conference to add a new expected result to paragraph 04232, as appropriate;
- 45. Recommends that in paragraph 01611 Yemen be included among the countries in which the cross-cutting theme project "Enhancing the socio-economic skills of deprived youth in the Arab States" is being carried out;

Major Programme II – Natural sciences

- 46. Expresses its satisfaction with the proposals made by the Director-General for the principal priority "Water and associated ecosystems", and highlights that this is an area where UNESCO needs to maintain and buttress its comparative advantage as a lead agency of the United Nations system;
- 47. <u>Supports</u> the proposals made by the Director-General for the subprogramme on "Ecological and earth sciences for sustainable development", and <u>underlines</u> its critical role, especially for developing countries;
- 48. <u>Requests</u> the Director-General to allocate in the work plans adequate resources for activities pertaining to the earth sciences, and particularly to the International Geoscience Programme (IGCP);
- 49. <u>Supports</u> UNESCO action aimed at preparing for and mitigating the consequences of disasters, including tsunamis;
- 50. <u>Strongly endorses</u> in that regard the proposal by the Director-General to contribute, through the Intergovernmental Oceanographic Commission (IOC), to the cooperative establishment of robust tsunami warning systems in the Indian Ocean and other regions, bearing in mind the need to enhance the reliability of such systems with a view to minimizing the rate of false alarms;

- 51. <u>Strongly supports</u> the work of the Intergovernmental Oceanographic Commission (IOC), the International Hydrological Programme (IHP), the International Geoscience Programme (IGCP), and the Man and the Biosphere (MAB) Programme, and <u>invites</u> the Director-General to facilitate synergies and increased operational efficiency;
- 52. Recommends that in the proposed resolution contained in paragraph 02120 the following words be inserted at the end of subparagraph (b)(ii) "champion the process leading to the proclamation of an international year of Planet Earth, and ensure UNESCO's leadership role in its implementation phase", and to add in paragraph 02124 among the expected results at the end of the biennium the following new expected result: "International Year of Planet Earth proclaimed by the United Nations General Assembly";
- 53. Recommends that in the proposed resolution contained in paragraph 02210, subparagraph (v), the words "and through the culture of maintenance" be deleted, that a new subparagraph (vi) be added with the following text "assist in building capacities in physical asset management for poverty eradication and sustainable development through the culture of maintenance", and that other subparagraphs be renumbered accordingly;
- 54. Further recommends that in "strategic approaches" the following words be inserted after the words "culture of maintenance": "as an intersectoral activity involving Major Programmes I and V", and that the following new expected result be added: "capacity for asset management improved" with the following performance indicators: "(i) capacities built through the African Regional Centre for the Culture of Maintenance at the Dar es Salaam Institute of Technology; (ii) training programmes and manuals on the culture of maintenance developed; (iii) sensitization and awareness seminars and workshops on the culture of maintenance organized; (iv) formulation of a culture of maintenance syllabus for integration into school curricula";
- 55. <u>Highlights</u> the significant role that the International Basic Sciences Programme (IBSP) as a flagship activity of UNESCO, with the principal goal of sustainably building capacities in science and science education through international and regional cooperation, is expected to play in pursuing one of UNESCO's core mandates;
- 56. Welcomes new proposals to strengthen in a holistic manner UNESCO's technical capacity-building for long-term results, particularly in areas such as water-related efforts, a basic science and mathematics education, and engineering and technology in support of sustainable development, and <u>calls for</u> effective intersectoral action in that regard, drawing also on action already envisaged in paragraph 08109, which should be redrafted accordingly in line with the three areas above;
- 57. <u>Requests</u> the Director-General, in support of capacity-building activities, to make use of the contribution of category 1 UNESCO institutes and centres, category 2 institutes and centres under UNESCO's auspices and other centres of excellence associated with UNESCO;

Major Programme III – Social and human sciences

58. <u>Endorses</u> the proposals contained in Major Programme III concerning the principal priority "The ethics of science and technology, with special emphasis on bioethics";

- 59. Recommends to delete in paragraph (vi) of the proposed resolution contained in paragraph 03110 the words "... a universal declaration of ethical principles for the environment ..." taking into account the discussion at the fourth session of COMEST, and to amend the narrative in the second paragraph of the section on "strategic approaches" accordingly;
- 60. Welcomes the adoption of the Intersectoral Strategy on Philosophy as contained in document 171 EX/12, and requests the Director-General to implement this Strategy through effective intersectoral cooperation, especially with Major Programme I, and in partnership with National Commissions for UNESCO and relevant stakeholders;
- 61. Recommends that in paragraph 03210 concerning the box on the new flagship activity "International Coalition of Cities against Racism and Discrimination" a reference be made in the third paragraph to the need "to devise regionally appropriate approaches when forming the coalitions in Africa, Asia and the Pacific, the Arab States and the Latin America and the Caribbean region";
- 62. Requests the Director-General to take measures aimed at improving the visibility of the MOST Programme as well as the mobilization of more extrabudgetary resources for its activities;
- 63. Recommends that paragraph 03213, the first expected result be amended to read "New mechanisms developed to counter various forms of racism, discrimination, xenophobia, intolerance and exclusion":
- 64. <u>Further recommends</u> that in paragraph 03122, the last expected result be amended to read "Research on new forms of violence, including terrorism, and new needs in peace education completed"; and that the related performance indicators be amended to read "Various studies on new forms of violence, including terrorism" and "Publication of notebooks on new forms of violence, including terrorism";

Major Programme IV - Culture

- 65. <u>Emphasizes</u> that the culture programme is an integral component of UNESCO's core mandate and constitutes a major asset for its relevance and visibility in Member States as well as in the United Nations system, and <u>expresses the wish</u> that this importance be fully highlighted and articulated in document 33 C/5;
- 66. <u>Endorses</u> the proposals contained in Major Programme IV concerning the principal priority "Promoting cultural diversity, with special emphasis on the tangible and intangible cultural heritage";
- 67. <u>Strongly endorses</u> the view that UNESCO's core mandate in culture includes the cultural challenges of the contemporary world as well as both tangible and intangible heritage, including sites not inscribed on the World Heritage List, and that this should be reflected in the capacities of the Secretariat units concerned;
- 68. Requests the Director-General to include in paragraph 04220, within existing resources, provisions for the development and implementation of additional cultural routes/roads, such as the proposed project Roads to Independence: the African Liberation Heritage and the proposed project Earthenware and Ceramics Road in the Asia and the Pacific region;

- 69. Recommends with respect to the proposed project Roads to Independence: the African Liberation Heritage, to insert in paragraph 04220 at the end of subparagraph (a)(i) the words "including roads to independence and liberation heritage in Africa, in collaboration with SADC, NEPAD and the African Union"; to insert in the related "strategic approaches" after the words "Great Lakes" the words "and Southern Africa"; and to insert after the words "slavery and its abolition" the words "as well as Roads to Independence: the African Liberation Heritage project";
- 70. Further recommends to add in paragraph 04221 "expected results at the end of the biennium" the following words in the second bullet: "seminar and" before the words "training activities", and to add in paragraph 04131 after the word "Africa" the words "including strategic direction and resources needed for the protection, conservation and development of the region's liberation heritage", as well as to insert after the words "drawn up" the words "including data and databases on types and location of heritage resources of African liberation in the SADC region";
- 71. Requests the Director-General to propose a detailed plan of action for UNESCO's overall strategy for an intersectoral programme on languages, including the designation of a focal point and a separate budget line in document 33 C/5 from the available resources foreseen in the regular budget;

Major Programme V – Communication and information

- 72. <u>Endorses</u> the proposals contained in Major Programme V concerning the principal priority "Empowering people through access to information and knowledge, with special emphasis on freedom of expression";
- 73. Calls upon the Director-General to implement fully and visibly during 2006-2007 the relevant outcomes of the first phase (2003) of the World Summit on the Information Society (WSIS I), to contribute constructively to the preparation of the second phase (2005) of the World Summit on the Information Society (WSIS II) based on UNESCO's four principles pertaining to the building of knowledge societies, and to incorporate and implement the relevant outcomes of WSIS II in the work plans relating to document 33 C/5;
- 74. <u>Takes note</u> of the concept of "information culture" considered by the Information for All Programme (IFAP), and <u>recommends</u> that appropriate references in this regard be included in Major Programme V;
- 75. Recommends that issues of ethics, as contained in paragraphs 52 and 55 of the Declaration of Principles adopted by the World Summit on the Information Society held in December 2003 in Geneva, be fully reflected in the relevant parts of Major Programme V;
- 76. Recognizes that the development of information and communication technologies (ICTs) provides opportunities to improve the free flow of ideas by word and image, but also poses challenges for ensuring participation of all in the global information society;
- 77. <u>Also recognizes</u> that different levels of economic development affect prospects for access to cyberspace, and that specific policies and increased solidarity are required to redress current asymmetries and to create inclusive knowledge societies;

- 78. Expresses appreciation for UNESCO's unfailing support for the protection, preservation and expansion of the public domain in the areas of information and knowledge, underscores the contribution of open access regimes to knowledge sharing, notes that broadcasting plays a pivotal role in building a knowledge society, and that breakthroughs in communication technology have presented the world with an unprecedented opportunity to deliver the benefits of knowledge to hitherto deprived sections of the population in developing countries, invites the Director-General, in accordance with 171 EX/Decision 65, to ensure that UNESCO, as a specialized agency within the United Nations system dealing with the issue of communication and information, plays an active role in any deliberations affecting its mandate, and further invites the Director-General to submit a proposal on a convention on broadcasting and emerging technologies to be examined at the next session of the Intergovernmental Committee of the International Convention for the Protection of Performers, Producers of Phonograms and Broadcasting Organizations (Rome Convention, 1961);
- 79. Requests the Director-General to continue giving strong emphasis to community media centres (CMC) in developing countries, thereby providing access to information and knowledge, and serving as platforms for the creation of linguistically and culturally diversified content:

UNESCO Institute for Statistics (UIS)

- 80. <u>Commends</u> the UNESCO Institute for Statistics (UIS) for its valuable role in providing the basis for evidence-based policy-making and programming;
- 81. Recognizes the need to provide UIS with requisite resources to carry out its mission, which also includes contributions to the monitoring of progress towards the implementation of the six Dakar EFA goals, the Millennium Declaration, and the internationally agreed development goals contained therein;

V

Specific programme issues

Intersectoral action

- 82. <u>Underlines</u> the significance of joint intersectoral action as a thrust for the future of UNESCO and as a genuine comparative advantage of the Organization and <u>requests</u> the further development of intersectorality both at Headquarters and in the field;
- 83. Welcomes the various joint intersectoral actions and mainstreaming issues contained in document 33 C/5, and requests the inclusion of an additional intersectoral initiative addressing the issue of youth violence in Central America, with allocation of resources to be provided in work plans in all fields of the Organization through the Major Programmes and the Bureau of Strategic Planning;
- 84. Recommends that in connection with the twentieth anniversary of the Chernobyl disaster in 2006, and in accordance with the Declaration of Principles on the CORE Programme adopted with the participation of UNESCO on 15 October 2003, a scientific analysis of the consequences of the disaster be conducted under the aegis of UNESCO, drawing on already existing research and the work of scientific institutes and laboratories, within the programme action envisaged for document 33 C/5;

Participation Programme

- 85. Recognizes that the Participation Programme is an essential part of the process of programme execution, and that it promotes the direct participation of National Commissions and their partners in the execution of the programme, at the national, regional and international levels, and emphasizes its importance in fostering the presence and visibility of UNESCO in Member States;
- 86. <u>Invites</u> the Director-General to consider maintaining the Participation Programme at the same level as in document 32 C/5;

VI

Budget issues

- 87. Having examined the Draft Programme and Budget for 2006-2007 (33 C/5),
- 88. Recalling 170 EX/Decision 4.1,
- 89. <u>Takes note</u> of the fact that the budgeting techniques are in accordance with 32 C/Resolution 83;
- 90. Noting the progress achieved in the presentation of document 33 C/5,
- 91. <u>Stresses</u> the need to further improve results-based management at all levels of the Organization;
- 92. <u>Notes</u> that the Director-General has put forward a single budget proposal of \$635 million, including additional proposals for an amount of \$25 million above the baseline of \$610 million to strengthen the delivery of UNESCO's principal priorities;
- 93. <u>Further notes</u> that this proposal of the Director-General received support from a number of Member States;
- 94. Requests the Director-General to keep exploring possibilities to reinforce principal priority programmes within the baseline of \$610 million;*
- 95. <u>Further requests</u> the Director-General to submit to the Executive Board at its 172nd session a further budget proposal based on the current proposal and the discussions held during its 171st session, with a baseline of \$610 million, accompanied by a supplementary proposal for the strengthened delivery of principal priorities identifying additional financial resources of up to \$25 million through innovative mechanisms, excluding carry-over, which could include firm pledging;
- 96. <u>Notes</u> that the Director-General has presented in document 171 EX/INF.7 supplementary information concerning additional financial estimates for field security in 2006-2007.

* *Inter alia*, by replacing lower-priority programmes and by further rationalizing financial resources allocated to central services, to Part III (B and D), and to those expenditures relating to programmes when they are not essential to the implementation of programme activities (travel expenses, publications, meetings, etc.)

METHODS OF WORK OF THE ORGANIZATION

Report by the ad hoc working group on relations between the three organs of UNESCO (171 EX/16 and Corr. (English only); 171 EX/61; 171 EX/62; 171 EX/63; 171 EX/64 Part I; 171 EX/65)

The Executive Board,

- 1. <u>Having examined</u> the final report of the ad hoc working group on relations between the three organs of UNESCO contained in documents 171 EX/16 and Corr.,
- 2. Having examined also the report of the Special Committee on this item,
- 3. <u>Thanks</u> the President of the 32nd session of the General Conference, Chairperson of the ad hoc working group, for the presentation of the report of the ad hoc working group to the Special Committee and for the explanations provided at the request of its members;
- 4. <u>Takes note</u> of the recommendations contained in the report of the ad hoc working group;
- 5. <u>Recommends</u> that the General Conference, when examining these recommendations, take into consideration the observations and the suggestions made by the Executive Board, as follows:

Comments on the report of the ad hoc working group (171 EX/16 and Corr.)

Recommendations 1, 3 and 4

With reference to the programme management cycle, the opinions were divided. While some Members of the Board underlined the technical advantages possibly afforded by such a cycle – namely the alleviation and improvement of the programming process, the alignment of the length of the Medium-Term Strategy with the new term of office of the Director-General, and the more precise and improved nature of the consultation with Member States – others emphasized its major disadvantages, such as possible difficulties at the national level with regard to a longer-term budgetary commitment, the lack of experience of such a cycle in the United Nations system, and the risk of rendering the programme less flexible and hampering UNESCO's ability to respond effectively to changing needs during its execution. It was recommended that a full debate on the subject take place in the General Conference.

Recommendations 2 and 5

There was a general endorsement of these recommendations.

Recommendation 6

The Executive Board recognized the need for a simpler procedure for the admissibility of draft resolutions, placed directly under the control and

responsibility of Member States themselves. In view of the complexity of this recommendation, amendments to the Rules of Procedure of the General Conference would be necessary.

Recommendation 7

While there was general agreement that a reduction of the number of agenda items would be useful for the conduct of business, some Members of the Board recalled that the right of Member States to place items on the agenda should in no way be curtailed. In this connection, it was suggested that the duration of the sessions of the General Conference should be extended.

Recommendations 8 to 12

The Executive Board took note of these recommendations. While generally agreeing with them, the Board would have wished further technical precision as to their implications.

Recommendation 13

No specific views were expressed on this recommendation.

Recommendation 14

Some Members of the Board expressed support for the shortening of the agenda, while others stressed that nothing should pre-empt the right of Member States to place items on the agenda as appropriate. The proposal that a number of agenda items could be identified for "taking note" only by the Executive Board was positively considered.

Recommendations 15 and 16

There was general agreement with the spirit of these recommendations. While the necessity of holding thematic debates was highlighted, opinions were divided as to whether these debates must be held inside or outside the ordinary sessions of the Board.

Recommendation 17

There was a general agreement that the debates on staffing issues could be carried out in a more effective manner. Opinions were divided as regards the systematic holding of private meetings at each session of the Board.

Recommendation 18

This recommendation gave rise to divergent, even opposed views. Some Board Members preferred option A, provided that the duration of the plenary be extended, stressing that it would enable greater participation of small delegations; however, they sought clarification concerning the membership of the expert groups proposed. Others expressed their preference for option B. Yet several other Members favoured the continuation of the present structure.

Recommendation 19

(i) Bearing in mind the historical background of the Special Committee and its specific mandate and role, many Members of the Board felt that the Committee should be maintained in its present format. Others were in favour of its abolition.

(ii) Several Members of the Board stressed that the mandate of the NGO Committee could be expanded and strengthened with a view to revitalizing its role. On this issue, the NGO Committee endorsed the conclusions of the ad hoc working group on relations between the three organs of UNESCO.

Paragraphs 43 and 52

There was a divergence of opinions concerning the mandate of the Committee on Conventions and Recommendations (CR) as reflected in paragraph 43 of the report of the ad hoc working group. While many Board Members – including those of the Committee itself – were generally in favour of reinforcing its current mandate on human rights-related issues, and agreed with the proposal that the monitoring of standard-setting texts could, on the other hand, be given higher priority within the Secretariat, others believed that human rights-related issues should not be part of the mandate of the CR Committee. On this issue, the CR Committee endorsed the conclusions of the ad hoc working group on relations between the three organs of UNESCO. Some Members of the Board also felt that the wording in paragraph 43 should have been formulated as a recommendation contained within recommendation 19.

Recommendations 20 and 21

Several Board Members expressed concern that a reduction of the size of the Executive Board would be detrimental to a truly inclusive and democratic decision-making process; others believed that it would enable the Board to fulfil its functions in a more efficient manner.

Recommendation 22

There was general agreement on this recommendation, provided that it would not slow down or jeopardize UNESCO's response in emergency situations, but rather bring additional support to the Director-General's interventions.

Recommendations 23, 24 and 25

These recommendations were generally endorsed. A number of Board Members thought that further clarifications were needed with regard to their concrete implications.

Recommendation 26

The Members of the Executive Board expressed their inability to commit to a concrete time-bound action plan before knowing which kind of measures would be actually be approved by the General Conference. They also noted that the report of the ad hoc working group required further deliberations and a negotiation process.

Report by the Director-General on the revised and completed principles and guidelines regarding the establishment and operation of UNESCO institutes and centres (category 1) and institutes and centres under the auspices of UNESCO (category 2) (171 EX/18; 171 EX/INF.10; 171 EX/64 Part II; 171 EX/65)

- 1. Recalling 21 C/Resolution 40.1, 30 C/Resolution 2 and 30 C/Resolution 83 of the General Conference, and 161 EX/Decision 3.2.4, 161 EX/Decisions 4.1 and 4.2, 162 EX/Decision 4.2, 165 EX/Decision 5.4 and 167 EX/Decision 4.5 of the Executive Board,
- 2. <u>Further recalling</u> the recommendations of the Legal Committee of the General Conference following the adoption by the Executive Board of 165 EX/Decision 5.4 (LEG/2002/REP, para. 11),
- 3. Having examined documents 171 EX/18 and 171 EX/INF.10,

- 2. <u>Approves</u> the overall strategy and its criteria set out by the Director-General in document 171 EX/19, and in particular in paragraphs 15 (a) to (z);
- 3. <u>Endorses</u> the standard model texts for UNESCO prize statutes and for financial regulations, as attached hereto as Annex I and Annex II, respectively;
- 4. <u>Authorizes</u> the Director-General to proceed with the termination and abolition of the following inactive or discontinued UNESCO prizes the Noma Prize (for Meritorious Work in Literacy), the Malcolm Adiseshiah International Literacy Prize, the Nessim Habif Prize, the UNESCO-ROSTSCA Awards for Young Scientists, the UNESCO Prize for Children's and Young People's Literature in the Service of Tolerance, the UNESCO/Françoise Gallimard Prize for Young Writers Expressing the Tensions and Hopes of Our Time, the Pacha Prize, the UNESCO Cities for Peace Prize, and the UNESCO Web Prize –, after due consultations with the donors concerned, as well as of the UNESCO prizes for architecture and landscape architecture, which are currently funded from the regular programme and budget,
- 5. <u>Further authorizes</u> the Director-General to enter into negotiations with donors and involved parties of current UNESCO prizes with a view to adjusting and aligning current practices and provisions with the overall strategy;
- 6. <u>Invites</u> Member States and other donors to consider making proposals for new UNESCO prizes, especially with a view to filling existing gaps in the coverage of programme areas by prizes;

7. Requests the Director-General to report, beginning in 2007, on a biannual basis, on the implementation of the strategy and the development of the overall situation with regard to UNESCO prizes.

ANNEX I

Standard Model Text for the Statutes of [prize name]

Article 1 – Purpose

The purpose of the ... [prize name] is to ... [e.g. reward the efforts of a [person/s] who has/have contributed, through ... [nature of the work], to the development and dissemination of ... [worldwide/regionally]]. The objective of the Prize is in conformity with UNESCO's policies, and is related to the programme of the Organization in the field of ... [programme, strategic objective and/or programme priority].

Article 2 – Designation, amount and periodicity of the Prize

- 2.1 The Prize shall be entitled "..." [prize name].
- 2.2 (a) Amount covering a one-time award: The Prize shall be funded by [donor or funding source] and shall consist of a [one time contribution] sum of US \$..., which shall cover both the monetary value of the Prize and the costs of administering the Prize. Any interest that may accrue will be added to the overall contribution. [Mention if the prize is to comprise other items, such as medals.]

or

- (b) Amount covering more than a one-time award: The Prize shall be funded by [donor or funding source], and shall consist of a recurrent payment of US \$.... [frequency to be determined in consultation with donor]. The value of the Prize shall be determined by the Director-General [in consultation with the donor] on the basis of the contribution received from ... [indicate donor or funding source], the interest on the sum deposited in the special account, in accordance with the Financial Regulations of UNESCO, and the charges to be borne by the account for the cost of administering the Prize. [Mention if the prize is to comprise other items, such as medals.]
- 2.3 All funds received and the interest accrued thereon shall be kept in a special interest-bearing account for the Prize (see Financial Regulations in Annex II).
- 2.4 The full staff support and operating/management costs of the Prize, including all costs related to the award ceremony and public information activities, estimated at [minimum amount to be decided] shall be fully covered by ... [donor or funding source name and country]. To this end, the Director-General shall determine a mandatory overhead cost amount to be applied and charged against the funds in the Special Account, which is to be established under the Financial Regulations for the Prize.
- 2.5 The Prize shall be awarded [specific periodicity to be decided], on an initial basis for ... biennia [to be decided by donor and UNESCO]. [If it is envisaged, in consultation with the donor, that the prize may be shared.] A prize amount may be equally divided among a maximum of three laureates.

Article 3 – Conditions/qualifications of candidates

Candidates shall have made a significant contribution to ... [prize purpose]. Prizes may be conferred upon individuals, institutions, other entities or non-governmental organizations.

Article 4 – Designation/selection of the prizewinner/s

The prize-winner/s [number of laureates] shall be selected by the Director-General of UNESCO on the basis of the assessments and recommendations made to him/her by a jury.

Article 5 – Jury

5.1 The Jury shall consist of a number of three or five independent members [to be determined for each case], of different nationalities and gender, appointed by the Director-General for a period of six years (unless a different term is determined in consultation with the donor in each case), eligible for re-election [to be decided in each case]. Representatives and alternatives of Members of the Executive Board cannot be appointed as

jurors. Jurors involved in a real or potential conflict of interest shall recuse themselves from further deliberations or be asked by the Director-General to do so. The Director-General may replace members of the Jury for reason.

- 5.2 The Jury shall elect its own Chair (if three members) and Deputy Chair (if five members). Members shall receive no remuneration for their work, but will receive allowances for travel and accommodation, where required. A quorum of two (in the case of three members) or three jurors (in the case of five members) present will be required for jury deliberations to proceed. The working languages for deliberations by the Jury shall be English and French.
- 5.3 The Jury shall conduct its business and deliberations in conformity with these Statutes, and shall be assisted in the performance of its task by a member of the UNESCO Secretariat designated by the Director-General. Decisions shall be taken by consensus to the extent possible, and otherwise by secret ballot until a simple majority is obtained. A member shall not take part in a vote concerning a nomination from his or her country.
- 5.4 The Jury shall meet ... every ... year [frequency to be decided in light of the periodicity of the Prize].
- 5.5 The Jury shall send an assessment of nominations and accompanying recommendations to the Director-General of UNESCO no later than ... of (year) [closing date to be decided].

Article 6 – Nomination of candidates

- 6.1 When UNESCO has received the funding of the prize [as well as other items, if any], as indicated in Article 2 above, the Director-General of UNESCO shall officially invite the submission of nominations to the Secretariat of the Prize, by ... [specific date and periodicity to be decided], from the governments of Member States, in consultation with their National Commissions, as well as from non-governmental organizations maintaining formal consultative relations with the Organization and active in relevant fields covered by a prize.
- 6.2 Nominations shall be submitted to the Director-General by the governments of Member States, in consultation with their National Commissions, and by non-governmental organizations maintaining formal relations with UNESCO. A self-nomination cannot be considered.
- 6.3 Each nomination shall be accompanied by a written recommendation, which shall include, in English or French, *inter alia*:
 - (a) a description of the candidate's background and achievements;
 - (b) a summary of the work or the results of the work, publications and other supporting documents of major importance, submitted for consideration;
 - (c) a definition of the candidate's contribution to the Prize's objectives.

Article 7 – Procedure for the awarding of the Prize

- 7.1 The Prize shall be awarded by the Director-General at an official ceremony held for that purpose in ... [location to be decided] on the occasion of ... [official event, if any, to be decided]. UNESCO shall present to the prizewinner/s a check for the amount of the Prize [as well as a diploma and a medal, to be decided]. UNESCO shall officially announce the name/s of the prizewinner/s.
- 7.2 If a work being rewarded has been produced by two or three persons, the Prize shall be awarded to them jointly. In no case may a prize amount be divided among more than three persons.
- 7.3 The prizewinner/s, if possible, shall give a lecture on a subject relevant to the work for which the Prize has been awarded. Such a lecture shall be organized during or in connection with the prize ceremony.
- 7.4 The work produced by a person since deceased shall not be considered for the Prize. If, however, a prizewinner dies before he or she has received the Prize, then the Prize may be presented posthumously [awarded to relatives or an institution].
- 7.5 Should a prizewinner decline the Prize, the jury shall submit a new proposal to the Director-General.

8.1 After a period of six years, the Director-General of UNESCO together with the donor will undertake a review of all aspects of the Prize and decide about its continuation or termination. The Director-General will inform the Executive Board of UNESCO about the results of this review.

8.2 In case of termination of the Prize, the use of any unspent balance of funds shall be determined by the Director-General, in accordance with the Financial Regulations of the Prize.

No appeals shall be allowed against the decision of UNESCO with regard to the award of the Prize. Proposals received for the award of the Prize may not be divulged.

Article 10 – Amendments to the Statutes of the Prize

Any amendment to the present Statutes shall be submitted to the Executive Board for approval.

ANNEX II

Standard Model Text for the Financial Regulations of the Special Account for [prize name]

(Ref. 161 EX/Decision 7.10)

Article 1 - Creation of a Special Account

- 1.1 In accordance with Article 6, paragraph 6, of the Financial Regulations of UNESCO, there is hereby created a Special Account for [name of Special Account], hereafter referred to as the Special Account.
- 1.2 The following regulations shall govern the operation of the Special Account.

Article 2 - Financial period

The financial period shall correspond to that of UNESCO.

Article 3 – Purpose

[description of purpose]

Article 4 – Income

The income of the Special Account shall consist of:

- (a) voluntary contributions from States, international agencies and organizations, as well as other entities;
- (b) such amounts provided from the regular budget of the Organization as might be determined by the General Conference;
- (c) such subventions, endowments, gifts and bequests as are allocated to it for purposes consistent with the object of the Special Account;
- (d) miscellaneous income, including any interest earned on the investments referred to in Article 7 below.

The Special Account shall be debited with the expenditure relating to its purpose as described in Article 3 above, including administrative expenses specifically relating to it.

- 6.1 The UNESCO Comptroller shall maintain such accounting records as are necessary.
- 6.2 Any unused balance at the end of a financial period shall be carried forward to the following financial period.
- 6.3 The accounts of the Special Account shall be presented for audit to the External Auditor of UNESCO, together with the other accounts of the Organization.
- 6.4 Contributions in kind shall be recorded outside the Special Account.

Article 7 – Investments

- 7.1 The Director-General may make short-term investments of sums standing to the credit of the Special Account.
- 7.2 Interest earned on these investments shall be credited to the Special Account.

Article 8 – Closure of the Special Account

The Director-General shall decide upon the closure of the Special Account at such time as he deems that its operation is no longer necessary and inform the Executive Board accordingly. The Director-General shall decide about the use of any unspent balance of funds.

Article 9 – General provision

Unless otherwise provided in these Regulations, the Special Account shall be administered in accordance with the Financial Regulations of UNESCO.

- 3. Decides:
 - (a) that the provisional agenda of the 33rd session of the General Conference shall comprise the items proposed in document 171 EX/24, as well as items which the Executive Board decided to include at its 171st session;
 - (b) that any other items submitted by Member States or Associate Members or by the United Nations, in accordance with Rule 9 of the Rules of Procedure, not later than 100 days before the opening of the session (i.e. by **24 June 2005**), shall be inscribed by the Director-General on the provisional agenda, which shall then be communicated to Member States and Associate Members not later than 90 days before the opening of the session (i.e. **4 July 2005**).

II

- 1. <u>Emphasizing</u> the need for UNESCO as a specialized agency of the United Nations system to contribute effectively both to inter-agency activities and also to the objectives of the wider multilateral system,
- 2. <u>Considering</u> that UNESCO has a comparative advantage within the United Nations system in specific, and important, priority areas (several of which are relevant to the goals set out in the Millennium Declaration) as described in the Medium-Term Strategy for 2002-2007 (31 C/4 Approved),

- 3. Recalling that document 31 C/4 Approved is due to be replaced by a new strategy in 2007,

Cooperation Agreement between the United Nations Educational, Scientific and Cultural Organization and United Cities and Local Governments

The United Nations Educational, Scientific and Cultural Organization (hereinafter referred to as "UNESCO"), United Cities and Local Governments (hereinafter referred to as "UCLG"),

represented by its Director-General,

represented by its Presidents,

Mr Bertrand Delanoë, Mr Smangaliso Makhatshwa

Considering that UNESCO was established to contribute to peace and security by promoting collaboration among the nations through education, science and culture in order to further universal respect for justice, for the rule of law and for the human rights and fundamental freedoms which are affirmed for the peoples of the world, without distinction of race, sex, language or religion, by the Charter of the United Nations,

Considering that UCLG, a new world organization, works to promote peace, democracy and citizenship, democratic urban governance and decentralization, cooperation among cities, and solidarity, and contributes to sustainable development and the enhancement of the status of cultural diversity in urban settings,

Taking into account the vital role of local government as a force for the achievement of the United Nations Millennium Development Goals, and the commitment of UCLG to renew and deepen its partnership with the United Nations and the global community,

Referring to the Local Government Declaration to the World Summit on Sustainable Development, adopted in 2002 in Johannesburg by the mayors, leaders and representatives of the cities and local governments of the world and their international and national associations,

Aware of the significance of the Final Declaration of the Congress establishing UCLG adopted on 5 May 2004 in Paris by the mayors, decision-makers and representatives of the cities and local governments of the world,

Reaffirming the importance of the Agenda 21 for Culture – An Undertaking by Cities and Local Governments for Cultural Development, adopted on 8 May 2004 in Barcelona by the mayors, decision-makers and representatives of the cities and local governments of the world,

Desiring to cooperate with a view to the achievement of their common aims, in particular with regard to the promotion of democracy and human rights, respect for cultural and linguistic diversity, local development, education and training, culture and communication, and the advancement of women in society,

HAVE AGREED AS FOLLOWS:

Article 1 – Cooperation

- 1. UNESCO and UCLG agree to cooperate through their competent bodies.
- 2. Such cooperation shall chiefly concern matters relating to:

local democracy and urban governance;
human rights and the fight against all forms of discrimination;
dialogue for peace;
urban policies and the right to the city;
the protection of cultural diversity and cultural development;
the identification and enhancement of cultural and heritage resources;
support for cultural creativity;
research on culture, urban policies and local development;
education and training;
the information society;
women's rights;
science and technology;
environmental protection.

3. Such cooperation shall be aimed in particular at strengthening the practices of decentralized cooperation, between cities of the North and the South and among cities of the South, so as to promote a new form of international cooperation.

Article 2 - Consultations

The competent bodies of UNESCO and UCLG shall hold regular mutual consultations on matters of common interest. When circumstances so require, the two organizations shall hold special consultations in order to determine the most appropriate means of optimizing the effectiveness of their respective activities under this Agreement.

Article 3 – Reciprocal representation

- 1. UNESCO shall invite UCLG, in accordance with the applicable procedures, to send observers to sessions of the General Conference and to other meetings that it may convene, when matters of mutual interest are under consideration.
- 2. For its part, UCLG shall invite UNESCO, in accordance with the applicable procedures, to send observers to its governing bodies and to other meetings that it may convene, when matters of mutual interest are under consideration.

Article 4 – Exchange of information and documents

Subject to provisions that may be necessary to preserve the confidential nature of particular documents, UNESCO and UCLG shall continuously exchange information and documents on matters of mutual interest.

Article 5 – Joint activities and technical cooperation

- 1. UNESCO and UCLG may engage in joint cooperation in the form of technical meetings, public seminars, training courses, activities specifically for youth, women and the most deprived, thematic projects and support measures for particular regions or countries.
- 2. Technical and financial arrangements for the design and implementation of such projects shall be determined by the relevant bodies of UNESCO and UCLG.

Article 6 – Execution of the Agreement

1. UNESCO and UCLG shall hold regular consultations on the conduct of activities relating to the execution of this Agreement.

2. The Director-General of UNESCO and the Presidents of UCLG may make such additional administrative arrangements as may be necessary to implement this Agreement.

Article 7 – Entry into force, amendment and term of the Agreement

- 1. This Agreement shall enter into force on the date of its signature by the Director-General of UNESCO and the Presidents of UCLG.
- 2. This Agreement may be amended by mutual consent. Amendments to the Agreement shall enter into force one month after notification of approval by the competent bodies of UNESCO and UCLG.
- 3. This Agreement shall be concluded for an indefinite period; it may be denounced by UNESCO or by UCLG provided that six months' notice thereof is given in writing.

- 4. <u>Invites</u> the Director-General, to that end, to consult with other partners and organizations, as appropriate;
- 5. Further invites the Director-General to report to it on this subject at its 174th session.

- 2. Having examined document 171 EX/41 Rev.,
- 3. <u>Further recalling</u> the role that UNESCO is called upon to play in order to satisfy the right to education for all and to meet the need for Palestinians to have safe access to the education system,
- 4. Recalling paragraph 31 of the Medium-Term Strategy (31 C/4 Approved), defining a "road map for a revitalized UNESCO: principles of action and programming", and paragraph 12 of 31 C/Resolution 43,
- 5. <u>Deeply committed</u> to the safeguarding of monuments, works of art, manuscripts, books and other historical and cultural properties to be protected in the event of conflicts,
- 6. <u>Supports</u> the efforts made by the Director-General with a view to the implementation of 32 C/Resolution 54 and 170 EX/Decision 9.3, and <u>requests</u> him to do everything possible to ensure that they are fully implemented, and that their implementation be reinforced in the framework of the Programme and Budget for 2006-2007 (33 C/5);
- 7. <u>Expresses its appreciation</u> for the substantial contributions of all concerned Member States, IGOs and NGOs to UNESCO's action in the Palestinian Territories, and <u>appeals</u> to them to continue assisting UNESCO in this endeavour;
- 8. <u>Thanks</u> the Director-General for the results which have been obtained in relation to the implementation of a number of current educational and cultural activities;

- 5. <u>Invites</u> the Director-General to support all efforts leading to the United Nations General Assembly proclaiming 2007 the "International Year of Planet Earth";
- 6. <u>Recommends</u> that the General Conference, at its 33rd session, adopt a resolution on this subject.

58 Universal Forum of Cultures – 2007 in Monterrey, Mexico (171 EX/53; 171 EX/64 Part II)

- 1. <u>Having examined</u> the report submitted by the Director-General on the Universal Forum of Cultures Barcelona 2004 (171 EX/53; 171 EX/INF.9),
- 2. <u>Having taken cognizance</u> of the decision of the government of the state of Nuevo León, Mexico, to hold the Universal Forum of Cultures Monterrey 2007,
- 3. <u>Considering with great satisfaction</u> the great significance and the success of the Barcelona 2004 Forum of Cultures, the close links between its objectives and those of UNESCO, and the importance of implementing the recommendations of the World Commission on Culture and Development,
- 4. <u>Noting</u> that the organizers of the Monterrey 2007 Forum are proposing that UNESCO should be their main partner, and <u>convinced</u> that such cooperation would be particularly fruitful for the attainment of common goals,
- 5. <u>Noting</u> in this respect that the costs of the Forum will be fully covered by its organizers, and that this cooperation would therefore have no budgetary implications for UNESCO,
- 6. Considering that UNESCO could play a particularly effective part, in the framework of the objectives set forth in the Medium-Term Strategy for 2002-2007 and the Programme and Budget for 2004-2005, both in formulating the approaches and major themes that could guide the implementation of the Forum and in encouraging official participation by Member States in the Forum and by networks of all kinds to ensure the impact and influence of the Forum.
- 7. <u>Decides</u> to recommend that the General Conference, at its 33rd session, in line with the proposal made by the organizers of the Universal Forum of Cultures Monterrey 2007, grant approval for UNESCO to be the main partner of the event throughout the various phases of the project;

- 8. <u>Invites</u> the Director-General to draw up, in cooperation with the Forum's organizers, a draft framework agreement on the modalities of the partnership, together with a plan of action, for submission to the Executive Board at its next session;
- 9. <u>Further invites</u> the Director-General to report to it at its 172nd session on the implementation of this decision.

Cross-sectoral activities in technical capacity-building (171 EX/54 and Add. and Corr.; 171 EX/INF.20; 171 EX/64 Part II; 171 EX/65)

- 1. <u>Recognizing</u> that in order to most effectively leverage its programmes, UNESCO should operate in a cross-sectoral manner and foster work structures conducive to cross-sectoral collaboration,
- 2. <u>Stressing</u> that technical capacity-building in basic and applied sciences, engineering and technology is a critical aspect of reducing poverty and establishing sustainable economic and social infrastructure, and that this capacity-building includes education, science, and communication and information elements,
- 3. Recalling that the Medium-Term Strategy for 2002-2007 (31 C/4) includes a strategic objective on "Enhancing scientific, technical, and human capabilities to participate in emerging knowledge societies",
- 4. <u>Further recalling</u> that the approved Programme and Budget for 2004-2005 (32 C/5) includes regular budget and extrabudgetary funds for capacity-building in science and technology for development, and states that the overall strategy of UNESCO in the engineering sciences and technology is to promote human and institutional capacity-building, particularly in developing countries,
- 5. <u>Noting</u> that the Executive Board, at its 170th session, outlined the priorities for the Natural Sciences Sector as follows:
 - (a) the principal priority shall be water and associated ecosystems;
 - (b) the other priorities shall be:
 - (i) oceans;
 - (ii) capacity-building in the basic and engineering sciences, the formulation of science policies, and the promotion of a culture of maintenance;
 - (iii) promoting the application of science, engineering and appropriate technologies for sustainable development, natural resource use and management, disaster-preparedness and alleviation, and renewable sources of energy;
- 6. Taking into consideration the above mandates,
- 7. Having examined documents 171 EX/54 and Add. and Corr. and 171 EX/INF.20,

- 8. <u>Welcomes</u> the establishment of a unit within the Science Sector to coordinate activities in capacity-building focused on:
 - (a) water-related efforts activities to include enhancement of the current hydrology effort as it relates to capacity-building efforts in engineering and water sciences to address water-related needs;
 - (b) basic science and mathematics education activities to include development of training materials and programmes in science and mathematics;
 - (c) engineering activities to include strengthening of the existing engineering programme, including training educators for developing countries, support of workshops for educators in curriculum development on best practices and quality assurance, and development of appropriate collaborations with industry;
 - (d) technology activities to include technology management and innovation management, including training in this area;
- 9. Requests the Director-General to develop cross-sectoral activities within UNESCO to emphasize building capacities in developing countries, and mainly, least developed countries (LDCs) and post-conflict countries to address elements of the goals for sustainable development outlined in the United Nations Millennium Declaration, particularly safe drinking water and poverty reduction;
- 10. <u>Invites</u> the Director-General to utilize existing budgetary resources to accomplish the development of these cross-sectoral capacity-building activities, and to develop benchmarks and an evaluation process;
- 11. <u>Further invites</u> the Director-General to take the necessary measures for the development of a cross-sectoral capacity-building programme, and to submit a report on progress to it at its 174th session.

Participation of the European Community in the intergovernmental meeting of experts (category II) on the preliminary draft convention on the protection of the diversity of cultural contents and artistic expressions (171 EX/47 and Add; 171 EX/62)

- 1. Recalling 169 EX/Decision 3.7.2, in which it invited the Director-General to convene meetings of government experts (category II) aimed at taking forward the preparation of the preliminary draft convention on the protection of the diversity of cultural contents and artistic expressions in order to report to the General Conference at its 33rd session,
- 2. <u>Having examined</u> document 171 EX/47 concerning the participation of the European Community in the intergovernmental meeting of experts (category II) on the preliminary draft convention on the protection of the diversity of cultural contents and artistic expressions submitted by the Member States of the European Union represented in the Executive Board.

- 3. <u>Invites</u>, on an exceptional basis, the European Community, while maintaining its observer status, to participate actively and as fully as appropriate in the work of the intergovernmental meeting of experts from 25 May to 4 June 2005;
- 4. <u>Recommends</u> that the General Conference, at its 33rd session, take this decision into account with respect to its consideration of the item relating to the preliminary draft convention on the protection of the diversity of cultural contents and artistic expressions.

Organization of a UNESCO regional ministerial conference on the strategic role of renewable energies in sustainable development in Central Asia (Kazakhstan, first half of **2006**) (171 EX/55; 171 EX/INF.20; 171 EX/64 Part II; 171 EX/65)

The Executive Board,

- 1. <u>Bearing in mind</u> United Nations General Assembly resolution 54/215 of 22 December 1999, which established a direct link between the importance of renewable energies and sustainable development and the outcomes of the World Summit on Sustainable Development held in Johannesburg in 2002, in particular the Plan of Implementation, in which renewable energies are considered to be a major instrument of sustainable development and poverty eradication,
- 2. Having examined documents 171 EX/55 and 171 EX/INF.20,
- 3. Recalling 32 C/Resolution 14,
- 4. Recalling also 155 EX/Decision 4.1, in which it recommended that specific action be taken to include renewable energies in the Programme and Budget (C/5),
- 5. <u>Referring also</u> to paragraph 45 of the same decision, in which it considered that UNESCO should continue its action in relation to the Aral Sea basin,
- 6. Welcomes the initiative taken by Kazakhstan and supported by the Member States concerned with a view to the organization of a UNESCO regional ministerial conference on the theme "The strategic role of renewable energies in sustainable development in Central Asia" in Kazakhstan in the first half of 2006;
- 7. Thanks the Director-General for the high profile given to renewable energies;
- 8. Invites the Director-General:
 - (a) to consider and define possible arrangements for the Organization's intellectual and financial involvement in the implementation of this project, as well as the dissemination of the results of this conference;
 - (b) to submit to it at its 172nd session a report thereon.

- 3. <u>Recalling</u> the functions of National Commissions as described in the Charter of National Commissions for UNESCO,
- 4. <u>Recognizing</u> the role of National Commissions in participating in the overall activities of UNESCO as a key actor in helping to forge Member States' views on the

Organization's strategies and programmes, and in endorsing and promoting the visibility of UNESCO's activities at the national level, as envisaged in UNESCO's Constitution,

- 5. <u>Also recognizing</u> that UNESCO field offices are an important platform for the preparation and implementation of UNESCO's activities in Member States,
- 6. <u>Reaffirms</u> the need for the UNESCO field offices and the National Commissions to work in close cooperation through mutual and regular consultations, in accordance with UNESCO's Constitution and the Charter of National Commissions for UNESCO;
- 7. <u>Invites</u> the Director-General to prepare guidelines for such cooperation and consultations between National Commissions and the UNESCO field offices, and to report to the General Conference at its 33rd session on the steps taken on the issue within the overall stated objectives of decentralization and reform of the structure of UNESCO;
- 8. <u>Further invites</u> the Director-General to prepare and submit to it at its 174th session a document on the involvement of National Commissions in the decentralization process.

Protection of the rights of broadcasting organizations (171 EX/59; 171 EX/INF.20; 171 EX/64 Part II; 171 EX/65)

- 1. Having examined documents 171 EX/59 and 171 EX/INF.20,
- 2. <u>Noting</u> that the issue of broadcasting comes within UNESCO's core mandate as part of the activities of the Communication and Information Sector,
- 3. Recalling that the principal priority identified for the Communication and Information Sector is "empowering people through access to information and knowledge, with special emphasis on freedom of expression",
- 4. <u>Further recalling</u> the International Convention for the Protection of Performers, Producers of Phonograms and Broadcasting Organizations (Rome Convention, 1961), the World Intellectual Property Organization (WIPO) Performance and Phonograms Treaty (WPPT), the WIPO Copyright Treaty (WCT), and the Agreement on Trade-Related Aspects of Intellectual Property Rights (TRIPS), which already provide protection to the rights of broadcasters,
- 5. <u>Takes note</u> of the developments at WIPO aimed at finalizing a new convention on broadcaster's rights, and of UNESCO's continuing role in the WIPO process;
- 6. Recognizing that attempts to impose another layer of rights over and above the intellectual property rights of copyright holders affect the rights of both the copyright holder(s) and the rights of the public at large, and act as an impediment to the preservation of information and universal access to it and to the participation of all in the emerging global information society,

- 7. <u>Stresses</u> the importance of promoting and enhancing the public domain as a vital means of providing access to information and knowledge and ensuring that any convention on broadcasting does not curtail access to public domain materials which are accessible only through broadcast;
- 8. <u>Also recognizing</u> that such regulations have a negative impact on the free flow of information essential to the building of knowledge societies, and that the separation between content and content-carrying signals is crucial for maintaining the distinction between the rights of copyright-holders as creators of works and broadcasters as transmitters of signals,
- 9. <u>Reaffirms</u> that UNESCO is committed to promoting freedom of expression, creating an enabling environment which is conducive to facilitating universal access to information and knowledge, developing effective infrastructures and stimulating the development of and access to, diverse contents;
- 10. <u>Thanks</u> the Government of India for taking an initiative on this issue of immense concern to UNESCO;
- 11. <u>Invites</u> the Director-General to ensure that UNESCO, as the specialized agency within the United Nations system dealing with the issue of communication and information, plays an active role in any deliberations affecting its mandate;
- 12. <u>Further invites</u> the Director-General to submit a proposal for a convention on broadcasting and the new technologies for examination at the next session of the Intergovernmental Committee of the Rome Convention, and to report thereon to the Executive Board at its 172nd session.

44 Report by the Director-General on the application of Rule 59 of the Rules of Procedure of the Executive Board (171 EX/PRIV.2)

In accordance with Rule 59 of the Rules of Procedure of the Executive Board, the Director-General <u>informed</u> the Board of the decisions taken since the 170th session regarding the appointments and extensions of contracts of staff members at grade D-1 and above whose posts come under the regular programme of the Organization. He also outlined some adjustments to be

brought to the structure of the Secretariat in order to increase its efficiency and rationalize its work. There followed an extensive debate in a questions and answers session between the Director-General and Board Members. Twenty-five of them took the floor.

Consideration of the procedure to be followed for the appointment of the Director-General of the Organization (171 EX/PRIV.1)

Following its deliberations on this item, the Executive Board <u>decided</u> on the measures required to give effect to Rule 58 of its Rules of Procedure. It <u>invited</u> its Chairman to send to Member States, by Friday 22 April 2005, the usual communication referred to in paragraph 1 of Rule 58, and <u>decided</u> that candidatures should be submitted by 29 July 2005 at the latest. No candidatures will be accepted after that date. In accordance with Rule 58 of the Rules of Procedure, it further <u>decided</u> to consider, at its 172nd session, in private meeting, such candidatures in accordance with the procedure adopted by it for that purpose.
