- 1. Having examined documents 180 EX/4 Parts I and II, and 180 EX/INF.19 and Corr.,
- 2. Recalling 34 C/Resolution 89,
- 3. <u>Welcoming</u> the new tables in the EX/4 report on programme execution and the clear definitions provided for assessing cost-effectiveness and sustainability,
- 4. <u>Further recalling</u> requests contained in document 34 C/5 to the Director-General to report in the statutory reports on the achievement of the expected results, including information on the cost-efficient use of human and financial resources, particularly in the areas of travel, publications and contractual services, for each of the results reported, following the principles of transparency, efficiency and rationalization,
- 5. <u>Noting</u> that documents 180 EX/4 Parts I and II meet this request only partially, and that information pertaining to the cost-efficient use of human and financial resources is not available yet,
- 6. <u>Considering</u> that results-based reporting is an essential tool for ensuring the accountability of the UNESCO senior management and for the Executive Board to discharge its responsibilities concerning the execution of the programme and the preparation of the next C/5 document,
- 7. Invites the Director-General, in preparing future EX/4 reports, to:
  - (a) improve the overall assessment of key results by providing a more concise analysis focusing on the achievement of expected results, using the performance indicators identified in the C/5 document;
  - (b) improve the online presentation of detailed information concerning results obtained at the MLA level by limiting to a minimum all other information relative to achieved outputs and by presenting, as appropriate, information in a SMART (specific, measurable, achievable, relevant, time-bound) manner;
- 8. <u>Notes</u> with satisfaction the progress achieved in a number of main lines of action as demonstrated, *inter alia*, by the high-level attention devoted to efforts to combat illiteracy, the increased number of Member States having benefited from assistance in science policy development, enhanced inclusion of cultural components in common country programming, and the recognition gained of the media development indicators;
- 9. <u>Invites</u> the Director-General to take the necessary measures to address the challenges identified in documents 180 EX/4 Parts I and II, and 180 EX/INF.19 and Corr. with regard, *inter alia*, to the need to streamline capacity development efforts in education by concentrating on an upstream approach, teacher training, and science and technology training in Africa, the management of the World Heritage Centre, the UNESCO World Reports, and the facilitation of the World Summit on the Information Society (WSIS) process.

# Implementation of 34 C/Resolution 47 and 179 EX/Decisions 9 and 52 relating to the Ascent to the Mughrabi Gate in the Old City of Jerusalem

- 1. Having examined document 180 EX/5 Add.3 Rev.,
- 2. Recalling 176 EX/Special Plenary Meeting/Decision, 177 EX/Decision 20, 179 EX/Decisions 9 and 52,
- 3. <u>Further recalling</u> Decisions 31 COM 7A.18 and 32 COM 7A.18 adopted by the World Heritage Committee at its 31st (Christchurch, 2007) and 32nd (Quebec City, 2008) sessions respectively,
- 4. <u>Also recalling</u> the relevant provisions on the protection of cultural heritage including, as appropriate, the four Geneva Conventions (1949), the Hague Convention for the

Protection of Cultural Property in the Event of Armed Conflict of 1954, the Convention for the Protection of the World Cultural and Natural Heritage of 1972, the inscription of the Old City of Jerusalem and its Walls at the request of Jordan on the World Heritage List (1981) and on the List of World Heritage in Danger (1982), and the recommendations, resolutions and decisions of UNESCO,

- 5. Reaffirming the purpose and spirit of the professional encounter at the technical level of 13 January 2008, as well as the follow-up meeting of 24 February 2008,
- 6. Being aware that the process for the design of the Mughrabi ascent, which allows for the taking into consideration of the proposals submitted during the professional encounter, is still under way, and that the World Heritage Centre is following closely the developments associated with this process through its Reinforced Monitoring Mechanism.
- 7. <u>Being aware</u> of the deep concerns regarding the decision taken by the Jerusalem District Planning and Construction Commission on the town planning scheme for the Mughrabi ascent,
- 8. Requests that, despite this decision, the process for the design of the Mughrabi ascent be inclusive of all concerned parties, in accordance with the spirit and content of previous World Heritage Committee decisions;
- 9. <u>Reaffirms</u> that no measures, unilateral or otherwise, should be taken which will affect the authenticity and integrity of the site, in accordance with the Convention for the Protection of the World Cultural and Natural Heritage of 1972;
- 10. Reiterates the request made by the World Heritage Committee at its 32nd session in Decision 32 COM 7A.18 that the Israeli authorities continue the cooperation engaged with all concerned parties, in particular with Jordanian and Waqf experts;
- 11. <u>Reiterates</u> the request made by the World Heritage Committee at its 32nd session in Decision 32 COM 7A.18 that the World Heritage Centre organize a technical follow-up meeting at the site with all concerned parties for additional exchanges of information to enable all necessary inputs to be considered;
- 12. <u>Notes with satisfaction</u> that the follow-up meeting requested by the World Heritage Committee at its 32nd session in Decision 32 COM 7A.18 is tentatively scheduled for early November 2008;

The Executive Board,

1. Having examined document 180 EX/6 Part I,

- 2. <u>Takes note</u> of the work accomplished in the implementation of the human resources policy reform framework and of the medium- and long-term staffing strategy;
- 3. Requests the Director-General:
  - (a) to pursue the implementation of the human resources policy reform framework, ensuring as appropriate harmonization with the United Nations common system policies and practices;
  - (b) to pursue the implementation of the medium- and long-term staffing strategy;
  - (c) to report to it at its 182nd session and to the General Conference at its 35th session on the implementation of the human resources policy reform framework and of the medium- and long-term staffing strategy.

- 1. Having examined document 180 EX/6 Part II,
- Recalling United Nations General Assembly resolution 62/208 concerning the 2007 triennial comprehensive policy review of operational activities for the development of the United Nations system,
- 3. <u>Also recalling</u> United Nations General Assembly resolution 62/277 of 15 September 2008 on system-wide coherence (reproduced in document 180 EX/INF.16),
- 4. Further recalling 30 C/Resolution 83 (criteria for opening offices),
- 5. Referring to the statement by the "Delivering as One" pilot countries Albania, Cape Verde, Mozambique, Pakistan, Rwanda, United Republic of Tanzania, Uruguay and Viet Nam, together with Malawi as from 23 May 2008,

  Force in considering long-term measures for strengthening the Organization's field
  presence within the new context of a reformed United Nations at country level and of
  the preliminary guiding principles to drive the adjustments to UNESCO's evolving
  decentralized system;

Recalling the demand in General Assembly resolution 62/208 (paras. 106-111) to strengthen the capacity of regional and subregional entities as well as inter-agency collaboration at the regional and subregional levels, as appropriate and consistent with their respective mandates, and aiming at supporting country-level development initiatives, as well as in close consultation with the governments of the countries concerned.
- 8. Requests the Director-General, in the framework of the planned adjustment of the decentralization system, to take all necessary measures to efficiently align UNESCO's decentralization system with the requirements of the United Nations reform in the field, including flexible human resource mechanisms in the field (180 EX/6 Part II, para. 21(d)) and the use of UNESCO desks in the United Nations country teams (180 EX/6 Part II, para. 22(f));

- 9. <u>Invites</u> the Director-General to take into account the outcome of the intergovernmental consultations taking place in New York as these results become available;
- 10. <u>Further invites</u> the Director-General to submit to it a final report on an adjusted decentralization system and structure building on the comprehensive action plan on the implementation of the 2007 triennial comprehensive policy review, at its 181st session.

- 4. <u>Emphasizing</u> the importance of the key role that UNESCO continues to play in promoting education in general, and support for EFA in particular, through a series of activities leading to the Eighth Meeting of the High-Level Group on EFA scheduled for December 2008,
- 5. Welcoming the generous offers of the Government of Ethiopia in cooperation with the African Union to host the next meeting of the High-Level Group on EFA, and of the Government of Thailand to host the subsequent meeting, and also the generous offer of the Russian Federation to host a UNESCO world conference on early childhood care and education in Moscow in 2010.
- Taking note of support for national efforts, notably through the preparation of UNESCO's National Education Support Strategies (UNESS) and through their contribution to existing initiatives and mechanisms such as the EFA Fast-Track Initiative and the United Nations reform process, based on the principles of the EFA Global Action Plan,
- 7. <u>Taking note with concern</u> of the discrepancy between needs and contributions and the decline in aid to basic education, early childhood care and education, and adult literacy, and the increasing gap between the pledged amount and delivery of these financial pledges from donor countries in support of EFA,
- 8. <u>Bearing in mind</u> the United Nations Literacy Decade (2003-2012) mid-Decade review prepared by UNESCO and the fact that the United Nations Literacy Decade Fund has recently been created with the aim of advancing the goals of the Decade and of EFA,
- 9. <u>Taking note with appreciation</u> of the report by the Director-General on implementation of the International Plan of Action for the United Nations Literacy Decade (contained in United Nations General Assembly document A/63/172),
- 10. <u>Also bearing in mind</u> the importance of establishing close linkages with the United Nations Decade of Education for Sustainable Development (2005-2014),

- 11. <u>Taking note</u> of UNESCO's endeavours to engage all relevant partners in the EFA process at all levels and, in particular, to strengthen and broaden collaboration among the five EFA convening agencies,
- 12. Also taking note of the findings in the EFA Global Monitoring Report that there has been considerable progress in many developing countries since the Dakar World Education Forum, especially regarding the increase in primary school enrolment, including the improvement in sub-Saharan Africa, but noting that many countries are still far from attaining the EFA goals,
- 13. <u>Encourages</u> UNESCO to further foster effective EFA partnerships by strengthening existing mechanisms and initiatives, and to continue articulating the joint efforts of donor countries and developing countries to ensure progress towards achieving the EFA goals:
- 14. Also encourages UNESCO to take into consideration and utilize all possibilities, including the sharing of best practices and proven methods, provided by South-South and triangular cooperation and by early operationalization of the Special Account for South-South Cooperation in Education, to take into account the needs for well-qualified teachers in developing countries, and to consider in the 35 C/5 process the provision of additional funds for initiatives such as the Teacher Training Initiative for Sub-Saharan Africa (TTISSA), the Literacy Initiative for Empowerment (LIFE), and for distance learning;
- 15. Requests the Director-General to further improve the sequencing of the launch of the EFA Global Monitoring Report and the meetings of the EFA Working Group and the EFA High-Level Group in order to provide sufficient time to prepare and plan the EFA High-Level Group Meeting;
- 16. <u>Also requests</u> the Director-General to improve the preparatory process for the High-Level Group Meeting by making it more transparent and inclusive and to ensure highlevel participation from donor countries and other convening agencies;
- 17. <u>Further requests</u> the Director-General, preparatory to the EFA thematic debate at its 181st session, to prepare an analytical report on the results of the Eighth High-Level Group Meeting in December 2008 and other relevant meetings on EFA, on the progress achieved regarding the implementation of the Global Action Plan to achieve EFA, the UNESCO National Education Support Strategy (UNESS) process, and the involvement of UNESCO in the EFA Fast-Track Initiative, as well as the concrete initiatives undertaken by UNESCO to foster South-South cooperation and triangular cooperation in the field of education;
- 18. <u>Further requests</u> the Director-General to prepare for its 182nd session a concise analytical report on the main obstacles (and their causes) to attaining the Dakar EFA goals by 2015 and outlining alternative ways of improving UNESCO's efforts to achieve the EFA objectives;
- 19. <u>Further requests</u> the Director-General to relaunch the appeal to the international community, in particular donor countries, to reduce the increasing aid gap by delivering resources for the whole cycle of education, including basic education, secondary education and higher education, as well as adult literacy and early childhood care and education for developing countries;

20. <u>Invites</u> Member States, especially the developed countries, international organizations and other stakeholders to contribute to the United Nations Literacy Decade Fund with a view to advancing the goals of the Decade and the EFA goals, and to strengthen their support to the Decade, in particular the three major areas which were identified by the mid-Decade review: stronger commitment, more effective delivery on the ground, and new resources for literacy.

Expresses its sincere thanks to the Director-General for his sustained efforts for the safeguarding of the cultural heritage of the Old City of Jerusalem, in compliance with the relevant resolutions and decisions of the General Conference and of the Executive Board, and <u>reiterates</u> its concern as to the obstacles, practices and actions, unilateral or otherwise, affecting the preservation of the distinctive character of the Old City of Jerusalem;
- 5. <u>Invites</u> the Director-General to pursue his efforts with the concerned parties for the safeguarding of the outstanding universal value of the Old City of Jerusalem;
- 6. <u>Thanks</u> the Jordanian authorities for having agreed to bear the cost of the storage fees to facilitate the delivery of the equipment for the manuscripts conservation laboratory in al-Ashrafīya Madrasa;

- 2. <u>Having examined</u> the report by the Governing Board of the UNESCO Institute for Statistics on the activities of the Institute since October 2007 contained in document 180 EX/20.
- 3. <u>Takes note</u> of the achievements of the Institute in the past year and of the fact that financial and administrative implications clearly fall within the parameters of the Programme and Budget for 2008-2009 (34 C/5 Approved);
- 4. <u>Invites</u> the Director-General to continue to be guided by the recommendations made by the Governing Board of the UNESCO Institute for Statistics;
- 5. Invites the UNESCO Institute for Statistics Governing Board to report to it at its 182nd session.

### DRAFT PROGRAMME AND BUDGET FOR 2010-2011 (35 C/5)

Preliminary proposals by the Director-General concerning the Draft Programme and Budget for 2010-2011 (35 C/5) (180 EX/21 Part I (A), (B) and (C); Part II (A) and (B); 180 EX/INF.19 and Corr.; 180 EX/INF.20; 180 EX/INF.21 and Corr.; 180 EX/INF.27)

The Executive Board.

- 1. Having considered the preliminary proposals by the Director-General for priority fields of action for the Draft Programme and Budget for 2010-2011 (35 C/5) contained in documents 180 EX/21 Part II (A) and (B), the regional consultations with National Commissions and the summary of responses by Member States and by intergovernmental and non-governmental organizations to the questionnaire by the Director-General contained in documents 180 EX/21 Part I (A), (B) and (C),
- 2. <u>Taking into account</u> its discussions at its 180th session on the preparations for the Draft Programme and Budget for 2010-2011 (35 C/5),

- 3. <u>Guided by and building on the Medium-Term Strategy for 2008-2013 (34 C/4), its global priorities, overarching and strategic programme priorities, and its intersectoral orientation, and its intersectoral orientation,</u>
- 4. <u>Mindful</u> of the current global financial crisis and its potential impact and the resultant need to allocate resources to priority programme activities and to implement programmes with utmost efficiency and effectiveness,

- 5. <u>Conscious</u> of the mandate of UNESCO to construct the defences of peace in the minds of men and to build a culture of peace, as enshrined in its Constitution and elaborated in document 34 C/4,
- 6. <u>Underscoring</u> the paramount need for UNESCO to concentrate and focus its action on its programme priorities,
- 7. Reaffirming the importance for UNESCO to accord priority in all its programmes and activities to the two global priorities of document 34 C/4, Africa and gender equality, and to allocate adequate resources to this end,
- 8. Reiterating its commitment to action in favour of least developed countries (LDCs), small island developing States (SIDS), the disadvantaged segments of society, including indigenous people, and countries in post-conflict and post-disaster situations, to be carried out in all major programmes,
- 9. <u>Resolved</u> to respond to the needs and expectations of youth through focused and effective action by all major programmes,
- 10. <u>Acknowledging</u> the fundamental importance of South-South cooperation and triangular North-South-South cooperation for the attainment of UNESCO's overarching and strategic programme objectives, which makes it imperative for them to be introduced and applied in all major programmes,
- 11. <u>Concurring</u> with the strengthening of intersectorality and interdisciplinarity as a key comparative advantage of UNESCO in the contemporary world through intersectoral platforms and other forms of multisectoral engagement, especially at the field level,
- 12. <u>Underlining</u> the importance of promoting and implementing UNESCO's normative and standard-setting instruments in all its domains;
- 13. <u>Recognizing</u> the crucial role of upstream policy advice, institutional and human capacity-building, and monitoring of global and regional trends in the Organization's fields of competence,
- 14. <u>Stressing</u> that UNESCO's global strategies in the various priority areas must be sufficiently flexible so as to be able to respond to specific regional situations and needs,
- 15. <u>Committed</u> to UNESCO's contributions to United Nations system-wide reform efforts in response to the needs of Member States at the country level,
- 16. <u>Emphasizing</u> that UNESCO's field structure must be appropriate and able to deliver on the Organization's priorities, as pursued through the UNESCO reform process,
- 17. Recalling the unique role of the National Commissions as constituent elements of UNESCO and contributors to programme implementation at the national level,
- 18. Recognizing that UNESCO needs to reinforce and extend its partnerships in order to attain its objectives,
- 19. <u>Underlining</u> the central role of the full and refined application of the results-based management (RBM) approach to all activities, on the basis of a reduced number of well-articulated, meaningful and, to the extent possible, measurable expected results, as against document 34 C/5, and of provisions for effective monitoring and evaluation of programme performance,
- 20. <u>Determined</u> to enhance the visibility of UNESCO's action at the global, regional and national levels, especially through the effective implementation of its programmes.

21. <u>Invites</u> the Director-General to prepare the Draft Programme and Budget for 2010-2011 (35 C/5) bearing in mind the guidance given in this decision, and in particular section II, as regards programme priorities;

### **GLOBAL PRIORITIES**

22. <u>Reaffirms</u> that the priority accorded to Africa and gender equality must be translated into action in all of UNESCO's fields of competence:

#### Africa

- 23. <u>Emphasizes</u> all provisions of document 34 C/4 concerning Africa, and <u>stresses in particular</u> that UNESCO needs to give priority and fresh impetus to its support for development efforts in Africa, aimed principally at meeting the major goals and international commitments, such as education for all (EFA), the Millennium Development Goals (MDGs), and those of the African Union (AU), including the New Partnership for Africa's Development (NEPAD), which provide a common framework for concrete international action:
- 24. <u>Calls</u> for increased cooperation with the African Union, including NEPAD, and relevant subregional organizations;
- 25. <u>Requests</u> the Director-General to provide support to African Member States on a priority basis in all domains of the Organization, and to allocate adequate resources to programmes and activities which reflect the priority status of Africa;

### **Gender equality**

- 26. Reiterates UNESCO's commitment to gender equality as a global priority of the Organization, to be implemented by integrating gender components in actions undertaken in all major programmes and through support for gender mainstreaming and related capacity-building, as envisaged in document 34 C/4 and the proposed Gender Equality Action Plan for 2008-2013;
- 27. <u>Requests</u> the Director-General to allocate to gender equality action adequate resources which reflect its priority status;

### **PRIORITIES FOR MAJOR PROGRAMMES**

### Major Programme I – Education

- 28. <u>Underlining</u> the fundamental role of education for the eradication of poverty, the attainment of all the Millennium Development Goals and the promotion of economic and social development,
- 29. Recalling the international commitments made to realize and accelerate the attainment of the six education for all (EFA) goals and the education-related Millennium Development Goals, and UNESCO's unique role in that regard,
- Reaffirming UNESCO's commitment to continuing to promote quality education at all levels and lifelong learning, which are key to building equitable and sustainable knowledge societies,
- 31. <u>Committed</u> to the strengthening and promotion of South-South cooperation in all areas of education, and <u>inviting</u> Member States to contribute to the Special Account for South-South Cooperation in Education,

- 32. <u>Emphasizing</u> the important role of inclusive education, especially in the context of the sixtieth anniversary of the Universal Declaration of Human Rights,
- 33. Reaffirming that UNESCO is uniquely positioned to pursue a holistic approach with respect to education systems and education reform, comprising early childhood care and education (ECCE), basic education, secondary education, technical and vocational education and training (TVET), higher education, literacy, teacher training and lifelong learning,
- 34. <u>Acknowledging</u> UNESCO's role in setting norms and standards and sharing best practices in education,
- 35. <u>Underlining</u> the centrality of the principles of non-discrimination and of equal opportunities in education expressed in UNESCO's Convention against Discrimination in Education, and <u>encouraging</u> the Director-General to pursue UNESCO's action in promoting and monitoring the exercise of the right to education,
- 36. <u>Calling on the Director-General to intensify action at the global, regional and country levels by affirming UNESCO's lead role in the United Nations Literacy Decade (2003-2012) and the United Nations Decade on Education for Sustainable Development (2005-2014),</u>
- 37. <u>Urging</u> the Director-General to pursue the Literacy Initiative for Empowerment (LIFE) and the Teacher Training Initiative for Sub-Saharan Africa (TTISSA), and to seek ways of expanding them to cover other countries,
- 38. Recalling the key role of higher education in attaining national development objectives and developing knowledge societies in a globalizing world,
- 39. <u>Underlining</u> the need for UNESCO to continue to focus on teacher training,
- 40. <u>Highlighting</u> the increasing need to address secondary education in education systems, and to provide support for technical and vocational education and training (TVET),
- 41. <u>Encouraging</u> the Director-General to continue to support regional education networks and projects, such as those of the African Union (AU), the South-East Asian Ministers of Education Organization (SEAMEO), the E-9 initiative, the Regional Education Project for Latin America and the Caribbean (PRELAC), and similar initiatives,
- 42. Recommends that the Director-General, in drawing up document 35 C/5 for Major Programme I, take into account the programme priorities emphasized by the National Commissions during the regional consultations, by Member States in their replies to the Director-General's questionnaire on the preparation of document 35 C/5, and by Member States at the 180th session of the Executive Board, and especially the following key priorities:
  - global lead and coordination role for education for all (EFA) at all levels;
  - literacy;
  - education for sustainable development;
  - South-South cooperation in education;
  - secondary education and technical and vocational education and training (TVET);
  - adult education;
  - higher education;
  - teacher education and training, including the Teacher Training Initiative for Sub-Saharan Africa (TTISSA);

### Major Programme II - Natural sciences

- 43. Recalling the important contribution of science, technology and innovation to sustainable development and the eradication of poverty,
- 44. <u>Stressing</u> the needs of Member States for assistance with the formulation and implementation of science, technology and innovation policies for sustainable development, and with the development of related capacities, including through support for the International Basic Sciences Programme (IBSP), especially in Africa and small island developing States (SIDS),
- 45. <u>Emphasizing</u> the role of UNESCO's science programme in fostering dialogue, cooperation, capacity-building, and knowledge-sharing,
- 46. <u>Underlining</u> UNESCO's commitment to action on climate change, in particular by helping Member States to build and maintain the requisite knowledge base, and to mitigate the causes of climate change,
- 47. <u>Acknowledging</u> the leading work of the Intergovernmental Oceanographic Commission (IOC) in improving governance and fostering intergovernmental cooperation through ocean sciences and services, as well as its central role in providing authoritative scientific and technical information for evidence-based policy recommendations,
- 48. <u>Emphasizing</u> UNESCO's role in assisting countries with preparedness for and mitigation of natural and human-induced disasters, including those of a technological nature, as well as desertification, through policy advice, knowledge sharing, and education,
- 49. <u>Bearing in mind</u> that access to safe drinking water is of vital importance for achieving Millennium Development Goals 1 and 7, and <u>underlining</u> in this context the valuable contribution being made by UNESCO's International Hydrological Programme (IHP),
- 50. <u>Underlining</u> the need to reinforce UNESCO's leading role in the scientific aspects of freshwater research, capacity-building and education, including the important roles of the International Hydrological Programme, the UNESCO-IHE Institute for Water Education and the World Assessment Programme (WWAP),
- 51. <u>Also underlining</u> the role of the Man and the Biosphere (MAB) Programme in gaining and sharing knowledge on biodiversity and sustainability, as well as on eco-system management,
- 52. <u>Mindful</u> of UNESCO's contribution to earth observation systems, facilitating the monitoring of changes in land, water and oceans, and to research and capacity-building through the geosciences,
- 53. <u>Emphasizing</u> the paramount role of science and technology education for capacity-building in science, engineering and technology and <u>recognizing</u> the importance of curriculum-building, content and teaching,
- 54. <u>Further emphasizing</u> the significant contribution to be made by Major Programme II in support of education for sustainable development,
- 55. <u>Underlining</u> the importance of capacity-building and the sharing of best practices in the field of renewable and alternative energies in support of sustainable development,
- 56. Recommends that the Director-General, in drawing up document 35 C/5 for Major Programme II, take into account the programme priorities emphasized by the National Commissions during the regional consultations, by Member States in their replies to the Director-General's questionnaire on the preparation of document 35 C/5, and by

Member States at the 180th session of the Executive Board, and especially the following key priorities:

- strengthening the role of science for sustainable development through fostering policies and capacity-building in science, technology and innovation;
- supporting the work of the Intergovernmental Oceanographic Commission (IOC) in improving the governance, management and protection of ocean and coastal areas:
- addressing climate change through the lead role of the Intergovernmental Oceanographic Commission in building the knowledge base and through contributions by other UNESCO scientific programmes;
- supporting the work of the International Hydrological Programme (IHP) in promoting the sustainable use of fresh water;
- promoting science education and teacher training;
- capacity-building in all areas of UNESCO's competence in natural sciences, including for disaster preparedness and mitigation;

### Major Programme III - Social and human sciences

- 57. Recognizing that full enjoyment of and respect for human rights is a universally accepted principle, and that a focus on and promotion of human rights, in all of UNESCO's fields of competence, are central to the mandate of the Organization,
- 58. <u>Mindful</u> of the potential of social and human sciences to assist countries in responding to the complex challenges of globalization and of UNESCO's unique role in that respect,
- 59. <u>Underlining</u> the potential of philosophy to address contemporary challenges, as well as the promotion of philosophical dialogue and reflection and the teaching of philosophy to promote a culture of peace, taking into account UNESCO's experience in this domain,
- 60. Recognizing the need to contribute to the fight against racism, discrimination and xenophobia,
- 61. Reaffirming that one of UNESCO's overarching objectives is to address emerging social and ethical challenges, including, *inter alia*, those relating to youth, youth violence, migration and climate change,
- 62. Recommends that the Director-General, in drawing up document 35 C/5 for Major Programme III, take into account the programme priorities emphasized by the National Commissions during the regional consultations, by Member States in their replies to the Director-General's questionnaire on the preparation of document 35 C/5, and by Member States at the 180th session of the Executive Board, and especially the following key priorities:
  - promotion of human rights in UNESCO's fields of competence, including the promotion of democracy and pluralism;
  - ethics of science and technology, especially bioethics;
  - implementation of the International Convention against Doping in Sport;
  - research-policy linkages on emerging critical social and ethical challenges;
  - management of social transformations (MOST);

### **Major Programme IV – Culture**

- 63. <u>Emphasizing</u> the central role of culture for sustainable development and for the attainment of national development objectives and the internationally agreed development goals, including the Millennium Development Goals,
- 64. <u>Further emphasizing</u> that cultural diversity forms a common heritage of humanity which must be preserved in order to serve as a force for dialogue, social cohesion, innovation and a culture of peace,
- 65. Acknowledging the vital role of creativity and cultural interaction, as recognized through a number of international legal principles enshrined in international UNESCO conventions in the field of culture.
- 66. <u>Stressing</u> that special attention needs to be paid to the protection of cultural heritage in danger, especially in countries in conflict, post-conflict and post-disaster situations,
- 67. <u>Emphasizing</u> the importance of the promotion and implementation of the conventions in the field of culture and the need to provide adequate human resources for the servicing of these conventions.
- 68. <u>Highlighting</u> the value of languages as symbols of identity and the reflection of various world views, and as concrete tools for communication and mutual understanding, and the importance of endangered languages,
- 69. Reaffirming the importance of the Slave Route project and its role in the preservation of memory for combating prejudice, developing intercultural skills, and highlighting shared values.
- 70. Recognizing the importance of arts education, both as a component of quality education and as a means to develop cognitive and creative capacities,
- 71. <u>Underscoring</u> the need to strengthen cultural and creative industries, notably in developing countries, with a view to fostering the emergence of local, viable markets and accessing international networks,
- 72. <u>Stressing</u> the importance of promoting community-based cultural tourism which contributes to sustainable development, notably through the preservation of cultural heritage, especially in Africa,
- 73. Recommends that the Director-General, in drawing up document 35 C/5 for Major Programme IV, take into account the programme priorities emphasized by the National Commissions during the regional consultations, by Member States in their replies to the Director-General's questionnaire on the preparation of document 35 C/5, and by Member States at the 180th session of the Executive Board, and especially the following key priorities:
  - the role of culture in promoting sustainable development:
  - implementation of the conventions in the field of culture, with special emphasis on the 1972, 2003 and 2005 conventions;
  - promotion of dialogue among civilizations and cultures and the fostering of a culture of peace;
  - promotion of languages and multilingualism;

### Major Programme V – Communication and information

- 74. <u>Emphasizing</u> UNESCO's role in helping Member States to build inclusive knowledge societies,
- 75. <u>Committed</u> to the follow-up to the relevant action lines of the World Summit on the Information Society (WSIS) Declaration of Principles and Plan of Action at the global, regional and country levels,
- 76. Reaffirming the importance of freedom of expression as a fundamental human right and as a prerequisite for the exercise and promotion of other rights, as well as the building of inclusive knowledge societies,
- 77. <u>Stressing</u> that press freedom and freedom of information as well as the development of independent and pluralistic media are essential elements of good governance, democracy and sustainable development,
- 78. <u>Underscoring</u> the need for UNESCO to support Member States in adopting policies and building capacities to foster access to information and the development of communication, which are essential for inclusive knowledge societies, in particular through support for the Information for All Programme (IFAP), including its Strategic Plan, and the International Programme for the Development of Communication (IPDC),
- 79. <u>Underlining</u> the importance of the multiplier effect resulting from the use of media and ICTs for the development of education, media and information literacy, the dissemination of scientific information as well as for the promotion of mutual understanding and intercultural dialogue,
- 80. Recommends that the Director-General, in drawing up document 35 C/5 for Major Programme V, take into account the programme priorities emphasized by the National Commissions during the regional consultations, by Member States in their replies to the Director-General's questionnaire on the preparation of document 35 C/5, and by Member States at the 180th session of the Executive Board, and especially the following key priorities:
  - promote freedom of expression and press freedom, media independence and pluralism;
  - provide access to information and knowledge through media and ICTs, including through the Information for All Programme (IFAP);
  - development of communication, especially through a strengthened International Programme for the Development of Communication (IPDC);
  - promote the use of media and ICTs as multipliers for action by the entire Organization, in particular for teacher training;
  - follow up the relevant action lines of the World Summit on the Information Society (WSIS) Declaration of Principles and Plan of Action;

### Intersectoral platforms

- 81. Recognizes that the 12 intersectoral platforms introduced in document 34 C/5 as a new modality for programme implementation are important tools for attaining the relevant expected results of the major programmes concerned, namely:
  - Priority Africa;
  - foresight and anticipation;
  - science education;
  - HIV and AIDS;

- education for sustainable development (ESD);
- implementation of the Mauritius Strategy for SIDS;
- fostering ICT-enhanced learning;
- · strengthening national research systems;
- languages and multilingualism;
- contributing to the dialogue among civilizations and cultures and a culture of peace;
- support to countries in post-conflict and disaster situations;
- UNESCO action to address climate change.
- 82. <u>Invites</u> the Director-General, in the light of the experience gained in 2008, and taking into account the discussions by the Executive Board at its 180th session, to make specific proposals in the Draft Programme and Budget for 2010-2011 on action to be pursued through intersectoral platforms and on the budgets and modalities proposed for their implementation, clearly identifying their administrative and financial impact;
- 83. Requests the Director-General to ensure that the strategies and expected results for these intersectoral platforms and the funds earmarked for this modality under the major programmes concerned add value to the attainment of the objectives and expected results of those major programmes as included in draft document 35 C/5;
- 84. <u>Requests</u> the Director-General to ensure that the Secretariat implement the programme in an intersectoral manner through other approaches and modalities, as appropriate, including for issues such as arts education;

85. <u>Invites</u> the Director-General, in the Draft Programme and Budget for 2010-2011 (35 C/5) which he will present to the Executive Board at its 181st session, to formulate proposed titles for the biennial sectoral priorities (BSPs) and the main lines of action (MLAs) which are action-oriented and reflect fully and clearly the principal programme priorities identified by the present decision, thereby enabling the Executive Board and its Drafting Group to conduct a full review at the 181st session.

### **Budgetary issues**

- 1. Recalling 175 EX/Decision 21 and 34 C/Resolution 92,
- 2. Having examined document 180 EX/21 Part II (B),
- Recognizing the need to make further improvements in the Organization in order to implement a results-based budgeting approach as a methodology to achieve increased budget transparency and accountability, and as a means of significantly enhancing the governance function of Member States by involving them more effectively in the programme and budget process;
- 4. <u>Notes</u> the need to maintain the overall purchasing power of the Organization in order to fulfil the main objectives and priorities established in the Medium-Term Strategy for 2008-2013 (34 C/4 Approved);
- 5. <u>Also notes</u> that the Director-General has proposed a single budget scenario of \$671 million;

- 6. <u>Invites</u> the Director-General, when preparing the Draft Programme and Budget for 2010-2011, to:
  - (a) reinforce the resources allocated to programmes, taking into account the discussions held at the 180th session of the Executive Board regarding priorities and the need to focus on the core mandate of the Organization;
  - (b) continue to undertake effective rationalization of financial resources, in particular resources allocated to central services and parts of the budget other than Part II.A;
  - (c) identify the proposed activities and projects implemented during the current biennium that will continue to be carried out in the period 2010-2011, making the appropriate adjustments or reorientation, taking into consideration the decisions taken by the General Conference and the Executive Board in respect of the relevant findings and recommendations of the evaluation and audit reports on such activities;
  - (d) submit an indicative list of the new activities, with time-frames, under each main line of action that will be carried out to implement the proposed objectives and priorities foreseen in document 35 C/5;
  - (e) ensure that all costs associated with programme delivery, such as the International Public Sector Accounting Standards (IPSAS), integrated management systems, results-based management, periodic programme evaluation, Headquarters renovation and maintenance, security staff, and field offices, are clearly identified and accommodated within the regular budget in order to ensure efficient delivery of the programme and the achievement of UNESCO's objectives without affecting the priority given to the reinforcement of the resources allocated to programmes;
- 7. Requests the Director-General to undertake a study of the needs and challenges involved in achieving results-based budgeting in the Organization, and present the findings to the Executive Board at its 182nd session;
- 8. <u>Further requests</u> the Director-General to present draft document 35 C/5 to it at its 181st session.

- 4. Recognizing that as an acknowledgement of their usefulness and effectiveness, there is broad support for continuing the joint meetings,
- 5. Reaffirming that formal continuation of the joint meetings should not, in any way, be interpreted as a prelude to the merger of the PX and FA Commissions,
- 6. <u>Decides</u> to continue the joint meetings of the PX and FA Commissions as a formal method of work of the Executive Board, while maintaining the present structure and division of functions of the PX and FA Commissions:
- 7. <u>Further decides</u> to continue to streamline the organization of the joint meetings, refine the criteria for allocation of agenda items, and establish a procedure for the examination of agenda items at the joint meetings of the Commissions to ensure that both programmatic and external relations and financial and administrative aspects are fully considered.

- (k) any other administrative and financial matters that the Chairs of the Executive Board, Finance and Administrative Commission and the Group of Experts jointly decide to refer to the Group of Experts for technical examination to assist the work of the Commission;

### Working methods of meetings

The concern for effectiveness in the search for an amicable solution means that communications are examined in the strictest confidence, in the Committee and also in the Board when it examines the report of the Committee. Nothing has ever been done to make public cases that have been considered and/or settled. Nevertheless, the Board has, on occasion, examined a communication in public meeting at the Committee's request.

Members of the Board who are not members of the Committee shall refrain from attending the Committee's meetings when it is considering communications, in accordance with paragraph 14(c) of 104 EX/Decision 3.3. This custom, based on a well-established practice of the Board, shall be drawn to the attention of all the Members of the Board at the first session following the renewal of the membership of the Executive Board and of the Committee.
- 37. Members of the Board not members of the Committee who, exceptionally, wish to have observer status shall submit their request in writing to the Chair of the Committee, who shall transmit it to the Committee for examination. In the exceptional case when an observer is thus admitted to one of its meetings, such observer shall be present neither for the private discussions leading to a decision on a communication nor for the adoption of the decisions."

  - (i) with respect to communications with Member States on the organization of the General Conference, give timely consideration to active consultation with their National Commissions, especially in the case of Member States which do not have a Permanent Delegation at UNESCO;
  - (j) ensure strict application of the rules concerning the admissibility of draft resolutions;

- (a) to encourage Member States to propose qualified candidates to serve as Chairs and other officers of the commissions, who shall be nominated by it at its 181st session;

- 2. Having examined document 180 EX/34,
- Takes note (Annexes I, II and III to document 180 EX/34), in particular with regard to the substantive technical review of the accounting standards which was conducted by UNESCO's dedicated project team, using a harmonized United Nations system-wide approach;
- 4. <u>Further takes note</u> of the shortfall of \$684,000 in the budget for the IPSAS project and of the Director-General's intention either to obtain additional funds from extrabudgetary sources or to find savings in the current biennium budget to finance the IPSAS project;
- 5. Requests the Director-General to submit to it at its 181st session a progress report on the implementation of the action plan, including any proposed amendments to the Financial Regulations.

# Report by the Director-General on alternative funding mechanisms for unfunded liabilities of staff benefits (180 EX/35; 180 EX/67)

- 1. Recalling 34 C/Resolution 73 requesting the Director-General to undertake an actuarial study on unfunded liabilities of staff benefits and to propose alternative funding mechanisms for that purpose,
- 2. <u>Recalling also</u> United Nations General Assembly resolution 61/264 concerning the liabilities and proposed funding for after-service health insurance benefits,
- 3. Having examined document 180 EX/35,
- 4. <u>Takes note</u> of the background information provided in document 180 EX/35 and in particular the development and progress made by the United Nations in identifying sources of funding for employee benefits;
- 5. <u>Also takes note</u> of the International Public Sector Accounting Standards (IPSAS) requirement for the Organization to recognize the employee benefits liability for the first time in its financial statements, effective 1 January 2010, and <u>notes</u> that this requirement applies irrespective of whether such liabilities are funded or not;
- 6. <u>Acknowledges</u> that by full recognition of this liability, the accounts of the Organization will show a significant overall negative equity;
- 7. Recognizes the complexity of the issue and the significant amount of liabilities, and requests the Director-General to prepare a comprehensive report which includes:
  - (a) detailed information regarding the proposals for possible funding mechanisms for UNESCO after-service health insurance scheme;
  - (b) disaggregated information in order to identify specifically the sources of the accrued after-service health insurance benefit liabilities;
- 8. <u>Invites</u> the Director-General to present the said report to it at its 184th session, in the light of the debate at the 180th session and the decisions taken in the United Nations system.

## Report by the Director-General on the status of contributions of Member States and of payment plans (180 EX/36 and Add.; 180 EX/67)

The Executive Board,

- 1. Recalling 34 C/Resolution 02 concerning all payment plans agreed upon between UNESCO and Member States in arrears with their contributions.
- 2. <u>Having examined</u> documents 180 EX/36 and Add., and <u>having taken note</u> of the up-todate information provided during the debate of the Financial and Administrative Commission at its 180th session,
- 3. <u>Expresses its gratitude</u> to Member States that have paid their contributions for the year 2008 and to those which have made efforts to reduce their arrears in response to appeals;
- 4. <u>Notes</u> that the efforts made by some Member States have not been sufficient to prevent recourse to internal borrowing from October to December 2007 to supplement the resources of the Working Capital Fund for the purpose of financing the programme;
- 5. Recalls that the prompt payment of contributions is an obligation incumbent on Member States under the Constitution and the Financial Regulations of the Organization;
- 6. <u>Strongly supports</u> the approaches the Director-General is continuing to make to Member States with a view to obtaining timely payment of contributions;
- 7. <u>Urgently appeals</u> to those Member States that are behind with the payment of their contributions to pay their arrears without delay;
- 8. <u>Urgently appeals</u>, more specifically, to those Member States that are in arrears on payment plans to settle their outstanding instalments at the earliest possible time as well as their regular assessed contributions, bearing in mind the risk of loss of voting rights that may otherwise ensue at the 35th session of the General Conference;
- 9. <u>Urges</u> Member States, on receipt of the Director-General's request for payment of assessed contributions, to inform him, as promptly as possible, of the probable date, amount and method of payment of the forthcoming contribution in order to facilitate his management of the Organization's treasury function;
- 10. <u>Notes in particular</u> the failure of 15 Member States to pay, by the end of June 2008, the amounts due by them against payment plans approved by the General Conference for settlement of their accumulated arrears in instalments, in addition to the current year's contributions;
- 11. <u>Recalls</u> the request of the General Conference to the Director-General to report to it at thereon its 35th session;
- 12. <u>Requests</u> the Director-General to compile information on the measures or incentives put in place by other United Nations organizations to overcome the problem of arrears, and to report to it at its 182nd session on his findings thereon.

- Also requests the Director-General to submit to it a report at its 181st session, explaining how the request in resolution 62/208 to plough back savings resulting from reductions in administrative and support costs into programme activities may be realized in UNESCO;
- 20. <u>Further requests</u> the Director-General to present to it at its 181st session a more proactive and forward-looking action plan on the implementation of resolution 62/208, based on an analysis of the situation, and presenting proposals for future steps, outlining the implications for the budget, the programme and the decentralization strategy;

21. <u>Further requests</u> the Director-General to take into account the outcome of intergovernmental work at the United Nations General Assembly concerning system-wide coherence on "Delivery as One", on harmonization of business practices, on funding, and on governance when presenting the draft plan on the implementation of resolution 62/208.

- 5. <u>Expresses its deep gratitude</u> to the Government of Equatorial Guinea for this initiative, and for the generous offer of \$3 million for the regular running costs of the Prize,

# Rabindranath Tagore, Pablo Neruda and Aimé Césaire for a reconciled universal (180 EX/58 Rev.2; 180 EX/INF.13; 180 EX/68 Part II)

### The Executive Board

- 1. <u>Having examined</u> document 180 EX/58 Rev.2, which highlights the interdisciplinary and intersectoral contents of the works of Rabindranath Tagore (1861-1941), Pablo Neruda (1904-1973) and Aimé Cesaire (1913-2008),
- 2. Recalling the importance of these works and the exemplary nature of their authors' commitment, in order to enhance UNESCO's efforts towards a reconciled universal,
- 3. <u>Noting</u>, in this International Year of Languages, that significant works have not been translated, including into the working languages of the United Nations or, more significantly, into other languages of national and regional importance,
- 4. <u>Considering</u> that, with the exception of the programme organized by UNESCO for the 100th anniversary of the birth of Pablo Neruda in March 2004, most, if not all, of the works of these three authors do not appear in the UNESCO Collection of Representative Works, thus making their dissemination and promotion more difficult,
- 5. <u>Taking into account</u> the awarding of the UNESCO-Toussaint Louverture Prize to Aimé Césaire, in 2004, by the international jury convened by the Director-General on the occasion of the celebration of the International Year to Commemorate the Struggle against Slavery and its Abolition,
- 6. Considering that the forthcoming dates of the 150th anniversary of the birth of Rabindranath Tagore (2011) and of the 100th anniversary of the birth of Aimé Césaire (2013) provide an opportunity to enrich national and international life through the topicality of their convergent messages, highlighting the originality of each of the works, while exploring the close relations between them, for the development of a universal which matches the expectation of peoples, in particular through the strengthening of bridges between civilizations,
- 7. <u>Invites</u> the Director-General to submit to it at its 181st session specific proposals for the implementation of interdisciplinary and intersectoral programmes built round the work of these three authors, and <u>encourages</u> him to support the activities and initiatives of States and public and private institutions which so request it;
- 8. Also invites Member States and public and private institutions in the field to translate and publish in national languages, and to deepen awareness of the rich tangible and intangible heritage constituted by these works, in strict observance of the rights of copyright holders and their legal successors;
- 9. Recommends the establishment of prizes and medals bearing the name of each of these three illustrious persons;
- 10. <u>Requests</u> that favourable consideration be given to the celebration, through suitable programmes, of the 150th anniversary of the birth of Rabindranath Tagore (2011) and of the 100th anniversary of the birth of Aimé Césaire (2013).
