Agenda, timetable of work, election of the Chairpersons of the Special Committee (SP) and the Committee on International Non-Governmental Organizations (NGO), and composition of the Special Committee (186 EX/I; 186 EX/INF.1; 186 EX/INF.3)

The Executive Board <u>adopted</u> the agenda and timetable of work as set out in documents 186 EX/1 and 186 EX/INF.1.

The Executive Board decided to refer the following items of its agenda to the commissions:

- 1. **Programme and External Relations Commission (PX)**: items 5, 6 Part II, 7, 9, 11, 12, 13, 32, 34, 35, 38, 40 and 43; and for programme-related aspects, items 4 and 15;
- 2. **Finance and Administrative Commission (FA)**: items 23, 24, 25, 26 and 27; and for administrative and financial aspects, items 4 and 15;

In accordance with Rule 16, paragraph 3, of the Rules of Procedure, the Executive Board <u>elected</u> Mr Ngwabi Mulunge Bhebe (Zimbabwe) Chair of the Special Committee (SP) to replace Ms Irène Rabenoro (Madagascar) for the remainder of her term of office, and <u>also elected</u> Mr Amr Ezzat Salama (Egypt) Chair of the Committee on International Non-Governmental Organizations (NGO) to replace Mr Hany Helal for the remainder of his term of office.

Further to previous decisions, and particularly 183 EX/Decision 11, which renewed the mandate of the Special Committee and decided on the composition of this Committee for the 2010-2011 biennium, and following the withdrawal of Greece from the membership of the Special Committee, the Executive Board <u>decided</u> to replace Greece with Belgium for Group I for the remainder of the 2010-2011 biennium.

4 Report by the Director-General on the execution of the programme adopted by the General Conference (186 EX/4 Part I and Add.; 186 EX/4 Part II and Corr.; 186 EX/INF.17; 186 EX/INF.19; 186 EX/INF.22; 186 EX/INF.25 Rev.; 186 EX/47; 186 EX/48)

The Executive Board,

- 1. Having examined documents 186 EX/4 Part I and Add.,
- 2. <u>Emphasizing</u> that the report by the Executive Board to the General Conference on the C/5 document currently being implemented and on the results of the previous biennium relies to a large extent on the ability of the Executive Board to make explicit decisions on the EX/4 reports on programme execution,
- 3. Reiterating the need to improve the EX/4 reports, especially the overall assessment of key results, by providing a more concise and evidence-based analysis, focusing on the achievement of expected results, as requested in 34 C/Resolution 89, 179 EX/Decision 21, 180 EX/Decision 4, 181 EX/Decision 23, 182 EX/Decision 26 (II) and 184 EX/Decision 4,
- 4. Taking into consideration:
 - (a) the acknowledgement by the Ad Hoc Working Group on the Independent External Evaluation of UNESCO of the need to strengthen the monitoring role of the Executive Board in the execution of UNESCO's programmes;
 - (b) the format proposed in document 186 EX/16 for the elaboration of a draft report to be submitted to the Executive Board at its 187th session and the information required as described in document 35 C/9,

Programme execution

- 5. <u>Noting</u> that document 186 EX/4 Part I identifies progress achieved, in particular, but not limited to:
 - (a) under Major Programme I, with regard to countries working on new or revised policies on literacy and non-formal education, including national implementation frameworks for the Literacy Initiative for Empowerment (LIFE), and to Member States providing national evaluation reports indicating concrete measures to integrate human rights education into their school systems;
 - (b) under Major Programme II, the strengthening of international partnerships, the recognition of UNESCO as a key partner in the United Nations Intergovernmental Science Policy Platform on Biodiversity and Ecosystem Services, the development of specific policy recommendations for the implementation of United Nations General Assembly resolution 63/124 on the law of transboundary aquifers;
 - (c) under Major Programme III, with regard to influencing policy development by providing key policy guidance for all actors in the social sciences in the *World Social Science Report 2010* and the high number of States Parties to the Convention against Doping in Sport;

- (d) under Major Programme IV, with regard to the high number of ratifications of the 1954, 1970, 2001 and 2003 conventions and the first projects funded under the International Fund for Cultural Diversity;
- (e) under Major Programme V, in the provision of technical support and internationally recognized standards for legislation regarding the media, press freedom and freedom of information and the application of the Media Development Indicators.
- 6. <u>Invites</u> the Director-General to take the necessary measures to meet the challenges identified in document 186 EX/4 Part I, in particular by:
 - (a) enabling and ensuring speedy recruitment;
 - (b) improving coordination mechanisms between the various entities as well as with the field;
 - (c) strengthening cross-disciplinarity and intersectorality;
 - (d) attaining greater strategic focus;
 - (e) identifying ways to address effectively the demands and expectations engendered by the Youth, Sports and Physical Education Section's more proactive engagement in the international system;
 - (f) striking a balance between fulfilling statutory obligations, capacity-building and conservation actions, and the resources for managing the culture conventions through greater concentration in other areas of the programme;

Programme monitoring and reporting

- 7. <u>Notes</u> the improvement in the presentation of overall strategic assessments for each major programme in relation to the challenges identified and lessons learned;
- 8. <u>Encourages</u> the Director-General to ensure that detailed online information is again available in tabular format concerning the results achieved at the main line of action level for major programmes and cost-effectiveness measures, as recommended by the Executive Board in decision 182 EX/26, and as requested in document 35 C/5 Approved, in order to facilitate the preparation of the Executive Board's report to the General Conference;
- 9. <u>Having examined</u> document 186 EX/4 Part I.C, and <u>recognizing</u> the measures taken by the Director-General to implement the recommendations of Internal Oversight Service (IOS) in order to enhance monitoring and reporting for the next C/3 document,
- Also recognizing the efforts of the Director-General to further improve results-based monitoring and reporting, as recommended in her report on the follow-up with respect to operational aspects of the independent external evaluation of UNESCO (186 EX/17 Part II),
- 11. <u>Notes with regret</u> that a majority of the expected results and performance indicators, as well as baselines and benchmarks introduced in draft document 36 C/5, do not support more qualitative outcome-based reporting in future EX/4 and C/3 documents;
- 12. <u>Reiterates its request</u> to the Director-General to focus the EX/4 document on concise evidence-based analyses of the extent to which expected results have been achieved,

- and <u>invites</u> her to present information on activities in a separate report in order to facilitate the monitoring role of the Executive Board;
- 13. <u>Also invites</u> the Director-General to present a two-page executive summary highlighting UNESCO's most significant achievements, as well as issues requiring particularly urgent attention, and to develop a structure for this executive summary, in consultation with Member States, drawing on examples from other organizations of the United Nations system;
- 14. <u>Further invites</u> the Director-General to include the following text in the summary of EX/4 documents:
 - "Action expected of the Executive Board: 34 C/Resolution 89 invites the Executive Board to '(a) have a wider and more strategic assessment of the performance of the programmes, including the EX/4 document, by expressing its views progressively during the biennium through explicit decisions on the performance of individual programmes at main-line-of-action level",
- 15. Requests the Director-General to continue her efforts to strengthen monitoring and reporting and to develop a time-bound action plan on how to address the remaining challenges, as identified in document 186 EX/4 Part I.C, relating to:
 - (a) implementation of a systematic and results-based programming, management, monitoring and reporting approach;
 - (b) transition from output-based to results-based monitoring and reporting;
- 16. <u>Also requests</u> the Director-General to submit to it at its 189th session a report on the status of the implementation of the above-mentioned action plan.

Report by the Director-General on the follow-up to decisions and resolutions adopted by the Executive Board and the General Conference at their previous sessions (186 EX/5 and Corr. and Add.-Add.2; 186 EX/INF.12; 186 EX/INF.24; 186 EX/INF.26; 186 EX/48)

Progress report on the United Nations Literacy Decade (2003-2012)

- 1. Recalling the report of the Director-General of UNESCO on the implementation of the International Plan of Action for the United Nations Literacy Decade, which was transmitted to the United Nations General Assembly at its 65th session, by the Secretary-General (A/65/172 of 26 July 2010), in which the urgent need to further scale up efforts and to consider the post-2012 strategy for addressing youth and adult literacy challenges is clearly outlined in the pursuit of the overall objectives of the Decade and the specific priorities established for the remaining years,
- Also recalling United Nations General Assembly resolution 65/183 of 4 February 2011, in which the United Nations General Assembly called upon Member States, their development partners, the international donor community, the private sector and civil society, in accordance with national law, to further scale up quality literacy efforts, and to consider the post-2012 strategy for addressing youth and adult literacy, bearing in mind that just over two years remain of the Decade, and that the target date of 2015 for the achievement of the education for all (EFA) goals and the Millennium Development Goals (MDGs) is approaching,
- 3. <u>Further recalling</u> resolution 65/183, in which the United Nations General Assembly requested the Secretary-General, in cooperation with the Director-General of UNESCO, to seek the views of Member States on the progress achieved in implementing their national programmes and plans of action for the Decade, undertake a final evaluation of the implementation of the Decade by Member States and other stakeholders, and submit to the General Assembly in 2013 a final report on the implementation of the International Plan of Action with specific recommendations for the post-Decade period,
- 4. Reaffirming that literacy is an integral part of the right to education, and that the acquisition of basic literacy skills is the foundation of lifelong learning for all and a tool for empowering individuals and their communities, and is a key condition for reducing poverty and achieving all the Millennium Development Goals,

- 5. <u>Noting</u> with deep concern that there are still 796 million adults without basic literacy skills, that nearly two-thirds of the world's adult illiterates are women and 67 million children are out of school, and that in some countries the absolute number of non-literates has increased, which indicates that literacy efforts are not keeping pace with population growth,
- 6. <u>Concerned</u> about the low quality of formal primary schooling in a significant number of countries, which results in many children leaving school without having acquired sufficient basic knowledge and skills for productive and active participation in their societies,
- 7. Also noting with deep concern that if present trends continue, the EFA goal of achieving a 50% improvement in levels of adult literacy by 2015, especially among women, will not be met,
- 8. <u>Takes note</u> of the progress report on the United Nations Literacy Decade (2009-2011) by the Director-General of UNESCO to the Executive Board at its 186th session (186 EX/5);
- 9. Reaffirms that literacy is a priority area for the Education Sector in the Programme and Budget for 2010-2011;
- 10. Recognizes that an urgent new thrust and renewed collective commitment to literacy is needed if the objectives of the Decade, the EFA goals and the Millennium Development Goals are to be met;
- 11. <u>Calls</u> on Member States to scale up their literacy efforts, backed by strong and sustained political commitment, clear policies and feasible, large-scale implementation strategies supported by strong legal and institutional frameworks and adequate funding;
- 12. <u>Appeals</u> to all Member States to increase the quality of delivery of an integrated literacy programme, where possible using state-of-the-art means of education, both in formal and non-formal settings, and to ensure that relevant, gender-sensitive, and development-responsive literacy programmes are designed, implemented and sustained;
- 13. <u>Calls</u> on the international community to raise the profile of literacy on regional and international agendas, and to scale up their commitments, especially in all matters connected with women's literacy;
- 14. <u>Appeals</u> to the international donor community to include literacy investments in the EFA Fast Track Initiative, in sector-wide approaches and in other aid for poverty reduction;
- 15. Requests UNESCO to reinforce its activities in the fight against illiteracy, through its role as coordinator and catalyst, *inter alia*, drawing on the pivotal work of the UNESCO Institute for Lifelong Learning (UIL);
- 16. Recalls resolution 65/183, in which the United Nations General Assembly requested all relevant entities of the United Nations system, in particular UNESCO, in cooperation with national governments, to take immediate, concrete steps to address the needs of countries with high illiteracy rates and/or with large populations of illiterate adults, with particular regard to women and persons with disabilities, including through programmes that promote low-cost and effective literacy provisions;
- 17. Requests UNESCO to undertake a final review of the implementation of the Decade by Member States and other important partners, and to submit to the Board at its 192nd

session (autumn 2013) a comprehensive final report on the implementation of the Decade, especially as regards the application of successful literacy programmes, and containing specific recommendations for the post-Decade period;

18. <u>Also requests</u> UNESCO to make literacy a key issue on the agenda of an international conference to be held in 2013, with the support of Member States, with a view to presenting and discussing the findings of the above-mentioned final report, and to developing an action plan for the post-Decade period.

The Executive Board,

- 4. Recommends that the General Conference, at its 36th session, approve the establishment, in Nsukka, Nigeria, of the international centre for biotechnology as a

category 2 centre under the auspices of UNESCO, and that it authorize the Director-General to sign the corresponding agreement.

Proposal for the establishment in Turin, Italy, of an international research centre on the economics of culture and world heritage studies

- 4. Recommends that the General Conference, at its 36th session, approve the establishment, in Turin, Italy, of the international research centre on the economics of culture and world heritage studies as a category 2 centre under the auspices of UNESCO, and that it authorize the Director-General to sign the corresponding agreement.

VII

Proposal for the establishment in Amman, Jordan, of an international museum for women in the arts as a category 2 centre

- 1. Having examined document 186 EX/14 Part VII,
- Aware of the importance of international cooperation for the creation of an international museum specifically devoted to women in the arts, with a focus on arts education geared to intercultural dialogue, freedom of expression, and empowerment of women, with the goal of promoting peace through art,
- 3. <u>Taking note</u> of the observations and conclusions of the feasibility study,
- 4. Welcomes the proposal by Jordan to establish an international museum for women in the arts, in Amman, Jordan, as a category 2 centre under the auspices of UNESCO, which is in line with the integrated comprehensive strategy and the guidelines concerning the creation of institutes and centres under the auspices of UNESCO (category 2) contained in the Annex to document 35 C/22, and approved by the General Conference in 35 C/Resolution 103;
- 5. Recommends that the General Conference, at its 36th session, approve the establishment, in Amman, Jordan, of the international museum for women in the arts as a category 2 centre under the auspices of UNESCO, and that it authorize the Director-General to sign the corresponding agreement.

Proposal for the establishment in Reykjavík, Iceland, of a Vigdís international centre for multilingualism and intercultural understanding

- 5. <u>Taking note</u> of IHP-IC Resolution XIV-11 adopted at the 14th session of the Intergovernmental Council of the International Hydrological Programme in June 2000,
- 6. <u>Deeming</u> the considerations and proposals contained in document 186 EX/14 Part IX to be such as to meet the requirements needed for UNESCO to grant its auspices to the International Centre, in line with the integrated comprehensive strategy and the guidelines concerning the creation of institutes and centres under the auspices of UNESCO (category 2) contained in the Annex to document 35 C/22 and approved by the General Conference in 35 C/Resolution 103,

- 7. <u>Approves</u> the establishment, in Delft, Netherlands, of the International Groundwater Resources Assessment Centre (IGRAC) as a category 2 centre under the auspices of UNESCO;
- 8. <u>Authorizes</u> the Director-General to sign the corresponding agreement.

- 1. <u>Having examined</u> the Draft Programme and Budget for 2012-2013 (36 C/5) prepared by the Director-General,
- 2. <u>Taking into account</u> its discussions in plenary and in the Programme and External Relations (PX) and Finance and Administrative (FA) Commissions at its 186th session on item 15 "Consideration of the Draft Programme and Budget for 2012-2013 (36 C/5) and recommendations of the Executive Board",
- 3. Recalling 185 EX/Decision 17,
- 4. Reaffirming the Medium-Term Strategy for 2008-2013 (34 C/4) and its two global priorities Africa and gender equality its overarching and strategic programme objectives, as well as its intersectoral orientation,
- Also reaffirming the five established functions of UNESCO as set out in document 34 C/4: laboratory of ideas, standards setter, clearing house, capacity-building in Member States in UNESCO's fields of competence, and catalyst for international cooperation,
- 6. <u>Underscoring</u> the continued relevance of UNESCO's mission to contribute to the building of a culture of peace and non-violence, the eradication of poverty and the promotion of sustainable development through education, the sciences, culture, communication and information,
- 7. <u>Notes</u> the efforts to gear the C/5 document to the achievement of the internationally agreed development goals, including the Millennium Development Goals (MDGs), and to launch the reflection on and lay the foundations for the Organization's action beyond 2015;
- 8. <u>Stresses</u> the need to scale up efforts towards reducing inequalities and reaching the marginalized and the most vulnerable communities by further focusing action in favour of the least developed countries (LDCs), guided especially by the Programme of Action for the Least Developed Countries for the Decade 2011-2020, adopted at the Fourth United Nations Conference on the Least Developed Countries, Istanbul, Turkey, 9-13 May 2011;

- Calls for further emphasis on the empowerment of youth as agents of change and active stakeholders in building peaceful, just, democratic, equitable and sustainable societies;
- 10. <u>Notes</u> that the Director-General has prepared a succinct document 36 C/5 in accordance with the general principles and programme priorities as defined by the Executive Board in 185 EX/Decision 17;
- 11. Welcomes the efforts towards greater concentration of the programme on activities intended to reinforce the impact of UNESCO's action, while maintaining the emphasis on the two global priorities of document 34 C/4, Africa and gender equality, and calls for further efforts to focus the programme more rigorously, as suggested in the independent external evaluation of UNESCO;
- 12. <u>Further welcomes</u> the Director-General's efforts to improve the ratio between resources allocated to programmes as against those allocated to support services, and <u>calls</u> for an intensification of such efforts;
- 13. <u>Notes</u> the increased efforts towards harnessing UNESCO's multidisciplinary expertise through a reduced number of more focused and strategically designed intersectoral platforms to address complex development challenges;
- 14. <u>Welcomes</u> the Director-General's commitment to reform, and <u>encourages</u> her to further pursue her efforts to reform the Organization in order to make it more relevant and enhance the impact of its actions, also implementing action in response to the independent external evaluation of UNESCO;
- 15. <u>Welcomes</u> the progress achieved in applying a consistent results-based management (RBM) approach throughout document 36 C/5, and <u>invites</u> the Director-General to pursue her efforts in that regard following a more outcome-oriented approach and focus on impact of UNESCO's action;

Intersectoral platform for the promotion of a culture of peace and non-violence

- 16. Noting that each major programme has identified programme activities in support of a culture of peace and non-violence, and that each major programme will be contributing to the programme of action of the intersectoral platform for the promotion of a culture of peace and non-violence, requests the Director-General to ensure an interdisciplinary, intersectoral, coherent and convergent approach aimed at the attainment of a realistic number of programmes with targeted objectives, and to engage partners during the implementation through regular consultations;
- 17. <u>Underlining</u> that the promotion of youth and civic engagement in favour of a culture of peace must be of central concern,
- 18. <u>Stressing</u> the need to mobilize all relevant stakeholders at the global, regional, subregional and national levels,
- 19. <u>Emphasizes</u> that the objectives of the intersectoral platform for the promotion of a culture of peace and non-violence shall address the following areas:
 - (a) Strengthening education for a culture of peace and non-violence to achieve intercultural solidarity and intergenerational dialogue and mutual understanding in favour of reconciliation and peace-building;
 - (b) Promoting natural sciences as a universal language and vehicle for intercultural dialogue and exchange and peace;

- (c) Underlining the role of social and human sciences in promoting universal values, democracy and human rights;
- (d) Highlighting the crucial role of cultural diversity, intercultural dialogue and heritage in all its forms for mutual understanding and reconciliation;
- (e) Exploring opportunities offered by the media as a vehicle for reconciliation, tolerance and intercultural understanding by highlighting the use of new media by youth;
- 20. <u>Requests</u> the Director-General to prepare, in consultation with Member States, a consolidated intersectoral programme of action for a culture of peace and non-violence with a realistic number of targeted actions along the lines of paragraph 19 above, and to include it in the alternative option for the programme and budget to be submitted to the Executive Board at its 187th session for transmission to the General Conference at its 36th session;
- 21. <u>Noting</u> that in section II below, the Director-General is requested to produce an alternative budget option with a budget envelope of \$653 million, <u>urges</u> the Director-General to favour resource allocations to focused programme activities while suggesting reductions in marginal and under-performing programmes and activities, as well as in administrative and support costs;
- 22. <u>Transmits</u> herewith to the General Conference the Draft Programme and Budget for 2012-2013 (36 C/5), together with the following recommendations by the Executive Board, which constitute document 36 C/6, and <u>recommends</u> that the General Conference examine the item concerning the Draft Programme and Budget for 2012-2013 (36 C/5) in the light of these documents.

- 23. <u>Resolves</u> that in the action plans for all C/5 draft resolutions reference be made to the need to attain sustainable impact and efficiency;

- 27. <u>Highlights</u> the imperative need for all major programmes to be implemented to the maximum extent possible through intersectoral collaboration and engagement;

- 28. <u>Expresses</u> its desire to keep the number of expected results in all draft resolutions within manageable limits, <u>considering</u>, in particular, that the Director-General will have to report on the implementation of the programme every six months, indicating progress achieved towards expected results as well as challenges encountered;
- 29. <u>Also decides</u> to amend in the draft resolution for each major programme the beginning of paragraph 2(b) to read as follows: "to report periodically to the governing bodies, in statutory reports, on the achievement of the following expected results, including relevant performance indicators:";
- 30. <u>Further decides</u> that in all relevant draft resolutions, paragraph 3 should read: "<u>Also requests</u> the Director-General to report in her six-monthly statutory reports on the implementation of the programme adopted by the General Conference on measures taken to optimize the use of resources in the implementation of programme activities, including travel, contractual services and publications";
- 31. Requests the Director-General to reflect in document 36 C/5 Approved information on UNESCO's approach and contribution to the preparatory process for the United Nations Conference on Sustainable Development to be held in June 2012 in Rio de Janeiro, Brazil (Rio+20), which will be devoted principally to the review of implementation gaps in Agenda 21 and the theme of a green economy;

Major Programme I – Education

32. <u>Endorses</u> the following biennial sectoral priorities and related main lines of action (MLAs) for Major Programme I:

Biennial sectoral priority 1: Scaling up equity, inclusion and quality in education and lifelong learning for sustainable development and a culture of peace and non-violence

- MLA 1: Accelerating progress towards education for all (EFA), in particular at the country level, including though information and communication technologies
- MLA 2: Building effective and inclusive education systems
- MLA 3: Supporting education system responses to contemporary challenges for sustainable development and a culture of peace and non-violence

Biennial sectoral priority 2: Strengthening global leadership in education

- MLA 4: Reinforcing leadership in education for all (EFA) through advocacy, partnerships and monitoring
- 33. <u>Decides</u> that both Major Programme I and Major Programme IV shall continue to implement activities pertaining to arts education;
- 34. <u>Decides</u> to make the following changes to the draft resolution pertaining to Major Programme I in Volume 1 of document 36 C/5:
 - (a) paragraph 1(b) to read: "to use, when necessary, South-South and North-South-South cooperation, including through the South-South Cooperation Programme/Fund for Education, in the implementation of the plan of action for Major Programme I, and partnerships with civil society, the private sector and the United Nations system as modalities for delivery of the programme in order to:"
 - (b) paragraph 1(b)(i) to read: "accelerate progress towards EFA, in particular at the country level, by focusing on four critical aspects of education: sector-wide policy

and planning, literacy, teachers and skills development for the world of work. UNESCO will support Member States in developing national capacities to prepare and implement robust sector policies and plans, including through information and communication technologies; promoting and building the knowledge base for improving literacy policies and programmes; expanding the pool of qualified teachers and advocating that their working conditions be appropriate; and reforming technical and vocational education and training systems. In each of these priority areas, emphasis will be placed on promoting quality and equity, including gender equality;"

- (c) paragraph 1(b)(ii) to read: "support Member States in providing quality, inclusive and relevant education systems throughout life, from early childhood care and education through to primary and secondary education, as well as higher education and research. Throughout this work, particular attention will be paid to ensuring smooth transitions between the different levels of education and the achievement of a sustainable and measurable impact on education systems;"

- MLA 1: Promoting STI policies and access to knowledge
- MLA 2: Building capacities in the basic sciences, including through the International Basic Sciences Programme (IBSP), in engineering and for the use of renewable energy
- MLA 3: Mobilizing broad-based participation in STI

Biennial sectoral priority 2: Mobilizing science for the sustainable use of natural resources, renewable energy and energy efficiency, and for natural disaster reduction and mitigation

- MLA 4: UNESCO Intergovernmental Oceanographic Commission (IOC): strengthening IOC with a view to improving governance and fostering intergovernmental cooperation to manage and protect oceans and coastal zones for the benefit of its Member States
- MLA 5: Freshwater systems under stress and societal responses, incorporating the work of the International Hydrological Programme (IHP) and the World Water Assessment Programme (WWAP)
- MLA 6: Enabling the application of ecological and earth sciences for sustainability, including through the Man and the Biosphere (MAB) Programme and the International Geoscience Programme (IGCP)
- MLA 7: Natural disaster risk reduction and mitigation
- 36. Recognizes the flagship role of the biosphere reserves within the MAB Programme and their potential for contributing to sustainable development, climate change mitigation, and education for sustainable development;
- 37. <u>Agrees</u> to insert in document 36 C/5 Approved the following box on UNESCO's engineering initiative:

UNESCO Engineering Initiative

Engineering plays an important role in addressing complex challenges, such as climate change, natural disaster risk reduction, clean technologies, and access to affordable healthcare. Engineering is also critical in poverty eradication, as it encompasses the part of the science, technology and innovation (STI) spectrum in which the results of research are translated into concrete products and services that can benefit local communities and create jobs for youth. Strengthening engineering, in particular in the developing world, is thus a high priority.

Major Programme II is spearheading the launching of the UNESCO Engineering Initiative, which will focus on applications of engineering for sustainable development, and which will prioritize capacity building, particularly in Africa. Elements of the Initiative include:

- Strengthening engineering at universities, including enhancing research capacity, supporting curricular innovation, and forging better interaction with industry;
- Enhancing the focus on engineering in science policy work in cooperation with Member States:
- Catalysing South-South and North-South-South partnerships for engineering capacity-building;
- Strengthening efforts to mobilize civil society support for and understanding of engineering, including attracting youth to the field, with a focus on women and girls.

The UNESCO Engineering Initiative, cutting across all MLAs draws on the engineering-related strengths of Major Programme II, and will involve partnerships with different sectors of society, including academia, the private sector and NGOs. A campaign to raise extrabudgetary resources will be launched. Lessons learned in the 2012-2013 biennium will inform plans for engineering in the next Medium-Term Strategy.

The UNESCO Engineering Initiative falls under overarching objective 2 in document 34 C/4 "Mobilizing science knowledge and policy for sustainable development" and contributes to strategic programme objective 4 "Fostering policies and capacity-building in science, technology and innovation".

The following expected results of Major Programme II will be directly addressed by the Initiative: For Priority Africa: expected results 2 and 5; for gender equality: expected results 1 and 4; under MLA 1, expected result 2; under MLA 2, expected results 4, 5 and 6; under MLA 3, expected result 7; under MLA 4, expected result 12; under MLA 5, expected results 15, 16 and 18; under MLA 6, expected results 20, 23 and 24.

- 38. Requests the Director-General to include in document 36 C/5 Approved a detailed narrative text, with clear expected results concerning the intersectoral platform on UNESCO's contribution to the Mauritius Strategy for the Further Implementation of the 1994 Programme of Action for the Sustainable Development of Small Island Developing States (SIDS), and also to include a separate expected result on student research leadership and career mentoring for young researchers (cf. expected result 6 for Major Programme II);
- 39. <u>Further requests</u> the Director-General to make explicit reference to the Sandwatch project among the performance indicators and benchmarks for expected result 9;
- 40. <u>Also requests</u> the Director-General to include in the narrative of document 36 C/5 Approved a text highlighting the flagship nature of biosphere reserves under the MAB Programme;
- 41. <u>Decides</u> to amend the following expected results of the draft resolution pertaining to Major Programme II in Volume 1 of document 36 C/5 to read as follows:
 - (1) Strengthened and self-driven national STI systems and policies developed
 - (6) Member States' capacities strengthened to develop models for enhancing student research leadership and career mentoring for young researchers, through university networks and professional societies, in particular for developing countries
 - (8) Local and indigenous knowledge-driven sustainable development policies and actions developed, and appropriate support provided for implementation at the global, regional and local levels
 - (10) Peace-building enhanced through diplomacy and cooperation in the field of science
 - (12) Member States' understanding improved of the ocean environment and related processes in the global climate, and skills and national capacities developed for adaptation to climate change impacts

- MLA 2: Promoting a culture of peace and non-violence through action pertaining to human rights, democracy, reconciliation, dialogue and philosophy and including all political and social partners, in particular youth
- MLA 3: Supporting Member States in responding to social transformations by building and strengthening national research systems and promoting social science knowledge networks and research capacities
- 43. <u>Decides</u> to amend paragraph 1 (a) of the draft resolution pertaining to Major Programme III in Volume 1 of document 36 C/5 to read as follows:
 - 1. Authorizes the Director-General:
 - (a) to implement the plan of action for Major Programme III, structured around the following two biennial sectoral priorities and three main lines of action, with special emphasis on the needs of Africa, gender equality, youth and the most vulnerable segments of society, LDCs, SIDS, and countries in post-conflict and post-disaster situations in order to:

Biennial sectoral priority 1: Promoting the ethics of science and technology

(i) support prospective studies and foresight with respect to new and emerging ethical challenges, in particular within the framework of an ethical approach to sustainable development;

- (ii) promote existing standard-setting instruments in the field of bioethics (Universal Declaration on the Human Genome and Human Rights, International Declaration on Human Genetic Data, Universal Declaration on Bioethics and Human Rights) and science ethics (1974 Recommendation on the Status of Scientific Researchers and 1999 Declaration on Science and the Use of Scientific Knowledge) and support Member States in their implementation, and explore the appropriateness of a standard-setting instrument in ethical principles pertaining to climate change;
- (iii) build capacities to support the development of bodies, institutions and policies at the national level to enable developing countries to address the ethical challenges of science and technology, with particular reference:
 - to the role of national bioethics committees in enhancing the capacity of Member States at the national level to identify and address bioethical challenges with due regard to appropriate human rights and gender equality frameworks;
 - to the development of ethically grounded policies to respond to development challenges arising from converging technologies and global environmental change;
- (iv) ensure, through education and awareness-raising, that relevant audiences are familiarized both with key ethical challenges and with the resources available to address them, in particular through the maintenance and development of the online Global Ethics Observatory (GEObs) and the development and dissemination of appropriate pedagogical materials;
- (v) foster international, regional and national debate on ethical issues relating to the development of science and technology, especially bioethics, in particular through the work of the World Commission on the Ethics of Scientific Knowledge and Technology (COMEST) the International Bioethics Committee (IBC) and the Intergovernmental Bioethics Committee (IGBC);

Biennial sectoral priority 2: Supporting Member States in their responses to social transformations, notably to promote democracy and sustainable development for the consolidation of a culture of peace and non-violence

- (vi) address social transformations and other global challenges on the basis of human rights, particularly in the context of the social inclusion of vulnerable groups, respond to the social and human dimensions of global environmental change, supporting youth development and participation in society, and contribute to overcoming violence affecting youth and women;
- (vii) advance knowledge of human rights in the fields of competence of UNESCO, with particular emphasis on the right to enjoy the benefits of scientific progress and the right to freedom of expression for scientists and intellectuals, and contribute to human rights mainstreaming within the United Nations Development Group (UNDG) through training on the human rights approach to programming;
- (viii) foster the social inclusion of vulnerable populations through the MOST Programme and the implementation of UNESCO's Integrated Strategy to Combat Racism, Discrimination, Xenophobia and Related Intolerance by:
 - reinforcing capacities to design inclusive and democratic policies including at the level of local authorities, working through the coalitions of cities against

racism and discrimination and similar city networks, with particular reference to the situation of migrants;

- combating HIV and AIDS related discrimination;
- promoting analysis and studies of the gender-related impact of social transformations in order to support the design of targeted policies;
- (ix) develop innovative actions for the fostering of a culture of peace through enhancement of democratic processes, reconciliation and non-violence, with particular emphasis on:
 - the prevention of violence against women and girls, especially in conflict and post-conflict situations and the development of programmes in the area of the prevention of youth violence;
 - the role of youth as partners in national and community development, peace and non-violence by promoting a rights-based policy environment for successful transitions to adulthood and constructive social engagement, particularly through the implementation of the UNESCO Strategy on African Youth and by building on findings and best practices in this area in other regions, especially Latin America and the Caribbean;
 - the continued development of the organization of the UNESCO Youth Forum, benefiting from a review of past experiences;
- (x) foster philosophical reflection and capacities for critical thinking within contemporary societies so as to identify and analyse the current and emerging challenges that need to be addressed for the establishment of a robust culture of peace, in particular through the promotion of spaces of exchange and of the inclusion of philosophy teaching in formal and non-formal education;
- (xi) strengthen social science capacities, especially in developing countries, in order to mobilize the skills, capacities, knowledge and infrastructures that reside within the social sciences as drivers of growth and innovation, within a framework of social development and inclusion, particularly through the mechanisms and activities of the MOST Programme;
- (xii) promote inclusion in international agendas of the inherently social and human dimensions of global environmental change, drawing on the contributions of the social and human sciences and paying priority attention to the situation of LDCs and SIDS, notably with respect to climate-driven migration, in particular through the MOST Programme, the work of the World Commission on the Ethics of Scientific Knowledge and Technology (COMEST), cooperation with the International Social Science Council (ISSC), notably in connection with the Second World Social Science Forum and the World Social Science Report and United Nations processes including the United Nations Task Force on the Social Dimensions of Climate Change;
- (xiii) capitalize on the potential of sport for social transformation, social inclusion and development, and peace processes, working where appropriate through the Intergovernmental Committee on Physical Education and Sport (CIGEPS) and its advisory body, the Permanent Consultative Council (PCC):
 - by setting up strategic partnerships to promote the role and potential of sport as a developmental engine;

by providing advice and good practices to Member States in order to integrate
the social dimension of sport into public policy and programmes, particularly
with regard to physical education and community sport;

and engage in international efforts to tackle doping in sport through administration and monitoring of the International Convention against Doping in Sport, as well as continuing to provide technical assistance, policy advice and financial assistance to States Parties (with priority given to Africa, LDCs and SIDS) from the Fund for the Elimination of Doping in Sport for the implementation of effective anti-doping activities;

- 44. <u>Decides</u> to amend the following expected results of the draft resolution pertaining to Major Programme III in Volume 1 of document 36 C/5 to read as follows:

- (ii) increase awareness about heritage protection and conservation through the further development of an integrated and comprehensive information and knowledge management system, as well as through promotional and awarenessraising activities that enhance the visibility of the Convention, and to this end facilitate the greater involvement of young people, women, indigenous communities and vulnerable groups in World Heritage conservation;
- (iii) promote cultural and natural heritage conservation as a key vector for sustainable development, social cohesion, dialogue and peace in particular by working with States Parties to manage the impact of tourism, urbanization and climate change;
- (iv) undertake action to promote the inscription of under-represented regions and categories of heritage on the World Heritage List, and operational conservation projects in priority regions and countries, including for properties on the List of World Heritage in Danger and in post-conflict and post-disaster situations;
- (v) promote standard-setting activities for the protection of cultural objects by supporting the statutory meetings of High Contracting Parties to the 1954 Convention for the Protection of Cultural Property in the Event of Armed Conflict and of the Parties to its Second Protocol, as well as of the Committee for the Protection of Cultural Property in the Event of Armed Conflict established under

- the Second Protocol, and undertake capacity-building and awareness-raising activities at the international, regional and national levels;
- (vi) ensure the effective implementation of the 2001 Convention on the Protection of the Underwater Cultural Heritage by providing effective support to meetings of States Parties to the Convention; encouraging new ratifications and undertaking capacity-building and awareness-raising activities in Member States;
- (vii) ensure the reinforcement of the implementation of the 1970 Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property, and provide support to the meetings of States Parties to the Convention, as well as to the meetings of the Intergovernmental Committee for Promoting the Return of Cultural Property to its Countries of Origin or its Restitution in case of Illicit Appropriation;
- (viii) promote related awareness of and involvement in the UNESCO policy on fighting traffic in cultural property through capacity-building activities and information sharing, including the expansion, translation and updating of the UNESCO Database of National Cultural Heritage Laws;
- (ix) ensure the effective implementation of the 2003 Convention for the Safeguarding of the Intangible Cultural Heritage, by facilitating the decision-making process of its governing bodies and the advisory services of their subsidiary and consultative bodies; support and process requests for international assistance from the Fund for the Safeguarding of the Intangible Cultural Heritage;
- (x) enhance the safeguarding and transmission of the intangible cultural heritage by supporting States Parties in developing and/or strengthening national policies and human capacities in the field of the intangible cultural heritage; facilitate the participation of communities, practitioners, NGOs, non-profit making organizations, experts and centres of expertise in the implementation of the Convention, with a special focus on youth and women; implement international assistance-funded safeguarding activities; and effective utilization of best practices for public awareness and strengthened safeguarding capacities, targeting, in particular, youth and women;
- (xi) increase general awareness of the importance of the intangible cultural heritage and its safeguarding for sustainable development, social cohesion, dialogue and peace through further development of an integrated and comprehensive information and knowledge management system, as well as effective promotion of best practices of safeguarding;
- (xii) support the governing bodies of the 2005 Convention on the Protection and Promotion of the Diversity of Cultural Expressions through the timely organization of statutory meetings and analysis of the periodic reports provided by States Parties, as well as through ensuring the effective management of the International Fund for Cultural Diversity, and the further development of knowledge management resources and tools;
- (xiii) develop awareness-raising activities to enhance the visibility of the Convention and further increase the number of States Parties to it; support the development and strengthening of policies that promote the creation, production, distribution and enjoyment of cultural expressions, as well as the development of cultural industries at the national level; and collect and disseminate best practices in this regard;

- (xix) demonstrate the role of cultural expressions, arts education and heritage in fostering dialogue and social cohesion, especially in post-conflict and post-disaster contexts, paying special attention to the needs of youth;
- (xx) promote the pedagogical use of the UNESCO general and regional histories, in particular the *General History of Africa* through the production of teaching materials and their integration into school curricula;
- (xxi) consolidate efforts to promote dialogue among cultures and increase awareness of cultural interactions, following on from the International Year for the Rapprochement of Cultures (2010), through flagship projects such as the Slave Route project, the intersectoral initiative Rabindranath Tagore, Pablo Neruda and Aimé Césaire for a Reconciled Universal, the Arabia Plan and the Roads to Independence: the African Liberation Heritage project;
- (xxii) promote multilingualism and enhance the intercultural skills of youth through information and communication technologies (ICTs);

- MLA 1: Promoting an enabling environment for freedom of expression in order to foster development, democracy, and dialogue for a culture of peace and non-violence
- MLA 2: Strengthening free, independent and pluralistic media, civic participation and gender-responsive communication for sustainable development

Biennial sectoral priority 2: Fostering information and communication capacities for universal access to knowledge to bridge the digital divide

- MLA 3: Supporting Member States in empowering citizens through universal access to knowledge and the preservation of information, including documentary heritage
- 51. <u>Decides</u> to amend paragraph 1(a) of the draft resolution pertaining to Major Programme V in Volume 1 of document 36 C/5 to read as follows:
 - 1. Authorizes the Director-General:
 - (a) to implement the plan of action for Major Programme V, structured around the two biennial sectoral priorities and three main lines of action mentioned below while ensuring priority to Africa, gender equality and youth. Emphasis will also be placed on least developed countries (LDCs), small island developing States (SIDS), indigenous peoples and countries in post-

conflict and post-disaster situations. The Communication and Information Sector will continue to develop partnerships with civil society, the private sector and other United Nations agencies, and to promote South-South and North-South cooperation;

Biennial sectoral priority 1: Promoting freedom of expression and information

- (i) Promote the free flow of ideas by sensitizing governments, public institutions and civil society to strive towards freedom of expression and freedom of the press as a central element in building strong democracies, for example, through the annual celebration of World Press Freedom Day and the awarding of the UNESCO-Guillermo Cano World Press Freedom Prize, while recognizing that the principle of freedom of expression must be applied not only to traditional media, but also to the Internet;
- (ii) Encourage governments to develop legislative instruments to defend freedom of expression, press freedom and freedom of information as basic human right. Provide support for the development of free, independent and pluralistic media, especially in countries in transition, as well as in conflict and post-conflict areas;
- (iii) Monitor the status of press freedom and safety of journalists, with emphasis on cases of impunity for violence against journalists, including monitoring the judicial follow-up through the Intergovernmental Council of the International Programme for the Development of Communication (IPDC). Build gender-sensitive capacities of media professionals to enable them to apply the highest ethical and professional standards, particularly in the application of best practices with regard to investigative journalism and reporting on elections;
- (iv) Foster dialogue, cultural expression, mutual understanding, peace and reconciliation, particularly in conflict-sensitive situations, and assist in the creation of enabling environments for freedom of expression, freedom of information and independent media. Build capacities of the media to report on disaster risk reduction and humanitarian action in post-disaster environments;
- (v) Assist with the development of free, independent and pluralistic media in developing countries and those in transition through the International Programme for the Development of Communication (IPDC). Support Member States in addressing media development needs in a strategic manner through multi-stakeholder assessments based on the UNESCO Media Development Indicators;
- (vi) Promote community media as learning platforms for development, and in particular for the involvement of marginalized groups, especially marginalized women, in democratic debate. Increase the level of United Nations inter-agency collaboration on communication for development at the country level;
- (vii) Build capacities of journalism training institutions to offer high quality journalism education based on the relevant UNESCO model curricula, the UNESCO criteria for institutional excellence in this field and the experience gained from media and broadcasting institutions. Improve science literacy among journalists to enable informed reporting on issues impacting on sustainable development;

(viii) Foster media and information literacy, particularly through teacher training institutions, and in partnership with broadcasting associations and media organizations as a larger civic education movement. Improve media and information literacy among user-generated content producers and users, and contribute to setting standards in user-generated content for publiclyfunded media organizations;

Biennial sectoral priority 2: Fostering communication and information capacities for universal access to knowledge to bridge the digital divide

- (ix) Support actions that help reduce the digital divide and promote opportunities to access information and communications technologies (ICTs) and the use of the Internet for development. Particularly develop and foster partnerships with both public and private sectors to address and diminish the digital divide and the gap between men and women, households, businesses and geographic areas at different socio-economic levels of this divide, including the needs of disabled persons. Coordinate UNESCO's role in the Broadband Commission for Digital Development, recognizing the importance of broadband for development;
- (x) Promote the application of ICTs to enhance the quality of and access to education, including the stimulation of production, sharing and access to open educational resources (OERs) and to build scientific knowledge through the promotion of open access to scientific research results;
- (xi) Promote multilingualism in cyberspace;
- (xii) Harness ICTs to endow local communities with the means to promote their heritage and cultural expressions;
- (xiii) Contribute to increasing the access of developing countries to and participation in the development of free and open-source software (FOSS) and open standards;
- (xiv) Protect and digitize documentary heritage through the Memory of the World Programme, and promote the preservation and safeguarding of original material, including through the Memory of the World Register and the UNESCO/Jikji Memory of the World Prize;
- (xv) Strengthen digital preservation and develop principles which should guide digitization;
- (xvi) Foster and strengthen libraries and archives as contributors to knowledge societies, and build the capacities of information professionals. Further strengthen the World Digital Library to make rare and unique documents from libraries and cultural institutions all over the world available online, free of charge;
- (xvii) Reinforce the international and national outreach of the Information for All Programme (IFAP) and assist Member States in elaborating and implementing national information policy frameworks for universal access to information;

 - (b) Amend paragraph 7 in section A to read as follows:
 - "7. Requests should be submitted as soon as possible at the beginning of the biennium and no later than the deadline set for the submission of requests, 28 February 2012, except for requests for emergency assistance or a regional project, which may be submitted at any time in the biennium;"
 - (c) Amend paragraph 8 in section A to read as follows:
 - "8. The Secretariat shall advise Member States of the response by the Director-General to the requests within three months of the deadline of 28 February 2012;"
 - (d) Add in section A after the first paragraph, a new paragraph to read as follows:
 - "2. Under the Participation Programme, priority will be given to proposals submitted by least developed countries (LDCs), developing countries, postconflict and post-disaster countries, small island developing States (SIDS), countries in transition and middle income countries:"

- (e) Amend paragraph 11 in section A to read as follows:
 - "11. Total amount of assistance. Whichever of the above forms of assistance is requested, the total value of the assistance provided for each request shall not be in excess of \$26,000 for a national project or activity, \$35,000 for a subregional or interregional project or activity, and \$46,000 for a regional project or activity. The financial provision made by the applicant must be sufficient to implement the activity satisfactorily. The activity must be executed and all funds disbursed in accordance with the Financial Regulations of the Organization. The expenditures must be made according to the distribution of the budget as approved by the Director-General and communicated to Member States in the letter of approval;
- (f) Amend subparagraph 15 (a) in section C to read as follows:
 - "(a) Emergency assistance may be accorded by UNESCO when:"
- (g) Add a new subparagraph in section C under paragraph 15 (c) to read as follows:
 - "(iv) Emergency assistance in cash or kind should correspond to the urgent needs as identified by the Member States;"
- (h) Amend subparagraph 15 (e) in section C to read as follows:
 - "(e) the total budget for any emergency assistance project shall not exceed \$50,000; it may be supplemented by extrabudgetary funds identified for this purpose or other sources of funding;"
- (i) Amend subparagraph 16 (d) in section C to read as follows:
 - "(d) the Secretariat shall report to the Member State on the assistance and the amounts it envisages providing and the follow-up, if any, which could be considered; the total value of the assistance provided shall not be in excess of \$50,000;
- (j) Under Part II, add a new subparagraph after subparagraph (d) to read as follows:
 - "(e): to seek extrabudgetary funds to supplement the emergency assistance programme for 2012- 2013 as needed;"

II - Budget issues

- 1. Having examined the Draft Programme and Budget for 2012-2013 (36 C/5),
- Recalling 185 EX/Decision 17,
- 3. <u>Noting</u> that the budgeting techniques are in accordance with 35 C/Resolution 105, and that the introduction of a results-based budgeting approach is not feasible at this time, but will be considered for document 37 C/5,
- 4. <u>Welcomes</u> the efforts made by the Director-General to increase resource allocations to the five major programmes, to rationalize the financial resources allocated to central services and parts of the budget other than Part II.A, as well as to increase decentralized resources;

- 5. <u>Notes</u> that other funding sources will be identified for Phase II of the Medium-Term Security Plan in accordance with 185 EX/Decision 30, and that a recommendation will be submitted to the Executive Board at its 187th session;
- 6. Also notes that the Director-General is proposing to absorb the additional costs, within the context of document 36 C/5, associated with the proposal to reform the MBF contribution system in 2012-2013, as well as Phase 1 of the Director-General's proposal for the reform of the field network:
- 7. Further notes that a lapse factor of 3% is applied to staff costs;
- 8. <u>Urges</u> the Director-General to move further towards the definition of expected results and the establishment of benchmarks which are outcome- and impact-based;
- 9. Requests the Director-General to submit to it at its 187th session an alternative budget option based on the \$653 million budget ceiling to enable comparison with the present version of the draft budget, taking into account discussions on this matter at the 186th session, the current global economic slowdown, and the United Nations efforts to reduce its own budget.

- 3. Having examined document 186 EX/16,
- 4. <u>Notes</u> that the outline submitted by the Secretariat follows the format agreed to by the Board at its 182nd session;
- 5. <u>Invites</u> the Director-General to submit to it for consideration at its 187th session a draft report, comprising decisions taken by it, as outlined in Annex I to document 186 EX/16, integrating relevant decisions taken, and in the light of the discussions held at its 186th session.

Recommendations of the Executive Board's Ad Hoc Working Group on the Independent External Evaluation of UNESCO

The Executive Board,

- 1. Recalling 35 C/Resolution 102 and 185 EX/Decision 18,
- 2. <u>Having examined</u> the report on the independent external evaluation of UNESCO as contained in documents 185 EX/18 and Add.,

I. Increasing UNESCO's focus

- 3. <u>Acknowledging</u> the need for a greater focus of UNESCO's programme, based upon its constitutional mandate, within the scope of its overarching/strategic programme objectives and bearing in mind its five recognized functions,
- 4. Recognizing the need to strengthen UNESCO's focus with a view to allocating a critical mass of its budgetary resources to activities permitting the attainment of relevant expected results and a clear impact,
- 5. <u>Underscoring</u> the need to define ways and procedures to achieve greater focus in all UNESCO Programmes as well as in the field,
- 6. Recommends that the General Conference adopt, at its 36th session, a limited number of strategic objectives, taking into account relevant internationally agreed development goals, including the Millennium Development Goals (MDGs), and other United Nations goals, with which programmes should be associated, in order to maximize impact;
- 7. <u>Further recommends</u> that the General Conference adopt, at its 36th session, a four-year programming cycle and an appropriate revision mechanism, with a view to increasing stability and coherence and enhancing the collaboration of UNESCO with its Member States in implementing the programme and mobilizing extrabudgetary resources, while maintaining a two-year budgetary programme;
- 8. <u>Propose</u> to the General Conference, at its 36th session, that the new C/5 document be informed by a Medium-Term Strategy (C/4), presented in a brief, succinct manner, of a rolling nature with an eight-year time frame;
- 9. <u>Decides</u> to develop, in the context of the proposed four-year programming cycle, a programme and timetable of work for the preparation and monitoring of the C/5 and C/4 documents to be submitted for adoption to the General Conference at its 37th session;
- 10. <u>Also decides</u> to adopt more detailed terms of reference and clear methods of work for its C/4 and C/5 drafting groups at the time of their establishment;
- 11. <u>Recommends</u> that the three organs of UNESCO systematically apply clear, precise criteria when introducing new and maintaining existing programmes in the C/5 document, such as, *inter alia*:
 - (a) alignment with the overarching/strategic programme objectives;

- (b) determination of the capacity to deliver and the probability of real impact through assessment of the budgetary and human resources available;
- (c) delineation and comparative advantage as well as complementarity with the activities of United Nations partners;
- (d) formulation of exit strategies and sunset provisions;
- (e) periodic assessment of programmes, their implementation rates and exit strategies based on decision-oriented evaluations;
- 12. <u>Invites</u> the Director-General to ensure that the above-mentioned criteria are also applied to activities financed through extrabudgetary funds, and that such activities are subject to accountability measures;
- 13. <u>Further invites</u> the Director-General to promote intersectorality in programme development and implementation in order to reinforce synergies;
- 14. Requests the Director-General to conduct a comprehensive review of the consultation process on the C/4 and C/5 documents with a view to enhancing priority-setting, allowing informed decision-making, and properly reflecting the opinions of Member States, and therefore invites the Director-General to propose a new consultation process to the Executive Board at its 187th session which includes a quantitative approach (i.e. through allocation of points) as well as a qualitative approach (i.e. based on an analysis of evaluation results);
- Further requests the Director-General to ensure that regional consultations on the C/5 document are addressed to Member States, including their National Commissions, with no additional cost implications;
- 16. <u>Calls</u> on the Director-General to further strengthen results-based management by:
 - (a) providing information in the C/5 document that is in conformity with recommendation 3 of 33 C/Resolution 92:
 - (b) ensuring that expected results are, where possible, expressed in terms for which the Organization can be held accountable;
 - (c) reinforcing the current process towards better reports on the execution of the programme EX/4 documents in line with 34 C/Resolution 89 and 176 EX/Decision 29, including through the provision of an executive summary in these documents.

II. Positioning UNESCO closer to the field

- 17. Acknowledging the need to position UNESCO closer to the field,
- 18. <u>Decides</u> to ensure that the introduction of the field network architecture is based on the principles referred to in 185 EX/Decision 29, notably in paragraphs 4 and 5, and is implemented with the necessary flexibility;
- 19. <u>Requests</u> the Director-General to further ensure the effectiveness of the field network architecture by, *inter alia*, responding to the specific needs and context of each region and subregion, while bearing in mind efforts to increase UNESCO's focus;
- 20. Also requests the Director-General to:

- (a) ensure policy coherence between country-level, subregional, regional and global priority-setting, planning, implementation, monitoring and reporting activities, while maintaining a coherent results-based approach;
- (b) define clearly the specific responsibilities, roles and expected outcomes of entities at all organizational levels – including category 1 institutes – as well as the expected synergies between levels;
- outline clearly the intended reporting line and chain of command in the proposed new field network architecture, and update the tables of authority and accountability as required;
- (d) strengthen the coordination and synergy between Headquarters and field offices;
- (e) ensure an ongoing evaluation process of the reform of the field network so as to identify necessary adjustments if required, in addition to a comprehensive review and evaluation of the proposed new field structure and its impact (x) years after its implementation;
- (f) ensure the provision of the necessary professional skills and competencies (both managerial and programmatic) required to meet the high quality standards necessary for the successful implementation of the strengthened field presence;
- (g) include in the new human resources strategy the necessary provisions and incentives to facilitate an effective and results-oriented implementation of the proposed new field structure;
- (h) provide a detailed estimate of the costs of the proposed new field structure;

III. Strengthening UNESCO's participation in the United Nations

- 21. <u>Acknowledging</u> the need for a stronger UNESCO engagement, better coordination and greater convergence with other United Nations agencies,
- 22. <u>Decides</u> to work with the Director-General and the General Conference to strengthen UNESCO's participation in the United Nations system and its contribution to system-wide coherence in order to improve UNESCO's effectiveness and positioning as a more significant actor within the United Nations;
- 23. <u>Invites</u> the Director-General to further strengthen the effectiveness of UNESCO's participation in joint United Nations planning and implementation processes at all organizational levels, as well as in the harmonization of business practices;
- 24. Recommends, in accordance with United Nations General Assembly resolution 63/232, the alignment of UNESCO's programme cycle with the new quadrennial comprehensive policy review of operational activities for development of the United Nations system, while bearing in mind efforts to increase UNESCO's focus;
- 25. <u>Requests</u> the Director-General to provide periodically information to the Executive Board on UNESCO's participation in United Nations coordination mechanisms and on inter-agency collaboration;
- 26. Also invites the Director-General to provide, when reporting on the field network, a clear definition of the role of the UNESCO liaison offices to the United Nations in New York and Geneva, as well as of the role of the newly established liaison offices with the African Union and the European Union:

- 27. <u>Further requests</u> the Director-General to develop a communication mechanism to provide Member States with systematic updates on the work of the liaison offices in New York and Geneva on issues related to UNESCO's mandate, with a view to enhancing policy coherence;
- 28. <u>Encourages</u> the Director-General to continue implementing the policies of geographical mobility and of inter-agency mobility within the United Nations, as well as developing the lists of competencies required for the posts of United Nations resident coordinators.

IV. Strengthening governance

- 29. Recalling the distinctive roles and responsibilities of the three organs of the Organization as defined by UNESCO's Constitution, and the need to avoid duplication, disconnect and responsibility drift,
- 30. Recognizing the complexity of translating these roles into clear-cut procedures and practices in the daily running of the Organization,
- 31. Recalling its overall executive role and the need to avoid impinging on the managerial and implementational role of the Secretariat,
- 32. <u>Underscoring</u> Article VI.5 of the Constitution, which states that "Each State Member of the Organization undertakes to respect the international character of the responsibilities of the Director-General and the staff, and not to seek to influence them in the discharge of their duties",
- 33. <u>Acknowledging</u> the need to further reform the Organization, and strengthen and enhance the coherence of governance within UNESCO with the aim of achieving the following:
 - (a) strengthening the role of the General Conference in strategy and policy formulation, priority-setting and decision-making;
 - (b) strengthening the participation of Member States in the work of UNESCO, *inter alia*, through programme delivery, strategic direction for the Secretariat, and enhancement of international cooperation;
 - (c) strengthening the monitoring role of the Executive Board in the execution of UNESCO's programmes, including follow-up to the recommendations of all evaluations:
 - (d) improving the quality and relevance of decisions by ensuring the provision of substantive, evidence-based information for the General Conference and Executive Board discussions;
- 34. <u>Invites</u> the Director-General to develop, in consultation with the Executive Board and the General Conference, an accountability framework for the relations between the governing bodies and the Secretariat;
- 35. Also invites the Director-General to submit to it at its 189th session a proposal for the establishment of a pilot monitoring mechanism involving representatives of Member States and the Secretariat to identify differences in expectations, duplications of functions and other "grey areas" in the interaction between the governing bodies and the Secretariat, in order to improve their working relations and enhance the efficiency of the Organization;

- 36. <u>Further invites</u> the Director-General to formally submit to the governing bodies relevant new initiatives within their prerogative prior to taking action;
- 37. <u>Encourages</u> the Director-General to make better use of the information meetings of the Secretariat by allowing, through consultations with regional groups, Member States to identify periodically the subjects which they would like to discuss;
- 38. <u>Requests</u> its Chairperson to convene a half-day special session of the Executive Board, when required, for the Director-General to consult the Board under the terms of Rule 59 of its Rules of Procedure;
- 39. <u>Decides</u> to organize the sessions and draw up the agendas of the General Conference with different tasks for each of its biennial sessions, calibrated to the requirements of managing a four-year programming cycle;
- 40. <u>Proposes</u> that the General Conference consider some items, upon recommendation of the Executive Board, without a preliminary debate, proceeding directly to the examination of the draft resolution texts, unless a Member State requests that such a debate takes place;
- 41. <u>Invites</u> the Director-General to present all decisions of the governing bodies of international and intergovernmental programmes and UNESCO international conventions having financial implications for the C/5 document in a single, well-structured report;
- 42. <u>Recommends</u> that the General Conference merge its ADM Commission (Finance and Administration) and its PRX Commission (General Questions, Programme Support and External Relations), on an experimental basis;
- 43. <u>Also recommends</u> that the General Conference formalize within its Rules of Procedure the current practice whereby programme commissions submit to plenary draft resolutions to amend the C/4 and C/5 documents;
- 44. Requests that the recommendation that draft resolutions with financial implications clearly identify the main line of action (MLA) from which the resources should come be made an admissibility criterion for such draft resolutions;
- 45. <u>Also decides</u> to organize its sessions and draw up its agendas with different tasks covering, *inter alia*, the major programmes for each of its sessions consistent with the requirements of managing a four-year programming cycle, and develop a biennial programme for its thematic plenary debates;
- 46. <u>Further decides</u> to increase the number of items discussed in joint meetings of the Programme and External Relations (PX) and Finance and Administrative (FA) Commissions in order to avoid duplication and unnecessary repetition of debates;
- 47. Requests the Director-General to propose to it at its 187th session a quality framework for Executive Board documents to ensure concise, analytical and action-oriented reports, taking into account all previous decisions, in particular 179 EX/Decision 19;
- 48. Requires, notwithstanding the right of Member States to present amendments, all substantive amendments to draft decisions to be provided in writing, and to be projected on-screen during the debates in the commissions, in order to improve the quality of Executive Board decisions;
- 49. <u>Decides</u> to ensure that draft decisions relating to the C/4 and C/5 documents be agreed in the respective commissions of the Executive Board prior to their consideration by the

- Drafting Group, thus ensuring that no new draft decisions are introduced in the meetings of the latter;
- 50. Also decides to adopt criteria similar to those of the General Conference for draft decisions aimed at amending the C/5 document at sessions of the Executive Board;
- 51. <u>Further decides</u> to suspend the work of the Group of Experts on Financial and Administrative Matters from the Board's 188th session, for an experimental period of two years;
- 52. <u>Decides</u> to establish, at its 188th session, on an experimental basis, an Ad Hoc Group with enhanced participation by all UNESCO Member States to support the preparation of the two plenary commissions of the Executive Board session, as described in the Annex;
- 53. Requests the Director-General to submit a comprehensive report on the UNESCO Secretariat accountability framework and its monitoring and evaluation mechanisms;
- 54. <u>Invites</u> the Director-General to put in place a change management team to ensure coherent implementation of the overall reform of the Organization.

V. Developing a partnership strategy

- 55. <u>Acknowledging</u> the need for UNESCO to develop a comprehensive policy and accountability framework for strategic partnerships that looks outwards to civil society, expert communities and the private sector,
- 56. <u>Invites</u> the Director-General to develop, in close cooperation with Member States, a draft comprehensive and outward-looking UNESCO policy framework for strategic partnerships, to be submitted to it at its 187th session for transmission to the General Conference at its 36th session:
- 57. <u>Encourages</u> the Director-General to take stock of and critically assess UNESCO's experience in working with different categories of partners, in order to base the comprehensive policy framework for strategic partnerships on lessons learnt and examples of good practices;
- 58. <u>Suggests</u> that the Director-General include in the comprehensive policy framework distinct strategies for each category of partners, within the entire range of UNESCO's programmes, as well as specific measures:
 - (a) to reach out to the range of partners of strategic interest to UNESCO, including IGOs, NGOs, civil society, expert communities, the private sector and other partners;
 - (b) to cover all forms of cooperation, including advisory functions to UNESCO, programme implementation and funding;
 - (c) to identify clear and objective criteria for the selection, approval and renewal of partnerships which, *inter alia*, allow the Director-General to respond quickly to partnership opportunities;
 - (d) to identify key elements to be included in all partnership agreements, including specific objectives, cooperation modalities, funding and accountability arrangements, duration and criteria for periodic evaluation of the cooperation and its impact;

- (e) to strike a better balance in partnerships from different regions, in particular from the South;
- 59. <u>Decides</u> to consider reviewing the mandate and working methods of the NGO Committee in order to make its work more focused;
- 60. Also invites the Director-General, in the interest of full transparency, to make available on the Internet updated information on all partnerships, and to report biennially to the Executive Board on activities under the comprehensive policy framework for strategic partnerships, including UNESCO funding to/from partners, an assessment of the outcome and impact of partnerships, the challenges identified, and the corrective measures taken:
- 61. Requests the Director-General to provide, in the course of the next biennium, a full overview of all UNESCO networks and the initiatives undertaken to strengthen the overall management of UNESCO's networks, with a view to optimizing the impact and value of the latter:
- 62. <u>Also decides</u> to ensure that the future human resources strategy takes into account, both in recruitment criteria and in training provisions for existing staff, the specific competencies required to interact professionally with the full range of UNESCO's diverse partners, and to successfully manage UNESCO's networks.
- 63. <u>Underlines</u> the important and unique role of the National Commissions in liaising with national partners and civil society;
- 64. <u>Calls upon</u> the Director-General to ensure that relations between the Secretariat and National Commissions are conducted in accordance with Article VII of the Constitution.

ANNEX

Parameters for an ad hoc group of the Executive Board

I. Mandate

- 1. The final mandate of the ad hoc group, to be established under Rule 17 of the Rules of Procedure of the Executive Board, will be determined by the Executive Board at its 188th session. Ideally, the mandate would be to examine a limited number of items (determined well in advance through consultations between the Chairpersons of the Executive Board, the Programme and External Relations (PX) and Finance and Administrative (FA) Commissions and the ad hoc group) so as to assist in the preparation of Executive Board discussions.
- 2. The items to be considered could include, *inter alia*, following examination, where appropriate, of information and documentation supplied by the Secretariat, the following:
 - (a) examination of information provided by the Director-General on the execution of the programme and related budget issues (contained in the EX/4 document), including intersectoral and extrabudgetary activities, as well as evaluations and their policy recommendations;
 - (b) preparations for and follow-up to major conferences and world reports, as required;

- (c) analysis of challenges and recommendations, as required, and how to address them through the ongoing programme implementation and in the planning of the future programme cycle;
- (d) preparation of substantive input to the draft Executive Board report to the General Conference on the implementation of the C/5 document (document C/9).

II. Working methods

- 3. The ad hoc group shall comprise 18 Board Members (3 from each electoral group) with enhanced participation by all UNESCO Member States.
- 4. The dates of the meetings of the ad hoc group shall be determined so as to ensure that the results of its work are transmitted to Members of the Executive Board at least 10 working days before the opening of the session.
- 5. The duration of the Ad Hoc Group's meetings shall be determined by the Board, taking into account the general organization of its work and the related budgetary allocations.
- 6. The ad hoc group shall work in English and French.
- 7. The States Members of the Executive Board designated as members of the ad hoc group which do not have a permanent delegation in France may request financial assistance to facilitate their participation in the work of the group.
- 8. Concerning questions falling within its competence, the ad hoc group may invite representatives of international organizations and relevant official partners, as well as qualified persons.

- Recognizing the importance of the comprehensive policy review, through which the United Nations General Assembly establishes key system-wide policy orientations for the development cooperation and country-level modalities of the United Nations system, as well as the desirability that UNESCO's Medium-Term Strategy reflect those orientations, as appropriate,
- 3. <u>Also recalling</u> the recommendations of the Executive Board's Ad Hoc Working Group on the Independent External Evaluation of UNESCO, in particular those related to strengthening UNESCO's participation in the United Nations and increasing its focus,
- 4. <u>Having examined</u> the reports contained in documents 185 EX/19 and 186 EX/17, in particular Part III of the latter and the scenarios discussed therein, as well as their respective implications,
- 5. Recommends that the General Conference, at its 36th session:
 - (a) extend the C/4 cycle from six to eight years in 2014, starting with document 37 C/4, with an appropriate mechanism for adjusting to the most recent quadrennial comprehensive policy review;
 - (b) maintain the rolling character of UNESCO's Medium-Term Strategy so as to ensure that the substance and directives of two consecutive quadrennial comprehensive policy review documents be reflected in the Organization's strategic documents, as appropriate;
 - (c) extend the C/5 programme cycle from two to four years, starting with document 37 C/5 from 2014, with an appropriate mechanism for adjustments every two years;
 - (d) maintain the biennial cycle for the budget of the C/5 document;
- 6. Requests the Director-General to submit to it at its 187th session a report on the modalities for introducing the changes outlined in paragraph 5 of this decision.
- 7. <u>Calls on</u> the Director-General, when implementing these changes throughout the programming cycle, to pay particular attention to the need to improve the division of labour and complementarity with other United Nations agencies;
- 8. <u>Invites</u> the Director-General to continue to present, in her reports on UNESCO's participation in United Nations coordination mechanisms and on inter-agency collaboration, the results of the enhanced cooperation with other agencies of the United Nations system, as well as the main challenges encountered;

9. <u>Decides</u> to inscribe this item on the provisional agenda of the 36th session of the General Conference and to schedule its examination before that of the preliminary proposals for documents 37 C/4 and 37 C/5 in the commissions.

Requests the Director-General to ensure that appropriate internal control procedures are in place and that all managers involved in recruitment have an adequate knowledge of and respect the principles and regulations governing recruitment at UNESCO, and to effectively implement strengthened accountability measures for managers involved in the recruitment of staff and consultants;
- 7. <u>Notes</u> with concern that agreed separations have been routinely paid with the maximum termination indemnities allowed by the Staff Regulations and Staff Rules;
- 8. Requests the Director-General to review these cases, reducing the payments, when such payments are in the interest of UNESCO, to the minimum reasonable amount, and ensuring that such agreed separations are in the best interests of the efficient management of the Organization;

Requests the Director-General to prepare and submit, as soon as possible, amendments to the Statutes of the Fund for consideration by it at its 187th session and possible adoption by the General Conference at its 36th session, taking into account the discussions at its 186th session and following consultation of the regional groups;

- 8. <u>Welcoming</u> the programmatic direction proposed by the Director-General in the introduction to document 36 C/5 that the time "has come for UNESCO to move decisively from efficiency to effectiveness, from an input-related approach to an impact-focused programme",
