The Executive Board,

1. Having examined the Director-General's report on donations and special contributions received since the beginning of the biennium and appropriated to the regular budget,

the transfers made between appropriation lines, as well as proposed transfers to reflect organizational restructuring, in accordance with 35 C/Resolution 106, paragraphs 2 (b), (d) and (e), and document 185 EX/4 Part II,

2. Notes that the Director-General has, as a consequence of these donations and special contributions, increased the appropriations to the regular budget by a total of **\$2,173,084** as follows:

Recalling 34 C/Resolution 80 and 35 C/Resolution 92 whereby the Director-General is authorized to continue to apply to the staff of UNESCO the measures affecting the salaries, allowances and other benefits that may be adopted either by the United Nations General Assembly or, by virtue of the authority conferred upon it, by the International Civil Service Commission (ICSC), and the provision of paragraph 2 (d) of the Appropriation Resolution for 2010-2011 by virtue of which the Director-General is authorized, with the prior approval of the Executive Board, to make transfers from Part IV of the budget (Anticipated Cost Increases) to the relevant appropriation lines in Parts I to III for the purpose of meeting increases in staff costs,

**Implementation of 35 C/Resolution 49 and 184 EX/Decision 5 (IV)  
relating to the Ascent to the Mughrabi Gate in the Old City of Jerusalem**

N.B. After considering this item and following a vote taken by roll-call, with 31 votes in favour, 5 votes against and 17 abstentions, the United States of America having voted against, the Programme and External Relations Commission recommended that the Executive Board adopt the following draft decision:

The Executive Board,

1. Having examined document 185 EX/5 Add.,
2. Recalling document 182 EX/5 (V),
3. Recalling 176 EX/Special Plenary Meeting/Decision, 177 EX/Decision 20, 179 EX/Decisions 9 and 52 and 184 EX/Decision 5 (IV),
4. Further recalling Decisions 31 COM 7A.18, 32 COM 7A.18 and 33 COM 7A.18 adopted by the World Heritage Committee at its 31st (Christchurch, 2007), 32nd (Quebec City, 2008), 33rd (Seville, 2009) and 34th (Brasilia, 2010) sessions respectively,

5. Also recalling the relevant provisions on the protection of cultural heritage, including the four Geneva Conventions (1949), the relevant provisions of the 1907 Hague Regulations on Land Warfare, the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict of 1954, the Convention for the Protection of the World Cultural and Natural Heritage of 1972, the inscription of the Old City of Jerusalem and its Walls at the request of Jordan on the World Heritage List (1981) and on the List of World Heritage in Danger (1982), and the recommendations, resolutions and decisions of UNESCO,
6. Recalling the Advisory Opinion of the International Court of Justice in the case concerning “the Legal Consequences of the Construction of a Wall in the Occupied Palestinian Territory” regarding the applicability of the four Geneva Conventions (1949) in the Occupied Palestinian Territory and the related duties of the United Nations and its specialized agencies thereon,
7. Reaffirming the purpose and spirit of the professional encounter at the technical level of 13 January 2008, as well as of the follow-up meeting of 24 February 2008,
8. Noting the Sixth Reinforced Monitoring Reports (February 2009) prepared by the World Heritage Centre,
9. Deeply regretting in this regard, the postponement of the follow-up meeting of experts which was scheduled for 12 November 2008, as called for in Decision 33 COM 7A.18 adopted by the World Heritage Committee in Seville and reiterated in 182 EX/Decision 5 (II), as well as of the planned visit of Jordanian technical experts to the Mughrabi Ascent site on 27 July 2009, and requested visits of 17 December 2009 and 9 March 2010 due to the repeated denial of access by Israeli authorities, to Jordanian technical experts to the Mughrabi Ascent site, to enable them to conduct the required measurements to finalize the Jordanian design in accordance with the World Heritage Committee decision (33 COM 7A.18) adopted in Seville and reiterated in 182 EX/Decision 5 (II),
10. Recognizing the deep concerns regarding the decision taken by the Jerusalem District Planning and Construction Commission on the town planning scheme for the Mughrabi Ascent,
11. Requests that, despite the decision mentioned in paragraph 10, the process for the design of the Mughrabi Ascent be inclusive of all parties concerned, in accordance with obligations and duties of such parties as stipulated in the content of previous World Heritage Committee decisions;
12. Reaffirms in this regard that no measures, unilateral or otherwise, should be taken which will affect the authenticity and integrity of the site, in accordance with the Convention for the Protection of the World Cultural and Natural Heritage of 1972 and the relevant provisions on the protection of cultural heritage of the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict of 1954;
13. Notes the request made by the World Heritage Committee at its 33rd session in Decision 33 COM 7A.18 and asks, in this regard, that the Israeli authorities resume cooperation with all concerned parties, in particular with Jordanian and Waqf experts;
14. Deeply regrets that Israel continues to act unilaterally in disregard of the relevant provisions of the instruments mentioned in paragraph 5 and Decision 33 COM 7A.18 adopted by the World Heritage Committee at its 33rd session (Seville, 2009), and 182 EX/Decision 15, and contrary to the purpose and spirit of the technical professional encounter of 13 January 2008, as well as the follow-up meeting of 24 February 2008,

which aimed at finding an accepted coordinated and monitored solution concerning the Mughrabi Ascent among all parties concerned;

15. Reaffirms the necessity of Israel's cooperation in order to arrange for access to the Mughrabi Ascent site for Jordanian and Waqf experts, and reiterates its call on the Director-General to organize a follow-up meeting of experts as soon as possible, once the parties concerned have reached an understanding;
16. Reaffirms that the UNESCO mandated process for designing of the Mughrabi Ascent, which allows for taking into consideration the designs submitted during the aforementioned professional encounter, is still under way and that the World Heritage Centre is following closely the developments associated with this process through its reinforced monitoring mechanism;
17. Calls upon Israel to enable the necessary access to the site to Jordanian and Waqf experts, most notably, in order to take the necessary measurements for the concept design proposed by Jordan, as evaluated by ICOMOS and ICCROM, and to enable Jordan as a concerned party to present its final design for the restoration and preservation of the Mughrabi Ascent;
18. Expresses its thanks to the Director-General for the actions she is taking to facilitate dialogue and professional exchanges between all parties concerned;
19. Invites the Director-General to submit to it a progress report thereon at its 186th session.

### **Implementation of UNESCO's Strategy on Human Rights and the Integrated Strategy to Combat Racism, Discrimination, Xenophobia and Related Intolerance**

The Executive Board,

1. Recalling 35 C/Resolution 35,
2. Having examined document 185 EX/6 Part I,
3. Takes note of the Director-General's efforts to reinforce the implementation of the programme concerning the UNESCO Strategy on Human Rights (2003) and of the Integrated Strategy to Combat Racism, Discrimination, Xenophobia and Related Intolerance (2003), as well as to mainstream human rights further into all UNESCO's programmes;
4. Requests the Director-General to submit to it at its 187th session, a summary of the outcome of the Organization's programme in this regard, where implemented.

## II

### **Revised Publication and Distribution Plan 2010-2011 and progress report on the implementation of 184 EX/Decision 6 (II)**

The Executive Board,

Emphasizing the need to strengthen UNESCO's cooperation with Haiti in support of the efforts of the Government to promote reconstruction, peace and development through education, the natural sciences, the social and human sciences, culture, and communication and information, following the devastating earthquake that struck the country on 12 January 2010,
4. Stressing UNESCO's role and that of its Member States in restoring education services and opportunities in a holistic manner and in strengthening the institutional capacities of the Haitian education system,
5. Recognizing the importance of culture, including cultural heritage in all its forms, to the rebuilding of Haiti and to the national identity of the Haitian people,
6. Welcoming the outcome of the first meeting of the International Coordination Committee for the Safeguarding of Haitian Cultural Heritage, held at UNESCO Headquarters on 7 and 8 July 2010,
7. Expresses its appreciation to the Director-General for her prompt initiatives and the action taken by UNESCO to respond to the urgent needs of Haiti and to develop the medium- and long-term cooperation strategy for Haiti in order to ensure consistent and sustainable support for the reconstruction in the Organization's fields of competence;

8. Approves the medium- and long-term cooperation strategy for Haiti submitted by the Director-General;
9. Calls on all Member States to consider supporting UNESCO's role and activities with regard to Haiti in all relevant international forums;
10. Further calls on Member States, intergovernmental, governmental and non-governmental agencies and foundations to provide extrabudgetary resources to reinforce UNESCO's efforts in support of the reconstruction and capacity-building of Haiti in its fields of competence;
11. Invites the Director-General to submit to it a progress report on the implementation of this decision at its 186th session, emphasizing the results achieved as well as the volume of resources disbursed.

3. Takes note of the work accomplished to date in preparation of the human resources strategy for 2011-2016, and invites the Director-General to pursue this work with a view to submitting the human resources strategy to it at its 186th session, taking into account UNESCO's staff policy.

Expresses its deep concern that despite the remarkable progress since 2000 in implementing education for all (EFA), if current trends continue, millions of children and adults, the majority of whom are female, will still be without access to learning opportunities by 2015 with the result that the agreed goals will not be achieved;
4. Encourages the efforts of the Director-General to advocate greater funding for EFA, in particular through innovative development financing sources;
5. Further encourages the Director-General to seek additional extrabudgetary resources for UNESCO's contribution to EFA;
6. Welcomes the efforts made by UNESCO to enhance the role of the High-Level Group on Education for All to improve the EFA coordination mechanisms and to strengthen UNESCO's active presence in the "One United Nations" framework in order to achieve the EFA goals;
7. Aware that the Director-General has intensified her efforts to ensure that the crucial role of education in development processes is reaffirmed in major forthcoming events,
8. Notes with satisfaction UNESCO's continued collaboration with the EFA convening agencies and attempts to reinforce links with other relevant United Nations organizations;
9. Reiterates to the Director-General the importance of promoting South-South cooperation and the exchange of best practices with a view to the achievement of the education-related Millennium Development Goals (MDGs) and EFA goals;
10. Requests the Director-General to include in her activity reports for the 186th session of the Executive Board information on the key outcomes of and UNESCO's participation in the Millennium Development Goals, the G-20 summits and other relevant international forums and planned follow-up activities;
11. Also requests the Director-General to submit to it at its 186th session a report that would include:
  - (a) key findings and recommendations of the EFA coordination review paper;
  - (b) updated information on EFA coordination and joint actions at the regional and national level in collaboration with the respective stakeholders and the result of UNESCO's action in the 20 priority countries;



- (c) the progress made under the Education Sector's programmes and activities aimed at achieving the EFA goals and the main results obtained, including best practices;
- (d) a plan of action for UNESCO's work on the advocacy of quality Education for All including measures envisaged until 2015 to give a new impetus to the implementation of EFA, in particular with respect to the quality of education.

Adopts the UNESCO Strategy for the Second Half of the United Nations Decade of Education for Sustainable Development (2005-2014), and recognizes the comprehensive nature of the Bonn Declaration as an important basis for guiding work on education for sustainable development (ESD) in the second half of the Decade;
4. Recognizes that the end-of-Decade conference, to be convened in Japan in 2014, will sum up various ESD efforts and outcomes of the implementation of the Bonn Declaration and the UNESCO Strategy;
5. Endorses the schedule and draft road map to the end-of-Decade conference, as contained in document 185 EX/9;
6. Invites all Member States to participate actively in the implementation of the UNESCO Strategy for the Second Half of the United Nations Decade of Education for Sustainable Development;
7. Calls upon the Director-General to:
  - (a) maintain ESD as one of the focal issues of the Education Sector in the drafting process leading to document 36 C/5;
  - (b) mobilize all UNESCO programme sectors and networks to contribute actively to the implementation of the Strategy and, as appropriate, in coordination with the National Commissions;
  - (c) present the Strategy to the United Nations General Assembly at its 65th session in Autumn 2010;
  - (d) ensure funding for the implementation of the Strategy within existing resources in the regular budget and extrabudgetary resources, including those mobilized through innovative funding;
  - (e) report to it at its 186th session on the implementation of the Strategy at the global and regional levels and keep it regularly informed regarding the implementation of the Strategy.

  - (c) that invitations to send observers to the Conference will be sent to the organizations of the United Nations system with which UNESCO has concluded mutual representation agreements and which are listed in paragraph 7 of document 185 EX/10;
  - (d) that invitations to send observers to the Conference will be sent to the organizations, foundations and institutions listed in paragraphs 8 and 9 of document 185 EX/10;
4. Authorizes the Director-General to send out any other invitations that she may deem useful for advancing the work of the Conference, notifying the Executive Board thereof.

8. Appreciating the Director-General's initial reflections on the role of the basic sciences in the context of preparing the next Medium-Term Strategy,
9. Invites the Director-General to:
  - (a) develop further the International Basic Sciences Programme in line with the recommendations of UNESCO's Ministerial Round Tables on "The Basic Sciences: The Science Lever for Development" (2005) and "Science and Technology for Sustainable Development and the Role of UNESCO" (2007) and in line with 181 EX/Decision 10 and 182 EX/Decision 14;
  - (b) ensure that the International Basic Sciences Programme and its specific mission are duly reflected in the next Medium-Term Strategy, on the basis of the consultation of Member States that she will hold in line with 182 EX/Decision 14;
  - (c) take into consideration the four areas of engagement by the Organization in the basic sciences, as expressed in paragraph 12 of document 185 EX/11.

4. Highlighting the particular need for human, institutional and infrastructure capacity-building in engineering and technology, especially in developing countries,
5. Considering the results of the feasibility study and the views of principal partner organizations, especially national member organizations of the World Federation of Engineering Organisations and the call from World Engineers' Conventions in 2000, 2004 and 2008,

6. Emphasizing that the goals of any future proposed international engineering programme should be in keeping with the strategic objectives set out in document 34 C/4 and the Organization's unique mandate within the United Nations system,
7. Requests the Director-General to make a proposal thereon to it at its 186th session in the context of her submission of the Draft Programme and Budget for 2012-2013 (36 C/5) and to present solutions on how to strengthen research, education and capacity-building in the field of engineering, focusing on UNESCO's comparative advantages and taking into account the discussion by the Executive Board at its 185th session.

4. Further recalling the UNESCO Strategy for Action on Climate Change (180 EX/16 Rev. – October 2008) and the Enhanced Plan of Action for the UNESCO Strategy for Action on Climate Change (182 EX/INF.7 Annex – September 2009),
5. Taking note of UNESCO's Climate Change Initiative (December 2009) which includes ethical and social questions in relation to climate change,
6. Also taking note of the views expressed by Member States and United Nations agencies in the course of consultation meetings and in response to the questionnaire circulated in February 2010,
7. Further taking note of the interim report by the World Commission on the Ethics of Scientific Knowledge and Technology (COMEST) entitled "Towards an Ethical Framework for Climate Change Policies" (June 2010),
8. Further taking note, too, of the recommendation made by COMEST at its extraordinary session (28-30 June 2010) that the preparation of a draft declaration of ethical principles in relation to climate change would not be feasible for submission to the General Conference at its 36th session,
9. Requests the Director-General to take into account recent scientific and scholarly findings on the ethics of climate change and submit to it at its 186th session a report reviewing the issues relevant to the assessment of the desirability of preparing a declaration of ethical principles in relation to climate change, with particular reference to the outcomes of the sixteenth Conference of the Parties to the United Nations Framework Convention on Climate Change (UNFCCC COP-16) and to related international processes, with a view to informing deliberation on the follow-up to 35 C/Resolution 36 by the General Conference at its 36th session,

10. Also requests the Director-General to invite COMEST to continue to work on the desirability of an ethical framework for climate change policies.

2. Also recalling resolutions and decisions of UNESCO on Jerusalem, as well as the provisions of the four Geneva Conventions (1949), the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict (1954) and the related Protocols and the Convention for the Protection of the World Cultural and Natural Heritage (1972),
3. Further recalling General Conference resolutions and Executive Board decisions regarding the appointment of a permanent representative of the Director-General of UNESCO on the issue of Jerusalem,
4. Affirming that nothing in the present decision, which is aimed at the safeguarding of the Cultural Heritage of East Jerusalem, shall in any way affect the relevant United Nations resolutions and decisions, in particular the relevant Security Council resolutions on the legal status of Jerusalem,
5. Expresses its deep concern over the ongoing Israeli excavations and archaeological works on the Al-Aqsa Mosque compound and in the Old City of Jerusalem, which contradict UNESCO decisions and conventions and United Nations and Security Council resolutions;
6. Also expresses its concern about the ongoing Israeli practices in East Jerusalem, that dangerously affect the city's distinctive character, both religious and cultural, historical and demographical;
7. Reaffirms the religious significance of the Old City of Jerusalem for Muslims, Christians and Jews;
8. Invites the Director-General to appoint, as soon as possible, the permanent and eminent expert(s) to be stationed in East Jerusalem to report on a regular basis about all the aspects covering the architectural, educational, cultural and demographical situation in the City of East Jerusalem;
9. Invites the Israeli authorities to facilitate the work of the expert(s) in conformity with its adherence to UNESCO decisions and conventions;
10. Invites Member States to provide the necessary assistance to finance the work of the expert(s) from extrabudgetary resources;

11. Thanks the international donors for their generous contributions for the implementation of projects within the framework of the UNESCO Action Plan for the Safeguarding of the Cultural Heritage of the Old City of Jerusalem;
12. Expresses its sincere thanks to the Director-General for her commitment to pursue the efforts for the safeguarding of the unique heritage of the City of Jerusalem, in compliance with the relevant General Conference resolutions and Executive Board decisions;
13. Decides to include this item in the agenda of its 186th session and invites the Director-General to submit a follow-up report on this matter.

Also recalling resolutions and decisions of UNESCO on the protection of the cultural heritage in the occupied Arab territories, as well as the provisions of the four Geneva Conventions (1949), the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict (1954) and the related Protocols and the Convention for the Protection of the World Cultural and Natural Heritage (1972),
3. Further recalling the Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property (1970),
4. Affirming that nothing in the present decision, which aims at the safeguarding of the cultural heritage located in the occupied Arab territories, shall in any way affect the relevant United Nations resolutions and decisions, in particular the relevant Security Council resolutions,
5. Sharing the concern expressed by the Director-General regarding the announcement made by the Israeli authorities that two sites, namely al-Ḥaram al-Ibrahīmī/Tomb of the Patriarchs in the city of al-Khalīl/Hebron and the Mosque of Bilāl bin Rabāḥ (Tomb of Rachel), in Bethlehem, both located in the occupied Palestinian territories, are to be included in the Israeli national heritage list,
6. Also sharing the conviction affirmed by the international community that the two sites are of religious significance for Judaism, Christianity and Islam,
7. Reaffirms that the two sites are an integral part of the occupied Palestinian territories and that any unilateral action by the Israeli authorities is to be considered a violation of international law, the UNESCO conventions and the United Nations and Security Council resolutions;
8. Regrets the Israeli authorities’ decision to include the two sites in the Israeli national heritage list;

9. Urges the Israeli authorities to abide by international law and the relevant international conventions and decisions;
10. Also urges the Israeli authorities to remove the two sites from the Israeli national heritage list;
11. Thanks the Director-General for her commitment to strengthening UNESCO's financial and technical assistance to the Palestinian educational and cultural institutions in compliance with the UNESCO General Conference resolution at its 35th session;
12. Invites the Director-General to submit to it a follow-up report at its 186th session and decides to include this item in the agenda of the 186th session of the Executive Board.

The Executive Board,

1. Having considered the preliminary proposals by the Director-General for priority fields of action for the Draft Programme and Budget for 2012-2013 (36 C/5) contained in documents 185 EX/17 Parts I and II, the regional consultations of National Commissions and the summary of responses by Member States and by intergovernmental and non-governmental organizations to the questionnaire by the Director-General contained in documents 185 EX/17 Part I and Corr. and Addenda (A), (B), (C) and 185 EX/PX/DR.7,



2. Taking into account its discussions in Plenary and in the PX and FA Commissions at its 185th session on the preparations for the Draft Programme and Budget for 2012-2013 (36 C/5),
3. Invites the Director-General to prepare the Draft Programme and Budget for 2012-2013 (36 C/5), bearing in mind the guidance given in this decision;

#### **GENERAL PRINCIPLES**

4. Restates its firm allegiance to UNESCO's mandate to construct the defences of peace in the minds of men and to build a culture of peace and non-violence, as enshrined in its Constitution;
5. Welcomes the Director-General's new vision for the work of UNESCO and her intention to enhance the relevance, impact and visibility of the Organization;
6. Concerned by the adverse impact of the multiple global crises on development gains and prospects and by their consequences for human well-being and sustainable development,
7. Emphasizes UNESCO's commitment and contribution to the attainment of the internationally agreed development goals (IADGs), including the Millennium Development Goals (MDGs);
8. Stresses that UNESCO's programme orientation until 2015 should be closely aligned with the relevant provisions of the Outcome Document adopted at the September 2010 High-Level Plenary Meeting of the United Nations General Assembly on the MDGs as well as the outcomes of the subsequent General Assembly's high-level review meetings on biodiversity and on small island developing States (SIDS);
9. Further stresses that UNESCO in designing its programmes must already now prepare to look beyond 2015, the year when the MDGs and the EFA Goals are to be attained;
10. Resolves to demonstrate UNESCO's leadership in building a culture of peace and non-violence;
11. Emphasizes that the Medium-Term Strategy for 2008-2013 (34 C/4), with its global priorities, overarching and strategic programme objectives and its intersectoral approach, must serve as the guiding framework for the preparation of the Programme and Budget for 2012-2013 (36 C/5);
12. Highlights the five established functions of UNESCO, as set out in document 34 C/4 – laboratory of ideas, standard-setter, clearing house, capacity-builder in Member States in UNESCO's fields of competence and catalyst for international cooperation;
13. Underscores the need to undertake prospective studies and exercise foresight in all of UNESCO's fields of competence;
14. Underlines the validity of UNESCO's standard-setting instruments and the need to foster their effective implementation;
15. Recalls UNESCO's commitment to promote in all of its programmes and with sufficient resources the two global priorities of the Organization, namely Africa and gender equality;
16. Calls for increased action in favour of the least developed countries (LDCs), small island developing States (SIDS), the poorest and disadvantaged segments of society, including indigenous peoples, and countries in post-conflict and post-disaster situations;

17. Acknowledges the important role and strategic contribution of UNESCO in responding to the needs of middle-income countries (MICs);
18. Further acknowledges that South-South cooperation and North-South-South cooperation are critical modalities for the delivery of UNESCO's Programme requiring special fund mobilization;
19. Considers that youth as a priority group must be involved in and benefit from UNESCO's programmes, as appropriate, and receive particular attention throughout UNESCO's programmes to facilitate their empowerment, inclusion and contribution to a culture of peace and non-violence;
20. Underlines the importance of intersectorality and interdisciplinarity in ensuring UNESCO's ability to provide flexible and consistent responses to complex contemporary challenges, especially at the country level;
21. Recognizes UNESCO's demonstrated ability and relevance to provide upstream policy advice and capacity and skills development, in the Organization's fields of competence, and the need to strengthen its action in these areas;
22. Stresses the continuing need to promote human rights in UNESCO's fields of competence and to apply a human rights-based approach to programming;
23. Underlines the need to reflect in document 36 C/5 UNESCO's full commitment to cooperation with the United Nations system, especially through common country approaches responding to national development priorities;
24. Recalls the need for UNESCO to take into account the recommendations of the United Nations General Assembly on the triennial comprehensive policy review of operational activities for development;
25. Underlines the unique role of the National Commissions as constituent elements of UNESCO and contributors to programme implementation;
26. Encourages the development of UNESCO's partnerships in order to reinforce its impact while respecting the values of the Organization;
27. Underscores that document 36 C/5 should comply with the principles of results-based management (RBM), including measurable results supported by meaningful performance indicators and benchmarks, and emphasizes the need to avoid input and output indicators;
28. Recalls that all extrabudgetary contributions must be complementary and coherent with the priorities of the regular programme;
29. Considers that the preparatory and consultative process leading to the preliminary proposals of the Director-General concerning the C/5 document should be reviewed in order to make it more targeted and cost-effective while improving its efficiency and maintaining its inclusive nature;
30. Recalls the absolute need for UNESCO to concentrate and focus its action on its programme priorities (180 EX/Decision 21, para. 6), bearing in mind also the relevant recommendations of the 2010 independent external evaluation (185 EX/18);

## GLOBAL PRIORITIES

31. Reaffirms that the global priority accorded to Africa and gender equality must be translated into action in all of UNESCO's fields of competence;

### Africa

32. Notes the opportunity and need for further strategic and operational contributions by UNESCO to meet the national development priorities of African Member States, taking into account the major goals set by the African Union (AU) and by the New Partnership for Africa's Development (NEPAD);
33. Decides that UNESCO shall also render assistance to African Member States in the areas of peace-building, culture of peace and non-violence, reconciliation, dialogue and regional integration, and in post-conflict and post-disaster situations;
34. Invites the Director-General to include in document 36 C/5 an overview of programme elements for UNESCO's engagement with Africa to be prepared in consultation with the African Member States and the African Union, taking into account, in particular, the Outcome Document of the September 2010 High-level Meeting of the United Nations General Assembly on the MDGs;
35. Requests that indications of resources earmarked for coordination purposes and for interventions by programme sectors in support of Africa be provided in document 36 C/5;
36. Recognizes the role of the office established to liaise with the African Union in Addis Ababa in facilitating cooperation between the two organizations;

### Gender equality

37. Underlines that the approved Priority Gender Equality Action Plan for 2008-2013 must be fully implemented and its expected outcomes attained, including through document 36 C/5;
38. Recognizes that gender equality concerns must be integrated into UNESCO's assistance to Member States at the regional and country levels;
39. Requests that indications of resources earmarked for coordination purposes and for interventions by programme sectors in support of gender equality, as envisaged by 181 EX/Decision 4 (I), be provided in document 36 C/5;
40. Underlines that it is important for UNESCO to develop close cooperation in all of its fields of competence with the new United Nations Entity for Gender Equality and the Empowerment of Women "UN Women", which envisages scaled-up United Nations action and a more effective and coherent inter-agency collaboration, including at the country level;

Reaffirms the need for the development of education for dialogue, tolerance and reconciliation, human rights education, values education, education for democracy and citizenship education as part of the promotion of a culture of peace and non-violence, including from an intersectoral perspective;
46. Emphasizes the continuing need to strengthen global advocacy of EFA in all its dimensions;
47. Recognizes the importance of a comprehensive, system-wide approach to education and lifelong learning, including formal, informal and non-formal education;
48. Calls on UNESCO to exert its leadership role for the Decade of Education for Sustainable Development (DESD) in an effective manner;

49. Reaffirms the importance of strengthening the linkages between ESD and EFA;
50. Insists on a comprehensive and integrated follow-up to all major education conferences held from 2008 onwards;
51. Calls for increased action in the area of higher education and research, including the follow-up to the recommendations of the 2009 World Conference on Higher Education and strengthened collaboration with the United Nations University (UNU) and the University for Peace;
52. Reaffirms the need to strengthen South-South cooperation at all levels of education with a view to the achievement of the education-related Millennium Development Goals (MDGs) and the six EFA goals and to intensify fund-raising efforts as part of UNESCO's strategy in this field;
53. Considers it desirable to develop mechanisms for innovative financing for education in Member States;
54. Stresses the importance of scaling up activities for the development of capacities and competences in the area of teacher training and of pursuing vigorously the Teacher Training Initiative for Sub-Saharan Africa (TTISSA);
55. Underlines the need to focus in Major Programme I on secondary education, skills development and technical and vocational education and training (TVET), science education and the use of ICTs in education;
56. Emphasizes the importance of category 1 institutes in education and their crucial contribution to UNESCO's programme;
57. Underscores the importance of responding to the needs of countries in post-conflict and post-disaster situations and of developing adequate approaches to disaster-risk reduction in the area of education;
58. Calls for increased cooperation with EFA partners at all levels, including United Nations organizations and non-governmental organizations at the global, regional and country levels;

64. Stresses the need for UNESCO to promote international cooperation and regional initiatives in the natural sciences;
65. Endorses the strong focus on the development of science, technology and innovation policies and the support for the emergence of a culture of innovation in developing countries, in particular Africa, in conjunction with multiple partners from civil society and at the grass-roots level;
66. Underscores the need to strengthen programmes for women and girls in the natural sciences as well as in engineering;

90. Urges more concentration and a much clearer focus of activities undertaken under Major Programme III, giving priority to concrete action in areas where UNESCO has a clear added value and focusing on work that has the greatest impact, in particular for the proposed MLA 2;
91. Underscores the relevance of the social and human sciences to the work of the Organization, and the potential of intersectoral engagement with all major programmes, in areas such as the university teaching of social and human sciences, the adaptation and dissemination of the General and Regional Histories for national education as appropriate, the inclusion of philosophy in school curricula and the integration of the issue of the ethical implications of climate change into curricula at all levels of education;

104. Reaffirms UNESCO's paramount comparative advantage in the field of cultural and natural heritage preservation, protection and safeguarding;
105. Underlines the importance of strengthening the fight against the illicit traffic of cultural property through the reinforcement of the implementation of the 1970 Convention;
106. Reaffirms the importance to UNESCO of supporting Member States in the development of national and local capacities in the field of culture, in the formulation of national and regional cultural policies and in the development of relevant cultural statistics, data and analysis as a basis for assessing the impact of the culture sector in and for development and with a view to informing national cultural policies;
107. Underscores that UNESCO should facilitate the development of "sustainable tourism" as a crucial contribution to the rapprochement of cultures and to the appreciation of the world's cultural diversity and as a source of income generation;
108. Supports the initiative for elaborating a programme on "cities for sustainable development, dialogue and peace";

109. Encourages UNESCO to support better integration of the cultural dimension into the work of the United Nations system at the country level, including common country programming processes such as the Common Country Assessment (CCA) and the United Nations Development Framework (UNDAF), and through the wider application and use of appropriate tools such as the Cultural Diversity Programming Lens;

115. Recalls the Second World Conference on Arts Education (Seoul, Republic of Korea, 25-28 May 2010), and further recalls 185 EX/Decision 44 on the appropriate follow-up;
116. Underlines the need for youth to be better reflected as a target group, as regards youth participation in the field of culture, in order to promote intercultural dialogue, social cohesion and peace-building;
117. Encourages UNESCO to develop its partnership with the Alliance of Civilizations, as foreseen in the 2010 Memorandum of Understanding, and underscores the importance of the joint implementation of specific activities;
118. Takes note of the ongoing work of the High Panel on Peace and Dialogue among Cultures;
119. Recalls the potential of UNESCO Chairs and networks and of UNESCO category 2 centres active in the field of culture;
120. Underscores the potential of ICTs for culture;
121. Takes note with interest of the proposal for the possible organization of a United Nations summit on culture and development in 2013, reflecting in particular the contribution of culture to development and to the attainment of the MDGs;

123. Reaffirms freedom of expression and universal access to information and knowledge as pillars of Major Programme V;
124. Recognizes the important role of Major Programme V in the follow-up to and implementation of the relevant World Summit on the Information Society (WSIS) action lines;
125. Stresses the need to continue UNESCO's efforts to bridge the existing digital and knowledge divide in the field of communication and information;
126. Encourages the Communication and Information Sector to continue its contributions to intersectoral activities;
127. Emphasizes the important role played by the two intergovernmental programmes, the International Programme for the Development of Communication (IPDC) and the Information for All Programme (IFAP) and its related Strategic Plan;
128. Further emphasizes the important role of the Memory of the World Programme for the preservation and accessibility of documentary heritage;
129. Calls for increased attention to the relationship of media and youth, focusing, in particular, on building media and information literacy;
130. Emphasizes the importance of the use of ICTs, especially the Internet, to support the transfer of knowledge and to promote a culture of peace and non-violence;
131. Encourages Major Programme V to pursue its work in the area of multilingualism in cyberspace;
132. Underscores the importance of journalism education and professional standards to quality media;

## UNESCO Institute for Statistics (UIS)

133. Endorses the three priorities for UIS activities, namely improving the quality of data, reinforcing statistics and indicators on learning outcomes and strengthening statistics in science, culture and communication;
134. Requests UIS to continue to support Member States in developing national strategies and their capacity-building efforts;

135. Invites UIS to present information and analysis on the dissemination and users of the statistics prepared;
136. Requests UIS to present the results of its Literacy Assessment and Monitoring Programme (LAMP) and to prepare follow-up action;

### **Intersectoral platforms**

137. Underlines the critical importance of UNESCO's intersectoral activities in addressing contemporary issues in a problem-oriented and innovative mode;
138. Endorses the formation of intersectoral platforms in areas of convergence of different major programmes, which allow an exchange of ideas and a more flexible programme delivery, enhancing value and impact;
139. Takes note of the proposal by the Director-General to include in document 36 C/5 a reduced number of thematic and coordinating intersectoral platforms;
140. Suggests that the themes of the six proposed intersectoral platforms could be:
  - (a) promotion of a culture of peace and non-violence (thematic platform);
  - (b) UNESCO's contribution to climate change mitigation and adaptation (thematic platform);
  - (c) UNESCO's contribution to the fight against HIV/AIDS (thematic platform);
  - (d) UNESCO's support to countries in post-conflict and post-disaster situations (coordinating platform);
  - (e) UNESCO's contribution to the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States (SIDS) (coordinating platform);
  - (f) Priority Africa and its implementation by UNESCO (coordinating platform in line with the provisions of document 34 C/4);
141. Requests the Director-General to specify in document 36 C/5 for each platform compelling objectives, programmes, expected results and performance indicators, modalities of operation and financial allocations proposed;
142. Underlines the need to avoid overlaps and duplication and to monitor regularly the execution of the platforms' activities, to ensure accountability and report on expected results, lessons learnt and obstacles encountered during implementation in the Director-General's statutory reports;
143. Emphasizes the importance of integrated action by Headquarters, field offices and category 1 institutes in the work of the platforms;
144. Stresses that intersectoral platforms should seek engagement and cooperation with National Commissions and all of UNESCO's partners and networks at the regional, subregional and national levels;
145. Highlights the need to promote a culture of intersectorality in the work of the Secretariat covering the Organization's activities as a whole, and calls on the Director-General to ensure that intersectoral work will be proactively pursued on issues other than those covered by the intersectoral platforms;

## **Intersectoral and interdisciplinary programme of action for a culture of peace and non-violence**

146. Takes note of the proposals of the Director-General, the terms of 185 EX/PX/DR.7 and the discussions on item 17 in the PX Commission, in addition to the discussions held during the thematic debate of the Plenary and in the drafting group on document 36 C/5 at the 185th session, and requests the Director-General to prepare, based thereon, a consolidated draft action programme for a culture of peace and non-violence to be included in draft document 36 C/5, and to hold information meetings with Member States prior to the 186th session of the Executive Board;
147. Agrees to continue to consider the desirability of a new international decade.

## II

The Executive Board,

1. Recalling 35 C/Resolution 105,
2. Having examined document 185 EX/17 Part II,
3. Notes that the preliminary budgetary estimates for document 36 C/5 have been calculated using approved budgeting techniques and methodology adopted by the General Conference in accordance with 35 C/Resolution 105;
4. Also notes that the Director-General has proposed a single budget estimate of \$687.3 million which is presented as a zero real growth (ZRG) approach for document 36 C/5 (2012-2013);
5. Further notes that this estimate does not include the possible additional costs associated with a number of other items to be examined by the Executive Board such as the Medical Benefit Fund reform and the implementation of the full Headquarters security and conservation plans;
6. Invites the Director-General when preparing the Draft Programme and Budget for 2012-2013 (36 C/5) to:
  - (a) take into account the discussions held by the Executive Board at the 185th session;
  - (b) consider the introduction of a results-based budgeting approach as the methodology for achieving increased budget transparency and accountability;
  - (c) reinforce the resources allocated to programmes, taking into account the discussions held at the 185th session of the Executive Board regarding priorities and the need to focus on the core mandate of the Organization;
  - (d) continue to identify measures for an effective and rational use of financial resources;
  - (e) ensure that the regular budget includes support for programme delivery such as the International Public Sector Accounting Standards (IPSAS), integrated management systems, Headquarters maintenance and security in order to ensure efficient delivery of the programme;

7. Further invites the Director-General to submit draft document 36 C/5 to it at its 186th session;
8. Requests the Director-General to submit to it at its 187th session a report on the advantages, disadvantages and practical implications of the continuing use of the constant dollar principle.

Taking note of the analysis in the report on the independent external evaluation (IEE) and of the recommendations building on five strategic directions: “Increasing UNESCO’s focus; Positioning UNESCO closer to the field; Strengthening UNESCO’s participation in the United Nations; Strengthening governance and developing a partnership strategy”,
4. Recognizing the comprehensive and general character of all of the recommendations and the need for their in-depth examination by Member States in order to identify possible action,
5. Underlining the common responsibility of the General Conference, the Executive Board and the Secretariat in the follow-up to the independent external evaluation (IEE), according to the prerogatives of each body,
6. Decides that the report shall be further examined in depth, taking into account the debate thereon at the 185th session of the Executive Board, so that the relevant recommendations of the report can be expressed, where appropriate, in concrete proposals;
7. Emphasizing the need to establish a mechanism for the follow-up to the independent external evaluation (IEE) that involves all UNESCO Member States,
8. Decides to establish an ad hoc working group whose mandate is to examine the report on the independent external evaluation (IEE) and to develop proposals concerning the recommendations thereof, taking into account the discussions held at the 185th session of the Executive Board, and to submit them to it at its 186th session;
9. Also decides that the ad hoc working group will be composed of 18 Member States of the Executive Board (3 from each electoral group), designated after consultation of the electoral groups by 19 November 2010;
10. Further decides that the ad hoc working group will:
  - (a) hold its first meeting no later than 19 December 2010;

- (b) designate its Chairperson and Vice-Chairperson at its first meeting;
  - (c) conduct its work in a consensual, constructive, transparent and cost-efficient manner;
  - (d) convene open-ended meetings, thus allowing enhanced participation of all Member States of UNESCO;
  - (e) use the two working languages of the Secretariat (English and French);
11. Requests the Director-General, within the limits of the existing 35 C/5 document, to assist the ad hoc working group by providing appropriate secretariat support;
  12. Invites the Director-General to appoint a representative from the Secretariat to liaise with the ad hoc working group to ensure coherence in the follow-up to the independent external evaluation (IEE);
  13. Further invites the Director-General to report to it at its 186th session on the follow-up by the Secretariat with respect to the operational aspects of the report on the independent external evaluation (IEE) that fall within her purview.

2. Having examined document 185 EX/19, the scenarios proposed in it and their respective implications,
3. Noting the findings of the report on the independent external evaluation (185 EX/18 and Add.),

Recognizing the importance of the comprehensive policy review, through which the United Nations General Assembly establishes key system-wide policy orientations for the development cooperation and country-level modalities of the United Nations system, as well as the desirability for UNESCO's Medium-Term Strategy to reflect those orientations as appropriate,
5. Recognizing the importance of a long-term framework for strategic planning,
6. Also recognizing the need to take into consideration the C/5 programming cycle in the examination of possible scenarios for alignment with the quadrennial comprehensive policy review of operational activities for development of the United Nations system (QCPR),
7. Requests the Director-General to deliver a thorough analysis of the implications, *inter alia* programmatic, financial and administrative, of changing:

- (a) the C/4 cycle from six to eight years, with an appropriate mechanism for adjusting to the most recent QCPR;
  - (b) the C/5 cycle from two to four years, with an appropriate mechanism for adjustments every two years;
8. Invites the Director-General to ensure that this analysis will feed into the follow-up to the independent external evaluation process;
  9. Requests the Director-General to submit a report on the analysis to it at its 186th session taking into consideration the debate at the 185th session and in the context of the follow-up to the independent external evaluation.

- (d) indicate clearly any foreseen cost-saving measures relating to the methods of work of the General Conference to be recommended by the Executive Board;

Being aware that more than 30 years have passed since it adopted 104 EX/Decision 3.3 and that in the light of developments and achievements within the United Nations system for the protection and promotion of human rights, the Executive Board has considered it appropriate to improve the effectiveness of the implementation of 104 EX/Decision 3.3 in order to achieve greater efficiency and visibility in UNESCO's action,
5. Emphasizing that:
  - (a) the 104 Procedure has succeeded in contributing to alleviating the suffering of several victims of human rights violations and that it constitutes a useful tool in this regard;
  - (b) the 104 Procedure is unique and at the same time complementary to other mechanisms of the United Nations system responsible for protecting human rights;
  - (c) the Committee on Conventions and Recommendations (CR) is working towards dialogue and good offices as a way to resolve matters that negatively affect the

practices of human rights within the fields of competence of UNESCO and that the Committee is not of a judicial nature;

- (d) the Committee applies the criteria for the admissibility of communications to each case, within the framework of the 104 Procedure;
6. Decides to adopt the following measures to improve the working methods of the Committee:
- (a) the representative of the Director-General shall present, at the beginning of each session of the Committee, an oral report summarizing the communications which have not been considered transmissible to the Committee under the terms of the conditions outlined in paragraph 14 (a) of 104 EX/Decision 3.3 and which have been removed according to paragraph 6 of the procedural practice reproduced in Annex II to document 184 EX/CR/2;
  - (b) the Committee shall examine at every session, in a private meeting, the communications transmitted to it by the Director-General, and shall also examine at every session the cases already before it, unless it decides otherwise;
  - (c) the Secretariat is invited to make the necessary arrangements to ensure that the communications relating to the member(s) of the Committee will be examined at the end of each daily meeting;
  - (d) the Committee may suspend the examination of a communication whose author has not transmitted new information during four successive sessions, but may resume its examination at any time;
  - (e) the Committee shall endeavour to avoid standard formulae when drafting its decisions;
  - (f) the Secretariat shall strive to obtain from the international organizations that have competence for the protection of human rights complementary information on the cases that are the subject of communications and shall transmit it to the members of the Committee;
7. Invites the Director-General to use her/his good offices in order to facilitate the emergence of solutions concerning the cases under examination by the Committee;
8. Also invites the Director-General to enhance the visibility of the 104 Procedure by:
- (a) making this procedure more easily accessible on the official website of UNESCO;
  - (b) ensuring the promotion of the procedure by other appropriate means.

1. Recalling 174 EX/Decision 31, 177 EX/Decision 57, 183 EX/Decision 13 and 34 C/Resolution 59,
2. Having examined document 185 EX/33,
3. Expresses appreciation for the continued efforts made by the Committee on International Non-Governmental Organizations to strengthen cooperation with NGOs in UNESCO's various fields of competence and at the international, regional and national levels;
4. Highlights the very important role of NGOs in the promotion of culture for sustainable development, cultural diversity and economic prosperity;
5. Recalls the need to enhance the diversity of civil society representation to UNESCO and to strengthen strategic partnership and cooperation with NGOs at the international and national levels, in particular through the National Commissions;

6. Encourages the establishment of partnerships to facilitate NGOs' contribution to the definition and dissemination of UNESCO's biennial objectives, relying in particular on the National Commissions, especially in post-crisis and post-disaster situations;
7. Requests the Director-General, with a view to facilitating the participation of civil society in developing countries in the work of the NGO Committee, to submit a report on various options to it at its 186th session;
8. Requests the NGO Committee to examine the scope of its current terms of reference with a view to including other actors in civil society;
9. Requests the Director-General to consider the theme of "the fight against violence in the contemporary world", in consultation with international youth NGOs maintaining official relations with UNESCO, for the next Youth Forum to be held at the General Conference at its 36th session.

### **35 Report by the Director-General on the cultural and educational institutions in Iraq (185 EX/35; 185 EX/52 Rev.)**

The Executive Board,

1. Recalling 182 EX/Decision 53,
2. Having examined document 185 EX/35,
3. Acknowledges with appreciation the results achieved in the implementation of educational, cultural, scientific and media activities and the continued mobilization of substantial extrabudgetary resources to this effect;
4. Encourages the Director-General to continue giving full support to the Iraqi Government in its implementation of educational, cultural, scientific and media programmes, in particular through capacity-building activities and by addressing the most urgent humanitarian needs of population groups most affected by the crisis, including displaced Iraqis;
5. Invites the Director-General to continue monitoring the implementation of the recommendations of the International Coordination Committee for the Safeguarding of the Cultural Heritage of Iraq (ICC);
6. Expresses its gratitude to all donors for their substantial contribution to UNESCO's action in favour of the Iraqi people, and appeals to them to continue to assist UNESCO in its efforts to foster reconstruction and dialogue in Iraq;

7. Calls upon donors to sustain their funding through the new funds-in-trust modality established within the United Nations Development Framework (UNDAF);
8. Invites the Director-General to present a further report to it at its 187th session.

**36 Implementation of 35 C/Resolution 75 and 184 EX/Decision 30 concerning educational and cultural institutions in the occupied Arab territories (185 EX/36; 185 EX/52 Rev.)**

N.B. After considering this item and following a vote taken by roll-call, with 41 votes in favour, 1 vote against and 15 abstentions, the United States of America having voted against, the Programme and External Relations Commission recommended that the Executive Board adopt the following draft decision:

The Executive Board,

I

1. Recalling 35 C/Resolution 75 and 184 EX/Decision 30, as well as Article 26 of the Universal Declaration of Human Rights with regard to the right to education, Articles 4 and 94 of the Fourth Geneva Convention with regard to the denial of the right of children to education, as well as the UNESCO Convention for the Protection of the World Cultural and Natural Heritage (1972) and the Hague Convention (1954) and its Additional Protocols,
2. Having examined document 185 EX/36,
3. Further recalling the role that UNESCO is called upon to play in order to satisfy the right to education for all and to meet the need for Palestinians to have safe access to the education system,
4. Committed to the safeguarding of monuments, works of art, manuscripts, books and other historical and cultural properties to be protected in the event of conflict,
5. Deeply convinced that the continuous strengthening of the reconstruction and development process in the Palestinian territories should be carried out in a context of non-violence and of mutual respect and recognition, as promoted by the objectives of the Road Map,
6. Supports the efforts made by the Director-General with a view to the implementation of 35 C/Resolution 75 and 184 EX/Decision 30, and requests her to do everything possible to ensure that they are fully implemented in the framework of the Programme and Budget for 2010-2011 (35 C/5 Approved);
7. Expresses its appreciation for the substantial contributions of all concerned Member States and intergovernmental organizations and non-governmental organizations to UNESCO's action in the Palestinian territories, and appeals to them to continue assisting UNESCO in this endeavour;
8. Thanks the Director-General for the results that have been obtained in relation to the implementation of a number of current educational and cultural activities, and invites her to strengthen UNESCO's financial and technical assistance to the Palestinian educational and cultural institutions in order to address new needs and problems resulting from recent developments;

9. Expresses its continuing concern about the harmful impact of the Separation Wall and other practices on the activities of cultural and educational institutions, as well as obstacles that result which prevent Palestinian schoolchildren and students from being an integral part of their social fabric and from exercising fully their right to education, and calls for the observance of the provisions of 35 C/Resolution 75 and 184 EX/Decision 30;
10. Shares, in this regard, the call by the Quartet on 17 March 2010 upon Israel “to freeze all settlement building, including natural growth, dismantle outposts erected since March 2001 and halt demolitions and evictions in East Jerusalem”, and hopes for the resumption of Israeli-Palestinian negotiations;
11. Encourages the Director-General to continue to reinforce her action in favour of the reconstruction, rehabilitation and restoration of the Palestinian archaeological sites and cultural heritage;
12. Invites the Director-General to address the needs for capacity-building in all UNESCO’s fields of competence by expanding the financial assistance programme for Palestinian students both from the regular budget and from extrabudgetary resources;
13. Requests the Director-General to organize, as soon as possible, the ninth meeting of the Joint UNESCO-Palestinian Authority Committee;

14. Also invites the Director-General:
  - (a) to continue the efforts she is making to preserve the human, social and cultural fabric of the occupied Syrian Golan, in accordance with the relevant provisions of this decision;
  - (b) to undertake efforts to offer appropriate curricula, and to provide more grants and adequate assistance to the educational and cultural institutions of the occupied Syrian Golan;
  - (c) to dispatch an expert to assess and evaluate the needs of the educational and cultural institutions in the occupied Syrian Golan, who would report to the Director-General before the 186th session of the Executive Board;

15. Decides to include this item in the agenda of the Executive Board at its 186th session, and invites the Director-General to submit to it a progress report thereon.

**37 Report by the Director-General on the reconstruction and development of Gaza: implementation of 184 EX/Decision 31 (185 EX/37; 185 EX/52 Rev.)**

N.B. After considering this item and following a vote taken by roll-call, with 41 votes in favour, 1 vote against and 15 abstentions, the United States of America having voted against, the Programme and External Relations Commission recommended that the Executive Board adopt the following draft decision:

The Executive Board,

1. Recalling the provisions of the four Geneva Conventions (1949), the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict (1954) and the related Protocols, and the Convention for the Protection of the World Cultural and Natural Heritage (1972), and the recommendations, resolutions and decisions of UNESCO on the protection of cultural heritage,
2. Also recalling 184 EX/Decision 31 and having examined document 185 EX/37,
3. Having also examined documents 184 EX/30 and Add.,
4. Noting with deep concern the very heavy toll suffered by Palestinian civilians, the deaths and injuries inflicted on Israeli civilians during the escalation of violence and hostilities in December 2008 and January 2009,
5. Also noting with deep concern the destruction of infrastructure, the significant deterioration of basic services, and the damage to schools, universities and cultural heritage sites in the Gaza Strip caused by the escalation of violence and hostilities in December 2008 and January 2009, and recognizing that schools, universities and cultural heritage sites should not be involved in military conflicts,
6. Recalling the strong commitment made by the international community in favour of the Gaza Early Recovery and Reconstruction Plan presented at the International Conference in Support of the Palestinian Economy for the Reconstruction of Gaza (2 March 2009, Sharm el-Sheikh, Egypt),
7. Thanks the Director-General for strengthening the UNESCO project antenna in Gaza City and the initiatives that have already been implemented in the field of education, and for the safety of media professionals, as reflected in the six UNESCO projects retained in the United Nations Flash Appeal for Gaza;
8. Calls upon the Director-General to continue contributing to the United Nations humanitarian response in Gaza within the Organization's fields of competence;
9. Deplores in this regard the continuous blockade on the Gaza Strip which harmfully affects the free and sustained movement of personnel and humanitarian relief items for the successful implementation of the above-mentioned projects;
10. Calls upon the Director-General to continue her participation actively in the integrated United Nations response to the Gaza Early Recovery and Reconstruction Plan developed by the Palestinian Authority, by focusing on UNESCO's contribution to its educational and cultural heritage protection components;
11. Invites the Director-General to organize an information meeting to provide Member States with an update on the outcome of the projects conducted in the Gaza Strip;

12. Thanks Member States and donors for their generous financial contributions to the UNESCO projects retained in the United Nations Flash Appeal for Gaza, and invites them to further assist in this regard through extrabudgetary funding;
13. Decides to include this item in the agenda of the Executive Board at its 186th session, and invites the Director-General to submit to it a progress report thereon.

**38 Report by the Director-General on the assessment of the effectiveness of the Overall Strategy for UNESCO Prizes (185 EX/38; 185 EX/53)**

The Executive Board,

1. Recalling 171 EX/Decision 24, by which it established an overall strategy for UNESCO Prizes,
2. Having examined document 185 EX/38,
3. Considering that, five years after the establishment of the global strategy for UNESCO Prizes, the implementation of the strategy should be improved in order to correct some insufficiencies and imbalances,
4. Encourages the Director-General to pursue her efforts aimed at improving the visibility and effective management of UNESCO Prizes as a tool for furthering the strategic objectives, programme priorities and prestige of the Organization, especially in its fields of competence;
5. Requests the Director-General to continue her efforts to improve the implementation of the global strategy for UNESCO Prizes and the application of its criteria in cooperation with Member States and private donors, as appropriate;
6. Invites the Director-General to consider updating the global strategy for UNESCO Prizes;
7. Reiterates that, in conformity with 182 EX/Decision 25, in future all prize proposals should only be adopted after a thorough examination of a feasibility study by the Director-General, which is accompanied by an explicit recommendation on her part and which should take the following key elements into account:
  - (a) equal treatment for all Member States;
  - (b) the prize's contribution to the Organization's strategic objectives and programme priorities;
  - (c) potential overlaps with other prizes;
  - (d) the financial sustainability of the proposal, including the provision of administration costs and the origin of the funds relating thereto;
  - (e) the impact of the prize on UNESCO's prestige, profile and visibility;
  - (f) the alignment with the prize criteria as outlined in the global strategy for UNESCO Prizes and any deviations therefrom;

- (g) the ethical considerations concerning the integrity of non-governmental, private or individual donors drawing on good practice, such as those set out by the United Nations Global Compact;
8. Decides that the Executive Board may recommend, on an exceptional basis, that the Director-General launch an appeal for additional voluntary contributions in order to finance the administrative costs of a prize, if it cannot be otherwise achieved;
  9. Also decides that the amount paid to each winner of a UNESCO Prize shall be determined by the Director-General, in consultation with the prize donor, bearing in mind that the ethical, moral and symbolic values of the prize are more important than its monetary value;
  10. Further decides that all future prizes bearing the name of a person should be named after a person whose outstanding moral, intellectual, scientific or artistic legacy corresponds to the ideals and objectives of UNESCO;
  11. Underlines the importance of securing the financial sustainability, including administrative costs, of UNESCO Prizes during the lifespan of the prize;
  12. Also decides to assess the impact of each prize four years after its creation, on the basis of a report by the Director-General;
  13. Underlines its prerogatives to re-examine any prize at any time if the fulfilment of the criteria is called into question and adopt accordingly new decisions on whether to pursue or discontinue the prize;
  14. Stresses the importance of the role of prizes, and requests the Director-General to ensure, in this connection, the enhancement of the prestige of UNESCO, the promotion of its image and improvement of the visibility of its action, through *inter alia* the appropriate use of information and communication technologies.

### 41 **UNESCO's contribution to the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States (SIDS)** (185 EX/41; 185 EX/INF.15; 185 EX/INF. 20; 185 EX/52 Rev.)

The Executive Board,

1. Taking into consideration the United Nations Secretary-General's report on the five-year review of the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of Small Island Developing States (SIDS) (A/65/115),
2. Also taking into consideration the United Nations General Assembly draft resolution A/65/L.2 and the Outcome Document of the High-level Review Meeting on the implementation of the Mauritius Strategy for the Further Implementation of the Programme of Action for the Sustainable Development of SIDS,
3. Recalling 32 C/Resolution 48, 33 C/Resolution 8 and 35 C/Resolution 33(II) regarding UNESCO's programme of action for the sustainable development of SIDS,

4. Also recalling the priority status assigned to SIDS in UNESCO's Medium-Term Strategy for 2008-2013 (34 C/4),
5. Acknowledging the commitment shown and action taken by SIDS in implementing the Barbados Programme of Action and the Mauritius Strategy,
6. Also acknowledging the range of valuable activities and programmes conducted by UNESCO and the unique contribution made to date through the intersectoral platform in efforts to implement the Mauritius Strategy,
7. Strongly reaffirming, in the face of continuing limited institutional capacity and resource limitations, the necessity to strengthen the resilience of SIDS in overcoming their unique and specific vulnerabilities,
8. Notes with concern that the five-year review of the Mauritius Strategy implementation has revealed that SIDS continue to face increasing sustainable development challenges caused by their unique vulnerabilities and that while SIDS have progressed in the area of gender, health, education and environment, their overall progress towards achieving the MDGs has been uneven;
9. Also notes with concern that the review has also revealed that SIDS have made less progress than most other groupings and, even in some cases, have regressed in economic terms, especially with regard to poverty reduction and debt sustainability, and have not achieved sustained high levels of economic growth owing in part to the ongoing negative impacts of the financial and economic crisis;
10. Convinced that proactive, innovative, timely and targeted measures need to be taken to address those challenges;
11. Urges therefore the Director-General to further consolidate UNESCO's efforts to support SIDS in implementing the Mauritius Strategy, with particular emphasis on *inter alia* the following measures:
  - (a) continuing to mainstream the Mauritius Strategy in the Organization's activities and work programmes through the establishment *inter alia* of distinct SIDS subprogrammes for the different SIDS subregions and the elaboration of measurable goals and indicators for monitoring and evaluating the progress made by UNESCO in supporting SIDS in implementing the Mauritius Strategy;
  - (b) taking appropriate measures to reinforce the intersectoral platform on UNESCO's contribution to the implementation of the Mauritius Strategy;
  - (c) strengthening UNESCO's efforts in providing capacity-building and expertise with regard to safeguarding tangible and intangible cultural heritage, for the creation and development of cultural industries and for the protection of underwater cultural heritage in SIDS;
  - (d) supporting the development and implementation by SIDS of measures to promote sustainable tourism;
  - (e) further consolidating action taken by UNESCO to build the resilience of SIDS against the adverse impacts of climate change and sea-level rise with particular focus on climate change education, mitigation and adaptation;
  - (f) further enhancing action taken by UNESCO to help SIDS to deal with the damaging impacts of natural and environmental disasters by strengthening and establishing, if necessary, effective regional and national programmes aimed at developing a preventive approach to natural disasters, notably through tsunami

- early warning systems and other disaster-risk reduction, management and coordination programmes;
- (g) enhancing support to SIDS in strengthening the implementation of their integrated coastal zone management strategies and their scientific research capacity, and in building capacity in science and technology;
  - (h) facilitating the sharing of good practices, success stories, experiences and information among SIDS in the field of sustainable development;
  - (i) facilitating the mobilization of extrabudgetary funds to ensure that adequate funding is available for the effective implementation of the different programmes and activities for SIDS;
12. Invites the Member States to enhance their efforts to support SIDS in the implementation of the Mauritius Strategy;
13. Invites the Director-General to report on the above to it at its 187th session.

#### **42 Reflection by UNESCO on the Internet (185 EX/42; 185 EX/INF.20; 185 EX/52 Rev.)**

The Executive Board,

1. Recalling the Organization's mandate to "promote the free flow of ideas by word and image" and to "maintain, increase and diffuse knowledge",
2. Noting the important role that UNESCO plays as one of the lead agencies in the overall coordination and as facilitator of the implementation of six action lines adopted by the World Summit on the Information Society (WSIS) (Geneva-2003 and Tunis-2005 phases),
3. Recalling 35 C/Resolution 62,
4. Reaffirming its support for the concept of building knowledge societies and for its four underlying key principles, namely freedom of expression, quality education for all, universal access to information and knowledge, and respect for cultural and linguistic diversity,
5. Reaffirming UNESCO's role in developing and implementing the concept of "knowledge societies" regionally and nationally,
6. Taking into consideration the significant changes that have come about in recent years, particularly with regard to the use of the Internet and the proliferation of virtual social networks, and bearing in mind the possible effects of these changes on the nature and daily behaviour of individuals, media professionals and policy-makers,
7. Requests the Director-General, in the light of the foregoing, to initiate reflection and analysis, in the context of UNESCO's existing programmes, on all aspects of the Internet;
8. Further requests the Director-General to inform it at its 186th session of the results of such reflection and analysis.

**43 UNESCO and the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services (IPBES) (185 EX/43 and Add. and Corr.; 185 EX/52 Rev.)**

The Executive Board,

1. Noting the important developments relating to biodiversity science and policy in the context of the International Year of Biodiversity (IYB, 2010), including the conclusions by representatives of governments at the third ad hoc Intergovernmental and Multistakeholder Meeting on an Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services (Busan, Republic of Korea, 7-11 June 2010) that an Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services (IPBES) should be established to strengthen the science-policy interface for biodiversity and ecosystem services for the conservation and sustainable use of biodiversity, long-term human well-being and sustainable development,
2. Expresses its satisfaction with the implementation on the part of UNESCO's Secretariat and the various UNESCO communities, notably Member States and National Commissions, of 182 EX/Decision 13 on UNESCO's contribution to and participation in the International Year of Biodiversity, as reflected by the information contained in documents 185 EX/4 and 185 EX/5;
3. Takes note of UNESCO's intention to seek institutional association with the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services (IPBES), if established;
4. Expresses its satisfaction at the excellent cooperation between UNESCO and the United Nations Environment Programme, the United Nations Development Programme and the Food and Agriculture Organization of the United Nations in relation to the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services and its expectation that such cooperation will continue until the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services is formally established and thereafter;
5. Requests the Director-General to utilize the opportunities provided by the International Year of Biodiversity and the likelihood of the establishment of the Intergovernmental Science-Policy Platform on Biodiversity and Ecosystem Services to develop a coherent UNESCO-wide initiative on biodiversity to address, in a holistic and integrated manner, all aspects relating to the conservation and sustainable and equitable use of biodiversity from the standpoint of UNESCO's mandate and relevant programmes and activities.

**44 Implementation of the “Seoul Agenda: Goals for the Development of Arts Education”, outcome document of the Second World Conference on Arts Education (185 EX/44; 185 EX/INF.20; 185 EX/52 Rev.)**

The Executive Board,

1. Recalling 35 C/Resolution 40, which encourages the promotion of arts education through the holding of and follow-up to the Second World Conference on Arts Education, and the development of an intersectoral partnership strategy,
2. Having examined document 185 EX/44,
3. Welcomes the positive outcome of the “Second World Conference on Arts Education – Arts for Society, Education for Creativity”, held in Seoul in May 2010, which promoted

the value of high-quality arts education for all in developing capacity for creativity in the twenty-first century and strengthened cooperation among the main actors (national authorities, local governments, teachers, artists, researchers, associations and NGOs) in order to work together to develop practices and reinforce the position of arts education in schools and in societies;

4. Invites UNESCO and its Member States to ensure the follow-up to the Second World Conference by employing the proposed strategies of the Seoul Agenda and by implementing the action items in a concerted effort to realize the full potential of high-quality arts education in order positively to renew education systems, achieve crucial social and cultural objectives and ultimately benefit children, youth and life-long learners of all ages;
5. Recommends that the General Conference take into account the follow-up to the previous two World Conferences on Arts Education and support future conferences, including the Third World Conference which Colombia has offered to host;
6. Invites the Director-General to take into consideration the outcomes of the two previous conferences, to seek the necessary extrabudgetary resources for UNESCO's follow-up thereto and to support the hosting of the Third World Conference on Arts Education;
7. Requests the Director-General to ensure adequate intersectoral cooperation between the Culture and Education Sectors of UNESCO in promoting and integrating arts education, in particular in the context of the education for all (EFA) and education for sustainable development (ESD) plans;
8. Further requests the Director-General, in the light of the outcomes of the previous two conferences, to recommend that the General Conference proclaim an international week of arts education, in order to draw attention to the critical value of arts education, and to encourage all Member States, civil society, professional organizations and communities to organize relevant activities in this regard at the national, regional and international levels.

**45 Promotion of South-South cooperation: Strategic partnership for the operationalization of the Consortium on Science, Technology and Innovation for the South (COSTIS)**  
(185 EX/45 Rev. 2; 185 EX/INF.20; 185 EX/51 and Corr.; 185 EX/52 Rev.)

The Executive Board,

1. Recalling the documents adopted by the Heads of State and Government of the Member States of the Group of 77 and China at the First and Second South Summits held in Havana, Cuba, from 10 to 14 April 2000, and in Doha, Qatar, from 12 to 16 June 2005, respectively,
2. Recalling the Dubai Declaration adopted by the Ministers of Science and Technology of the Member States of the Group of 77 and China at their meeting in Dubai, United Arab Emirates, held from 27 to 30 October 2002,
3. Recalling the decision adopted on 3 September 2006 by the Ministers of Science and Technology of the Member States of the Group of 77 and China on the occasion of the tenth General Conference of the Academy of Sciences for the Developing World (TWAS) and the ninth General Assembly of the Third World Network of Scientific Organizations (TWNSO) held at Angra dos Reis, Rio de Janeiro, Brazil, establishing the Consortium on Science, Technology and Innovation for the South (COSTIS), and endorsed by the Ministers for Foreign Affairs of the Member States of the Group of 77

and China at their thirtieth and thirty-third annual meetings held at United Nations Headquarters in New York on 22 September 2006 and 25 September 2009, respectively,

4. Welcoming the launching of COSTIS by the Ministers of Science and Technology of the Member States of the Group of 77 and China on the occasion of the World Science Forum held in Budapest, Hungary, from 4 to 6 November 2009,
5. Taking note of the Declaration adopted by the Ministers for Foreign Affairs of the Member States of the Group of 77 and China at their thirty-fourth annual meeting held at United Nations Headquarters in New York on 28 September 2010,
6. Recognizing the contribution of UNESCO in promoting South-South cooperation in the field of science and technology and the need for a long-term strategic partnership between developing countries and UNESCO,
7. Urges the Director-General to cooperate with the Group of 77 and China in mobilizing the extrabudgetary resources needed for the implementation of such a project and for the convening of the first General Conference of COSTIS before the Third South Summit of the Group of 77 and China, which is to be held in March 2011, and thus provide the necessary technical support for the operationalization of COSTIS;
8. Requests the Director-General to submit to it at its 187th session a preliminary report on progress in operationalizing COSTIS.

  - (b) that invitations to send observers to the Meeting of Experts will be sent to the organizations of the United Nations system with which UNESCO has concluded mutual representation agreements and which are listed in paragraph (d) of the annex to document 185 EX/46;
  - (c) that an invitation to send an observer, as defined above, will be sent to Palestine, as mentioned in paragraph (c) of the annex to document 185 EX/46;

- (d) that invitations to send observers to the Meeting of Experts will be sent to the organizations, foundations and institutions listed in paragraphs (e), (f), (g), (h), (i), (j) of the annex to document 185 EX/46;
4. Authorizes the Director-General to send out any other invitations that she may deem useful for advancing the work of the above-mentioned intergovernmental meeting (category II), notifying the Executive Board thereof.
