

- 5. <u>Notes</u> that the Director-General has made transfers between appropriation lines in support of UNESCO's participation in country-level programming exercises and for staff movements effected during the period January-June 2014 (net impact \$0), as detailed in paragraphs 3 and 4 of document 195 EX/4 Part II;

Consolidated biennial report on the comprehensive partnership strategy

- 1. Recalling 34 C/Resolution 86 and the Directives therein concerning the use of the name, acronym, logo and Internet domain names of UNESCO,
- 2. Also recalling the relevant recommendations made in the independent external evaluation of UNESCO (185 EX/18, para. 56), and 186 EX/Decision 17 (I) and 192 EX/Decision 5 (III) (E),
- 3. Having examined document 195 EX/4 Part IV,
- 4. <u>Emphasizing</u> that the name and logo of UNESCO are strategic assets that must be protected and that all partnerships must be in line with the values and principles of the Organization,
- 5. Reiterating the importance of establishing and actively managing partnerships in order to reinforce the relevance, impact, credibility, efficiency, effectiveness and visibility of UNESCO's work,
- 6. <u>Welcomes</u> the first consolidated biennial report on the comprehensive partnership strategy;
- 7. <u>Expresses its appreciation</u> for the efforts made by the Director-General to develop a more streamlined organization of the online partnership resources, *inter alia*, by improving the partnerships page on UNESCO's website;
- 8. <u>Invites</u> the Director-General to include in the partnerships page on UNESCO's website, and in an annex to the consolidated biennial report on the comprehensive partnership strategy, information about each private sector partnership signed, including its value, programme area and duration;
- Also invites the Director-General to identify and approach partners that are relevant to the current programme of UNESCO, in order to strategically increase the number of partners from all regions;
- 10. <u>Encourages</u> the Director-General to continue reflecting on how to enhance the comprehensive partnership strategy, taking into account, *inter alia*, the need for:
 - (a) common basic principles and appropriate selection criteria for each category of partner that are consistent with the values and principles of UNESCO;
 - (b) coherent results-based monitoring and evaluation mechanisms;
 - (c) alignment of private sector partnerships with the United Nations Global Compact principles;
 - (d) mechanisms to encourage, in close cooperation with the Secretariat and National Commissions, productive interaction and synergies between different categories of partners, including Goodwill Ambassadors, parliamentarians, the private sector and the media;
 - (e) an action plan for every Goodwill Ambassador;
 - (f) a more equitable geographical distribution of partnerships in all categories;

- 11. Requests the Director-General to submit to it at its 196th session an annex to document 38 C/5 with the targets and expected results for each category of partner covered by the comprehensive partnership strategy, together with a chart showing the anticipated amount of yearly contributions by category of partner, especially for the private sector;
- 12. <u>Also requests</u> the Director-General to present to it at its 199th session the next biennial report on the comprehensive partnership strategy, including information about any outstanding monies, how the contributions raised are spent, and details of any cancelled memoranda of understanding (MOUs).

New format for EX/4 documents: report of the Preparatory Group

- 1. Recalling 194 EX/Decision 4 (I) (B) requesting the Preparatory Group to propose a new format for EX/4 documents which would be more efficient, compliant with the International Aid Transparency Initiative (IATI), forward-looking and making effective use of sunset clauses.
- 2. Having examined document 195 EX/4 Part V PG/Report,
- 3. Also recalling the resolutions on the major programmes adopted by the General Conference at its 37th session which include the requirement to undertake, during the period 2014-2017, a review of the main lines of action and their expected results, including those of the intergovernmental and international programmes pertaining to each major programme, and to propose their continuation, reorientation, including possible reinforcement, exit strategies or termination, based on clear evaluation criteria.
- 4. <u>Having considered</u> the current volume and nature of reporting to the governing bodies in the light of the transition to a four-year programme, and the need to further embed the principles of results-based management and results-based budgeting,
- 5. <u>Keeping in mind</u> the relevant previous resolutions of the General Conference on reporting requirements to the Executive Board, and without prejudice to them,
- 6. <u>Endorses</u> the principle that a clear distinction should be made between reporting on activities and output delivery, and reporting on expected results and outcomes;
- 7. Requests the Director-General to prepare the reports to the Executive Board based on the objectives and elements, and following the format and periodicity described in document 195 EX/4 Part V PG/Report, in particular the proposed timetable annexed hereto:
 - (a) a programme implementation report (PIR) for each spring session;
 - (b) an analytical programme implementation report (APIR) for the spring session of the first year of each quadrennium;
 - (c) a strategic results report (SRR) for the third spring session of each quadrennium;
- 8. <u>Also requests</u> the Director-General to continue to make available online implementation information, to continuously improve its quality and coverage and to produce it, to the extent possible, in the two working languages of the Secretariat (English and French);

- 9. <u>Further requests</u> the Director-General to undertake an online survey in the first quarter of each quadrennium which will be used to obtain feedback from stakeholders and beneficiaries on the quality, use and utility of UNESCO activities and outputs from the preceding C/5 document, in view of the recommendation to incorporate such feedback;
- 10. <u>Decides</u> to continue to implement a C/5 content and programmatic priorities survey of Member States, relevant international organizations and NGOs in order to inform the preparation of the subsequent Draft Programme and Budget (C/5);
- 11. <u>Requests</u> the Special Committee to make proposals with regard to the Executive Board's calendar in order to make best use of these reports and to enable an in-depth debate on select major programmes and cross-cutting issues with a view to ensuring full coverage during a quadrennium;
- 12. <u>Requests</u> the Director-General to review the current Internal Oversight Service (IOS) evaluation programme in order to align it better with the reporting, debates and decisions foreseen herein;
- 13. Recommends that the General Conference at its 38th session endorse this approach to reporting;¹
- 14. <u>Also requests</u> the Director-General:
 - (a) to prepare and circulate concrete examples of what the reports would look like;
 - (b) to consult widely with Member States before 31 December 2014 and to refine the examples if needed.

- 1. Recalling 37 C/Resolution 26 on the further examination of the parameters of possible UNESCO global geoparks and 194 EX/Decision 5 (I) (G),
- 2. Having examined documents 195 EX/5 Part I (A) and 195 EX/5 INF,
- Acknowledging the decisions taken and agreements reached by the Global Geoparks Network (GGN) at its 2014 General Assembly, held in Canada, where the members unanimously endorsed the establishment of the Network as a legally constituted, notfor-profit association,
- 4. <u>Expressing its appreciation</u> to the Global Geoparks Network (GGN) for its generous financial support enabling the working group on UNESCO global geoparks to meet,
- 5. <u>Notes</u> the progress made by the working group on UNESCO global geoparks at its fifth meeting, with a view to formalizing the establishment of UNESCO global geoparks;
- 6. <u>Takes note</u> of the draft proposed operational guidelines for UNESCO global geoparks contained in document 195 EX/5 INF, including the reference to the role assigned to the Executive Board:
- 7. Recognizing the need to promote synergies and cooperation between the proposed UNESCO global geoparks initiative and other UNESCO programmes and conventions,
- 8. <u>Invites</u> the Director-General to:
 - (a) consider creating a formal partnership with the Global Geoparks Network association, taking account of the association's legal character and its intended role in an international geoscience and geoparks programme (IGGP) based on an analysis of the added value of such a partnership;
 - (b) report on any decision taken by the International Union of Geological Sciences (IUGS) at the meeting of its Executive Committee in January 2015 on proposed changes to the existing International Geoscience Programme (IGCP), and amend the partnership with IUGS as appropriate;
 - (c) undertake, after the establishment of an international geoscience and geoparks programme (IGGP), capacity-building activities in the field of geoparks funded by contributions made by Global Geoparks Network members so as to achieve equitable geographical distribution:

Implementation of 37 C/Resolution 44 and 194 EX/Decision 5 (I) (C) relating to the Ascent to the Mughrabi Gate in the Old City of Jerusalem

OCCUPIED PALESTINE

The Executive Board,

1. Having examined document 195 EX/9 and the related report of the Director-General (195 EX/5 Part I (D) and (E)), and having considered documents 190 EX/39, 191 EX/35, 192 EX/34, 195 EX/29 and Add., 195 EX/10 and 195 EX/DG.INF.2,

This decision includes the decisions under agenda items 5.I (E), 9, 10 and 29.

- 2. Recalling the provisions of the four Geneva Conventions (1949) and their Additional Protocols, the 1907 Hague Regulations on Land Warfare, the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict (1954) and its related Protocols, the Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property (1970) and the Convention for the Protection of the World Cultural and Natural Heritage (1972), the inscription of the Old City of Jerusalem and its Walls at the request of Jordan on the World Heritage List (1981) and the List of World Heritage in Danger (1982), and the recommendations, resolutions and decisions of UNESCO on the protection of cultural heritage, as well as resolutions and decisions of UNESCO relating to Jerusalem, also recalling previous UNESCO decisions relating to the reconstruction and development of Gaza as well as UNESCO decisions on the two Palestinian sites in al-Khalīl/Hebron and in Bethlehem.
- 3. Affirming that nothing in the present decision, which is aimed, *inter alia*, at the safeguarding of the Palestinian cultural heritage and the distinctive character of Jerusalem, shall in any way affect the relevant Security Council and other United Nations resolutions and decisions on the legal status of Palestine and Jerusalem,

I

A Jerusalem and the implementation of 37 C/Resolution 44 and 194 EX/Decision 11

- 4. Regrets the absence of progress in the implementation of previous UNESCO decisions concerning Jerusalem, particularly 185 EX/Decision 14, and <u>reiterates</u> its request to the Director-General to appoint, as soon as possible, a permanent and eminent expert(s) to be stationed in East Jerusalem to report on a regular basis about all the aspects covering all UNESCO fields of competency in East Jerusalem;
- 5. <u>Deplores</u> the failure of Israel, the occupying Power, to cease the persistent excavations and works in East Jerusalem, particularly in and around the Old City, and <u>reiterates</u> its request to Israel, the occupying Power, to prohibit all such works, in conformity with its obligations under the provisions of the relevant UNESCO conventions, resolutions and decisions;
- 6. Also deplores the continuous Israeli violations, such as: closure and restrictions of access to the Muslim holy site al-Aqşà Mosque (also known as al-Ḥaram ash-Sharīf); the attempts to change the pre-1967 status quo; the targeting of civilians including religious figures, sheikhs, and priests, as well as all restoration works near and around the Mosque, <u>further deplores</u> the large number of arrests and injuries inside and around al-Aqṣà Mosque by the Israeli forces as well as the frequent intrusions of religious-extremist groups and uniformed forces into the Mosque and <u>urges</u> Israel, the occupying Power, to end these abuses which inflame the tension on the ground;
- 7. Reaffirms in this regard the need to protect and safeguard the authenticity, integrity and cultural heritage of al-Agsà Mosque and to respect the pre-1967 status quo:
- 8. <u>Thanks</u> the Director-General for her efforts to implement previous UNESCO decisions on Jerusalem and <u>requests</u> her to maintain and reinvigorate such efforts;
- B Implementation of 37 C/Resolution 44 and 194 EX/Decision 5 (I) (C) relating to the Ascent to the Mughrabi Gate in the Old City of Jerusalem
- 9. <u>Noting</u> the 13th Reinforced Monitoring Report and all previous reports, together with their addenda prepared by the World Heritage Centre, as well as the state of conservation report submitted to the World Heritage Centre by Jordan and Palestine,

- 10. <u>Deplores</u> the continuing Israeli unilateral measures and decisions regarding the Ascent to the Mughrabi Gate and <u>reaffirms</u> that no Israeli unilateral measures shall be taken in conformity with its status and obligations under the 1954 Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict;
- 11. - 21. <u>Deplores</u> the continuous Israeli restrictions that in effect amount to a blockade of the Gaza Strip, which harmfully affects the free and sustained movement of personnel and humanitarian relief items for the successful implementation of UNESCO reconstruction projects, as well as the targeting of children, the attacks on schools and other educational and cultural facilities, and the denial of access to education, as reflected in document 195 EX/DG.INF.2 and in the Gaza Situation Reports by the United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA), and <u>urges</u> Israel, the occupying Power, to immediately ease this blockade in accordance with the spirit and essence of the 2014 Cairo agreement between Israel and Palestine for a long-term ceasefire in Gaza;

Requests the Director-General to upgrade the UNESCO Antenna in Gaza in order to ensure the prompt reconstruction of schools, universities, cultural heritage sites, cultural institutions, media centres and places of worship that have been destroyed or damaged by the consecutive Israeli raids on Gaza, particularly during July-August 2014:

Welcomes the strong commitment made by the international community in favour of the reconstruction of Gaza, expressed in the International Conference on Palestine "Reconstructing Gaza" held in Cairo, Egypt, on 12 October 2014, thanks Member States and donors for their generous financial contributions for the reconstruction of Gaza, and invites them to further assist UNESCO projects for the reconstruction of Gaza through extrabudgetary funding;
- 24. <u>Thanks</u> the Director-General for initiatives that have already been implemented in Gaza in the field of education, and for the safety of media professionals, and <u>calls upon</u> her to continue her active involvement in the reconstruction of Gaza's damaged educational and cultural components;
- 25. <u>Also requests</u> the Director-General to organize, prior to the Executive Board's 196th session, an information meeting to provide Member States with the most recent assessment of damage, due to the last Israeli raids on Gaza, in the fields of competence of UNESCO and an update on the outcome of the projects conducted in the Gaza Strip-Palestine;

- 4. <u>Deplores</u> the damaging impact of the most recent Israeli operations (July-August 2014) on Gaza in the fields of competence of UNESCO where 26 schools have been completely destroyed and 122 damaged, 75 of them United Nations Relief and Works Agency for Palestine Refugees in the Near East (UNRWA) schools, and at least 11 higher-education facilities have also been damaged, affecting more than 500,000 schoolchildren and students as reported in 195 EX/DG.INF.2, as well as the severe damage inflicted on cultural heritage sites and cultural institutions;
- 5. <u>Reaffirms</u>, in this regard, that schools, universities and cultural heritage sites enjoy special protection and should not be targeted in situations of armed conflict;
- 6. Expresses its growing concern about the harmful impact of the Separation Wall and other practices on the activities of cultural and educational institutions, as well as obstacles resulting therefrom which prevent Palestinian schoolchildren and students from being an integral part of their social fabric and from exercising fully their right to education, and calls for the observance of the provisions of relevant UNESCO conventions, resolutions and decisions, particularly 37 C/Resolution 67 and 185 EX/Decision 36:
- 7. <u>Notes with deep concern</u> the Israeli censorship of the Palestinian curricula of schools and universities in East Jerusalem, and <u>urges</u> Israel, the occupying Power, to immediately halt this censorship;

Recalling decision 30 COM 8B.33 of the World Heritage Committee and bearing in mind the importance of an international indentured labour route project, which would be complementary to the Slave Route Project and the General History of Africa and implemented in the context of the International Decade for People of African Descent (2015-2024),
- Acknowledging the need to create a corpus of professionals in various fields such as history, anthropology, archaeology and heritage in order to develop an international database on indentured labour, accessible worldwide, so as to disseminate information about a major historical event and build greater understanding and cooperation among peoples,
- 3. <u>Also acknowledging</u> the synergies between the international "Indentured Labour Route" project and the Slave Route Project, and the need to identify focused and coordinated activities, with appropriate extrabudgetary funding, involving both projects;
- 4. <u>Welcomes</u> the establishment of a secretariat of the international "Indentured Labour Route" project through the Aapravasi Ghat Trust Fund to be funded by the Government of Mauritius:
- 5. <u>Notes</u> the proposed establishment of an international scientific committee whose terms of reference would be elaborated along with a detailed plan of action, to be regularly monitored, and <u>emphasizes</u> that it should not have any direct or indirect financial implications for the regular budget;
- 6. <u>Requests</u> the Director-General to provide technical support for the international "Indentured Labour Route" project with extrabudgetary funding as appropriate;
- 7. Also notes that efforts will be made at the international and regional levels to encourage Member States, especially those associated with indentured labour, to contribute through voluntary contributions to the international "Indentured Labour Route" project during the implementation stage;
- 8. <u>Encourages</u> Member States to support the international "Indentured Labour Route" project, and <u>welcomes</u> similar projects aimed at further promoting a culture of peace, cultural pluralism and intercultural dialogue.

31 Protection of Iraqi heritage (195 EX/31; 195 EX/DG.INF; 195 EX/41)

- 1. Recalling that the purpose of UNESCO is to contribute to peace and security by promoting collaboration among the nations through education, science and culture in order to further universal respect for justice, for the rule of law and for the human rights and fundamental freedoms which are affirmed for the peoples of the world, without distinction of race, sex, language or religion, by the Charter of the United Nations,
- 2. <u>Reaffirming</u> its commitment to respect for the sovereignty, unity and territorial integrity of Iraq within its internationally recognized borders,

- 3. Also recalling the provisions of the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict (1954), the UNESCO Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property (1970), the Convention for the Protection of the World Cultural and Natural Heritage (1972), the Convention for the Safeguarding of the Intangible Cultural Heritage (2003), the UNIDROIT Convention on Stolen or Illegally Exported Cultural Objects (1995), the UNESCO Universal Declaration on Cultural Diversity (2001) and other relevant international agreements,
- 4. Further recalling the relevant United Nations Security Council resolutions, including resolution 1483 (2003), in particular paragraph 7 on the return of Iraqi cultural property, resolution 1546 (2004), resolution 2056 (2012), and resolution 2170 (2014), in particular paragraph 2 regarding the destruction of cultural and religious sites, as well as Human Rights Council resolution S-22/1 (2014) on the human rights situation in Iraq,
- 5. Recalling that the parties to an armed conflict should refrain from any act of hostility directed against cultural property, that they should seek to prevent incidental damage that could be caused to cultural property, and that any use of the property and its immediate surroundings or of the appliances in use for its protection for purposes which are likely to expose it to destruction or damage in the event of armed conflict, is prohibited, and may be waived only in cases where military necessity imperatively requires such a waiver,
- 6. Also reaffirming that damage to the archaeological, historical, cultural and religious tangible and intangible heritage constitutes damage to the cultural heritage of humanity as a whole, and that under the Rome Statute of the International Criminal Court, adopted on 17 July 1998, intentionally directing attacks against buildings dedicated to religion, education, art, science or charitable purposes and historic monuments, provided they are not military objectives, is a war crime, in the framework of both international armed conflict and armed conflict not of an international character.
- 7. <u>Stressing</u> the need to respect the archaeological, cultural and religious heritage of Iraq, to continue to protect it, and to protect museums, libraries and monuments, to safeguard social practices, rituals and cultural expressions recreated by Iraqi communities, and to provide accountability for the destruction of such heritage,
- 8. <u>Also recalling</u> the adoption by UNESCO's General Conference, at its 33rd session, of the UNESCO Declaration concerning the Intentional Destruction of Cultural Heritage,
- 9. <u>Condemns</u> the destruction of Iraq's cultural heritage, notably by Daesh (ISIL) and associated armed groups, whether such destruction is incidental or deliberate, and including the targeted destruction of religious heritage;
- 10. <u>Also condemns</u> the use of cultural property for military purposes, and <u>calls for</u> the obligations under international law to be respected, in particular those of the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict (1954);
- 11. <u>Further condemns</u> attacks on the country's cultural diversity and on the practices, representations, expressions and skills that Iraqi groups and communities recognize as part of their intangible cultural heritage;
- 12. <u>Calls for</u> an immediate halt to the destruction of the Iraqi heritage, and for the preservation of such heritage by protecting cultural property and sites in Iraq and preventing the subversion of educational, cultural and religious institutions, in accordance with United Nations Security Council resolution 2170, of 15 August 2014;

- 13. Also calls for respect for international agreements on the protection of cultural heritage, including the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict (1954), the UNESCO Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property (1970), and the Convention for the Protection of the World Cultural and Natural Heritage (1972);
- 14. <u>Calls on</u> all parties concerned to ensure respect for the practices, rituals and cultural expressions of the different ethnic and religious communities in Iraq and for their safeguarding, in accordance with the Convention for the Safeguarding of the Intangible Cultural Heritage (2003);
- 15. <u>Supports</u> the new Iraqi Government in its efforts to protect the Iraqi heritage, by involving, in respect for cultural diversity, all components of the Iraqi population, in a spirit of unity and national reconciliation, and ensuring that all those responsible for violations of international agreements on the protection of the cultural heritage are held to account;
- 16. <u>Calls upon</u> the international community to assist the Iraqi authorities, in observance of cultural diversity in the country, to protect and safeguard the Iraqi heritage and to combat trafficking in cultural property, including manuscripts, illegally excavated from archaeological sites, or taken from museum collections and libraries;
- 17. <u>Invites</u> States Parties to the World Heritage Convention, and States members of the Intergovernmental Committee for Promoting the Return of Cultural Property to its Countries of Origin or its Restitution in Case of Illicit Appropriation, the Intergovernmental Committee for the Protection and Promotion of the Diversity of Cultural Expressions, and the Subsidiary Committee of the Meeting of States Parties to the Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property (1970), to report, at future sessions of these bodies, on actions they have undertaken for the protection and safeguarding of the cultural diversity of Iraq, and its tangible and intangible cultural heritage;
- 18. <u>Calls upon</u> all countries and all professional groups involved in the areas of customs and trade, as well as individuals and tourists, to verify the origin of cultural property that may have been imported, exported or offered for sale illegally, and <u>calls upon</u> Member States that are not yet Parties, to consider joining the UNESCO Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property (1970);
- 19. <u>Further calls for</u> the urgent implementation and strengthening of the UNESCO Emergency Response Action Plan for the Safeguarding of Iraq's Cultural Heritage, drawn up in July 2014, which provides for close monitoring of the conservation status of Iraqi heritage, training of professional curators and support for staff in place, including for the development of emergency measures for the possible transfer of movable property, in particular library holdings and manuscript collections;
- 20. <u>Invites</u> the Director-General to send a mission to Iraq as soon as possible, to be funded by voluntary contributions, so as to assess the extent of damages, in coordination with national and local authorities and in consultation with the United Nations Assistance Mission for Iraq (UNAMI) and to identify urgent needs in terms of conservation and safeguarding, and to ensure that this mission presents a preliminary report on the situation at an information meeting of the Executive Board to be convened for this purpose, followed by a written report to be submitted at its 196th session and also submitted to the committees mentioned in paragraph 17;

- 21. <u>Calls for international organizations</u>, particularly those in the United Nations system, to strengthen, in their policies and actions on the ground, their consideration for the safeguarding of the cultural heritage and cultural diversity in Iraq;
- 22. <u>Also invites</u> the Director-General of UNESCO to ensure that the Secretariat works with the above-mentioned organizations, where appropriate, to assist them in the development and implementation of such policies;
- 23. <u>Invites</u> Member States to make voluntary financial contributions for this purpose.

The Executive Board,

- 1. <u>Recalling</u> decision 32 COM 8B.102 of the World Heritage Committee inviting Cambodia, in cooperation with UNESCO, to establish an international coordination committee (ICC) for the Temple of Preah Vihear,
- 2. <u>Noting</u> that relevant parties are cooperating with each other regarding the establishment of an international coordination committee,
- 3. <u>Taking into account</u> the measures taken by Cambodia on the human, technical and financial level to ensure the smooth functioning of an international coordination committee, without having recourse to UNESCO's regular budget,
- 4. Also noting that all activities to be carried out by or under an international coordination committee (ICC) for the Temple of Preah Vihear shall be without prejudice to the rights and duties of Thailand and Cambodia with regard to the land boundary under international law, and shall by no means prejudge the outcome of future consultations between Thailand and Cambodia regarding the International Court of Justice Judgment of 11 November 2013.
- 5. <u>Welcomes</u> the Director-General's cooperation with Cambodia in working to establish an international coordination committee (ICC) for the Temple of Preah Vihear.

- (d) invitations to send observers to the intergovernmental meeting of experts (category II) will be sent to the organizations, foundations and institutions listed in paragraphs (d), (e) and (f) of the annex to document 195 EX/35;
- 4. <u>Authorizes</u> the Director-General to send invitations to the entities listed in paragraph (g) of the annex to document 195 EX/35, and to any other entities she may deem useful for advancing the work of the intergovernmental meeting of experts (category II), notifying the Executive Board thereof,
- 5. <u>Thanks</u> the Government of Brazil for its continued support for this process, and <u>invites</u> other Member States to consider making voluntary extrabudgetary contributions to support the funding of the intergovernmental meeting of experts (category II) and related activities in order to meet all costs that will be incurred.
