## SECOND PROTOCOL TO THE HAGUE CONVENTION OF 1954 FOR THE PROTECTION OF CULTURAL PROPERTY IN THE EVENT OF ARMED CONFLICT

**Item 9 of the Provisional Agenda:**  
**Form for the tentative list for cultural property that may be submitted**  
**for the granting of enhanced protection**

1. In December 2011, the Committee for the Protection of Cultural Property in the Event of Armed Conflict ('the Committee') at its sixth Meeting encouraged "Parties to submit tentative lists of cultural property for which a Party intends to request the granting of enhanced protection". On this basis, the Secretariat sent on 31 January 2012 an e-mail to all Parties to the Second Protocol to invite them to submit such lists.
2. One tentative list was received from Belgium, and another Party informed the Secretariat of its intention to submit such a list (situation updated on 30 September 2013).
3. A page on the website of the 1954 Hague Convention and its two Protocols dedicated to the tentative lists was created. It presents the provisions of the Second Protocol and the paragraphs of the Guidelines for the Implementation of the Second Protocol related to the tentative lists as well as the tentative list of cultural properties presented by Belgium. 4. At its informal meeting held on 8 and 9 July 2013, the Bureau of the Committee considered the possibility of creating a form for the submission of tentative lists available in order to facilitate the task of Parties. At its meeting held on 16 September 2013, it decided to submit such a form to the Committee at its eighth Meeting.
5. The form proposed to the Committee (Annex 1) is user-friendly and was elaborated on the basis of the form for the submission of requests for the granting of enhanced protection.
6. The Committee may wish to adopt the following decision:

The Committee,

1. Having considered document CLT-13/8.COM/CONF.203/6,
2. Thanks the Bureau for its proposal to create a form for the tentative list for cultural property that may be submitted for the granting of enhanced protection,
3. Approves such a form;
4. Encourages Parties to submit to the Secretariat tentative lists by using the above-mentioned form;
5. Requests the Secretariat to make this form available on its website.
