El Salvador – Request for Financial Assistance from the Fund for the Protection of Cultural Property in the Event of Armed Conflict

I. Introduction

- 1. Article 29(1) of the Second Protocol allows for the possibility of providing financial or other assistance in support of preparatory or other measures to be taken in peacetime. Such assistance is provided by the Committee for the Protection of Cultural Property in the Event of Armed Conflict (the 'Committee') from The Fund for the Protection of Cultural Property in the Event of Armed Conflict (the 'Fund').
- 2. The modalities of the use of the Fund are further elaborated in the guidelines concerning the use of the Fund.
- 3. On 17 June 2011, the Permanent Delegation of El Salvador to UNESCO submitted to the Secretariat a request for international assistance for the funding of preparatory measures concerning the following cultural properties: (i) Monument to the Memory and Truth, (ii) La Casona ("the Mansion") Museo forma, (iii) San Miguel Arcángel Parish Church, (iv) Corinto Cave or Cave of the Holy Spirit, and (v) Barrientos' Family House.
- 4. Following the consideration of this request by the informal meeting of the Bureau of the Committee held on 5 and 6 September 2011 at UNESCO Headquarters and its subsequent conclusion that this request falls more within the category of requests for financial or other assistance from the Fund than the international assistance, the Permanent Delegation of El Salvador submitted to the Secretariat on 22 September 2011 a revised request for financial assistance from the Fund. The request is attached in the annex.
- 5. In addition to the request, the authorities concerned also provided the following information:
 - •An El Salvador Cultural Heritage Identification Form was submitted for each cultural property in English;
 - Photographs of the above-mentioned properties were provided with the request as part of the El Salvador Cultural Heritage Identification Forms;
 - Maps were also provided for each of the above-mentioned properties;
 - The texts of national legislation concerning the protection of the above-mentioned properties were submitted in English.
- 6. It should be recalled that El Salvador previously submitted two requests for financial assistance under UNESCO's Participation Programme¹. The Participation Programme, to which all Member States and Associate Members of UNESCO may apply, provides assistance that may include the provision of: (a) the services of specialists and consultants, not including staff costs and administrative support; (b) fellowships and study grants; (c) publications, periodicals and documentation; (d) equipment (other than vehicles); (e) conferences, meetings, seminars and training courses: translation and interpretation

services, participants' travel costs, the services of consultants, and other services deemed necessary by all concerned (not including those of UNESCO staff members); and (f) financial contributions.

- 7. The projects or action plans submitted by the Member States under the Participation Programme must relate to the activities of the Organization, particularly the major programmes, interdisciplinary projects, the activities on behalf of Africa, least developed countries, youth and women and the activities of the National Commissions for UNESCO. The present budget approved for the Participation Programme for 2010-2011 is US\$ 19,000,000. Financial and analytical reports should be submitted to UNESCO after implementation of the project.
- 8. The requests for financial assistance from the Participation Programme submitted by El Salvador were for the first two phases of the current project for which the same authorities submitted a request for financial assistance from the Fund in 2011. In 2002, US\$ 20,000 was granted under the Participation Programme for phase I of a comprehensive programme to mark cultural property with the Blue Shield. The goals of this project included marking cultural property with the Blue Shield, contributing to El Salvador's accession to the Second Protocol to the Hague Convention, and creating awareness-raising publications for national distribution. El Salvador contributed US\$ 34,286 to this phase of the project.
- 9. Then, in 2008, the sum of US\$ 20,000 was granted for phase II of this project to mark a total of 11 sites with the Blue Shield, to broadcast the Hague Convention through mass media, as well as to show cultural properties that had been marked with the Blue Shield. El Salvador contributed US\$ 14,500 to this phase of the project.
- 10. The request for financial assistance (see annex) represents the next phase of this project. Further, the Permanent Delegation of El Salvador to UNESCO has stated that the relevant authorities of El Salvador do not wish to request the granting of enhanced protection to these five above-mentioned cultural properties at this time.

THE REQUEST FOR FINANCIAL ASSISTANCE FOR THE PROTECTION OF CULTURAL PROPERTIES IN EL SALVADOR HAS BEEN MADE ACCORDING TO ARTICLE 29(1)(A) OF THE SECOND PROTOCOL, IN ORDER TO BE CONSIDERED BY THE COMMITTEE.

THE FIVE CULTURAL PROPERTIES ARE HISTORICAL MONUMENTS AND ARCHEOLOGICAL SITES OF NATIONAL SALVADORIAN IMPORTANCE. THEY HAVE BEEN RECOGNIZED AS NATIONAL MONUMENTS BY THE APPROPRIATE NATIONAL AUTHORITIES, AS FOLLOWS:

THE MONUMENT TO THE MEMORY AND THE TRUTH WAS DECLARED A NATIONAL MONUMENT BY RESOLUTION 001/2011, ADOPTED BY THE SECRETARY OF CULTURE OF THE PRESIDENCY OF THE REPUBLIC, AND PUBLISHED IN DIARIO OFICIAL NO. 33, VOLUME 390, DATED 16 FEBRUARY 2011.

<u>Museo Forma</u> was declared a national monument by agreement No. 4417 of the Executive Branch of the republic, and published in Diario Oficial No. 46, Volume 338, dated 9 March 1998.

<u>SAN MIGUEL ARCÁNGEL PARISH CHURCH</u> WAS DECLARED A NATIONAL MONUMENT BY LEGISLATIVE DECREE NO. 19, DATED 26 JULY 1978, AND PUBLISHED IN DIARIO OFICIAL NO. 155, VOLUME 260, DATED 23 AUGUST 1978.

<u>CORINTO CAVERN</u> WAS DECLARED A NATIONAL MONUMENT BY LEGISLATIVE DECREE NO. 25, DATED 29 JUNE 1972, AND PUBLISHED IN DIARIO OFICIAL NO. 129, VOLUME 236, DATED 12 JULY 1972.

<u>Barrientos' family house</u> was declared a national monument by legislative decree No. 78, dated 10 October 1991, and published in Diario Oficial No. 231, Volume 313, dated 9 December 1991.

THE CULTURAL PROPERTIES ARE DESCRIBED BRIEFLY BELOW:

MONUMENT TO THE MEMORY AND THE TRUTH

THIS SCULPTURAL MONUMENT COMMEMORATES THE VIOLATIONS OF HUMAN RIGHTS WHICH OCCURRED DURING THE SALVADORIAN ARMED CONFLICT FROM 1980 TO 1992. THE MONUMENT WAS CONSTRUCTED ON THE RECOMMENDATION OF THE TRUTH COMMISSION, AFTER THE PEACE ACCORDS WERE SIGNED.

IT IS COMPOSED OF ONE CURVED WALL OF BLACK GRANITE, THREE METERS IN HEIGHT AND EIGHTY-FIVE METERS IN LENGTH, STRUCTURED IN TWO PARTS: THE FIRST PART IS A MURAL WHICH REPRESENTS THE SERIOUS VIOLATIONS WHICH OCCURRED DURING THE ARMED CONFLICT, AS WELL AS SALVADORIAN NATIONAL SYMBOLS. THE SECOND PART IS A LIST, ORGANIZED BY YEAR, OF THE APPROXIMATELY SEVENTY-FIVE THOUSAND VICTIMS OF THE REPRESSION. IT SERVES AS A COMMON GRAVESTONE FOR THOSE PERSONS WHO HAD NO FORMAL BURIAL AND WHOSE REMAINS HAVE NOT YET BEEN FOUND.

"LA CASONA" ("THE MANSION") - MUSEO FORMA.

THIS BUILDING WAS DESIGNED AS A PRIVATE RESIDENCE, SURROUNDED BY GARDENS AND GREEN AREAS. THE STYLISTIC CHARACTERISTICS INCLUDE NEO-COLONIAL VOLUMETRY AND MORPHOLOGY, AS WELL AS NEOCLASSICAL AND BAROQUE ELEMENTS AND ORNAMENTATION, AS WELL AS A COMPLEX INTERIOR PLAN.

IT HAS TWO LEVELS. THE MAIN ENTRANCE IS DECORATED WITH A VERTICAL CYLINDER WHERE THE STAIRS ARE LOCATED, CONNECTING THE FIRST AND SECOND LEVELS. THE EASTERN AND NORTHERN FACADES ARE SURROUNDED BY ARCADES ON THE FIRST LEVEL AND OPEN GALLERIES ON THE SECOND LEVEL. THE ROOF IS PITCHED AND STRUCTURED IN WOOD AND COMPOSED OF SEVERAL SLOPES, ADAPTED TO THE VOLUMETRY OF THE BUILDING. THE BUILDING IS CHARACTERIZED BY LARGE OPEN SPACES IN WHICH THE COMMON AND SOCIAL AREAS ARE LOCATED.

SAN MIGUEL ARCÁNGEL PARISH CHURCH

THE PARISH CHURCH WAS BUILT IN THE BAROQUE TRADITION DURING THE COLONIAL PERIOD. ALTHOUGH MODEST, IT HAS ELEGANT ALTARPIECES OF CARVED WOOD, WHICH IS HIGHLY REPRESENTATIVE OF THE BAROQUE TRADITION.

IT FACES THE WEST. ALL THE FACADES ARE BUTTRESSES, GIVING STRUCTURAL SUPPORT TO THE SMOOTH AND UNORNAMENTED WALLS. IT HAS THREE ACCESS POINTS: ONE ON THE NORTH SIDE, ONE ON THE WEST SIDE, AND ONE ON THE SOUTH SIDE. EACH ACCESS POINT IS DECORATED WITH PILASTERS ENDING AT CORNICE MOULDINGS. THE MONASTERY AREA IS BUILT IN A NORTH – SOUTH ORIENTATION, WITH AN ENTRY IN ALL ITS LENGTH. THE BUILDING IS RECTANGULAR, DIVIDED INTO THREE SECTIONS. THE CENTRAL SECTION ACCOMMODATES THE SEATS, WHILE THE LATERAL SECTIONS ARE UTILIZED AS

HALLWAYS, SEPARATED BY COLONNADES OF WOOD WHICH SUPPORT STRETCHED ARMOURS FOLLOWING THE TRADITION OF ANDALUSIA STUCCOES.

CORINTO CAVERN OR CAVERN OF THE HOLY SPIRIT

KNOW AS CAVERN OF THE HOLY SPIRIT, THIS SITE IS A ROCKY SHELTER WITH CAVE PAINTINGS AND GRAPHIC ROCK DEMONSTRATIONS. THE FIRST SCIENTIFIC MENTION ABOUT THE ARCHAEOLOGICAL SITE IS ATTRIBUTED TO SANTIAGO I. BARBERENA, AT THE BEGINNING OF THE 20TH CENTURY (BARBERENA, 1926).

IN THE DECADE OF THE 70'S, WOLFGANG HABERLAND CARRIED OUT AN ARCHAEOLOGICAL INVESTIGATION BY MEANS OF EXCAVATIONS IN THE FLANKS OF THE ROCKY SHELTER (HABERLAND, 1972). FILES OF THE DEPARTMENT OF ARCHEOLOGY (1972) AND FILES OF THE DEPARTMENT OF INVESTIGATIONS OF THE MUNA (1972), DOCUMENT THE WORK CARRIED OUT BY MANUEL LÓPEZ AND HABERLAND. A BRIEF DESCRIPTION OF THE SITE AND THE CAVE PAINTINGS CAN BE FOUND IN THE FILES. THE CAVERN WALLS ARE PAINTED WITH SEVERAL FIGURES OF ANIMALS, HUMANS BODIES, AND GEOMETRIC FIGURES IN COLORS AS DIVERSE AS YELLOW, RED AND EVEN PURPLE.

BARRIENTOS' FAMILY HOUSE

THIS FAMILY INCLUDED SOME OF THE MOST CONSPICUOUS MEMBERS OF THE SOCIETY OF IZALCO, WHERE THEY EXERCISED LEADERSHIP. THE BARRIENTOS FAMILY RECEIVED A ROYAL CONCESSION OF AN IMPORTANT QUANTITY OF LAND AS RECOGNITION OF THEIR MERITS. AFTER THE SOCIOPOLITICAL CRISIS OF THE THIRTIES IN THE 20TH CENTURY, THEIR WEALTH AND POWER GREATLY DIMINISHED.

ARCHITECTURALLY, THIS SITE IS ONE OF THE BEST EXAMPLES OF COLONIAL ARCHITECTURE. IT CENTERS AROUND A CENTRAL PATIO. IT HAS TESTED ANTIQUE VALUE ACCORDING THE DATE IN ONE OF THE CORNERSTONES, MARKED WITH THE YEAR 1864 AND THE ABBREVIATION DRB (POSSIBLY MEANING MR. RAFAEL BARRIENTOS — BUSINESSMAN, MERCHANT AND LANDOWNING). ON THIS POINT, THE HOUSE CONSERVES ITS ORIGINAL ARCHITECTURAL LAYOUT. IT ALSO CONSERVES FLAT CLAY TILES, WALLS OF ADOBE, AND ARCHES OF STONEWORK COVERED WITH WOOD AND TILES. TRULY, IT IS ONE OF THE MOST REPRESENTATIVE BUILDINGS OF COLONIAL ARCHITECTURE.

THIS PROJECT IS PART OF THE ACTIONS UNDERTAKEN SINCE 2004 BY THE GOVERNMENT OF EL SALVADOR IN THE FRAMEWORK OF THE SECOND PROTOCOL OF THE HAGUE CONVENTION OF 1954 FOR THE PROTECTION OF CULTURAL PROPERTY IN THE EVENT OF ARMED CONFLICT, ARTICLE 29 PARAGRAPH 1(A).

THESE ACTIONS CAN BE MADE POSSIBLE BY THE FINANCIAL SUPPORT OBTAINED FROM THE FUND FOR THE PROTECTION OF CULTURAL PROPERTY IN THE EVENT OF ARMED CONFLICT, IN SUPPORT OF PREPARATORY OR OTHER MEASURES TO BE TAKEN IN PEACETIME IN ACCORDANCE WITH, INTER ALIA, ARTICLE 5, ARTICLE 10 SUB-PARAGRAPH (B) AND ARTICLES 29(1) AND 30 OF THE SECOND PROTOCOL.

THE ACTIVITY WILL BENEFIT FIVE DIFFERENT COMMUNITIES ACROSS THE COUNTRY, AND THE SAME NUMBER OF CULTURAL PROPERTIES WILL BE MARKED WITH THE BLUE SHIELD WITHIN THE FRAMEWORK OF GENERAL PROTECTION.

4. IDENTIFICATION OF THE PLACE OF ACTIVITY:

THE FIVE CULTURAL PROPERTIES WHICH WILL BE MARKED ARE LOCATED IN DIFFERENT ZONES OF THE COUNTRY, NOTED BELOW:

THE MONUMENT TO THE MEMORY AND THE TRUTH IS LOCATED AT THE NORTHWEST SIDE OF CUSCATLAN PARK NEXT TO ALAMEDA ROOSEVELT AND 25TH SOUTH AVENUE IN THE CITY OF SAN SALVADOR, IN THE CENTRAL ZONE OF THE COUNTRY. ACCORDING UTM SYSTEM IS LOCATED IN ZONE 16, LAT. BAND P, COORDINATES 261,207.99 M E / 1515590.65 M N.

THE MUSEUM FORMA IS LOCATED AT COLONIA ESCALÓN, NEXT TO PASAJE SENDA FLORIDA AND ALAMEDA MANUEL ENRIQUE ARAUJO, IN THE CITY OF SAN SALVADOR, IN THE CENTRAL ZONE OF THE COUNTRY. ACCORDING UTM SYSTEM IS LOCATED IN ZONE 16, LAT. BAND P, COORDINATES 259,292.29 ME/1,515,744.42 MN.

SAN MIGUEL ARCÁNGEL PARISH CHURCH IS LOCATED ON HERMANOS AGUILAR AVENUE AND NEXT TO PASAJE SAN MIGUEL, IN THE CITY OF HUIZÚCAR, DEPARTMENT OF LA LIBERTAD, CENTRAL ZONE OF THE COUNTRY. ACCORDING UTM SYSTEM IS LOCATED IN ZONE 16, LAT. BAND P, COORDINATES 257,910.94 M E / 1,503,091.25 M N.

THE <u>CORINTO CAVERN</u> IS LOCATED 1,5 KILOMETERS NORTH-EAST FROM CORINTO TOWN OR 20,5 KILOMETERS NORTH-EAST FROM THE CITY OF SAN FRANCISCO MORAZÁN, DEPARTMENT OF MORAZÁN, <u>EASTERN</u> ZONE OF THE COUNTRY. ACCORDING UTM SYSTEM IS LOCATED IN ZONE 16, LAT. BAND P, COORDINATES 395,845.12 M E / 1,528,332.44 M N.

THE <u>BARRIENTOS' FAMILY HOUSE</u> IS LOCATED IN THE INTERSECTION OF FIRST WESTERN STREET AND FIRST NORTH AVENUE, BARRIO LIBERTAD OF IZALCO CITY IN THE DEPARTMENT OF SONSONATE, <u>WESTERN ZONE OF THE COUNTRY</u>. ACCORDING UTM SYSTEM IS LOCATED IN ZONE 16, LAT. BAND P, COORDINATES 210,662.34 M E / 1,521,377.53 M N.

EACH CULTURAL PROPERTY WILL BE MARKED DURING A CEREMONY. BEFORE THE CEREMONY, THREE WORKSHOPS WILL TAKE PLACE WITH THE PARTICIPATION OF ACTIVE MEMBERS OF LOCAL COMMUNITY AND NATIONAL AUTHORITIES DIRECTLY RESPONSIBLE FOR THE PROTECTION AND CONSERVATION OF THE CULTURAL PROPERTIES ABOVE MENTIONED, AS FOLLOWING:

FIRST, IN EACH COMMUNITY A GENERAL WORKSHOP ON HUMANITARIAN INTERNATIONAL LAW WILL TAKE PLACE.

A SECOND WORKSHOP ON THE 1954 HAGUE CONVENTION AND ITS TWO PROTOCOLS (1954 AND 1999) WILL BE ORGANIZED.

FINALLY, ANOTHER GENERAL WORKSHOP WILL BE CARRIED OUT IMMEDIATELY BEFORE THE CEREMONY OF PLACEMENT OF THE BLUE SHIELD EMBLEM.

THIS EFFORT SEEKS TO CONTRIBUTE TO THE DISSEMINATION OF HUMANITARIAN INTERNATIONAL LAW, THE 1954 HAGUE CONVENTION AND ITS TWO (1954 AND 1999) PROTOCOLS, AND THE PROMOTION OF THE BLUE SHIELD EMBLEM IN PEACETIME, AS WELL AS TO CONTRIBUTE TO THE PROCESS OF PLACING THE EMBLEM AT EACH ONE OF THE FIVE CULTURAL PROPERTIES.
