REPORT BY THE INTERGOVERNMENTAL COUNCIL OF THE INTERNATIONAL PROGRAMME FOR THE DEVELOPMENT OF COMMUNICATION ON ITS ACTIVITIES (1998-1999)

OUTLINE

Source: Article 11 of the Statutes of the International Programme for the Development of Communication.

Background: The Intergovernmental Council of the International Programme for the Development of Communication (IPDC) submits this report to the General Conference in accordance with 21 C/Resolution 4/21 and in pursuance of Article 11 of its Statutes adopted at the 21st session, which stipulates that the Council shall submit reports on its activities to the General Conference at each of its ordinary sessions.

Purpose: The present report covers the work of its eighteenth and nineteenth ordinary sessions (March 1998 and March 1999 respectively), the activities of the programme, and the voluntary contributions received in 1998 and 1999. It gives an overview of the working methods and procedures of IPDC and the important reforms made during the last six years. It also mentions the evaluation of terminated IPDC projects, describing some of the problems encountered. A list of projects financed under the IPDC Special Account and funds-in-trust in 1998-1999 is provided in the Annex.

Decision required: No decision is required on this document.

INTRODUCTION

- 1. The Intergovernmental Council of the International Programme for the Development of Communication (IPDC) submits this report to the General Conference in accordance with 21 C/Resolution 4/21 and in pursuance of Article 11 of its Statutes adopted at the 21st session, which stipulate that the Council shall submit reports on its activities to the General Conference of UNESCO at each of its ordinary sessions.
- 2. Since submitting its report to the 29th session of the General Conference in 1997, the Intergovernmental Council of IPDC has met twice at UNESCO Headquarters in Paris: the eighteenth session was held from 24 to 27 March 1998 and the nineteenth session from 23 to 26 March 1999.
- 3. At the eighteenth session, elections were held to elect new members to the Bureau of the Council, comprising the Chairperson, three Vice-Chairpersons, a Rapporteur and three members. By consensus of the Council and by acclamation, the Bureau was elected as follows:

Chairperson: Mr Reinhard Keune (Germany)

Vice-Chairpersons: Cuba, Malaysia, Yemen (followed by Saudi Arabia in 1999)

Rapporteur: Ms Barbara Gloudon (Jamaica)

Members: France, Mali, Russian Federation

4. **The IPDC-UNESCO Prize for Rural Communication.** In the absence of a candidate fulfilling all the criteria, the Bureau, which performed the function of the jury, decided to use the amount of US \$25,000 (comprising the amount of the prize and its relating costs) to launch the IPDC-Maurice Garrison Fellowship Programme for journalists working in community media.

WORKING METHODS AND PROCEDURES OF IPDC

5. At the eighteenth session, Mr Torben Krogh, outgoing Chairperson of IPDC, reviewed the six years in which he had served as the head of the Intergovernmental Council. A number of important reforms had been made in this period in order to improve the working methods of IPDC. They had been designed:

to confer on the Bureau as an experiment the following task:

to select and approve the projects which respond to the priorities of IPDC;

to allocate to these approved projects financial assistance from the Special Account not exceeding two thirds of the budget frame;

to refer to the Council for final decision the projects which by their complexity require an examination in the Council;

to extend financial support to private projects;

to perpetuate the thematic debate in the Council sessions in order to focus the work of IPDC;

to evaluate systematically the terminated IPDC projects and to include them in the ongoing work of the Secretariat;

to give priority to training and human resources development to enhance the use of new technology with the aim of improving the editorial product.

At its meeting held during the nineteenth session of the Council the Bureau decided that, in view of the late arrival of contributions pledged, the Secretariat may employ the unused balance of funds from projects already implemented for financing approved that may have to be implemented immediately and for other IPDC activities (preparatory assistance, training, assistance to the IPDC Secretariat and promotion).

Evaluation of terminated IPDC projects

6. IPDC is certainly one body that has systematically evaluated its projects in depth after their completion in order to learn lessons for the future. During the last six years, IPDC has called on independent consultants to evaluate 86 terminated projects that had been financed from its Special Account in Africa, Asia and the Pacific, Latin America and the Caribbean, the Arab States and Europe. A further 42 evaluations were submitted at the last two sessions. The conclusions made by evaluators have shown that the majority of projects have succeeded. The following projects are a sample of some of the successfully completed projects:

Asiavision: Expansion of television news exchange to Central Asia (PDC/15 RAS/04);

Central Asia: Youth tolerance and television (PDC/16 RAS/04);

Pacific Women Television Programme Exchange Project (PDC/16 RAS/04);

Bangladesh: Establishment of a Bengali language news agency service (PDC/14 BGD/01);

People's Republic of China: Training of women journalists in the print and electronic media (PDC/14 CPR/01);

Kyrgyzstan: Establishment of a media resource centre (PDC/14 KIR/01);

Lao People's Democratic Republic: National News Agency (KPL) Communications Network Development Project (PDC/12/16 LAO/01).

However, a number of problems frequently occurred:

harmful effects of local methods of administration or considerations of a technical nature (Journalism/media training at the Kazak State University) (PDC/15 KZH/01);

Development of independent radio stations (Kyrgyz Republic) (PDC/15 KIZ/OA);

Media training at the Kyrgyz National University (PDC/16 KIZ/01);

Audiovisual production centre of the cooperative movement (Costa Rica) (PDC/14 COS/01);

Rural information unit (Trinidad and Tobago) (PDC/15 TRI/01);

laxity in administrative and financial management (People's Republic of China: Retraining of journalists (PDC/15 CPR/01));

inability (or the reluctance of some beneficiaries) to provide a detailed statement of accounts and all the documentation required for an objective assessment of the use made of the investments approved by the Council (Media training at the Kyrgyz National University) (PDC/16 KIZ/01);

Audiovisual production centre of the cooperative movement of Costa Rica (PDC/14 COS/01);

a lack of coordination between the beneficiaries and equipment providers and the Regional Communication Advisers: Ibero-American and Caribbean Network: television for integration (PDC/13 RLA/01);

Audiovisual production centre of the cooperative movement of Costa Rica (PDC/14 COS/01).

The proposals contained in the evaluation reports are taken into account in order to increase IPDC's efficiency, reliability, speed of action and the most rational use of the funds approved.

THEMATIC DEBATES

The IPDC Council organized two thematic debates in 1998-1999:

POLITICAL, TECHNOLOGICAL AND ECONOMIC CHALLENGES OF PUBLIC SERVICE BROADCASTING (eighteenth session)

Known specialists in the field were invited to present the political, technological and economic aspects of the new challenges to public service broadcasting to the IPDC Council. Attention was drawn to the promises in digitization of media, such as increased information sites available to individuals, access to uncontrolled sources of information, improved pluralism, greater interactivity of communication, increased creativity and democratization of media. They called on public service broadcasters to offer programmes, which present audiences with a structured view of their cultural needs. They held the view that public service broadcasters face the following challenges: providing quality entertaining and socially relevant educational programming in the face of increased competition and audience fragmentation from commercial broadcasters; reformulating their legal status to maintain editorial independence; forming strategic alliances and joint ventures with agencies and nongovernmental organizations involved in educational and cultural activities. They emphasized that public service television must be different from commercial television, either because it does something that commercial television does not or cannot do, or because it does the same thing but in a different manner. However the key question today is what place and status should the public service broadcasting be given in the landscape of mainly commercial television.

COMMUNICATION AND CIVIL SOCIETY - REACHING OUT TO PEOPLE, REACHING OUT TO REMOTE AREAS, REACHING OUT TO PLURALISM (nineteenth session)

8. The Chairman of the Haute Autorité de l'Audiovisuel et de la Communication of Benin drew attention to the fact that many African countries have seen a relaxation of State control, an assertion of freedom of expression, the liberalization of the airwaves and the emergence of independent and private newspapers, radio and television stations. In his opinion, African countries needed to design and establish media systems that took due account of the national sociocultural, geopolitical and economic context. The representative of the Caribbean News Agency (CANA) in Barbados said that the advent of the Internet had increased opportunities for exchanging information among all mass communication institutions in the Caribbean. The former President of the World Association of Community Radio Broadcasters (AMARC), in Montreal spoke of the obstacles encountered, particularly government censorship, low budgets and pressure exerted on community radio stations to fall into line with government policies and to become commercial. An expert from the National Radio Broadcasting Council of Poland said that UNESCO genuinely had a significant role to play in the process of democratization of society and the media. He considered citizenship to be akin to the foundations of a house, with democratic government and civil society as its walls and the media acting as a roof, observing everything, but trying to ensure overall cohesion.

10. **IPDC received the following contributions in kind:** The **Republic of Korea** covered all the expenses of 40 participants to attend two courses on production of television programmes organized in collaboration with the Research and Training Institute of the Korean Broadcasting System (KBS). Since 1984, 260 trainees from 120 countries have been trained in KBS's studios in Seoul. IPDC organized three workshops on ethics and a code of conduct for the press in Cameroon, Côte d'Ivoire and Mali, with the support of the **German Foundation for International Development.** Four courses for further training of African professionals were held in **Israel.** Since 1996, Israel has received 91 IPDC trainees. In 1999, IPDC co-financed with the **Government of Argentina** a training course for five Spanish-speaking journalists at the Training Centre of National Radio in Buenos Aires. IPDC co-financed a training course for 20 participants on new media technologies in cooperation with the **Russian Federation** and is preparing to implement a fellowships programme with **Brazil.**

PROJECTS APPROVED FOR 1998 AND 1999 FISCAL YEARS

11. With respect to the eighteenth and nineteenth sessions of the Council, 124 projects were received by the Secretariat. The amount of funding requested for all projects amounted to US \$18,693,000. The Council approved a budget of US \$4,712,000 (US \$4,674,000+US \$38,000) originating from the Special Account in order to finance 108 projects. Fifteen projects received US \$1,954,532 in 1998 and 1999 thanks to funds-in-trust provided by Denmark, France, Germany, Luxembourg, Portugal and Saudi Arabia (for a list of projects financed under the IPDC Special Account and Funds-in-Trust see Annex).
