- torture

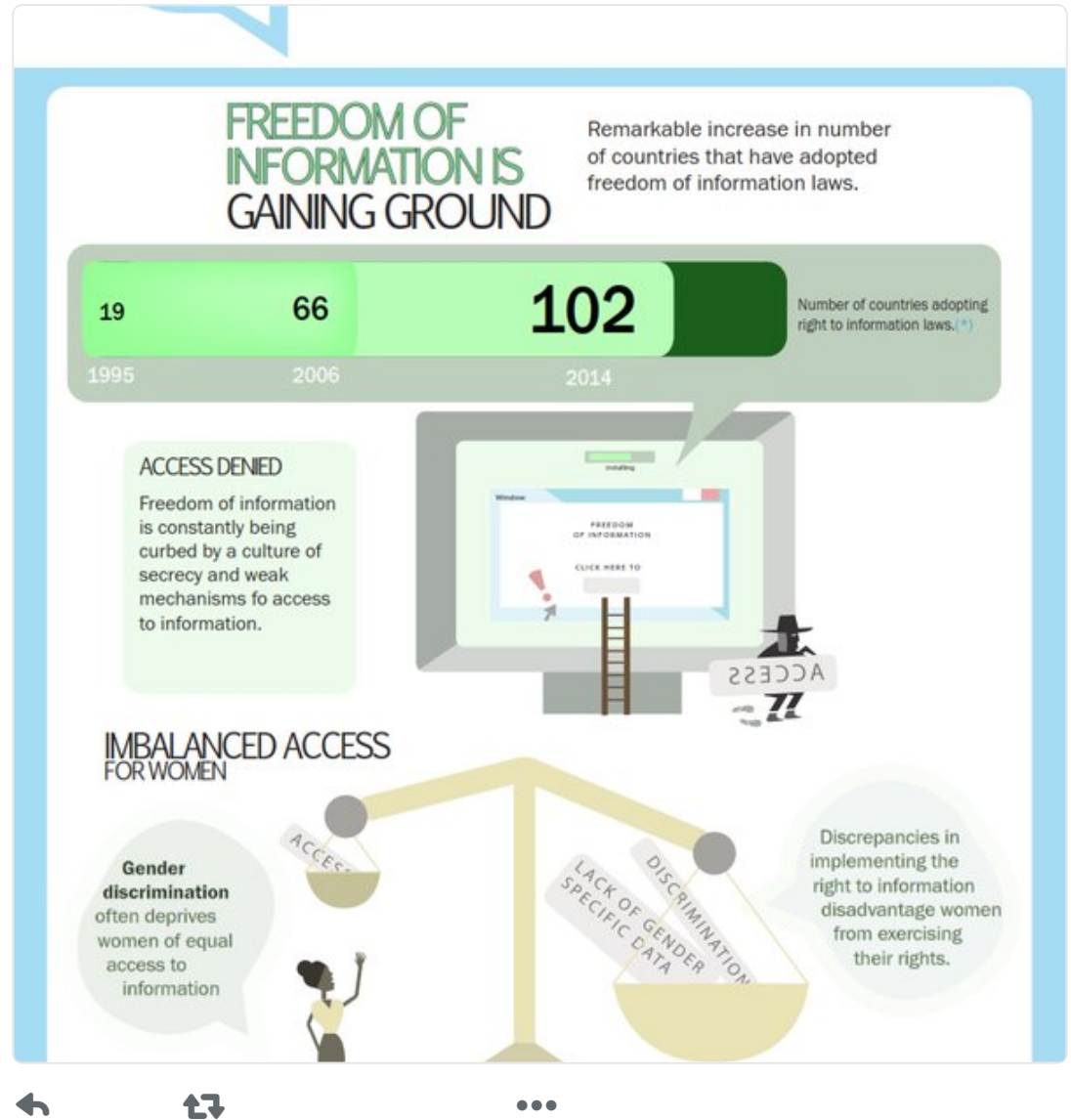

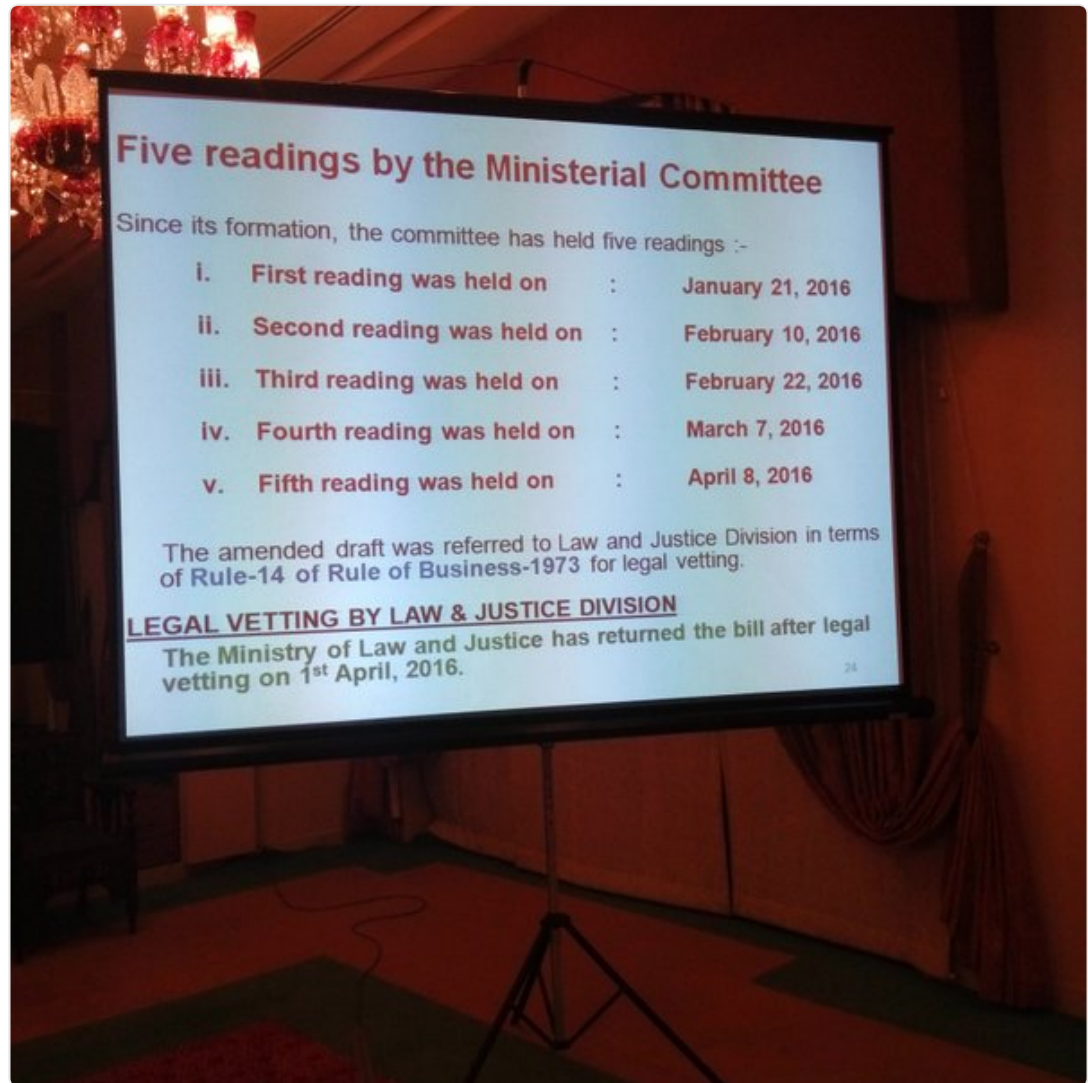

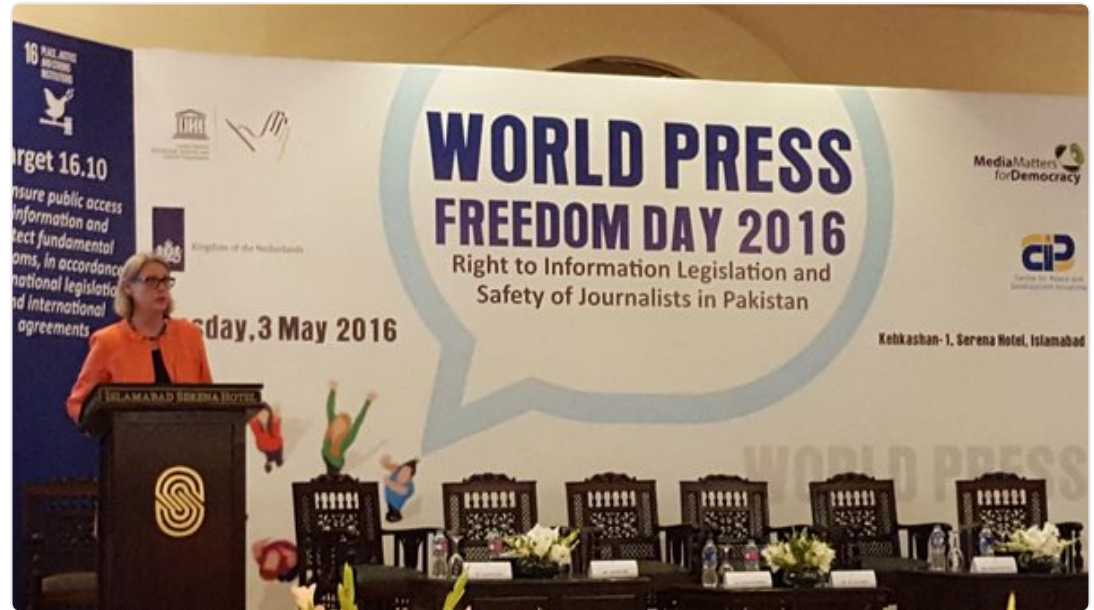
