# Fight against illicit traffic of cultural property in South-East Europe

Gaziantep, Turkey. 19-21 November 2012

A meeting organized within the initiative









## Background

The fight against illicit traffic remains today very high on the political agenda of all South-East European countries, which have all ratified the 1970 Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property.

For UNESCO, a major priority is to help countries in building their human and institutional capacities: national inventories, databases, tools for information and communication, exchange of best practices, awareness-raising, etc. This meeting is therefore a very opportune moment to reflect on global cooperation strategies, focusing on the enhancement of legislations, international cooperation, and specialized national services.

In this context, the UNESCO Regional Bureau for Science and Culture in Europe, in cooperation with relevant national authorities, has already organized in 2011 two meetings, in Ohrid (13 October 2011) and Tirana (23 November 2011), that brought together key national players affected by the implementation of the 1970 Convention, international experts from specialized bodies (Interpol, Carabinieri, OCBC, Swiss Federal Office for Culture) and actors involved in communication and outreach policies and strategies. These two meetings took place further to the realization in May 2011 of a 20 minutes awareness-raising video, with the support of National Commissions and Ministries of Culture from the region, on the sensitization to the fight against the illicit traffic of cultural goods, specifically dedicated to South-East Europe.

This new meeting in Gaziantep on "Capacity-building and awareness-raising on the fight against illicit trafficking of cultural property", organized at regional level for the South-East European countries, comes as a follow-up to the celebrations of the 40th anniversary of the 1970 Convention on the Means of Prohibiting and Preventing the Illicit Import, Export and Transfer of Ownership of Cultural Property (March 2011) and the Second Meeting of States Parties to the Convention (20-21 June 2012), and upon proposal of the UNESCO Director-General, Ms Irina Bokova.

It is jointly organized by the General Directorate for Cultural Heritage and Museums, Ministry of Culture and Tourism of Turkey and UNESCO, with the support of the Gaziantep Governatorate, Municipality and Zeugma Mosaics Museum, and will take place in the recently opened Zeugma Mosaic Museum. It is part of a series of regional capacity-building trainings meeting coordinated in 2012-2013 in the world by UNESCO/Secretariat of the 1970 Convention.

## **Objectives**

Within the framework of UNESCO's new global initiative, "Culture: a Bridge to Development", this meeting aims at building regional and local capacities in South-East Europe (invited countries are Albania, Bosnia and Herzegovina, Bulgaria, Croatia, Greece, Montenegro, Romania, Serbia, Slovenia, The former Yugoslav Republic of Macedonia, and Turkey), with the following objectives: ratification and effective implementation of the 1970 Convention and other relevant instruments on the fight against illicit traffic and the restitution of cultural objects; effective use of legal and operational tools to safeguard and preserve cultural heritage; development of national capacities for the protection and conservation of movable cultural property; awareness raised on the need of fighting against the illicit trafficking of cultural property.

The meeting, conducted by an international pool of experts and professionals, will last three days and be structured around two trainings (a legal and an operational one), with the following modules:

- assessment of international and national legislations
- modalities for return and restitution
- training on the use of operational tools, especially for museums and cultural institutions
- police and customs role in the fight against illicit trafficking
- media and Awareness raising

Beneficiaries from the training will be high level professionals from the region, representing experts from the ministries of culture, ministries of interior, the judiciary system, cultural sites or institutions challenged by situations of illicit trafficking, and media professionals.

The activities to be covered in the present project will take into account the need for an integrated and multi-disciplinary approach, whereby all stakeholders share a common vision on measures to be taken to fight illicit trafficking at all levels.
