EASTERN PARTNERSHII

What happens in the countries in Eastern Europe and the Southern Caucasus affects the European Union. Successive EU enlargements have brought these countries closer to the EU and their security, stability and prosperity increasingly impact on the EU's. The potential these countries offer for diversifying the EU's energy supplies is one example.

All these countries, to varying degrees, are carrying out political, social and economic reforms, and have stated their wish to come closer to the EU. The conflict in Georgia in August 2008 confirmed how vulnerable they can be, and how the EU's security begins outside our borders.

The European Commission put forward concrete ideas for enhancing our relationship with: Armenia, Azerbaijan, Belarus, Georgia, Republic of Moldova and Ukraine. This would imply new association agreements including deep and comprehensive free trade agreements with those countries willing and able to enter into a deeper engagement and gradual integration in the EU economy. It would also allow for easier travel to the EU through gradual visa liberalisation, accompanied by measures to tackle illegal immigration.

The Partnership will also promote democracy and good governance, strengthen energy security, promote sector reform and environment protection, encourage people to people contacts, support economic and social development and offer additional funding for projects to reduce socio-economic imbalances and increase stability.

First-ever Eastern Partnership Ministerial Conference on Culture

This high-level event of the Eastern Partnership Initiative held on 27-28 June 2013 in Tbilisi, Georgia, was organised by the European Commission – Directorate General for Education, Culture, Multilingualism, Youth & Sport and the Ministry of Culture and Monument Protection of Georgia. The Tbilisi declaration was signed by the Ministers and Heads of Delegation participating in the Conference.

The conference represented a milestone in the cultural dimension of the Eastern Partnership, aiming to give guidance for future work and providing an occasion for a mid-term assessment of the Eastern Partnership Culture Programme.

Yolanda Valle-Neff, Director of the UNESCO Regional Bureau for Science and Culture in Europe, Venice (Italy), represented UNESCO at this first-ever Eastern Partnership Ministerial Conference on Culture.

Likewise participated in the event: Androulla Vassiliou, European Commissioner for Education, Culture, Multilingualism and Youth; Bidzina Ivanishvili, Prime Minister of Georgia; and the ministers of culture of Georgia, Armenia, Azerbaijan, Belarus, Lithuania, Poland, Republic of Moldova and Ukraine.

The conference highlighted the contribution culture can bring to the different threads of development (political reforms, civil society development, economic development, job creation and social cohesion), while also providing the opportunity for a mid-term

assessment of the Eastern Partnership Culture Programme and to offer information about the future Creative Europe Programme.

Three sessions were scheduled: 1 - Culture as a vector for political reforms and social development:

2 - Culture as a vector of economic growth and job creation; and,

3 - EU instruments and international cooperation - perspectives for the future.

The event closed with the release of the Tbilisi declaration.

The Eastern Partnership Initiative (EaP) is created to support sustainable reforms in Eastern European countries with a view to accelerating their political association and economic integration with the European Union (EU) and to facilitating the mobility of citizens.

At the heart of this joint endeavour lies a shared commitment to fundamental values, such as democracy, the rule of law, respect for human rights and fundamental freedoms. »Full story

Tbisili Declaration

We, the Ministers and Heads of delegations participating in the first Eastern Partnership Ministerial Conference on Culture, held on 28 June 2013, in Tbilisi, Georgia:

Recalling:

- the principles underpinning the Eastern Partnership, including a shared commitment to fundamental values, such as democracy, the rule of law, the respect for human rights and fundamental freedoms: - the vision of culture referred to in the Commission Communication on the Eastern Partnership, adopted on 3 December 2008 whereby the EU has specifically recognised the value of cultural cooperation and intercultural dialogue as an integral part of all external policies and has underlined the importance of cultural cooperation in addressing political processes and challenges; - the importance of further enhancement of co-operation and policy dialogue on culture reflected in the Joint Declaration of the 2nd Eastern Partnership Summit (Warsaw, 29-30 September 2011);

- the principles stated in the UNESCO Convention on the Protection and Promotion of the Diversity of Cultural Expressions of 20 October 2005, including the link between culture and development, as well as the importance of maintaining, adopting and implementing policies for the protection and promotion of the diversity of cultural expressions;
- the standards developed by the Council of Europe and enshrined in The European Cultural Convention and specific conventions.

Reaffirming:

- the role of culture in human and socio-

economic development, as well as in political reforms;

Acknowledging:

- the essential role of the Eastern Partnership Platform 4 "Contacts between People" in providing a framework for a policy dialogue on culture between the EU and Eastern Partners:
- the results achieved through the series of seminars and meetings held in the context of the work programme of Platform 4, taking forward this dialogue on cultural policy; the important added value of the Eastern Partnership Culture Programme, both in terms of allowing for a strong participation of cultural operators from the region in cooperation projects as well as in providing capacity building to public institutions;

Welcoming:

- the opportunities opening up under the new Creative Europe Programme, and in particular the possibility for Eastern Partners to fully participate in the Culture and MEDIA strands of the programme, on an equal footing with EU Member States and candidate and potential candidate countries, provided a number of technical conditionalities are fulfilled;

5. Express our commitment:

-to pursuit the reform and modernisation of our cultural policies and to fully implement the UNESCO Convention on the Protection and Promotion of the Diversity of Cultural Expressions of 20 October 2005; -to include culture in our development agendas and to harness the potential of

culture in smart, sustainable and inclusive growth;

- -to foster inter-ministerial cooperation on cultural issues, in the spirit of acknowledging the transversal nature of culture strongly contributing to e.g.: social integration, economic growth, education and intercultural dialogue;
- -to develop cultural policies in close cooperation with civil society, and to this end encourage and strengthen dialogue structures;
- -to enhance a balanced, comprehensive and strategic approach to cultural and creative sectors, covering in particular architecture, archives and libraries, artistic crafts, audio-visual (including film, television, video games and multimedia), cultural heritage, design (including fashion design), festivals, music, performing and visual arts, publishing and radio;

Therefore call on the EU:

- to pursue its support for the modernization of cultural policies in the Eastern Partnership countries, in particular by ensuring a continuation of the capacity building component of the Eastern Partnership Culture Programme;
- to facilitate and, if necessary, to co-finance the participation of the Eastern Partnership countries in the Creative Europe Programme by ensuring the necessary information and communication about the requirements for participation:
- to look at ways of enhancing cultural cooperation in the Eastern Partnership framework.

Following through on commitments made at its first international conference to "Safeguard the cultural heritage in Kosovo[1]" in 2005, UNESCO is zooming in on the antique settlement of Novo Brdo/ Novobërdë in cooperation with and funding from the European Union.



the economic and trade center of the medieval Serbian state, this site is of significant historical and archaeological value. Novo Brdo/ Novobërdë was one of the most important late medieval cities in the central Balkans. Its growth was predicated on the rich lead, silver and gold mines in the vicinity whose extensive exploitation began in the first decades of the fourteenth century. Situated on a hill in the southeast region of Pristina, the municipality and its invaluable cultural heritage underwent significant damage during, and especially following, the armed conflict in the region.

Once thriving from its mining exploitations and duly inhabited. Novo Brdo/ Novobërdë included a large valley settlement, a fortified hill and citadel. Today, the fortifications survive

in a ruinous state, growing increasingly extensive assessment with regards to conservation needs and archeological exploration.

Further, UNESCO considers the protection of cultural heritage as a valuable multi-purpose framework, capable of creating reconciliation opportunities, fostering peaceful relations within once torn communities and developing a positive ripple across neighboring regions. Consequently, the European Union has partnered with UNESCO in a joint management project aimed at (a) revitalizing the Castle through conservation and restoration efforts and (b) managing and valorizing the municipality's cultural heritage assets through socio-economic development initiatives.

Revitalization of Novo Brdo/Novobërdë Fortress, one of the most important late medieval cities in the central Balkans

This project is developed in line with and as part of the European Union umbrella mission, "Balanced Regional Development."

Expected results of this project partnership are: the preservation and revitalization of cultural heritage asset and archeological explorations' yielding key insights on medieval Balkans; local sustainable development through the strategic management of cultural heritage asset, vielding enhanced tourism capacities and socio-economic conditions; and, public (regional/ global) and educational (local) awareness of the value of cultural heritage preservation. >>full story

Introducing Education for Sustainable Development in Biospheres Reserves and other Designated Areas at EuroMAB 2013

Within the 2013 EuroMAB Network Meeting in Canada, the UNESCO Regional Bureau for Science and Culture in Europe, Venice (Italy), is scheduling a training seminar on Education for Sustainable **Development from 19-20 October** 2013. This event shall contribute to enhancing the capacity of **Biosphere Reserves to fulfill this** third function by developing **Education for Sustainable Development-oriented activities** and, by doing so, to widen their impact on our societies while encouraging sustainable ways of living.

EuroMAB is the oldest and largest regional network of Biosphere Reserves, consisting of over 284 sites in 52 countries. This network represents a wealth of experience, knowledge and passion to implement conservation and sustainable development principles. Biosphere Reserves are designated by the UNESCO Man and Biosphere Programme (MAB) as areas of significant ecological importance where a variety of actors are engaged in the common pursuit of building sustainable communities.

The Frontenac Arch Biosphere will welcome world sustainability leaders to EuroMAB 2013 from 15-19 October under the theme, "Engaging our Communities". The event highlights the essential contributions of a variety of groups in implementing MAB objectives, including local populations and

organizations, academia, different levels of governments, and the private sector.

The training on Education and Sustainable Development (ESD) is a post-event of EuroMAB 2013 which will allow participants to share their experiences and exchange knowledge, good/best practices and lessons learnt in relation to ESD activities developed in and around BRs; it will focus especially on good practices and lessons learnt related to activities demonstrating the third function of a BR, how it logistically supports ESD projects.

The publication "Education for Sustainable Development in Biosphere Reserves and other Designated Areas: A Resource Book for Educators in South-Eastern Europe and the Mediterranean" will be distributed to the participants during EuroMAB 2013.

The book published by the UNESCO Venice Office is the result of a large teamwork that has the ambition to effectively promote ESD in the field and in particular in Biosphere Reserves (BRs) of the Man and the Biosphere (MAB) Programme of UNESCO, as well as in other designated areas that share some fundamental features with MAB BRs.

The combination with attempts to get a "win-win" result is: ESD can be well developed and demonstrated in such areas while ESD activities

extended beyond the schooling system bring substance, interest and support to the management and protection of BRs. Developed in close co-operation with MIO-ECSDE, the handbook is an illustration of what UNESCO can achieve when it takes advantage of its multifaceted mandate, combining resources from its various sectors together with the demonstrated influence in the field of the MAB Programme and its network of BRs.

While focusing on a particular region of the world, there is no doubt this resource book contains elements of interest for all members of the EuroMAB network, especially for those interested in increasing the capacities of trainers and educators seeking to design and implement innovative educational projects, using BRs and other designated areas as authentic "ESD laboratories". »full story

Transboundary Biosphere Reserves: towards a more effective management of shared ecosystems and sustainable development of bordering territories

Within the 2013 EuroMAB Network Meeting in Frontenac Arch Biosphere, Canada, the UNESCO Regional Bureau for Science and Culture in Europe, Venice (Italy), will hold a workshop on Transboundary Biosphere Reserves on 17 October 2013 with the aim to enhance the capacity of EuroMAB countries to establish and manage their biosphere reserves, particularly transboundary ones, and to look at the transboundary potential within the EuroMAB network through innovative approaches to conservation and sustainable development.

The Frontenac Arch Biosphere will welcome world sustainability leaders to EuroMAB 2013. The EuroMAB 2013 workshops will serve as key opportunities to build and strengthen relationships among participants to encourage and guide further engagement after the event; workshop presenters will share practical knowledge and insights they have gained through their experiences.

In particular, the workshop on Transboundary Biosphere Reserves (TBRs) will aim to enhance the capacity of EuroMAB countries to help establish and manage their Biosphere Reserves – BR(s), particularly transboundary ones, and look at the transboundary potential within the EuroMAB network through innovative approaches to conservation and sustainable development. The workshop will provide an opportunity to discuss added values of BRs in the integrated management of shared water resources. The workshop will also help bridge the Man and Biosphere Programme (MAB) and the International Hydrological Programmes (IHP) of UNESCO while implementing activities towards sustainable development of transboundary areas.

At this time, over ten countries of sub-regions under the coverage of the UNESCO Venice Office - South-Eastern European (SEE), Mediterranean, Black Sea and Caucasus countries - have

initiated and/or undergone processes for the establishment of possible TBRs.

There is a need to facilitate these processes – in particular, at a crucial moment when stakeholders require support and communities and authorities need clarification about their engagement, responsibilities and benefits - and to move forward with the designation process(es).

The workshop on Transboundary Biosphere Reserves is open to all interested countries and their representatives in EuroMAB 2013 Network Meeting. The workshop will bring specific added values to the South East European, Mediterranean, Black Sea and Caucasus countries

and it will strengthen the promotion and use of the BRs as a network of experimental sites established in the frame of the MAB Programme of UNESCO, in order to promote Sustainable Development in the subregions concerned.

Finally, the workshop shall contribute to catalyse the establishment of new BRs in the above countries, in particular in transboundary contexts, providing them with tools for the comanagement of shared ecosystems (related in particular to water) and facilitate the dissemination of good practices and policy advice on Sustainable Development including a green economy approach. »Full story

Garbage Patch State 1

A seagull is flying over a supermarket from which a man exits and guzzles a bottled drink. Instead of disposing of this bottle in its appropriate bin, he throws it into the ocean. The bottle is met with more and more floating debris until it forms a mound of garbage. This is the Garbage Patch State, an area of over 15,916,000 square kilometers of litter floating in the ocean. Two monster-like garbage trucks are taking in piles of trash and then dispensing them into the ocean next to a seagull, who is then hit by a discarded bottle. The garbage floats along the ocean, eventually entering the mouth of a whale who becomes ill as a result and shoots it out of his blow-hole. A flying bottle again hits the injured seagull, and lands on a massive accumulation of trash. Both the bottle and the upset seagull are shown atop this accumulation, which is the Garbage Patch State. The first international forum on Renewable Energy REENFOR-2013 will take place from 22-23 October 2013 in Moscow at the initiative of the Russian Academy of Sciences and the Non-Profit Partnership "Scientific-Technical Council of the Unified Energy System".

On Day 1, UNESCO Regional Bureau for Science and Culture in Europe, Venice (Italy), will organize the plenary session on "Energy education and training of specialists for renewable energy sector" (PS I2). The forum is organized by RAS Scientific

Councils for Complex Energy Problems, for Renewable Energy Sources (RES), for Reliability and Security of Large Power Systems and Non-profit Partnership "Agency of scientific and business communications" (NP "ANDK"), in partnership with the UNESCO Venice Office, and UNESCO institutions and centres on Sustainable Energy Development.

REENFOR considers the issues surrounding efficiency and practical uses of advanced renewable technologies, how to improve their output and economic performance

in various climatic and socioeconomic conditions and to analyze the best practices in the use of RES in the Russian Federation. REENFOR is expecting the involvement of representatives from leading international organizations, research centers and foreign companies active in the field of renewable energy. REENFOR aims to establish closer scientific, technical and business cooperation amongst parties interested in participating in the development of RES in the Russian Federation. It also aims to discuss their potential participation in creating a prototype model for renewable energy installations within the country.

The forum will consist of plenary sessions, panel discussions and presentations by companies and regional representatives on the issues of development and practical uses of available conversion technologies, such as: solar, wind, biomass, hydrokinetic, geothermal, natural and low-grade waste heat pumps. »Full story

KULTURisk workshop: benefits of disaster prevention measures

The third workshop of the KULTURisk collaborative project, Knowledge-based approach to develop a cULTUre of Risk prevention, funded under the Seventh Framework Programme (FP7) - Environment was held in Venice on 19-20 September 2013.

The UNESCO Regional Bureau for Science and Culture in Europe, Venice (Italy), intervened in the third session and presented some insights on the UNESCO strategy in Disaster Risk Management (DRM) and on the multiple actions undertaken by the Office in order to strengthen the capacity of South-East European Member States in Disaster Risk Reduction (DDR) and preparedness.

Effective strategies and plans of Disaster Risk Reduction are

built on a good understanding about the risks a community is facing. This understanding can only be achieved through a Risk Assessments methodology that considers the multi-faceted physical/environmental, social and economic aspects. The extreme consequences of recent catastrophic events have highlighted that risk prevention still needs to be improved to reduce human losses and economic damages.

The project, coordinated by UNESCO-IHE Institute for Water Education one the largest international postgraduate water education facility in the world based in Delft, the Netherlands, aims at supporting the spreading of a culture of prevention, by offering the possibility to evaluate the actual economic, environmental, cultural and social benefits of different risk reduction measures. This evaluation is carried

out with the use of a comprehensive risk assessment methodology. The methodology has been developed and validated on water-related hazards (i.e. floods, debris flows and landslides, storm surges), in different European case studies and with different receptors/elements at risk.

One objective of the project is to generalize this methodology and explore the applicability of the KULTURisk approach to different types of natural hazards, like earthquakes, forest fires, etc. >>full story







Cultural Diversity, Civil Society and International Cultural Cooperation in South-East Europe

The 2013 Conference on Cultural Diversity, Civil Society and **International Cultural Cooperation in** South-East Europe, organized jointly by the Culturelink/IRMO and the Centre for Democracy and Law Miko Tripalo, in co-operation with the **Croatian Commission for UNESCO** and the UNESCO Regional Bureau for Science and Culture in Europe. Venice (Italy), was successfully held in Zagreb on 3 and 4 June 2013. bringing together representatives of national focal points for the 2005 **UNESCO** Convention, researchers. professionals, artists, members of the Culturelink Network and other participants from the region of South-East Europe and beyond. The event was attended by 55 participants from 16 countries.

Following its adoption and the first round of periodic reports that have been received and analysed by UNESCO, the question of the effective implementation of the 2005 UNESCO Convention on the Protection and Promotion of the Diversity of Cultural Expressions is more pertinent than ever.

The Convention aims to strengthen the link between culture and development, to foster cultural interaction and dialogue, and to establish innovative approaches towards international cooperation and solidarity. It encourages opening towards other cultures, and recognizes and defends the distinctive nature of cultural activities, goods and services as vehicles of identity, values and meaning.

The Convention also encourages its signatories from the developed world to offer preferential treatment to artists and cultural workers from developing countries in order to assist in the development of their cultural industries. It emphasizes the role

and the legitimacy of public/cultural policies in the promotion of cultural diversity and defines their relations with other international instruments.

The discussions at the Conference were focussed around a set of key issues concerning the implementation of the Convention, aiming to analyse good practices and expectations from the international community. Special attention was paid to the analysis of the information submitted to UNESCO through the periodic reports, with focus on the state of affairs in South-East Europe. The conference was structured around 4 thematic round tables, centring around different levels of intervention: policy-advice and planning, information-sharing, operational partnerships and civil society. >>full story

PreserVenice unveils UNESCO-funded smartphone application and website on public art in Venice

The UNESCO Regional Bureau for Science and Culture in Europe, Venice (Italy), and the Worcester Polytechnic Institute (WPI) Venice Project Center announced the release of the "PreserVenice" website and smartphone app aimed at publicizing and protecting the unique collection of public art that adorns the streets and canals of the city of Venice, a UNESCO World Heritage site.

The PreserVenice website showcases all of the 1,098 coats of arms, 943 patere (roundels), 394 reliefs, 173 sculptures, 109 street altars, 109 fountains, 75 crosses, 56 flagstaff pedestals, 32 decorations, 30 inscriptions and 25 fragments, for a total of 3,044 elements of Venice's urban decor.

Each piece's information can be viewed in individual wiki pages on Venipedia and in more succinct forms viewable directly by clicking on artifact symbols on the map of Venice.

The companion PreserVenice app is usable on all smartphones, from the

web browser, and it designed to elicit participation through crowdsourcing and crowdfunding from interested users who are willing to contribute to the upkeep of each collection piece by flagging erroneous data, by providing updated information or by taking new photos, and also by donating money towards chosen artifacts that need urgent repair.

An additional 5,000 artifacts that await funding to be included in the PreserVenice web site and app. The goal is to complete the publishing of all collected data and then creating a nonprofit organization called PreserVenice, that will collaborate with the UNESCO Venice Office to

actively preserve and restore these outdoor testimonials of Venice's past.

The team plans a KickStarter campaign to fund the next phase of the project. In the spirit of the entire initiative, PreserVenice will employ "crowdfunding" techniques to collect restoration funds from many small contributors, who can make micro-donations in real time from the Venipedia wiki as well as from the mobile app.

The PreserVenice app currently runs on Chrome, Safari and Firefox. Internet Explorer might be supported at a later date. >>full story

The International Centre for Underwater Archaeology (ICUA) in Zadar launched its second Advanced Underwater Archaeology Course. The course lasted two weeks and took place in Pula, Croatia, from 16-28 September 2013. It was organized with the support of the UNESCO Regional Bureau for Science and Culture in Europe, Venice (Italv).

The course consisted of theoretical and practical (hands on) instructions in the techniques of underwater archaeological excavation, data processing and use of new technologies in underwater documentation

Archaeologists from ICUA and guest lecturers conducted theoretical lessons, complemented by optional courses in specialty diving according to the requirements of the SSI or PADI systems. Practical instruction took place in the frame of underwater archaeological researches of ancient shipwrecks in Ližnjan, Pula environs, in order to prepare the participants to actively take part as a regular member of an underwater archaeological excavations team.

The course's beneficiaries were archaeologists with diving experience and basic practical underwater archaeology experience.
The course was designed to develop advanced skills and experience in underwater archaeological work and project planning basics. Participants from the following countries were eligible for coverage of participation costs: Albania, Bosnia and Herzegovina, Bulgaria, Croatia,

Cyprus, Greece, Montenegro, Republic of Moldova, Romania, Serbia, Slovenia, The former Yugoslav Republic of Macedonia and Turkey.

The theoretical part of the course was conducted at the diving center in Pula, and the practical part at the nearby archaeological site of Uljeva, Ližnjan. Lectures included: Introduction in the conservation of underwater finds; Amphorae in archaeological context; Research and publication of project results; Advanced methods and techniques of underwater documentation; Postmedieval pottery finds in Adriatic; and 3D survey and computer post-processing of data.

Practical exercises - which every participant had to learn - were divided by days, so each group of two to four students had to deal with them daily: logistical organization of personal and team equipment; basic boat operations; use of water pump and hoses: underwater use of water dredge in a trench excavation; underwater photo documentation of a trench and a site; lifting of heavy objects from the sea bottom; packing, labelling and transport of finds; underwater drawing documentation and post-processing of data: practical use of site recorder computer program for documenting of the site; and area survey with use of a boat mounted side scan sonar.

All participants took part as novice members of a team in archaeological excavations of the ancient shipwrecks for on-site training. Participants who completed the course received the ICUA official certificate of successful course completion. »full story

Auschwitz-Birkenau: Building a new common exhibition in former Yugoslav Block 17

The Auschwitz-Birkenau Memorial and State Museum hosted on 3-4 July 2013, with the support of the UNESCO Regional Bureau for Science and Culture in Europe, Venice (Italy) a meeting of the international steering committee in charge of coordinating, under the auspices of UNESCO, the establishment of a renovated joint exhibit space within the ex-Yugoslav pavilion (Block 17).

The meeting was organized to continue discussions on the renovation and transformation of the former Yugoslav block nr. 17, situated within the State Museum Auschwitz-Birkenau, Poland, and the setting up of a joint exhibit on the Holocaust. The meeting allowed experts to present selected items and discuss common approaches for the contents of the joint exhibit.

The renovated Block 17, which also comprises the Austrian pavilion (ground floor), is due to open in 2015, coinciding with the 70th anniversary of the Liberation of the Auschwitz-Birkenau concentration camp. The experts also used this opportunity to consult archives and visit other recently renovated national pavilions (Belgium, France, Hungary, Jewish, Netherlands, Roma) situated within the Memorial, a World Heritage site since 1979.

The international steering committee comprises relevant Ministry representatives and Holocaust experts from each of the six successor states (Bosnia and Herzegovina, Croatia, Montenegro, Serbia, Slovenia and The former Yugoslav Republic of Macedonia), UNESCO, as well as representatives of the following

internationally recognized institutions: Shoah Memorial (France), The Topography of Terror (Germany), Holocaust Memorial Museum (USA), with the participation as Observers of the National Fund for Victims of National Socialism (Austria) and the Auschwitz-Birkenau Memorial and State Museum (Poland).

The objectives of this meeting resonated with UNESCO's overall mission to promote Holocaust education, as well as the role of museums as tools for intercultural understanding, research and dialogue. The meeting was supported by UNESCO's Intersectoral Platform for a Culture of Peace and Non-Violence, and is organized within the overall framework of UNESCO's global initiative "Culture: A Bridge to Development".

Towards the finalization and implementation of the Management Plan for Stari Ras and Sopocani

The UNESCO Venice Office will support the organization of site-specific, thematic workshops intended to develop the capacities of national and local stakeholders in the management of selected World Heritage sites and other UNESCO designated sites (Man and the Biosphere Reserves), with special focus on the integration of management plans with local development programmes and strategies.

The first workshop will take place in the World Heritage site of Stari Ras and Sopocani, in Serbia, on 11-14 November 2013. It will be organized by the Serbian Ministry of Culture and Media, in cooperation with the Institute for the Protection of Culture Monuments of Serbia with the support of the UNESCO Regional Bureau for Science and Culture in Europe, Venice (Italy).

No heritage management plan has been completed or adopted in Serbia so far. Currently, a plan for the World Heritage site Gamzigrad - Romuliana is in the final stage of preparation and it is expected to be soon ready for public review. The preparation of a plan for the Stećci medieval tombstone as part of the nomination

dossier is also underway, while the preparation of a plan for Stari Ras and Sopoćani is hugely delayed.

Although in Serbia management plans are not mandatory under the law, experts and government officials are increasingly aware of their importance as well as of the importance of integrating such documents with other relevant planning tools. This awareness is also the result of several trainings and consultations carried out in Serbia since 2009. However, when it comes to local stakeholders, the situation is different.

Local communities seem not to have developed so far a sufficient understanding of the function and purpose of management plans, especially in terms of fostering local sustainable development, nor of their key role in the definition and implementation of such plans. On the contrary, management plans have been sometimes the reason of additional controversies related to local political, economic, cultural and/or religious issues. Stari Ras and Sopoćani is a very clear example of this.

The site is inscribed in the World Heritage list since 1979. Although

several years have passed since the initial drafting of the document, the scarce awareness, involvement and ownership by the local communities with regard to the preparation of Plan, combined with an insufficient dialogue among the relevant stakeholders (representatives of the state planning and preservation institutions at both central and local level, representatives of religious communities, NGOs, the private sector, etc.) have severely hampered the process.

Accordingly, the establishment of a broad and inclusive participatory approach seems to be the top priority for the definition of a shared and high-quality planning document, as well as for its future implementation. »full story



Restoration of Ottoman cultural heritage in South-East Europe at the Tirana Regional Centre for the Restoration of Monuments

The Regional Centre for the Restoration of Monuments based in Tirana, Albania, and the Turkish International Cooperation and Development Agency (TIKA), in cooperation with the UNESCO Regional Bureau for Science and Culture in Europe, Venice (Italy), are launching this first regional training workshop. Of a duration of 2 weeks, the event will take place in Tirana and Berat from 21 October to 2 November 2013.

The training programme will consist of theoretical and practical (hands-on) activities aimed to introduce relevant conservation and restoration techniques, in compliance with internationally recognized conservation principles and standards. Lectures and site work will address the principles of conservation and restoration on monuments, buildings decorations and artefacts from the Ottoman period, with a special focus on wall paintings, including insights into historical techniques of

execution, deterioration processes, conservation treatments and methods, as well as maintenance requirements. The course will include a one-week theoretical training module at the Tirana Regional Centre for the Restoration of Monuments and a two-week field module in the city of Berat, a UNESCO World Heritage site, focusing on the complex of the King's Mosque, one of the oldest in Albania, built in the 15th century under Sultan Bayezid II (or Sultân Bayezid-î Velî). Training activities will

be led by a team of experts - two Turkish and one Albanian - under the joint coordination of the Regional Centre for the Restoration of Monuments, the TIKA Headquarters and Office in Tirana, and the UNESCO Venice Office.

The course is intended for young restorers and conservators - ideally under 30 years of age - willing to develop their professional capacities in the training topics. >>full story

The seminar will encourage discussion on how EaP countries address different aspects of policies to promote the diversity of cultural expressions, including diversity of local cultural content, diversity through greater exchanges of cultural content regionally or at an international level,

A great number of policies are concerned in this context: not only policies in direct support of the cultural and creative sectors, but also policies that help create an enabling environment in which these sectors can operate and grow, and policies which ensure a broad access to diverse cultural goods and services such as intellectual property rights, information society/digitization, taxation, social affairs, local and regional development, international relations and cooperation, international trade. »Full story

In memoriam

Prof. Dr. Ahmet Eyüce, Member of our Scientific Council



Yolanda Valle-Neff, Director of the UNESCO Regional Bureau for Science and Culture in Europe, Venice (Italy), expressed deep sadness over the news of the death of Prof. Dr. Eyüce, member of the Office's Scientific Council since 2012, on 9 August 2013.

Prof. Eyüce had earned his Bachelor of Architecture degree from the Department of Architecture in the Faculty of Architecture at Middle East Technical University (METU) in 1973. In the same year, he started working as an assistant at Ege University (E.U.). He earned his Master of Architecture degree in 1976 and Ph.Degree in 1979 at the Faculty of Fine Arts of Ege University. He conducted his research at the TU Karlsruhe Institute Für Industrielle Bauproduktion with a German Academic Exchange Service (D.A.A.D.) research fellowship.

Prof. Eyüce was a founding member of the Department of Architecture at KAAU, Jedda (1981) and Um-al-Kurra University, Mecca (1983). He taught at the Faculty of Architecture at Dokuz Eylül University from 1988 to 1995 and, served as an adviser in Betontaş A.Ş. from 1998 to 1992. In 1995, he taught at the Faculty of Architecture of the Izmir Institute of Technology (IYTE). In the same year, he served as a deputy dean at the Faculty of Architecture. In 1998, Prof. Eyüce was awarded the National Architecture Award for the Project 'Izmir Aquarium'. Between 1999 and 2004, he was an adviser to the Izmir Metropolitan Municipality. In 2004, Prof. Eyüce was transferred to the Faculty of Architecture at Bahçesehir University and in 2006, he became the Dean. During his career, Prof. Eyüce participated in numerous conferences and symposia in the U.S.A., Japan, Korea, Malaysia, Singapore, Russia, Saudi Arabia, Tunisia and many European countries. He carried out many projects and his academic works were published in Turkey and abroad.

Information on Prof. Eyüce's passing was shared by the Turkish Ministry of Culture and Tourism. "I wish to express my heartfelt condolences to the family of Prof. Eyüce, as well as the country, the Ministry and the Bahçeşehir University for the loss of this outstanding person and professor", said Yolanda Valle-Neff. "His passing is a great loss to us and to the cultural and academic communities. Prof. Eyüce will be sorely missed in Venice where he was highly appreciated, not only for having enriched our work and for the positive impact he had during his two-year mandate as member of our Scientific Council, but also for his unique human qualities.
