PROVISIONAL TIMETABLE OF THE SHS COMMISSION

MAJOR PROGRAMME III

1. The Chairperson submits for the approval of the Commission the provisional timetable that has been drawn up taking into account the organization of the work of the session as approved by the General Conference (34 C/2, 34 C/2 Add. and Add.2) and in accordance with the agenda of the General Conference (34 C/1 Prov. Rev.).
2. The joint statement of the chairpersons of the six science programmes (IBSP, IGCP, IHP, IOC, MAB, MOST) will be dealt with during the first session of the SHS Commission.
3. The debate on the Draft Medium-Term Strategy for 2008-2013 (item 3.1) will also take place during the first session, while item 3.2 on the preparation of the Draft Programme and Budget for 2010-2011 will be examined separately during the fifth session on Tuesday morning, 30 October.
4. The debate on the Draft Programme and Budget for 2008-2009 – Part II.A: Major Programme III – Social and Human Sciences (item 4.2) will take place during sessions 2 to 4 of the Commission. The Chairperson draws attention to the fact that this debate will consist of three separate discussions – each discussion on one of the three biennial sectoral priorities.
5. The Chairperson reminds the Commission of the need to keep to the timetable and to avoid delays. Time for interventions by delegations will be limited to two minutes for each sub-discussion on item 4.2 and to three minutes for all other items. If the work of the Commission progresses faster than expected, the Chairperson reserves the right to move on to the examination of an item initially scheduled for the following session.
6. The Chairperson draws attention to the fact that item 3.3 on the overall review of Major Programmes II and III will be examined during a joint session of the SC and SHS Commissions which will be held on Monday morning, 29 October.
7. The Commission will adopt its report on Wednesday afternoon, 31 October. The recommendations of the SHS Commission will therefore be submitted for approval in the plenary meeting of the General Conference.
