Jumpstarting new opportunities for women scientists and engineers



Professor Deborah Belle of Boston University (BU) has released findings on the impact of receiving a National Science Foundation ADVANCE program grant, which helps universities develop systematic approaches to increasing representation and advancement of women faculty in science and engineering careers.

"For participants in the BU Women in Networks Mary Erskine grant program, the jump to a promising new research venture was facilitated ... the awards helped women build

key networks, removed research barriers and ultimately promoted a diverse science and engineering faculty at BU.'

1. UN Women Civil Society Advirosy Group for Latin America and the Caribbean

Professor Gloria Bonder, Chairholder of the UNESCO Regional Chair Women, Science and Technology in Latin America and Coordinator of the Global Network of UNESCO Chairs on Gender was appointed as member of the UN Women Civil Society Advisory Group for Latin America and the Caribbean. Their first planning meeting took place in Panama, on 29-31 October 2012.

2. Women/Girls in ICT Working Group

Professor Gloria Bonder has also been invited to join the new Women/Girls and ICT Working Group. It seeks to connect the key people across sectors that are focusing on the intersection of leveraging technology for women/girls as a means of improving development outcomes. The goal is to coordinate and join forces where appropriate, and raise visibility of the topic potentially by articulating some high-level targets. It will be integrated by experts in this field working in different organizations, such as UN Women, FCC, ITU, GSMA, mHealth Alliance, APC, UNESCO, Intel, Yahoo, Cisco, Grameen, the US State Dept. Its first meeting will take place on December 2012 in New York.

3. Development and Local Policies with a Gender Equality and Human Rights Approach

The UNESCO Regional Chair Women, Science and Technology in Latin America is developing in cooperation with UN Women blended (on site and on-line) training programme on "Development and Local Policies with a Gender Equality and Human Rights Approach". It is addressed to Government Officials, representatives of Gender Equality machineries and Human Rights Offices, and members of NGOs from municipalities of El Salvador, Honduras and Dominican Republic. Its goal is to renew the knowledge and create the abilities and resources to strengthen the quality, efficiency and sustainability of programs and policies on local development with a gender equality and human rights approach. It will consist of four modules on the topics of e-development, planning and management of programs and policies, leadership and strategic use of ICT.

4. TECNOPOLIS TV

The UNESCO Regional Chair Women, Science and Technology in Latin America is developing a TV campaign on women/gender, science and technology in collaboration with the Ministry of Science, Technology and Innovation of Argentina. It will be shown by TEC-NOPOLIS TV. (http://www.tectv.gov.ar, first entirely digital TV signal on Science and Technology of Argentina). It includes producing short films (1.30 minutes long) and programmes (16 minutes). Its main purpose is to disseminate attractive messages that create awareness on existent gender inequalities in science and technology, as well as successful experiences and policies that aim at overcoming these inequalities, both in Latin America and globally.

5. UNITWIN Gender Case Study to be Used in Course at Tufts' Fletcher School of Law and Diplomacy

The Academic Dean and Professor of International Humanitarian Studies at the Fletcher School of Law and Diplomacy at Tufts University in Massachusetts, Dr. Peter Uvin, has written that he will be using "Srihaswani (Creative Manual Skills for Self-reliant Development): A Gender Case Study, Shantiniketan, West

9. Focal Point for Gender In Site

The UNESCO Regional Chair Women, Science and Technology in Latin America was designated the focal point in Latin America for the GenderInSITE campaign, organized by WIGSAT. GenderInSITE – Gender in Science, Innovation, Technology and Engineering is a global initiative involving stakeholders from various sectors to promote: a) the role of women IN science, technology and innovation, and b) how science, technology and innovation can be FOR women, or how can it serve women's lives and livelihoods at the grass-roots level. Overall vision and message is to promote the awareness of decision makers at all levels that STI for development policy and programs will be more effective, equitable and sustainable when the gender lens is applied – that is, when they reflect the vision, aims concerns, perspective, knowledge and abilities of both women and men.

9. Participation of the UNESCO Chair and the Centre for Gender Studies of the University of Cyprus in an Online Discussion on Gender Training in Europe, Organized by the EuroGender Network (25-26 September 2012)

The European Institute for Gender Equality (EIGE) organized a two-day online discussion and event on gender training in Europe on the 25th and 26th of September 2012. The UNESCO Chair in Gender Equality and the Centre for Gender Studies of the University of Cyprus were among the participants and were involved in a fruitful discussion and exchange of ideas with other gender experts and scholars from across Europe. The new postgraduate programme for Gender Studies at the University of Cyprus was introduced. Practical and theoretical questions were covered, and concerns and experiences were shared in this constructive and European-wide event.

The Profile of Women Politicians on Cyprus TV: A Gender-Based Analysis

The UNESCO Chair in Gender Equality and Women's Empowerment at the University of Cyprus has been awarded a new research project titled "The profile of women politicians on Cyprus TV: a gender-based analysis", within the Framework Programme for Research and Technological Development 2009-2010 (HUMANITIES/SOCIO/0609 (BE)) of the Research Promotion Foundation.

The project aims to describe the profile of Cyprus women politicians as this is presented on Cyprus TV and, more specifically, it aims to: (a) do an in-depth investigation of the profile of women politicians on Cyprus TV (covering the period of one year), within the following parameters: presence in quantitative and qualitative terms, subjects upon which women politicians are called to comment or discuss, discourse and stereotyped representation of women politicians; (b) examine the women politicians profile in relation to that of their male counterparts, and in relation to the way their male counterparts are represented in, and use, discourse, themselves; (c) analyze the women politicians profile through semi-structured interviews with party leaders, a sample of parliament representatives (both male and female), the owners-directors of the Cyprus TV broadcasting channels, press reporters and journalists; (d) through the dissemination of results, to raise awareness of the role of the media in the promotion of equal men and women participation to decision making centres and processes.

The awareness-raising campaign will be aimed not only at politicians and the media, but also at the general public, thus strengthening the voice of Cyprus women politicians alongside and in conjunction with the voice of their male counterparts.

The necessity and need to which this project responds come from the need to strengthen the practices followed by Cyprus media – media being one of the most significant means of socialization – in relation to the representation of women politicians, so that they can meet the requirements of EU (European Commission, 2006) and UNESCO (2008) policies on the one hand and, on the other, the need to promote women's participation in Cyprus political and current affairs (Cyprus Republic, 2007).

International Conference: Women, Creativity and Social Concern

On January 5th-7th, 2012, a UNIT-WIN/Network partner, the Women's Studies Centre at Visva-Bharati in Shantiniketan, West Bengal, India, hosted an International Conference on Women, Crea-

tivity, and Social Concern organized by Professor Asha Mukherjee. Nobel Laureate Amartya Sen and Professor Martha Nussbaum of the University of Chicago were the keynote speakers

The Conference focused on the "social construction of gender in the Indian context by analyzing various institutions such as education, household, community, market, and the state" and hoped that discussion would "help to evolve perspectives on development and strategies to counter the inter-linked forces of caste, class and patriarchy." The European Project VICTIMS (2009-2011) Came to an End: Main Findings



The project VICTIMS (Victimizing Children Through Injuring MotherS) was designed and conducted in four

different countries (Cyprus, Italy, Romania, Slovakia) with co-funding obtained by the European programme DAPHNE III (action grants 2007-2013). It elaborated on the background of the effects of violence against women-mothers upon their children if exposed, and on how these may be externalized in different contexts, such as the school environment. Professor Mary Koutselini, holder of the UNESCO Chair, had the scientific administration of the project, while Ms. Floria Valanidou, scientific personnel at the Department of Education, was the main researcher of the project for Cyprus.

The project came to an end achieving its initial aim, which was to contribute to the promotion of awareness and to the sensitization of target groups, i.e., of persons, organizations or institutions who are directly or indirectly involved in the development and education of children aged 9-11, regarding the indirect harmful effects of violence against women on their children, if directly exposed. Such target groups were women's and children's organizations - GOs and NGOs, parents' associations and school sectors such as teachers' associations.

The main project findings were: a) children exposed to violence against their mothers exhibit reactions which are more aggressive than what is ordinarily expected in an ordinary situation, while they are exposed to violence and while witnessing violence. Boys are those who tend to be more aggressive and externalize their feelings of anger in a more intensive way; b) children exposed to violence also prefer to adopt behaviours which are

more passive than what might ordinarily be expected in an ordinary situation and while witnessing violence. Girls are those who tend to be more passive and who do not externalize their feelings; c) children exposed to violence tend to have lower levels of positive self-image. They feel less accepted by their peers and less popular among significant others, their classmates or friends. Children exposed to violence also tend to be less happy with the way they lead their lives; and, d) children exposed to violence tend to believe that they are not such good students. They tend to believe that they have a poor school performance and evaluate themselves as failures.

During the final stage of the project, several materials were produced, such as a social TV spot-

message, informational leaflets, and manuals for teachers, parents and social workers, titled "Children Exposed to Violence against Their Mother, Identifying and Dealing with the Effects of Children's Victimization", that were disseminated in each partner country. In terms of the project's follow-up activi-

ties and development, the materials produced continue to be disseminated accordingly; at the same time, a new, future project is being considered, which will aim to create and design new interventions for children who have been exposed to violence against their mothers, in order to prevent those children from becoming abusers in the future. 
2. Title: "An Immense and (In)complete Democracy: A Tocquevillean Perspective on India's Experiment with Democratic Citizenship" by Niraja Gopal Jayal

in Partha Chatterjee and Ira Katznelson (Eds.) *Anxieties of Democracy: Tocquevillean Reflections on India and the United States.* New Delhi: Oxford University Press. 2012.

"The relationship between social equality and democracy occupies a central place in Tocqueville's account of democracy in America. Tocqueville did not however address the question of inequality in his treatment of what he called "the two unlucky races" or women. The inclusions and exclusions of citizenship were peripheral to his account of citizenship, which centered on its practice and performance, privileging the site of the local.

On the assumption that the idea of differentiated citizenship administers a corrective to the Tocquevillian account of citizenship, this paper explores policies and practices of differentiated citizenship in India to comment on the relationship between social inequality and democracy. It

focuses on the question of women as objects of differentiated citizenship policies, as also on the possibilities afforded by the local as a site for their performance of citizenship."



5. International Conference Proceedings: Human Rights and Violent Behaviour, The Social and Educational Perspective

The proceedings of the International conference "Human Rights and Violent Behaviour: The Social and Educational Perspective", held at the University of Cyprus on the 18 and 19 of November 2011, are now published by the UNESCO Chair in Gender Equality and Women's Empowerment of the University of Cyprus. The papers included in the proceedings range from research findings and theoretical discussions to analysis of practice. Thus, the papers deal with a number of themes which pertain to the general scope of human rights and violent behaviour, such as: a) women experiencing violence and subjection, b) bullying and aggressive behaviour, c) intercultural

dimensions of violence and marginalization, d) conflict and violence at school, e) child neglect and abuse, f) gender equality, g) educational system and students' human rights, h) disability, special educational needs and youth at risk, i) domestic violence, j) education, gender and children's human rights, and k) multilateral perspectives on violence.
