- 1. <u>Having considered</u> documents 194 EX/3 & Corr. (*English, French, Russian and Chinese only*) and Corr.2 (*French, Spanish, Russian and Arabic only*) and Add. on major changes to the organizational structure of the Secretariat,
- 2. <u>Takes note</u> of the information contained therein, and <u>requests</u> the Director-General to take into consideration the debates that took place at its 194th session in order to further refine the design of the organizational structure.

The announcement appearing at the end of these decisions reports on the Board's consideration of this subject in private meeting.

Content of the EX/4 document

The Executive Board,

- 1. Recalling recommendation 13 of 33 C/Resolution 92, and 33 C/Resolution 78, in which the General Conference requested the Executive Board to report to it at each session on the implementation of the current programme and budget (C/5), together with the results achieved in the previous biennium (C/3).
- Also recalling 34 C/Resolution 89 inviting the Executive Board to "have a wider and more strategic assessment of the performance of the programmes, including the EX/4 document, by expressing its views progressively during the biennium through explicit decisions on the performance of individual programmes at the main line of action (MLA) level",
- 3. <u>Further recalling</u> 184 EX/Decision 4, 186 EX/Decision 4, 191 EX/Decision 4 and 192 EX/Decision 4.
- 4. Having examined document 194 EX/4 Part I Draft 38 C/3,
- 5. <u>Welcomes</u> the efforts to improve the structure of the report, the analytical approach and the quality of information and evidence presented therein, and <u>recommends</u> further improvement;
- 6. Recognizes the important work undertaken by the Secretariat to assert UNESCO's leadership at the global and inter-agency levels in the core areas of its mandate, particularly in the preparation processes of the post-2015 development agenda;
- 7. <u>Thanks</u> the Director-General for her efforts and the measures taken to implement the programme and to achieve the 36 C/5 expected results despite significant budgetary cuts;
- 8. <u>Notes</u> the key achievements realized in all programme areas, and the progress made in reforming the Organization as a whole;
- 9. Requests the Director-General to transmit document 194 EX/4 Part I Draft 38 C/3 to the General Conference at its 38th session for its examination.

The Executive Board,

- 4. <u>Further recalling</u> UNESCO's commitment, in 190 EX/Decision 46, to publish programme information in line with an internationally-agreed United Nations transparency reporting standard,
- 5. <u>Takes note</u> of the summary findings of the IOS/BSP evaluation on results reporting as reflected in document 194 EX/4 Part I (A);
- 6. <u>Welcomes</u> the proposals outlined in documents 194 EX/4 Part I (A) and 194 EX/4 Add.2 as a starting point in a consultative process with Member States;

 - (e) how the reporting cycle can support the introduction of a more strategic organization of the Executive Board agenda over the C/5 quadrennial period to allow more in-depth discussion of each major programme;

- 3. Notes, with appreciation, the progress made by the Secretariat in the implementation of the recommendations of the Ad Hoc Working Group on the Independent External Evaluation of UNESCO (IEE), and the Director-General's action plan with respect to the operational aspects of the independent external evaluation of UNESCO; as well as the efforts being made by the Director-General to achieve the 18 roadmap targets;

- 4. <u>Decides</u> to consider (out of the 22 IEE recommendations and the 11 roadmap targets that were considered as still open and ongoing in 192 EX/Decision 4 (III)), the following seven IEE recommendations and planned actions and the following three roadmap targets as contained in document 194 EX/4.INF as completed in terms of IEE and roadmap follow-up and monitoring, given that necessary actions have been carried out, recommended change processes have been fully integrated into the regular systemic practices, or are an integral part of the ongoing reform and restructuring processes of the Organization: SD2 (i) (k) (o); SD 3 (b); SD4 (aa); SD 5 (b) (f), and roadmap targets 4, 11 and 18;
- 5. <u>Invites</u> the Director-General to continue implementing the recommendations and planned actions of all reform processes and initiatives that were put in place in the framework of the IEE follow-up and the roadmap;
- 6. Requests the Director-General to conclude the specific reporting on the IEE follow-up and roadmap and to report on the remaining fifteen IEE action items SD1 (f) (g) (j) (l) (m) (n); SD2 (e) (g) (p); SD 3 (d); SD4 (g) (t) (v) (y) (z) and the eight roadmap targets 5, 6, 7, 13, 14, 15, 16, and 17 that are considered as still ongoing and open and the related reform processes through the Director-General's EX/4 reports and other relevant Board documents or progress reports on specific matters.

- 6. <u>Requests</u> the Director-General to ensure an appropriate alternative mechanism that would carry out the functions initially foreseen for the regional support platform;
- 7. <u>Also requests</u> the Director-General to ensure the deployment of adequate human resources to field offices in Africa and to provide to it, at its 195th session, details, for each field office in Africa, on the number and functions of staff;
- 8. <u>Further requests</u> the Director-General to report to it at its 196th session on the sustainability of the current field network under the \$507 million expenditure plan, and

- on the programme delivery capacities of the field offices within their respective available financial and human resources, as well as on the decentralization of programme resources from the programme sectors;
- 9. Requests the Director-General to ensure, ideally by its 195th session, but no later than the end of 2014, that all directors of field offices have signed performance agreements with clear objectives and targets, with consistent associated indicators.

PROGRAMME AND EXTERNAL RELATIONS COMMISSION (PX)

Item 5 Follow-up to decisions and resolutions adopted by the Executive Board and the General Conference at their previous sessions – Part I, *Programme Issues* – Implementation of 37 C/Resolution 44 and 192 EX/Dec.5 (I, D) relating to the Ascent to the Mughrabi Gate in the Old City of Jerusalem

DRAFT DECISION

Submitted by: Algeria, Egypt, Kuwait, Morocco, Tunisia and United Arab Emirates

The Executive Board adopted this decision upon a recommendation made by consensus by the Programme and External Relations Commission (PX).

- 1. <u>Having considered</u> the report of the Director-General (194 EX/5 Part I (C)),
- 2. Recalling the relevant provisions on the protection of cultural heritage, including the four Geneva Conventions (1949), the relevant provisions of the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict of 1954 and its protocols, the Conventions for the Protection of the World Cultural and Natural Heritage 1972, the inscription of the Old City of Jerusalem and its Walls at the request of Jordan on the World Heritage List (1981) and the List of World Heritage in Danger (1982), and the recommendations, resolutions and decisions of UNESCO,
- 3. Also recalling previous UNESCO decisions relating to the Ascent to the Mughrabi Gate in the Old City of Jerusalem, including 180 EX/Decision 5 (II), 189 EX/Decision 5 (II), 191 EX/Decision 5(I), 192 EX/Decision 5 (I.D) and decision 37 COM 7A.26 of the World Heritage Committee (Phnom Penh, 2013),
- 4. <u>Taking note of</u> the 12th Reinforced Monitoring Report and of all previous reports, together with their addenda prepared by the World Heritage Centre,
- 5. <u>Deplores</u> the fact that neither the reactive monitoring mission to the Old City of Jerusalem and its Walls nor the meeting of experts on the Mughrabi Ascent have taken place despite the relevant Executive Board and World Heritage Committee (WHC) decisions: 189 EX/Decision 5(II), 189 EX/Decision 8, 191 EX/Decision 5 (I), 192 EX/Decision 5 (I.D), 191 EX/Decision 9 and WHC decision 34 COM 7A.20 (Brasilia consensus decision), and <u>urges</u> Israel to honour its commitments to implement the aforementioned decisions;
- 6. Recognizes the concerns raised, in this regard, about the decision by the Jerusalem District Planning and Construction Commission on the town planning scheme for the Mughrabi Ascent, and the subsequent decision by Israel's National Council for Planning and Construction to adopt "an alternative plan for the Mughrabi Ascent", approved on 31 October 2010 by the aforementioned Commission;
- 7. Requests that, despite the decisions mentioned in paragraph 6 of this decision, the process for the design of the Mughrabi Ascent be inclusive of and accepted by all parties, in accordance with the obligations and duties of such parties as stipulated in the content of the conventions mentioned in paragraph 2 of this decision and in previous World Heritage Committee decisions.
- 8. Affirms, in this regard, that the UNESCO process for the follow-up of the design of the Mughrabi Ascent, which is aimed at finding an accepted and monitored solution concerning the Mughrabi Ascent, be coordinated among all parties concerned, in accordance with the spirit and content of previous World Heritage Committee decisions, recognizes the concerns raised regarding Israel's submission and the content of its plan for the Mughrabi Ascent referred to in paragraph 6 of this decision, and requests that the World Heritage Centre be proactive and follow closely, in the context of the Reinforced Monitoring Mechanism, the developments associated with this process and the evaluation of the Jordanian design received;
- 9. Reaffirms in this regard that no measures, unilateral or otherwise, shall be taken which affect the authenticity, integrity and cultural heritage of the site, in accordance with the Convention for the Protection of the World Cultural and Natural Heritage of 1972, and the relevant provisions on the protection of cultural heritage of the Hague Convention for the Protection of Cultural Property in the Event of Armed Conflict of 1954 and the relevant decisions of UNESCO's Executive Board and World Heritage Committee referred to above;
- 10. <u>Reiterates</u> its thanks to Jordan for its cooperation, <u>urges</u> Israel to cooperate with Jordanian Awqaf Department in accordance with the relevant provisions of UNESCO Conventions for the protection of cultural heritage referred to above, and <u>calls</u> on Israel to facilitate access of Jordanian Awqaf experts with their tools and material to the site;
- 11. <u>Expresses</u> its concern regarding the continuous, intrusive Israeli archaeological demolitions, excavations and works in and around the Ascent to the Mughrabi Gate despite World Heritage Committee decisions 36 COM 7A.23 and 37 COM 7A.26, and requests the Israeli authorities to end

such excavations and works in conformity with this decision and the relevant UNESCO conventions for the protection of cultural heritage;

- 12. <u>Deplores</u> the recent construction by Israel of a platform in the Burāq (Western Wall) Plaza, in violation of its obligations under the conventions referred to above, and <u>requests</u> Israel to remove the structure built, immediately restore the site to its original character, and refrain from taking any further unilateral steps which jeopardize the site, and its integrity and authenticity;
- 13. <u>Expresses</u> its concern regarding the Israeli authorities' admittance of provocative religious-extremist groups and uniformed forces into the al-Aqsà Mosque compound (also known as the al-Ḥaram ash-Sharīf compound) through the Mughrabi Gate, and <u>regrets</u> the systematic violations of the sanctity of the compound and the continued interruption of the freedom of worship therein;

The Executive Board adopted this decision upon a recommendation made by consensus by the Programme and External Relations Commission (PX).

- 3. Also recalling 185 EX/Decision 37,
- 4. <u>Noting with deep concern</u> the slow progress in the reconstruction of schools and other cultural heritage sites in the Gaza Strip that were damaged during the 2008-2009 war and the November 2012 war.
- 5. <u>Deeply regrets</u> the damaging impact of the November 2012 war on UNESCO fields of competence in Gaza, where 280 education facilities were damaged, affecting approximately 250,000 students, as reported in document 191 EX/35, as well as the severe damage inflicted to one cultural heritage site of the Palestinian Tentative List, the Port of Anthedon (the old port of Gaza);
- 6. <u>Affirms</u>, in this regard, that schools, universities and cultural heritage sites should not be involved and/or targeted in military conflicts;
- 7. <u>Deplores</u> the continuous Israeli blockade of the Gaza Strip, which harmfully affects the free and sustained movement of personnel and humanitarian relief items for the successful implementation of UNESCO reconstruction projects, as well as the injury of children, the attacks on schools, and the denial of access to education, as reflected in document 190 EX/39;
- 8. <u>Thanks</u> Member States and donors for their generous financial contributions to the UNESCO projects for Gaza, and <u>invites</u> Member States, international organizations and relevant international, national and private institutions to provide further assistance in this regard through extrabudgetary funding;
- 9. <u>Thanks</u> the Director-General for initiatives that have already been implemented in the field of education, and for the safety of media professionals, and <u>calls upon</u> her to continue her involvement actively in the reconstruction of its damaged educational and cultural heritage components;
- 10. Requests the Director-General to organize an information meeting to provide Member States with an update on the outcome of the projects conducted in the Gaza Strip-Palestine;

Recalling the UNESCO Universal Declaration on Cultural Diversity of 2 November 2001, which highlights the importance of "encouraging linguistic diversity [...] at all levels of education, wherever possible, and fostering the learning of several languages from the earliest age" as well as "promoting through education an awareness of the positive value of cultural diversity and improving to this end both curriculum design and teacher education",

- 4. <u>Also recalling</u> the Convention on the Protection and Promotion of the Diversity of Cultural Expressions of 20 October 2005, which states that "linguistic diversity is a fundamental element of cultural diversity", and reaffirms "the fundamental role that education plays in the protection and promotion of cultural expressions",
- 5. <u>Further recalling</u> 30 C/Resolution 12 "Implementation of a language policy for the world based on multilingualism", and <u>taking into consideration</u> the specific mission that has been entrusted to UNESCO, within the United Nations system, of fostering peace, economic, cultural and individual development through cooperation, education and the promotion of cultural and linguistic pluralism, <u>reaffirms</u> the following principles:
 - (a) Linguistic diversity is a common good of humankind; it falls primarily to education to provide the broadest possible access to several languages;
 - (b) Learning and mastering several languages develops intercultural understanding and the spirit of tolerance; this contributes to the economic, social and cultural development of societies by promoting exchanges, cooperation and international mobility, which should be made available to all categories of the population, especially the younger generations;
- 6. <u>Calls</u> for additional efforts to implement educational policies promoting multilingualism by diversifying and raising awareness of the range of languages taught in appropriate educational establishments, encouraging both children and parents to learn several languages, and enhancing students' language skills;
- 7. <u>Encourages</u> Member States to take appropriate steps to promote the teaching of mother-tongue languages;
- 8. <u>Invites</u> Member States to endeavour to promote the teaching of at least two languages in addition to the main language of instruction within their respective educational systems;
- Also encourages Member States to work to improve the quality of language teaching, including by means of training language teachers, developing teaching materials, promoting exchanges between the education systems of different States, and encouraging the use of digital technologies in the training of language teachers and students;
- Also invites Member States to endeavour to further develop existing indicators for the measurement, certification and mutual recognition of language levels, in order to facilitate educational and professional mobility, particularly among younger generations;
- 11. <u>Further encourages</u> Member States to promote the safeguarding and enhancement of their linguistic heritage by promoting the teaching and the use of indigenous languages, where they exist.

The role of foresight and evaluation in UNESCO's new programmatic and strategic context (194 EX/30 and Add.; 194 EX/DG.INF; 194 EX/36)

The Executive Board,

1. <u>Acknowledging</u> the new programming cycle (four years instead of two) and strategic cycle (eight years instead of six), which started with document 37 C/5 for the period 2014-2017 and with document 37 C/4 for the period 2014-2021, and which make it

- imperative to establish more regular and systematic evaluations to better anticipate challenges for the Organization,
- 2. Recalling that, in its synthesis report (document 185 EX/18) and its full evaluation report (document 185 EX/18 Add.), the independent external evaluation team recommended a renewal strategy built on five strategic directions: (1) increasing UNESCO's focus; (2) positioning UNESCO closer to the field; (3) strengthening participation in the United Nations; (4) strengthening governance; and (5) developing a partnership strategy,
- 3. <u>Noting</u> that the prioritization of UNESCO's programme activities, decided at its 5th special session (see 5 X/EX/Decisions) and adopted at the 37th session of the General Conference, requires UNESCO to be more proactive and more attuned to the problems emerging worldwide in its fields of competence,
- 4. Reaffirming the need for UNESCO to contribute to the preparation, elaboration and implementation of the post-2015 development agenda, and to strengthen its leadership role in its fields of competence (see *inter alia* documents 37 C/56, 37 C/64, 191 EX/6, 192 EX/8, 194 EX/6 and 194 EX/14),
- 5. Recognizing the need to strengthen organizational capacity in programme evaluation and strategic foresight in order to:
 - (a) support Member States in improving their capacity to respond to emerging and future global challenges and risks in the Organization's fields of competence;
 - (b) better adapt UNESCO's activities to current, emerging and future challenges;
 - (c) renew the Organization's programmes, whether to enable them to evolve or to terminate those whose continuation is no longer justified;
 - (d) improve accountability;
 - (e) be constantly flexible, creative, innovative, proactive and responsive in programme planning and implementation,
- 6. Requests the Director-General to take adequate measures to ensure the integration of foresight and evaluation in the assistance provided to Member States in capacity-building for policy formulation, review and reforms in the fields of competence of the Organization;
- 7. <u>Also requests</u> the Director-General to provide to it at its 195th session an analytical assessment of the situation, together with recommendations concerning the links between strategy, programming, evaluation and foresight which should form an integral part of the proposed new format and cycle of regular reporting on programme implementation, and which addresses, among other things, the following points:
 - (a) the role of foresight and evaluation in positioning UNESCO closer to the field and strengthening the capacities of the Member States to meet the new global challenges in its fields of competence;
 - (b) the role of foresight and evaluation in improving results-based budgeting (RBB) and results-based management (RBM);
 - (c) integration of the results of foresight and evaluation into the activity reports (EX/4 and C/3 documents);

(d) the role of foresight in UNESCO's contribution to the formulation of the post-2015 agendas.

- 2. <u>Bearing in mind</u> that the year 2015 will be a landmark in the history of the Organization, coinciding with events which are crucial for the values that it holds, in particular, the adoption of the United Nations post-2015 development agenda in all its aspects, and other major events with which UNESCO will be associated in 2015,
- 3. <u>Stressing</u> the need to prepare UNESCO fully to mark these events and contribute to the respective processes in the most effective manner,
- 4. Recalling United Nations General Assembly resolutions 68/188 and 68/3,
- 5. Also recalling 190 EX/Decision 7 (I), 191 EX/Decision 6, 192 EX/Decision 8, and 37 C/Resolution 64,
- 6. <u>Having considered</u> document 194 EX/14 on UNESCO's participation in the preparations for the United Nations post-2015 development agenda,

7. Decides to:

- (a) make full use of UNESCO's wealth of expertise and of its role as an intellectual and cultural hub wielding immense potential in addressing global contemporary challenges in the areas covered by its mandate, and accordingly to organize in 2014 and 2015 a series of events and debates within the framework of the initiative entitled "UNESCO: Future Prospects", with the participation of eminent personalities and high officials of national and international bodies and agencies, with a view to enriching UNESCO's contribution to the events mentioned in paragraph 2 above;
- entrust its Chair, in consultation with the President of the General Conference and the Director-General, with the organization of this series of events and debates;
- 8. <u>Decides further</u> that these events shall be financed from extrabudgetary sources;
- 9. <u>Invites</u> all Member States and all UNESCO partners to contribute to this process;
- 10. <u>Also invites</u> its Chair to present the main ideas and conclusions of the various events to the General Conference at its 38th session.

Celebration of the 70th anniversary of UNESCO

The Executive Board,

Follow-up by UNESCO of the situation in the Autonomous Republic of Crimea (Ukraine)⁸ (194 EX/32; 194 EX/35)

The Executive Board,

- 1. <u>Mindful</u> of the fundamental principles of UNESCO contained in the preamble to its Constitution and in all relevant human rights instruments,
- Reaffirming UNESCO's essential role in ensuring education for all, in protecting the cultural, historical and natural heritage of humanity, and in facilitating the free flow of ideas,
- 3. Recalling United Nations General Assembly resolution 68/262 of 27 March 2014.

Absent: Gambia, Malawi, Mali, Morocco, Turkmenistan, United Arab Emirates.

The Executive Board adopted this decision upon a recommendation made by the Programme and External Relations Commission (PX) following a roll-call vote: 28 votes in favour, 4 vote against and 20 abstentions:

In favour: Afghanistan, Albania, Austria, Belize, Chad, Czech Republic, Dominican Republic, Estonia, France, Germany, Indonesia, Italy, Japan, Mauritius, Mexico, Montenegro, Netherlands, Nigeria, Papua New Guinea, Republic of Korea, Spain, Sweden, the former Yugoslav Republic of Macedonia, Togo, Uganda, Ukraine, United Kingdom, United States of America.

Against: Brazil, China, Cuba, Russian Federation.

Abstentions: Algeria, Angola, Argentina, Bangladesh, Ecuador, Egypt, El Salvador, Ethiopia, Gabon, Guinea, India, Kuwait, Mozambique, Namibia, Nepal, Pakistan, Saint Kitts and Nevis, Thailand, Trinidad and Tobago, Tunisia.

- 4. <u>Takes note</u> of the information presented by Ukraine with regard to the situation in the Autonomous Republic of Crimea (Ukraine) in the main fields of UNESCO competence;
- 5. <u>Expresses deep concern</u> that the growing presence of Russian military forces poses serious threats to equal access to education and freedom of expression for the residents of Crimea, and places Crimea's cultural heritage in danger,
- 6. <u>Invites</u> the Director-General to follow up on the situation in Crimea in the fields of UNESCO's competence and report back to it at its 195th session on the latest developments.
